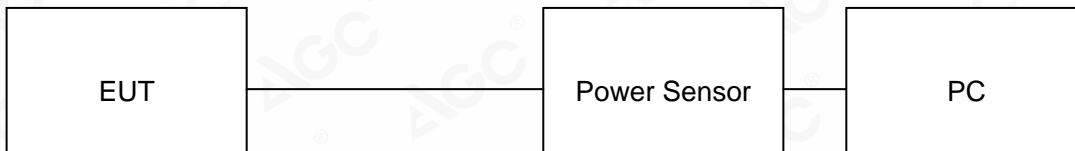

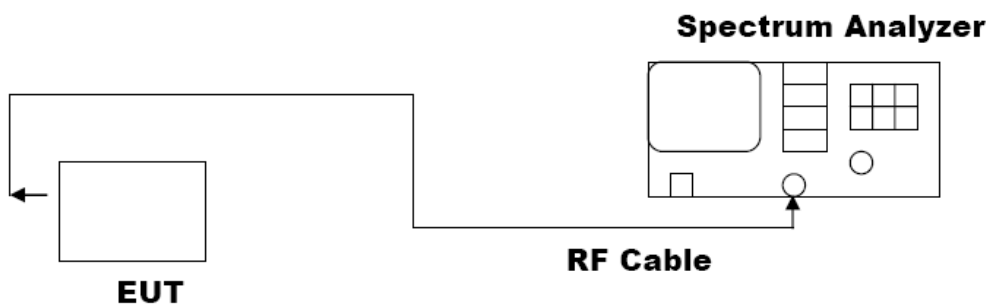

8.1. MEASUREMENT PROCEDURE

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Centre Frequency = Operation Frequency, RBW= 100 KHz, VBW \geq \times RBW.
4. Set SPA Trace 1 Max hold, then View.

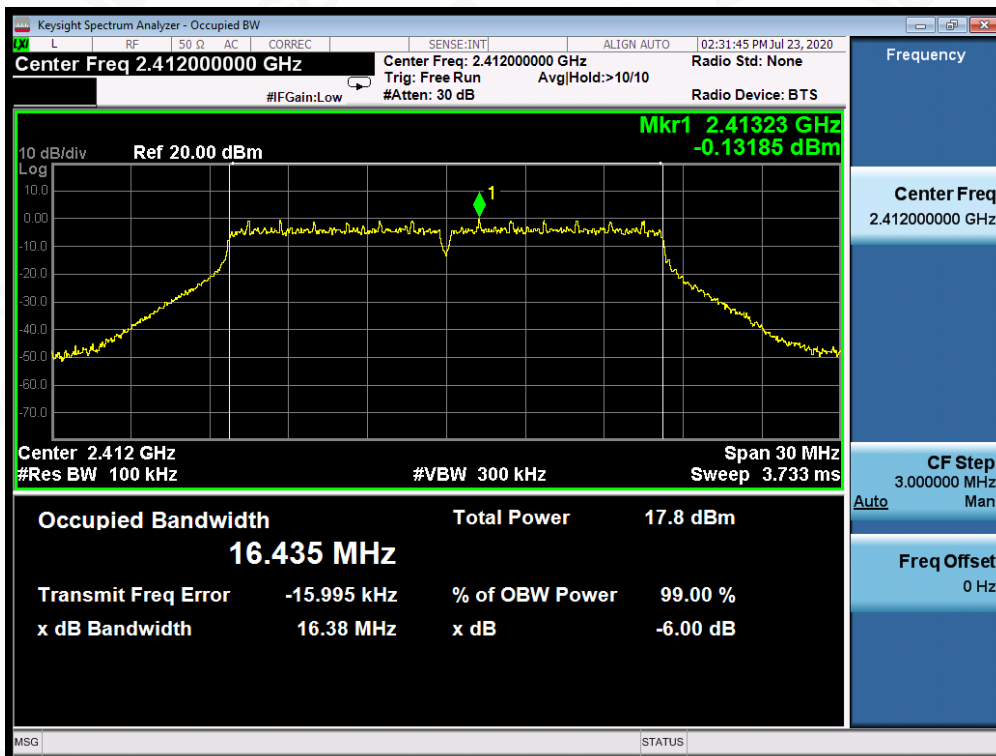


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

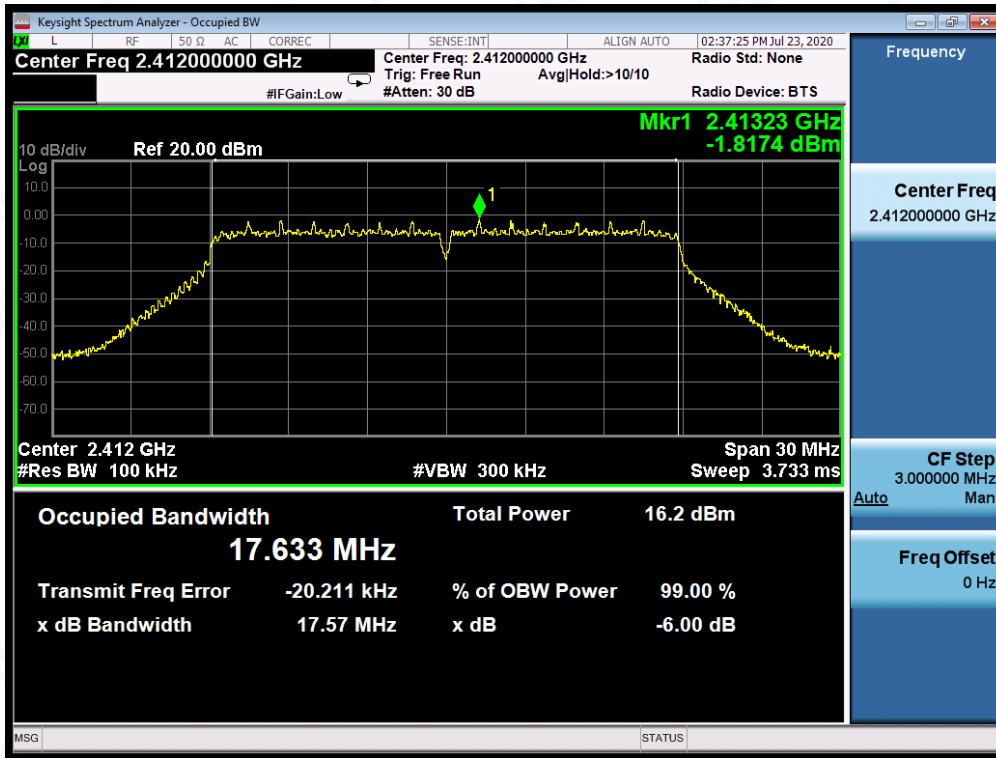

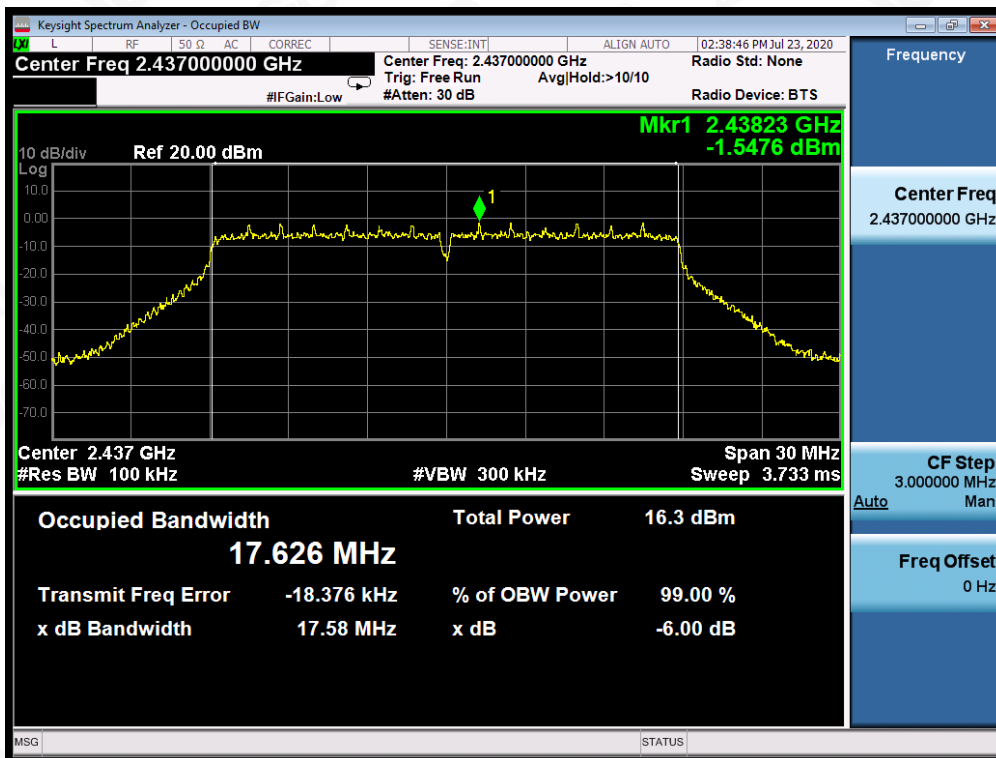

TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL

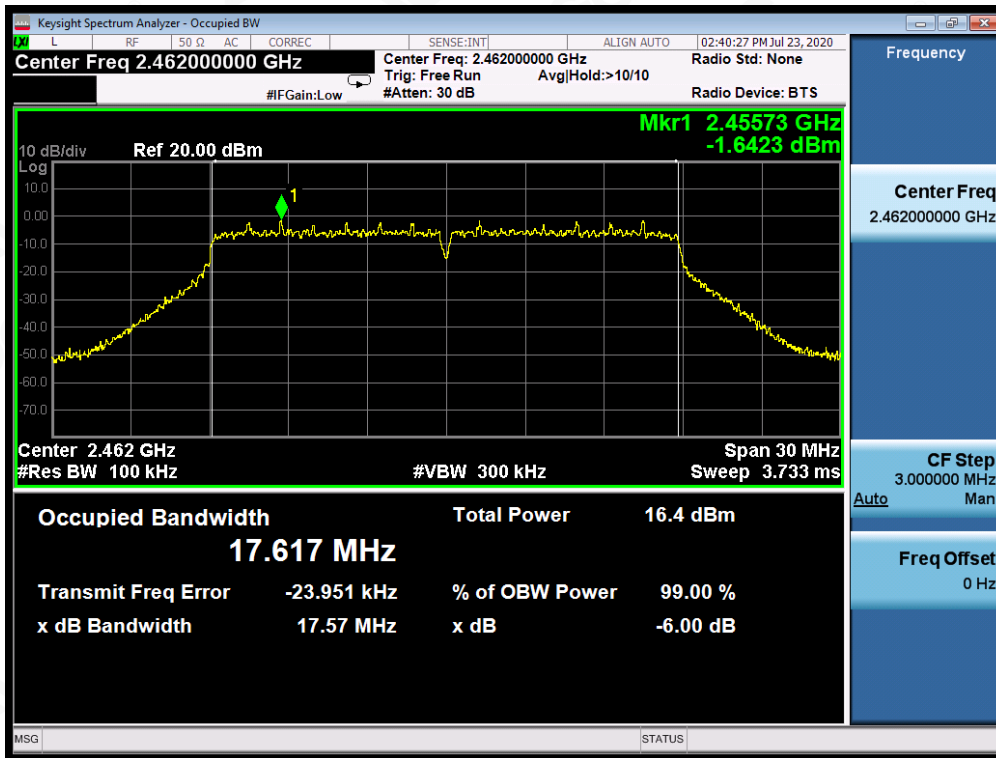

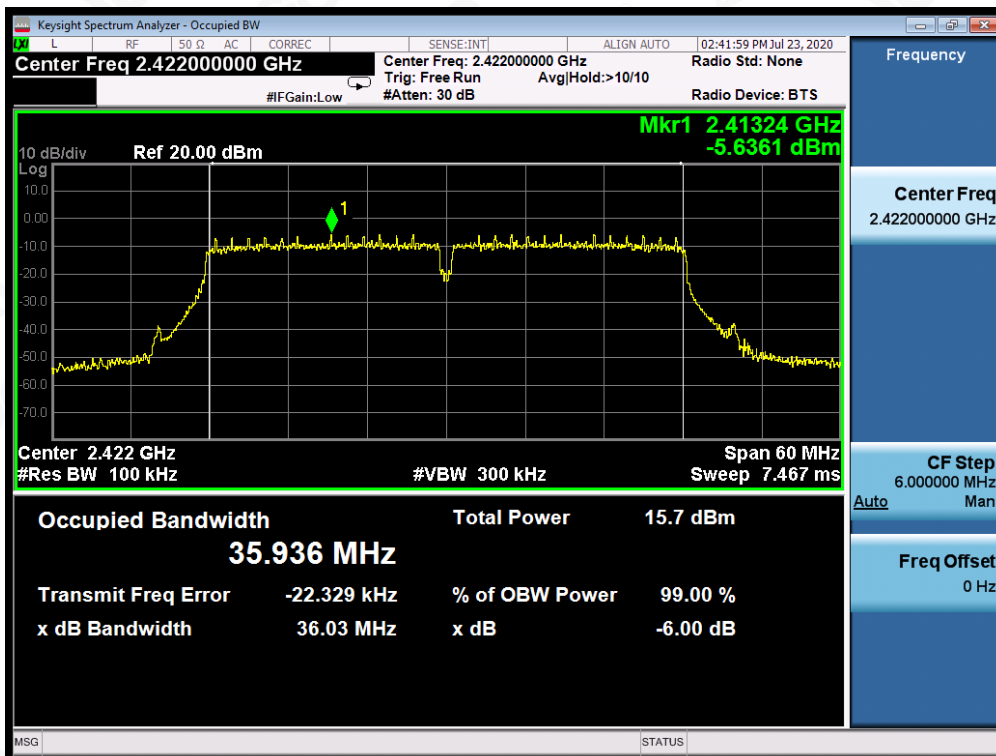


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

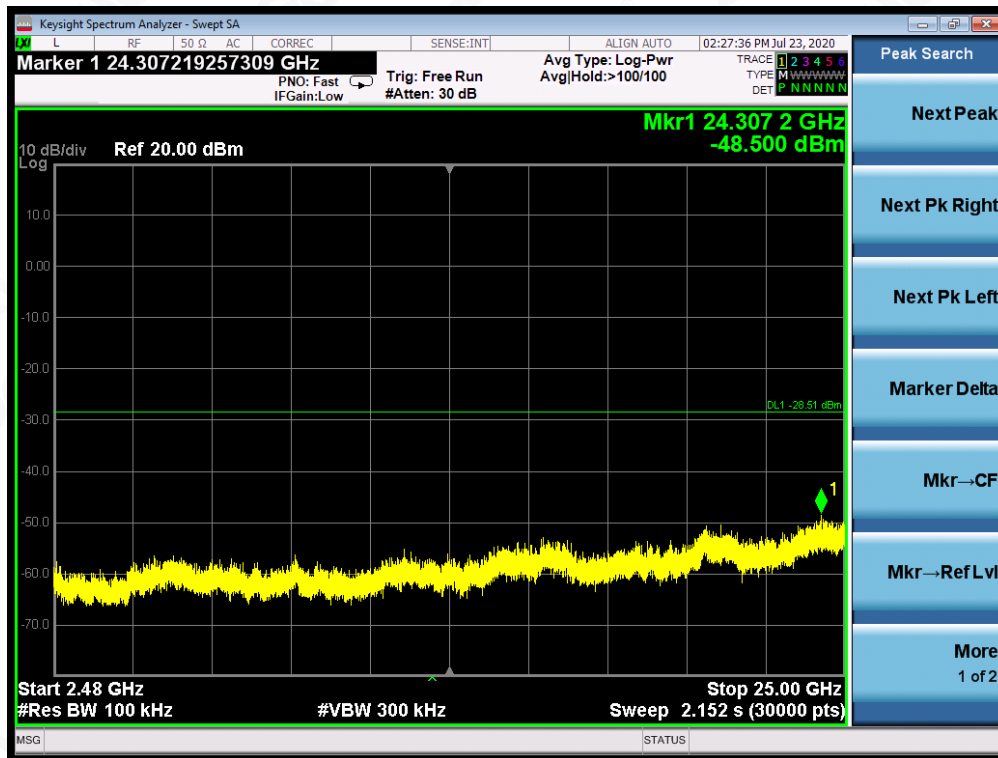
TEST PLOT OF OUT OF BAND EMISSIONS WITH THE WORST CASE
OF 802.11b FOR MODULATION IN LOW CHANNEL



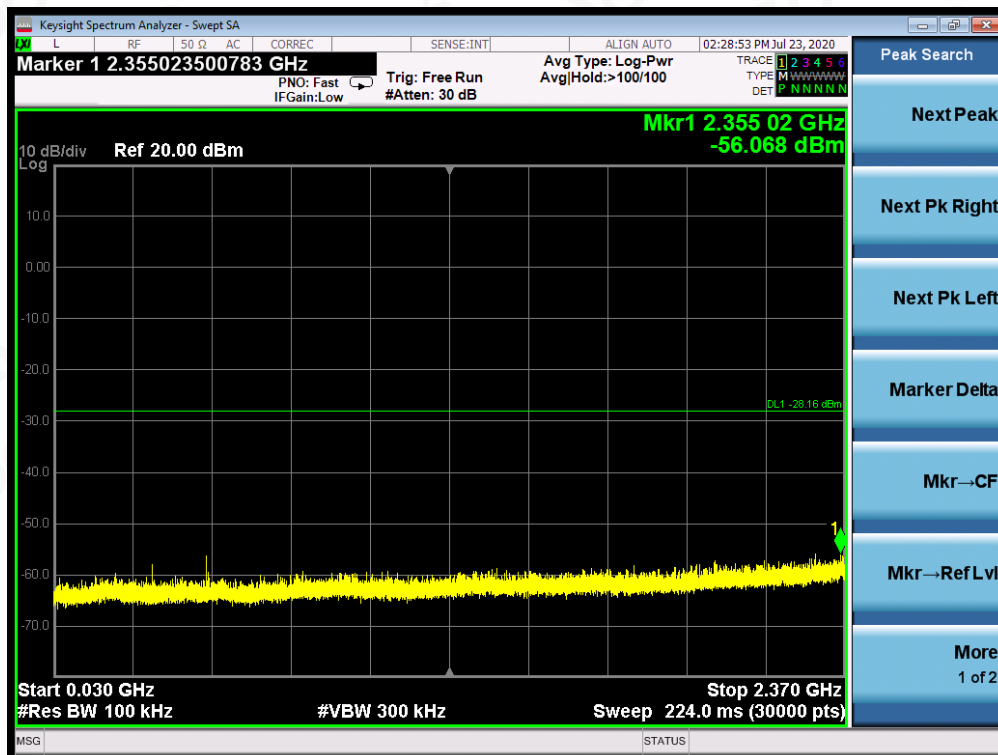
