Where

S: power density

P: power input to the antenna

G: power gain of the antenna in the direction of interest relative to an isotropic radiator.

R: distance to the center of radiation of the antenna

Simultaneous transmission MPE Considerations

According to KDB447498: All transmitters and antennas in the host must be either evaluated for MPE compliance, by measurement or computational modeling, or qualify for the standalone MPE test exclusion in section 7.1. Simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on the calculated/estimated, numerically modeled or measured field strengths or power density, is ≤ 1.0 .

This means that:

$$\sum \text{ of MPE ratios } \leq 1.0$$
