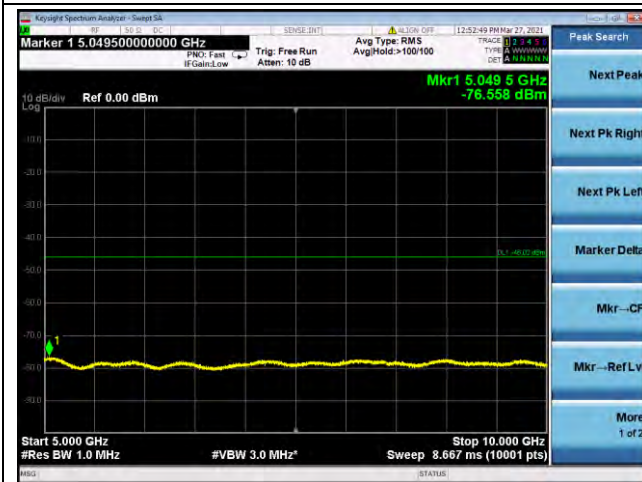
QPSK Low channel - 9kHz~3530MHz



QPSK Low channel - 3720MHz~5000MHz



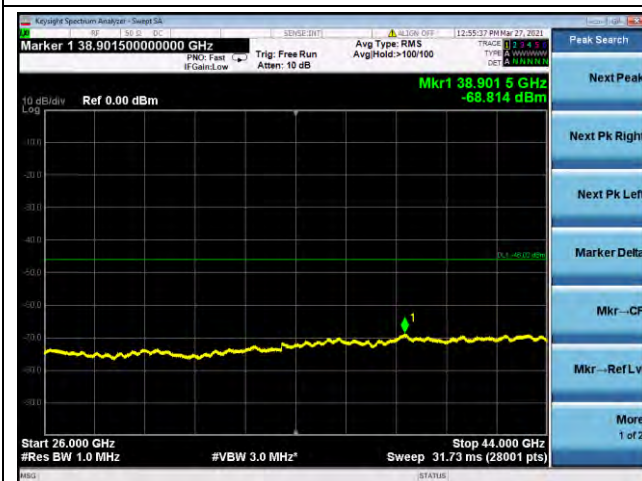
QPSK Low channel - 5GHz~10GHz



QPSK Low channel - 10GHz~26GHz

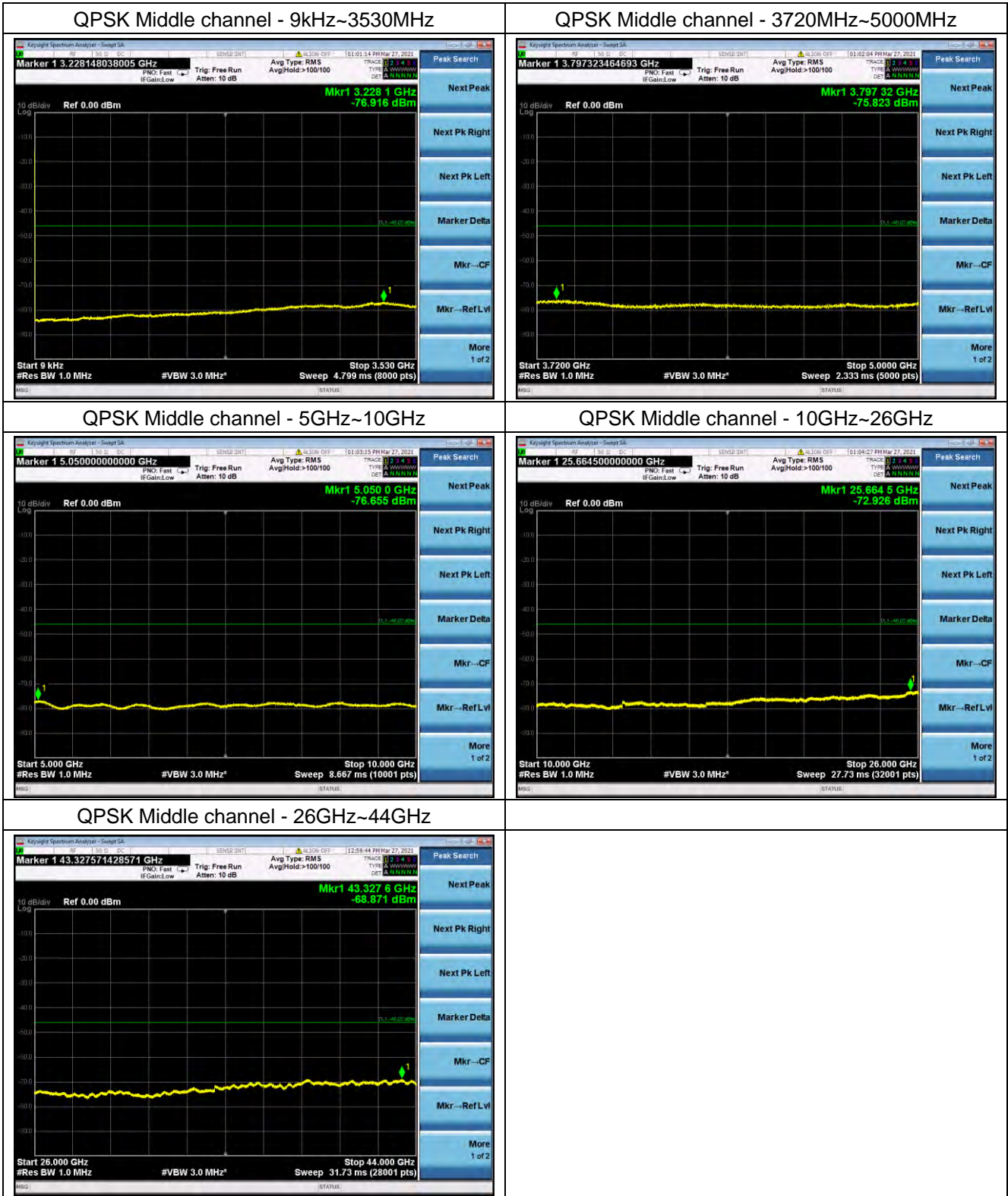


QPSK Low channel - 26GHz~44GHz





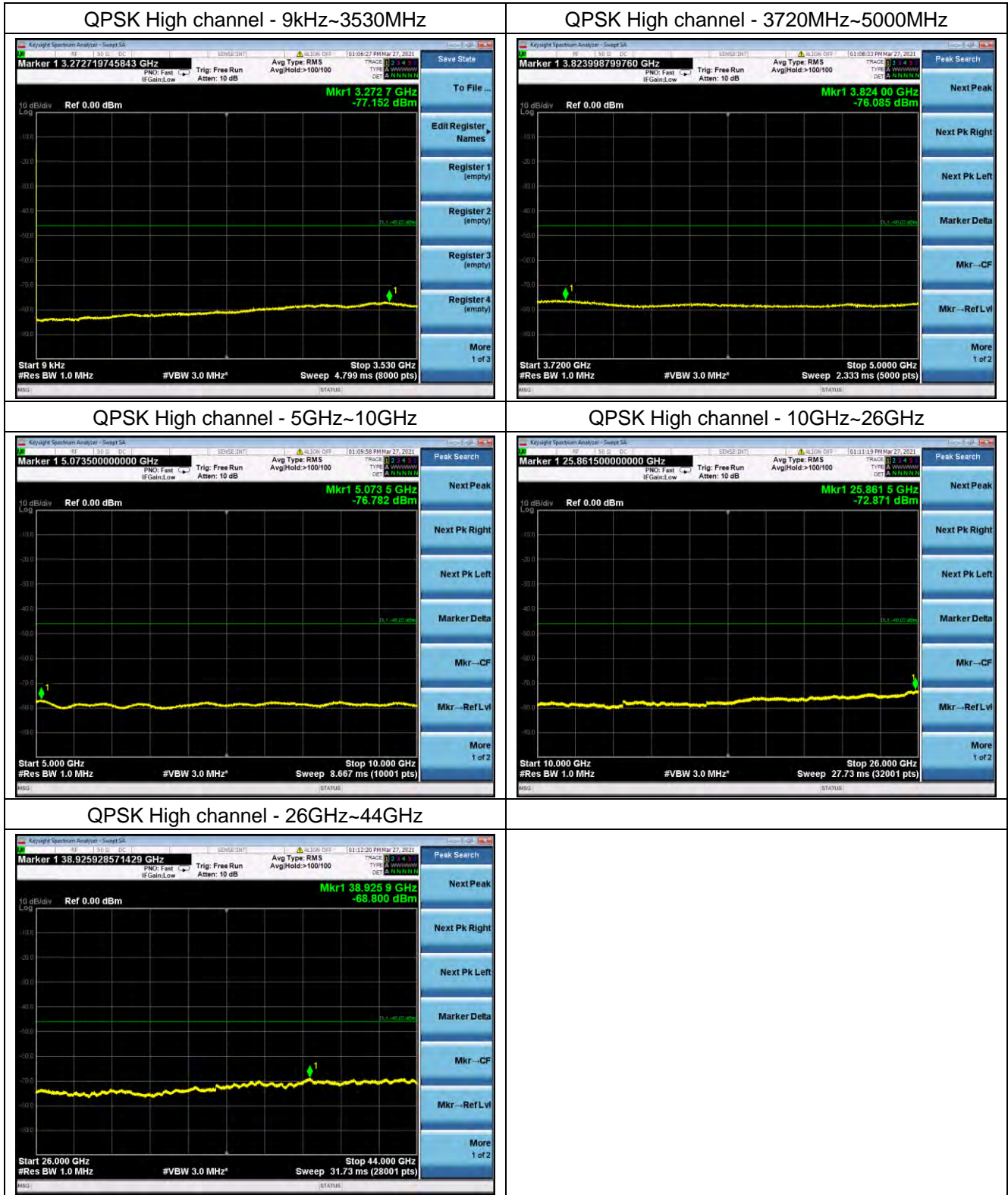

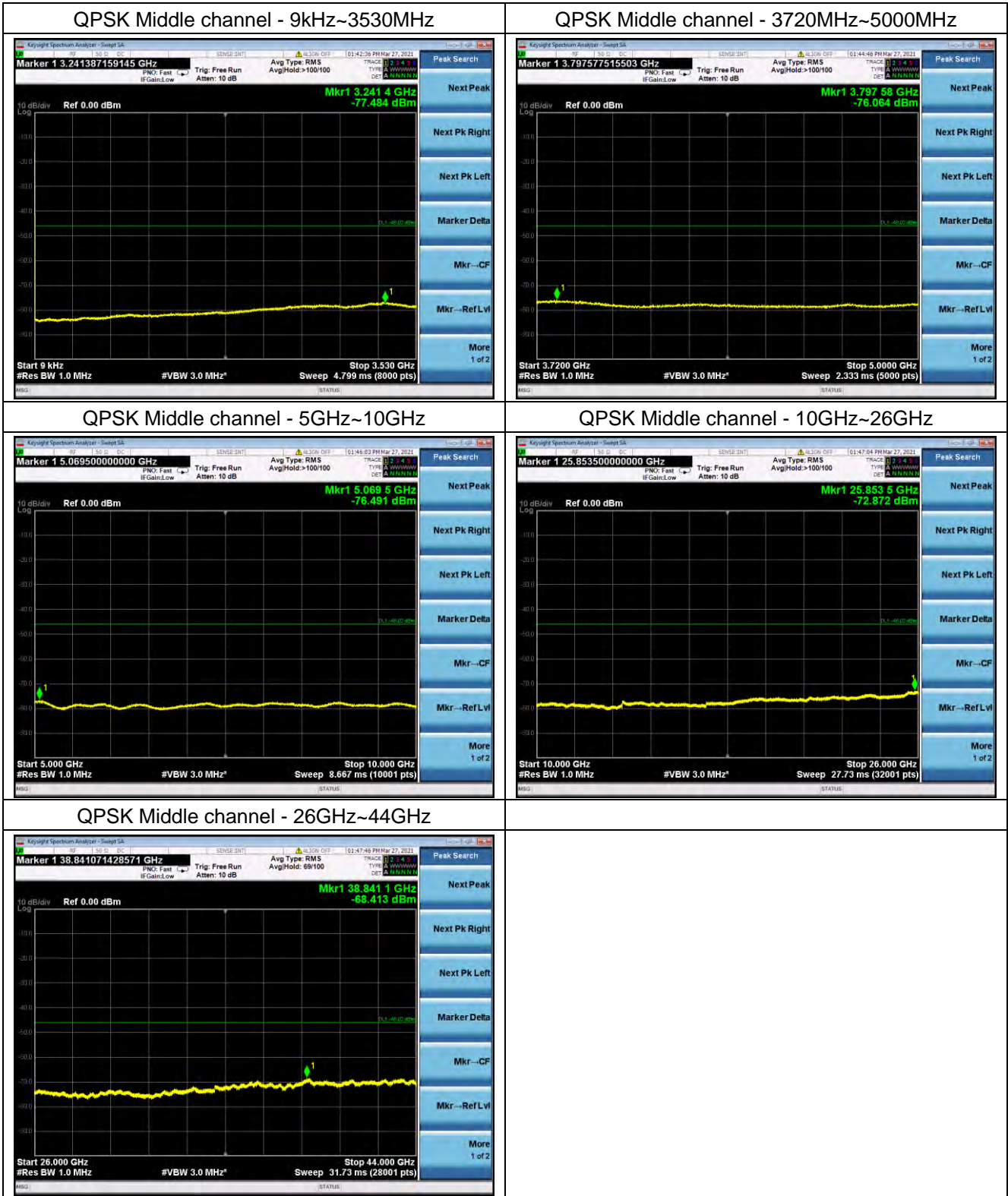


LTE TDD Band 48 Intra-band Continuous CA, Nominal Bandwidth: 20M+15M



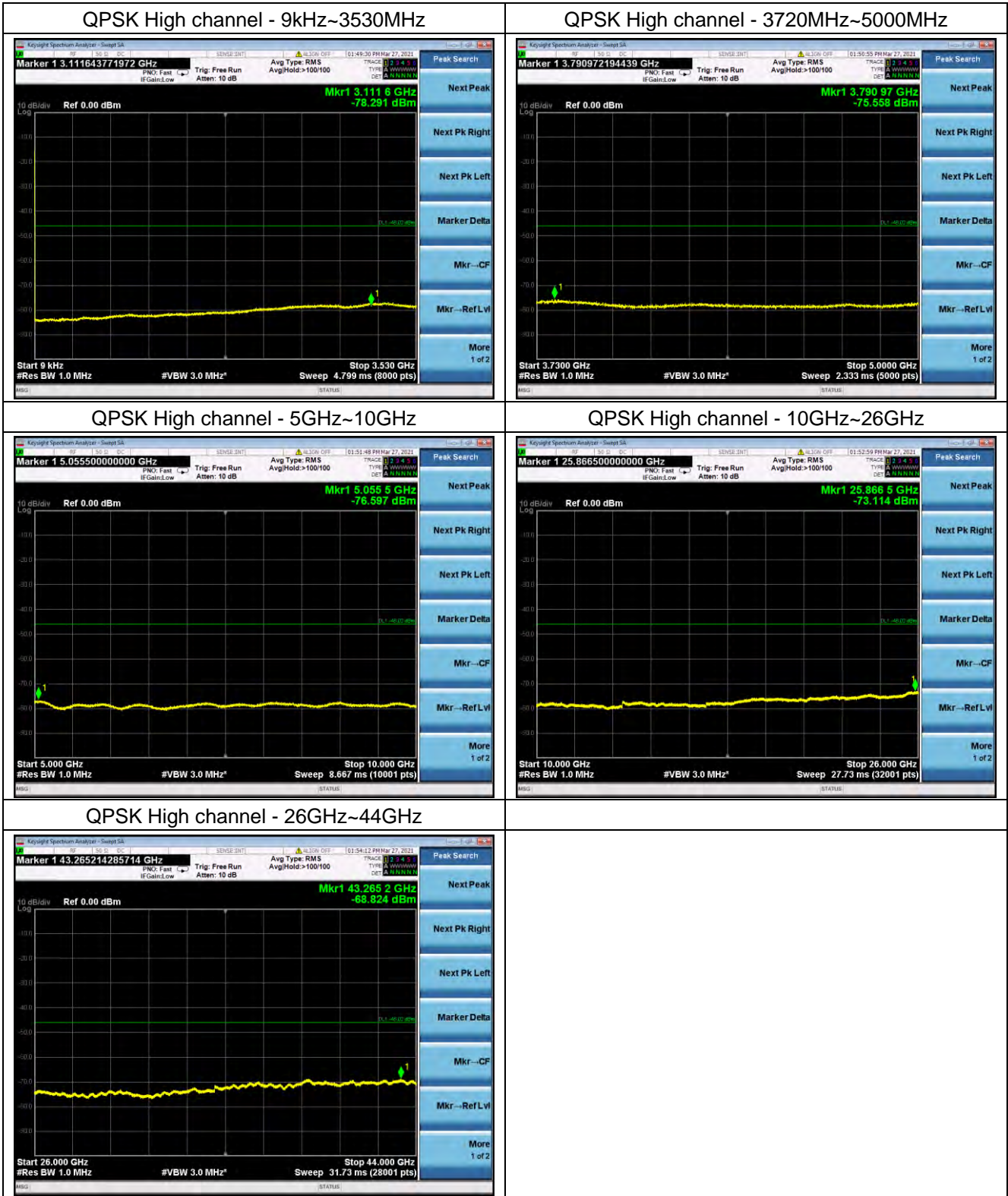

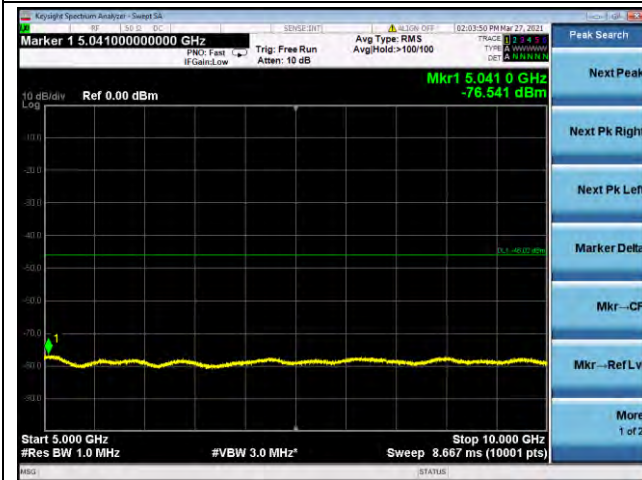
QPSK Low channel - 9kHz~3530MHz



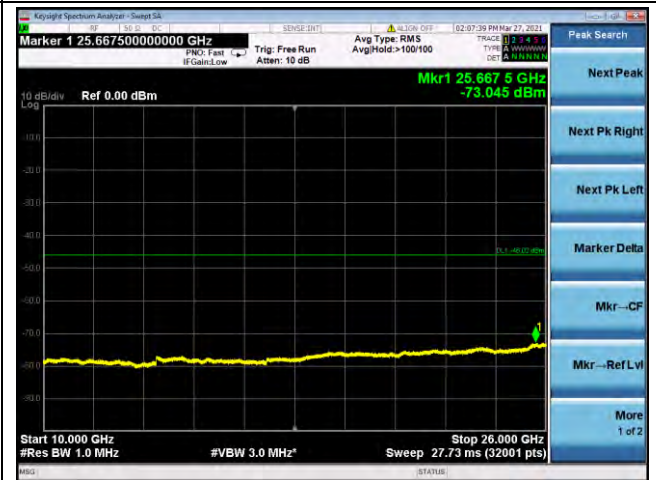
QPSK Low channel - 3720MHz~5000MHz



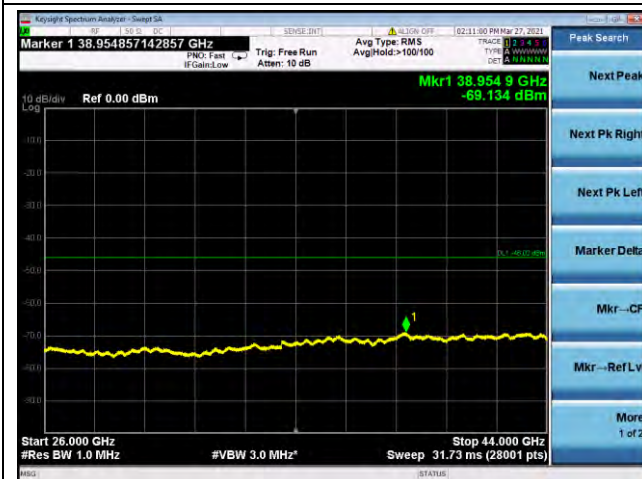
QPSK Low channel - 5GHz~10GHz
