#### Where

**Pd** = power density in mW/cm<sup>2</sup>, **Pout** = output power to antenna in mW;

**G** = gain of antenna in linear scale, **Pi** = 3.1416;

**R** = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

Remark: WIFI antenna gain=0.89dBi, 433MHz antenna gain=-0.4dBi The device could support transmission with BLE, WIFI and 433.92MHz simultaneously. Power Density at R=20cm (mW/cm2):0.0015+0.0198+0.00005=0.021 (1.0 Limit (mW/cm2), So a SAR test is not required.
