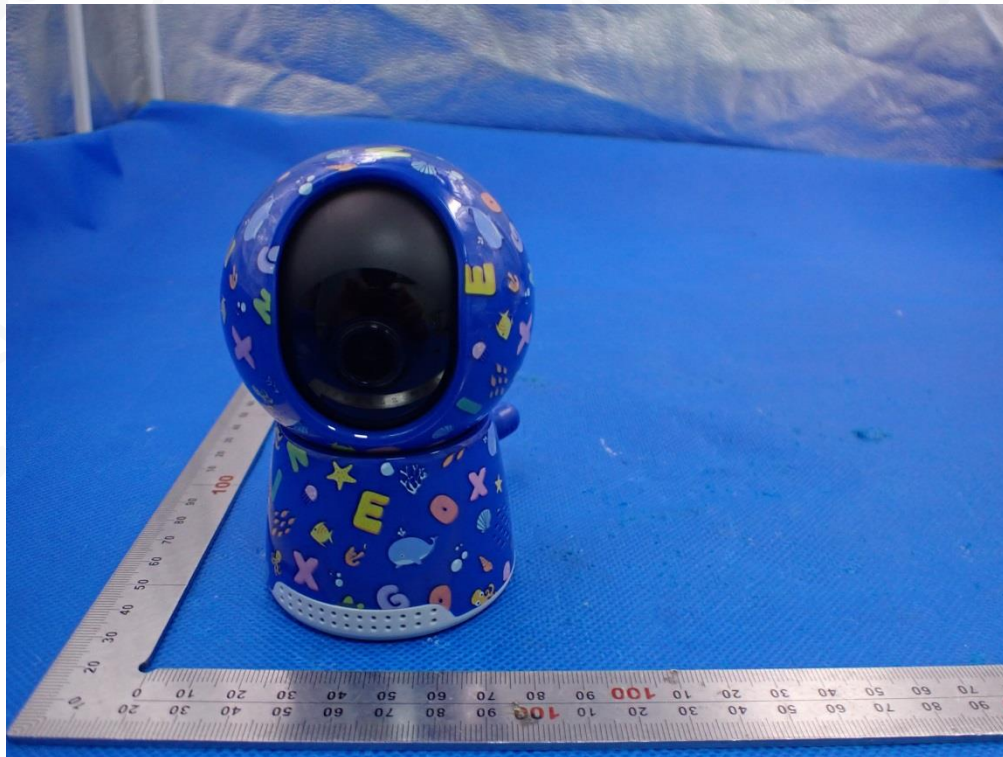

TOP VIEW OF EUT

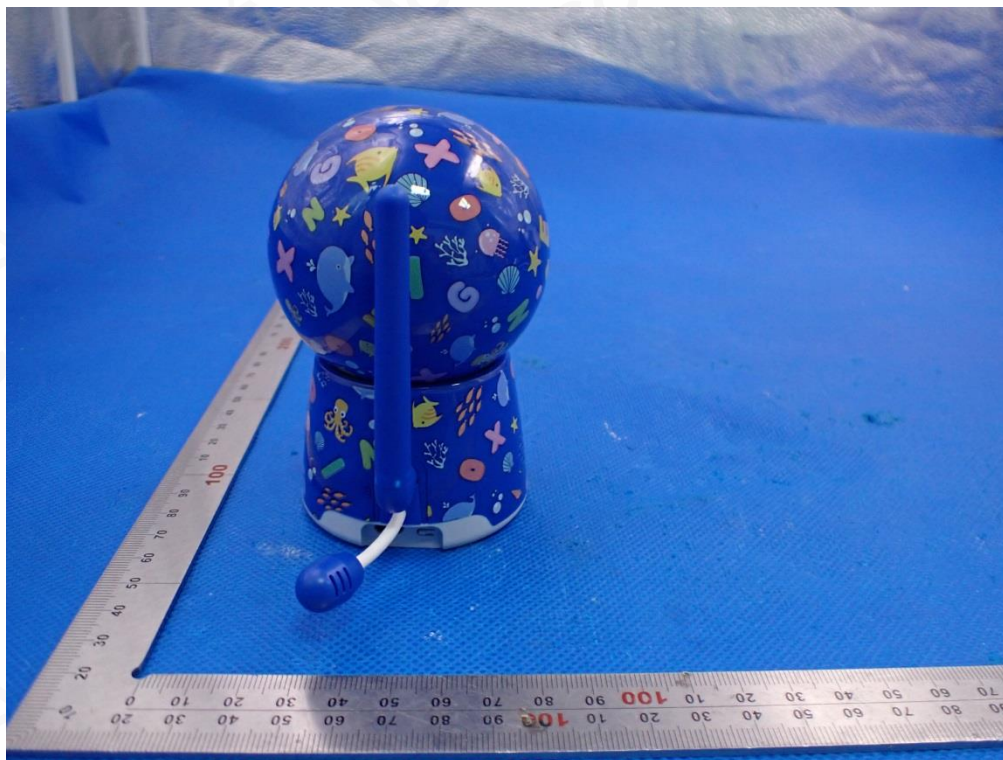

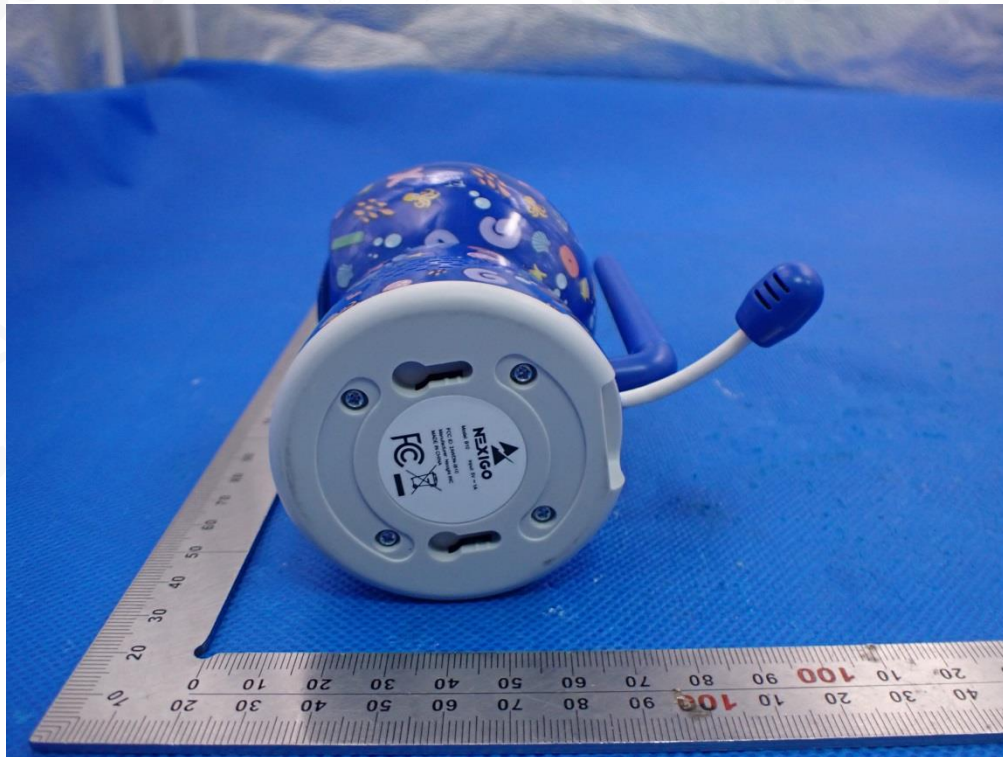

FRONT VIEW OF EUT

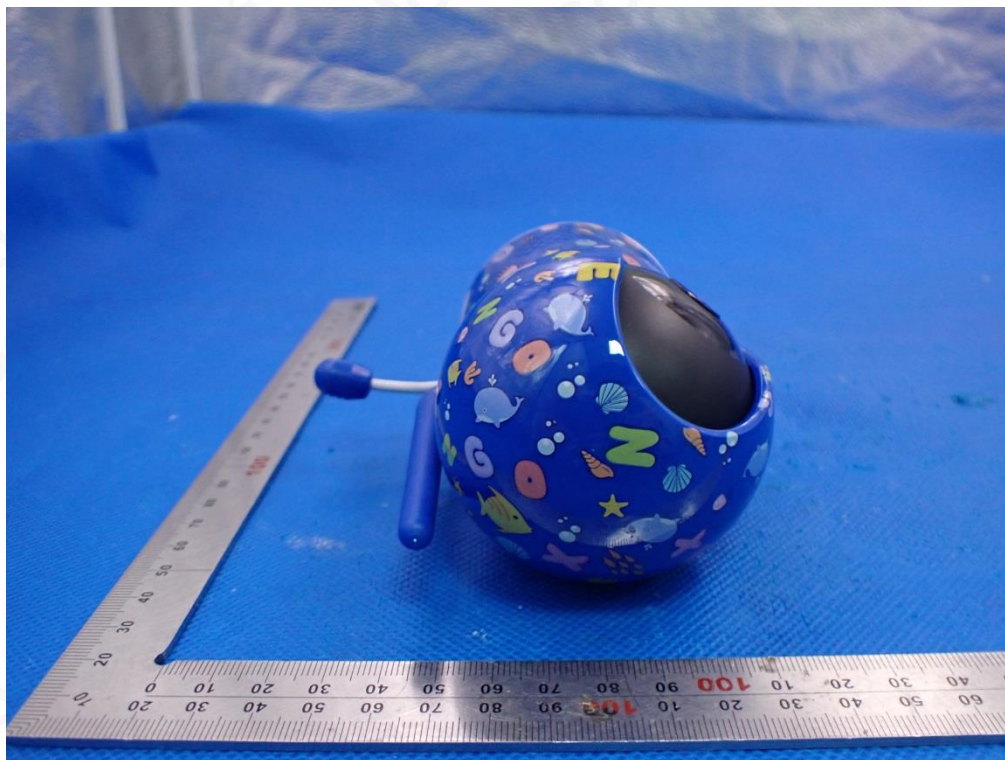

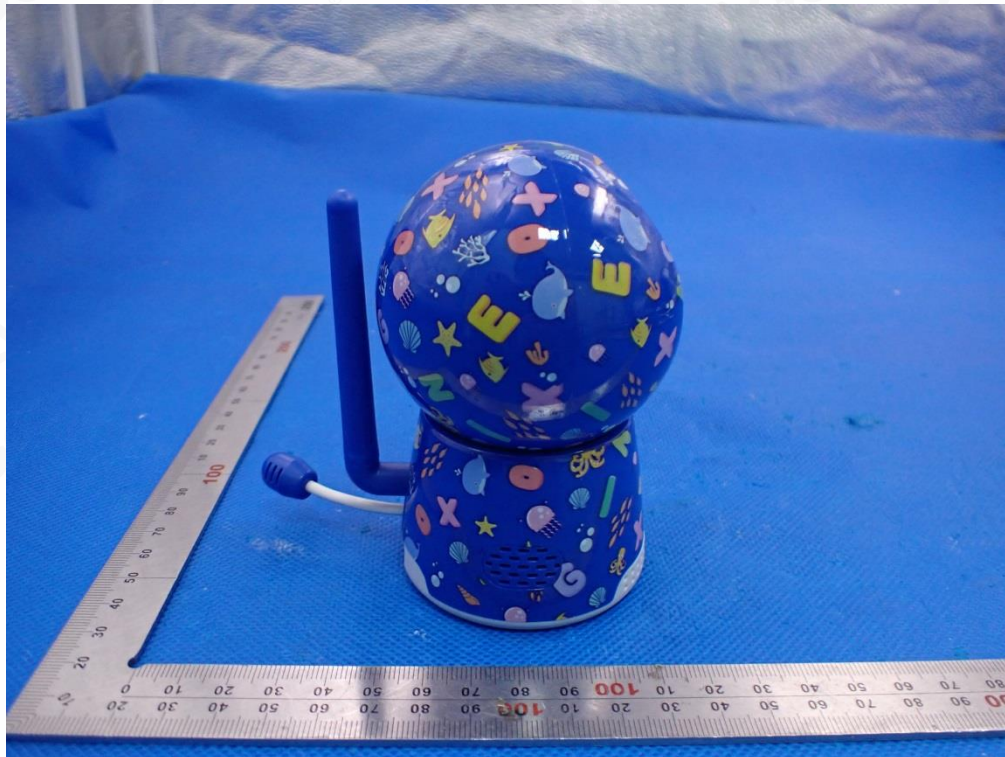

LEFT VIEW OF EUT

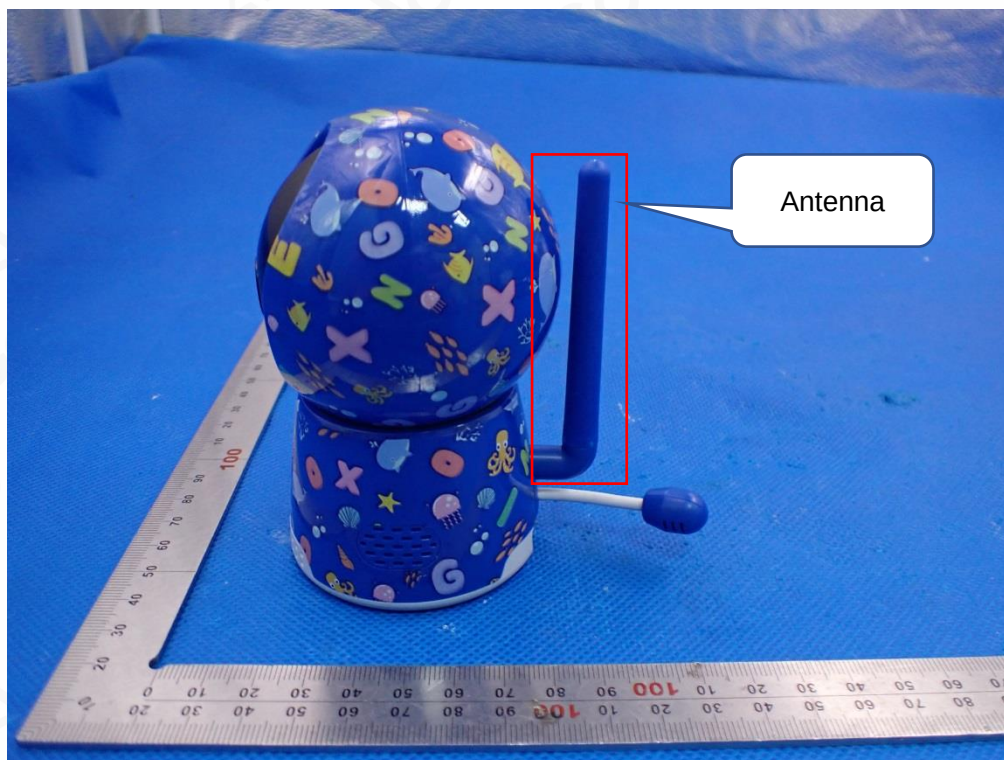

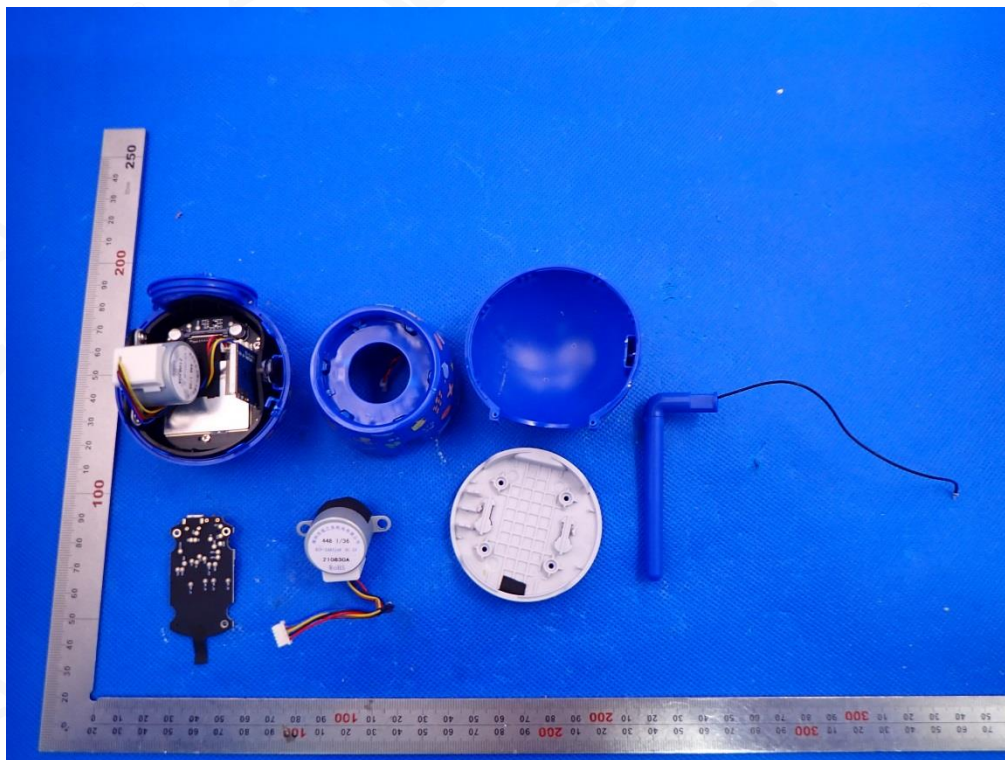

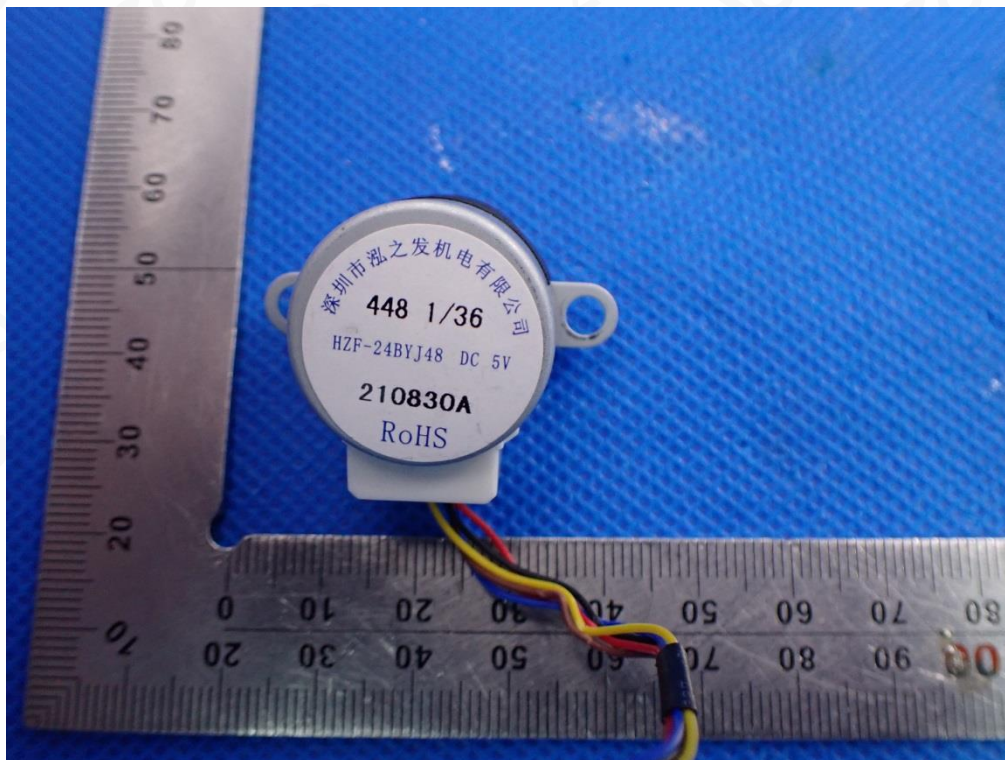

VIEW OF BATTERY

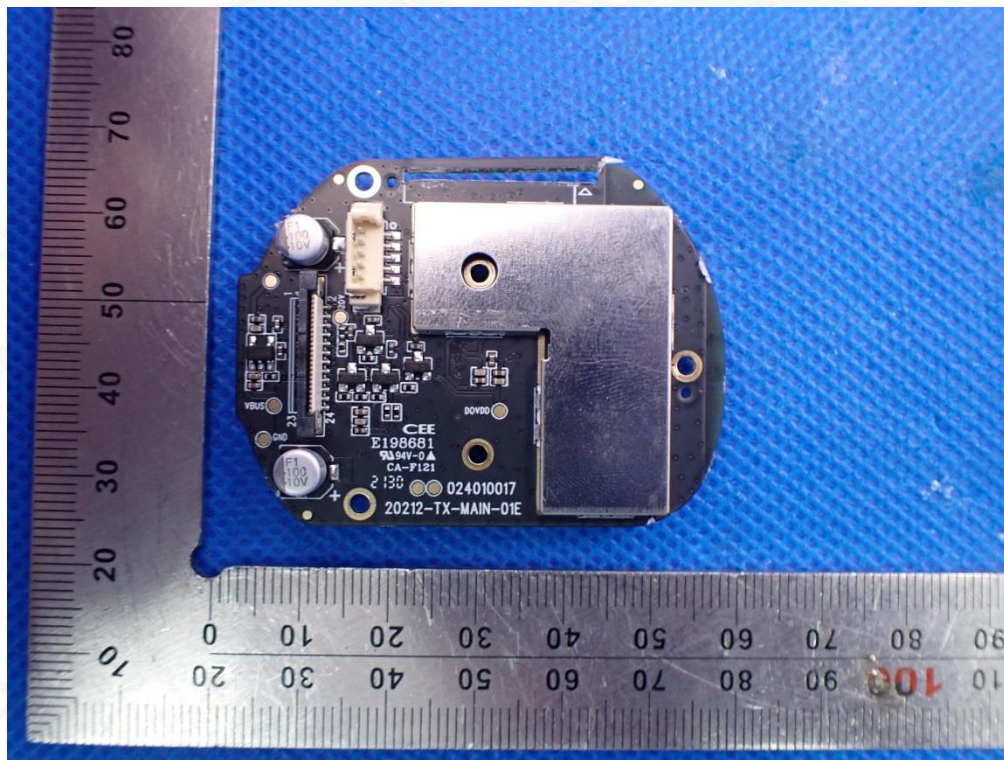

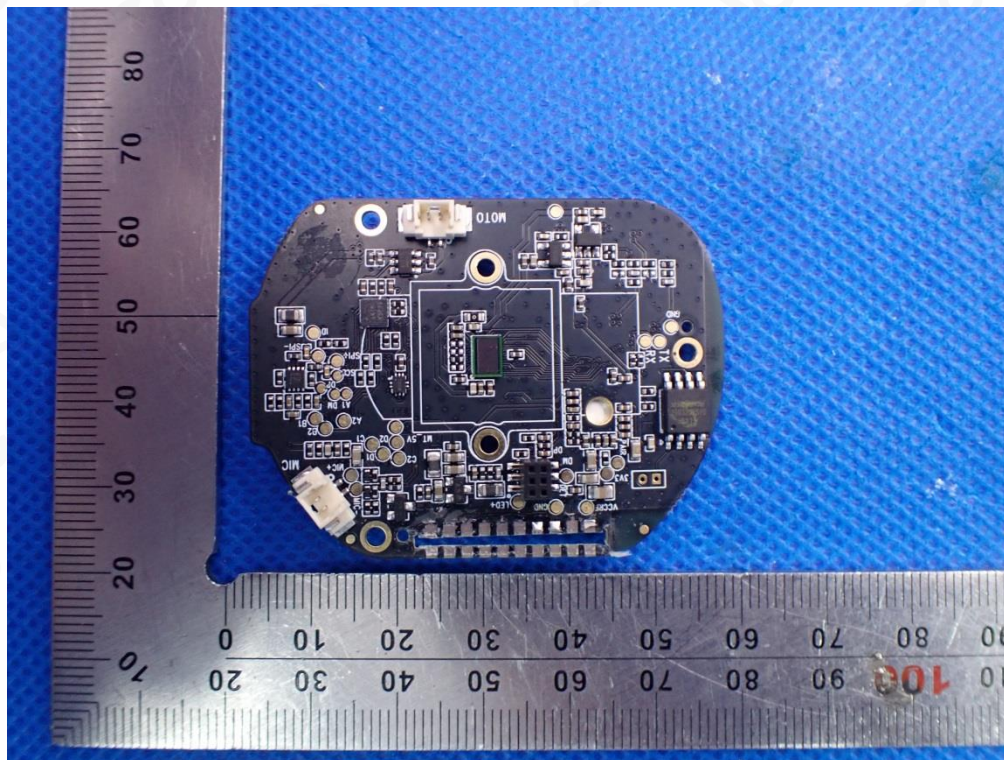

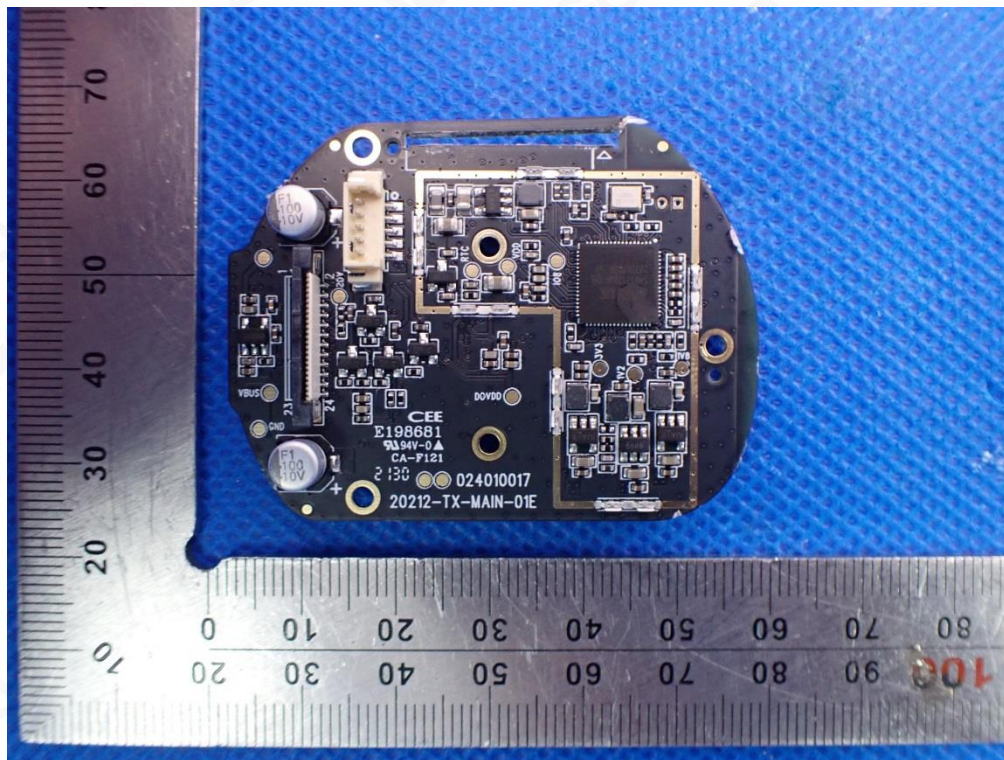

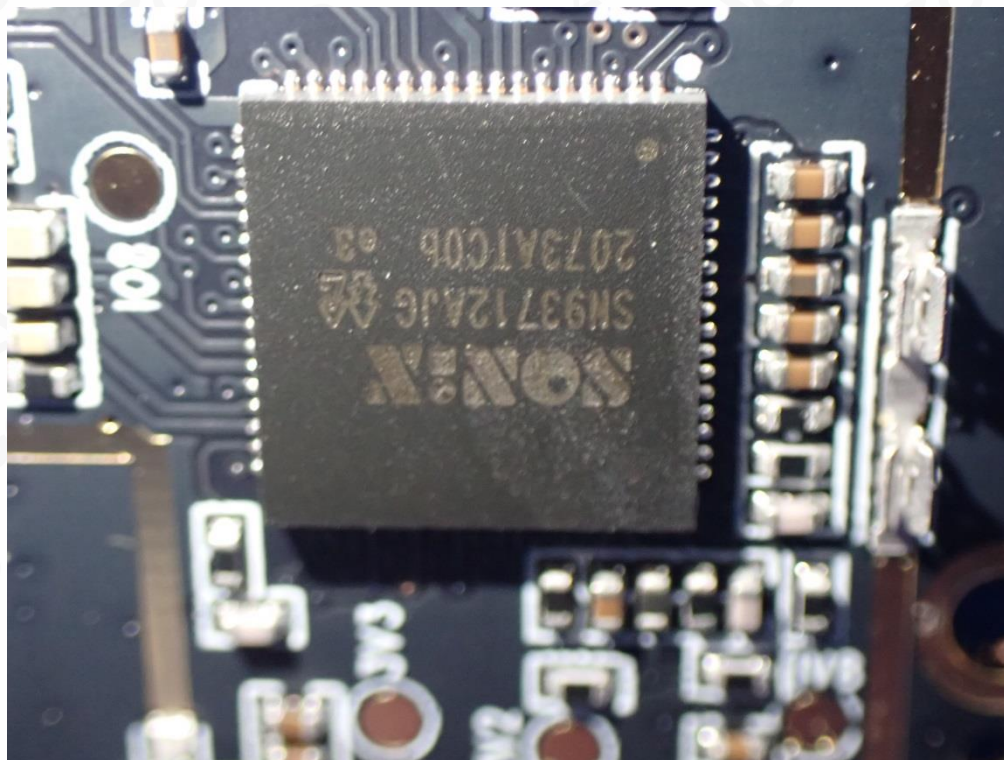

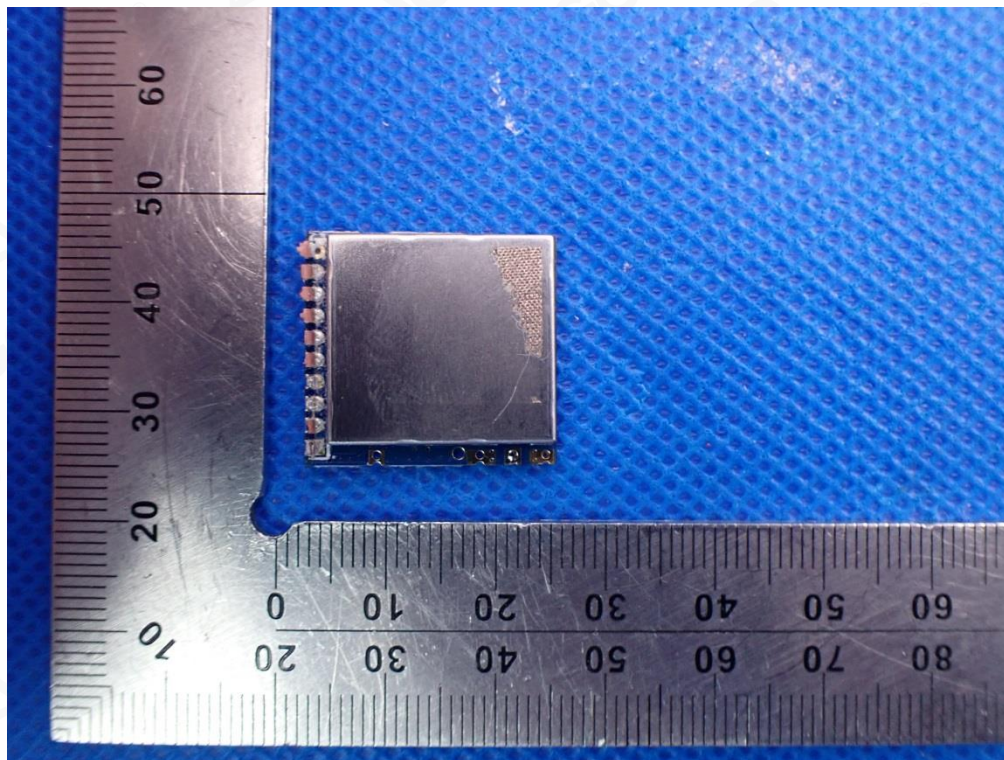

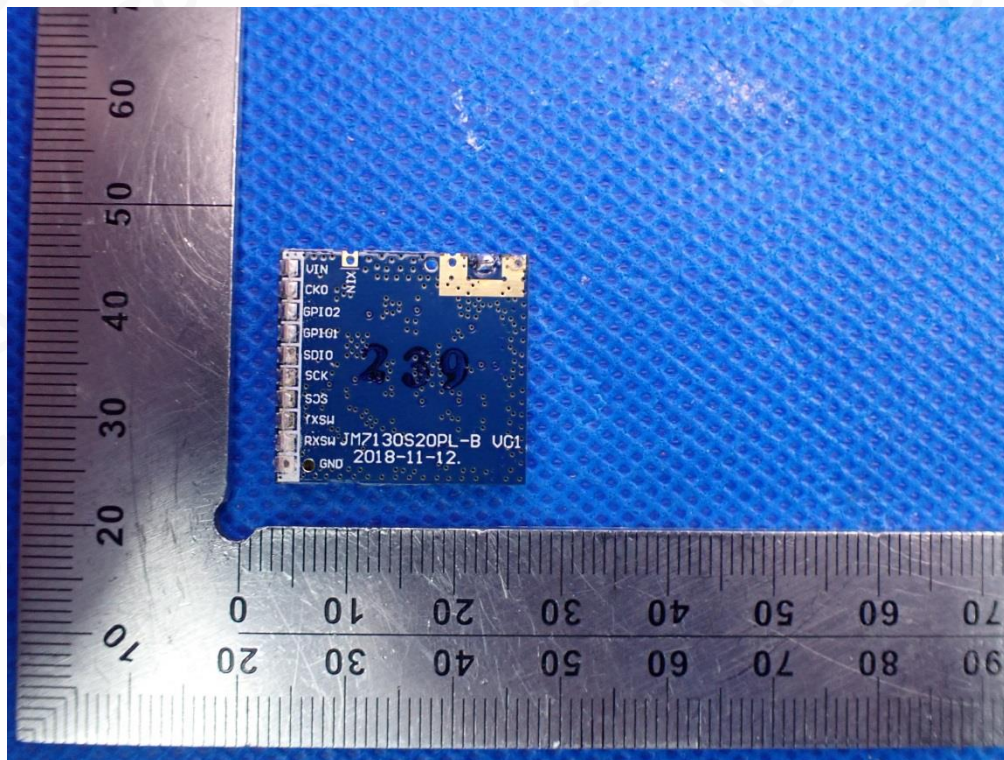

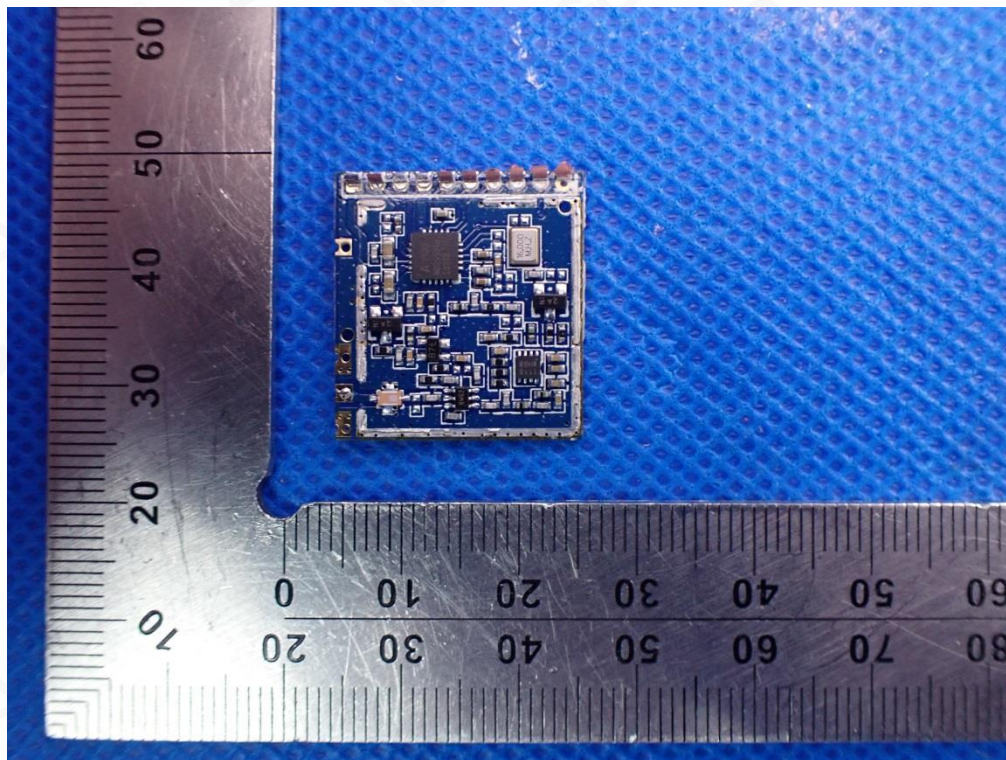

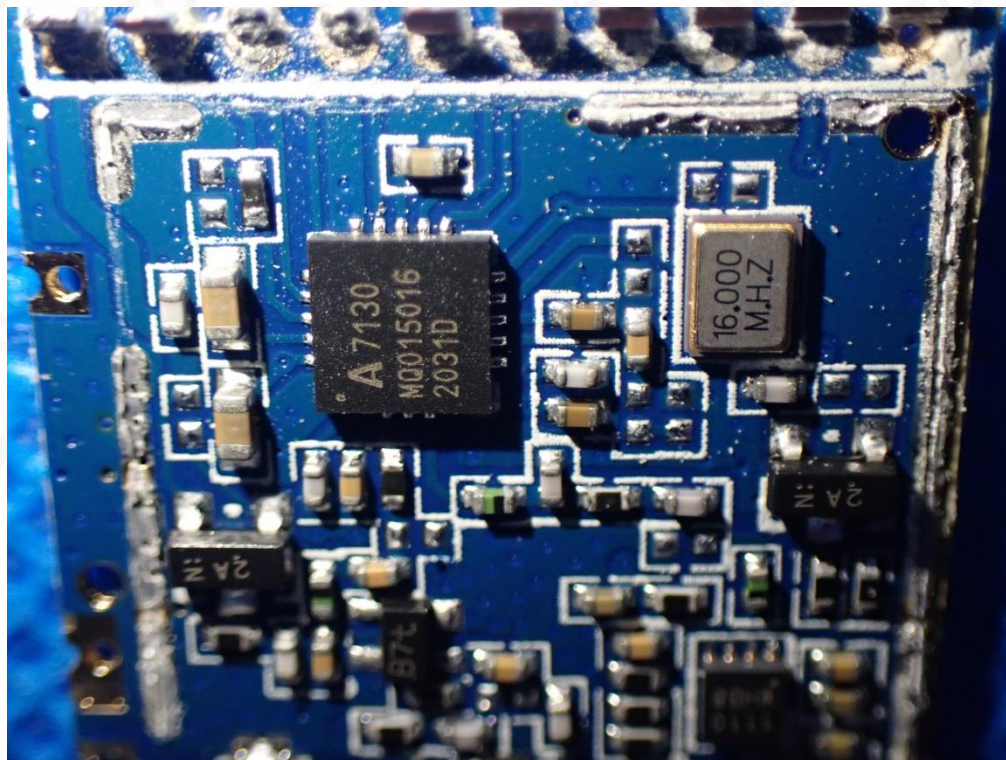

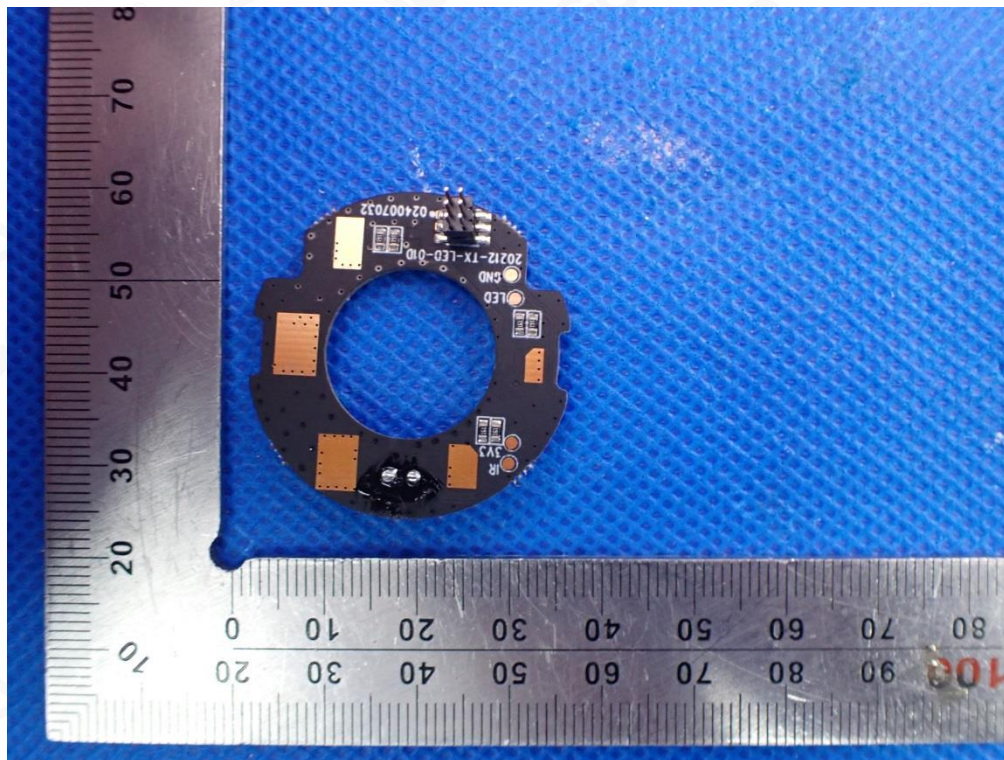

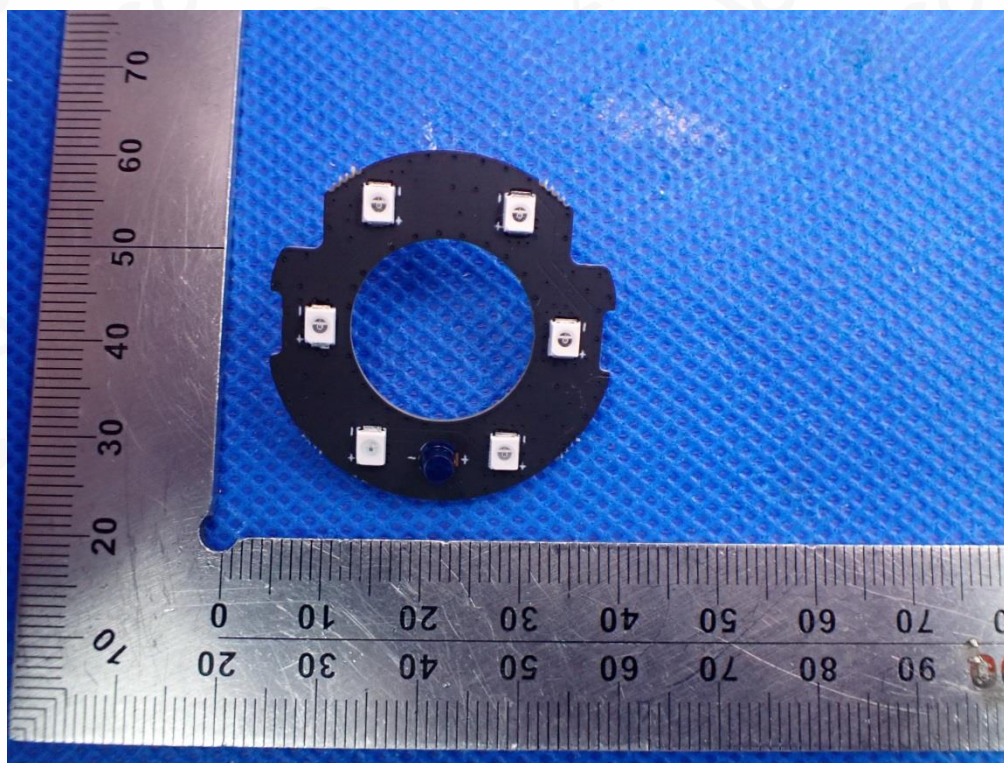
