


# Operation steps


1. Put the ball head into the nut first, then insert it into the socket on the back of the holder, tighten the nut




2. Loosen the knob and open the hook, insert the hook onto vent blade, then fasten the knob



# 3. Use the Type-C charging cable in the package to connect the holder and the car charger.




4. Place your phone. It will be securely attached to the charger holder with its auto alignment function.
