

# Power on/off

 Power on: In the power off state, press and hold the power key until the system enter into power on animation, will show lock screen in about 30 seconds, slide to unlock

 Power off. In the power on state, long press the power key for 3 seconds, the screen displays the shutdown confirmation interface, select the shutdown option, the system will shut down

## Battery management and charging

At the first time, you should charge the battery to 100% to make sure that it is fully charged and then use.

B when the battery power is completely exhausted, please charge for at least 5 minutes and then restart.




Figure 3: (FDA CFR 1040.10 Figure 1) - Explanatory Label

Your LUME PAD is a radio transmitter and receiver. It is designed and manufactured not to exceed the emission limits for exposure to radiofrequency (RF) energy set by the Federal Communications Commission of the U.S. Government. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons, regardless of age and health. The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC is 1.6 W/kg. \* Tests for SAR are conducted with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output.
