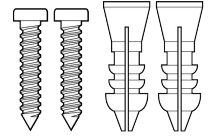

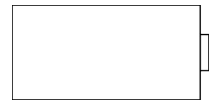

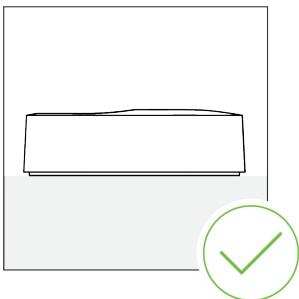

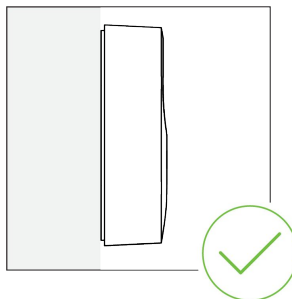
- BH61 Wireless Alarm Hub

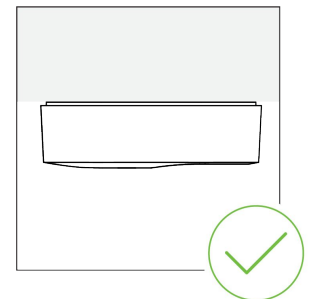
Above surface



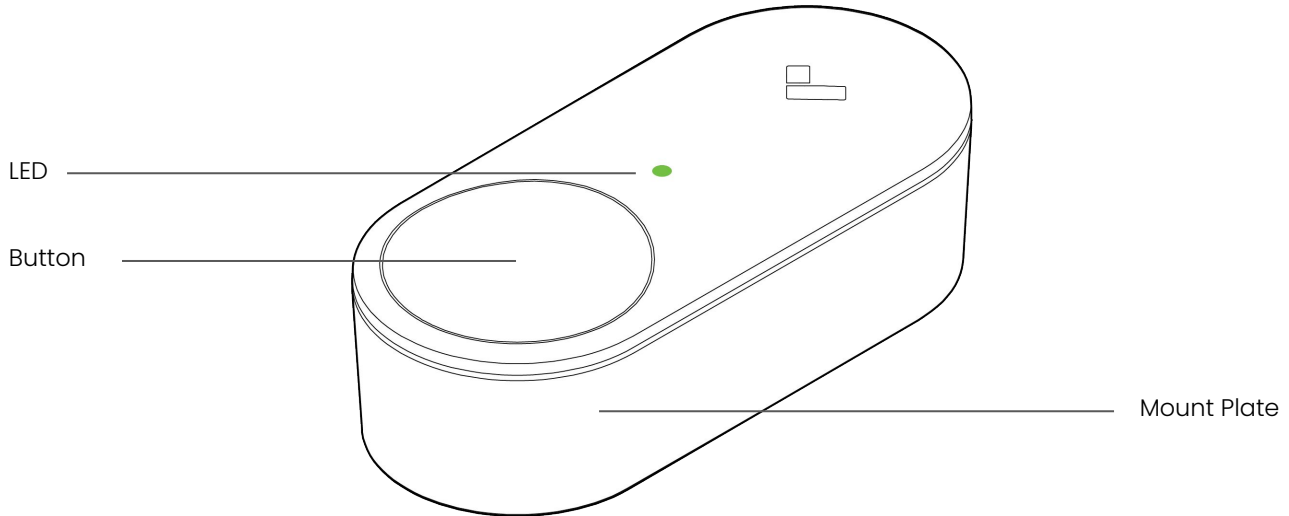
Side of surface

## Sensor overview



### LED Behavior

#### LED off

Default state  
(check status in Verkada Command)

#### LED blinking fast

Panic button pressed, but signal has not been received by hub

#### LED on for 1 minute

Panic button pressed and signal received by hub

#### LED blinks 3 times, every 2 minutes

Low battery

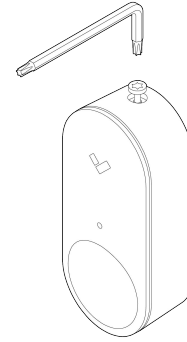

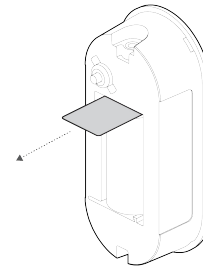
## Installation

### Mounting with screws

Unscrew captive T10 security screw to remove Button Unit from Mount Plate.

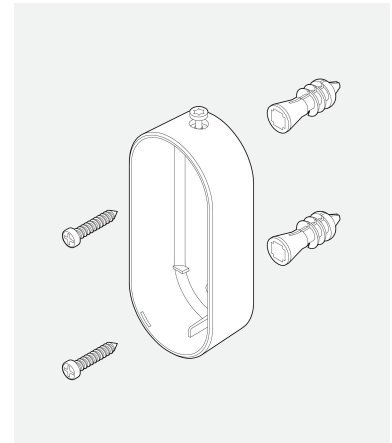


Remove pull tab between battery and battery contacts in Button Unit.



Drill holes in mounting surface.

Secure the Mount Plate to the mounting surface using the 2 screws and 2 wall anchors (included).



Insert Button Unit into Mount Plate until you hear a click.

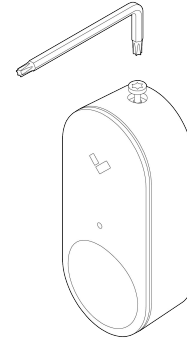
Secure Button Unit in Mount Plate with the captive T10 security screw and T10 screwdriver.



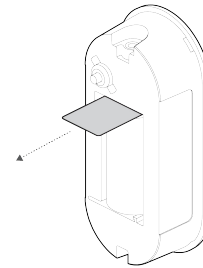
## Installation

### Mounting with VHB

Unscrew captive T10 security screw to remove Button Unit from Mount Plate.

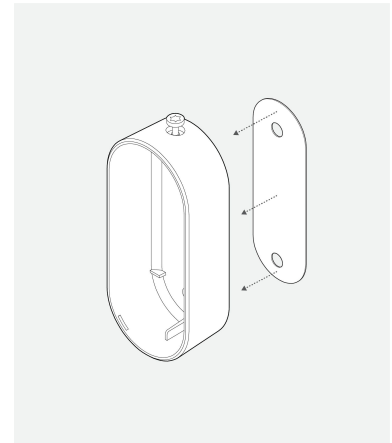


Remove pull tab between battery and battery contacts in Button Unit.



Peel protective film from one side of the adhesive mounting strip. Adhere to back side of device.

Peel the remaining protective film and adhere to the mounting surface.



Insert Button Unit into Mount Plate until you hear a click.

Secure Button Unit in Mount Plate with the captive T10 security screw and T10 screwdriver.
