ACCOUNT SET-UP

There are two steps to setup your account
STEP 1. Register an account
STEP 2. ADD your device to your account

STEP 1

1. Go to website kycalocate.com.
2. Click on Register.
3. Enter a valid email address.
4. Slide the blue box all the way to right.
5. Click next.
6. Check email for code (spam folder).
7. Enter verification code click ok.
8. Enter an account name, contact name password, confirm password click next.
9. You will be directed to the login screen.

STEP 2 (add device)

1. Use your email registered above as login name
2. Enter password you created above.
3. Go to top menu and hover over Info Manage and click drop down option "Vehicle".
4. Go to top menu under home find and click blue circle with star icon.
5. Enter your 15 digit device id# click activate.
6. Device id is located on the device and on your registration email.



DOWNLOAD THE KYCS LOCATE APP

Your KYCS Locate device will be activated within 48 hours after purchase and receipt of your registration. Registration is provided by an authorized KYCS Locate dealer or representative.

1. Download the free KYCS Locate app from Apple App store and/or Google Play.
2. Login using your credentials.
3. You are now ready to monitor your KYCS Locate device. Start by tapping on "User & Device" located on the bottom menu, then tap on the asset name to monitor its location. Note: the KYCS Locate device is preset to one (1) location ping per day.
