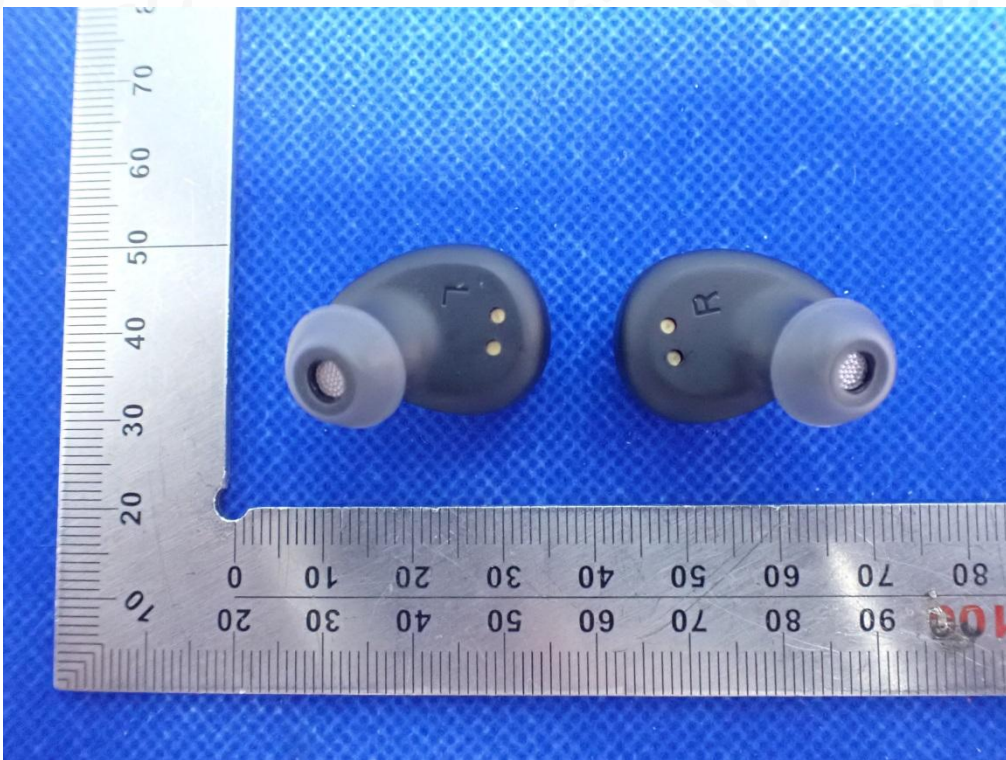

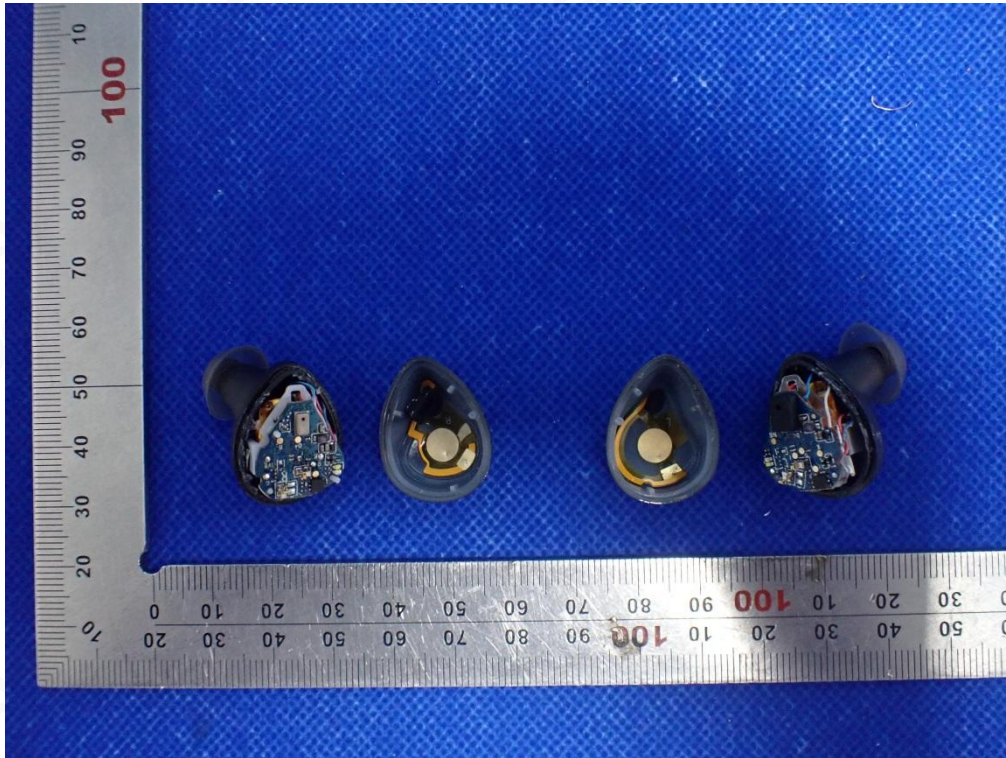

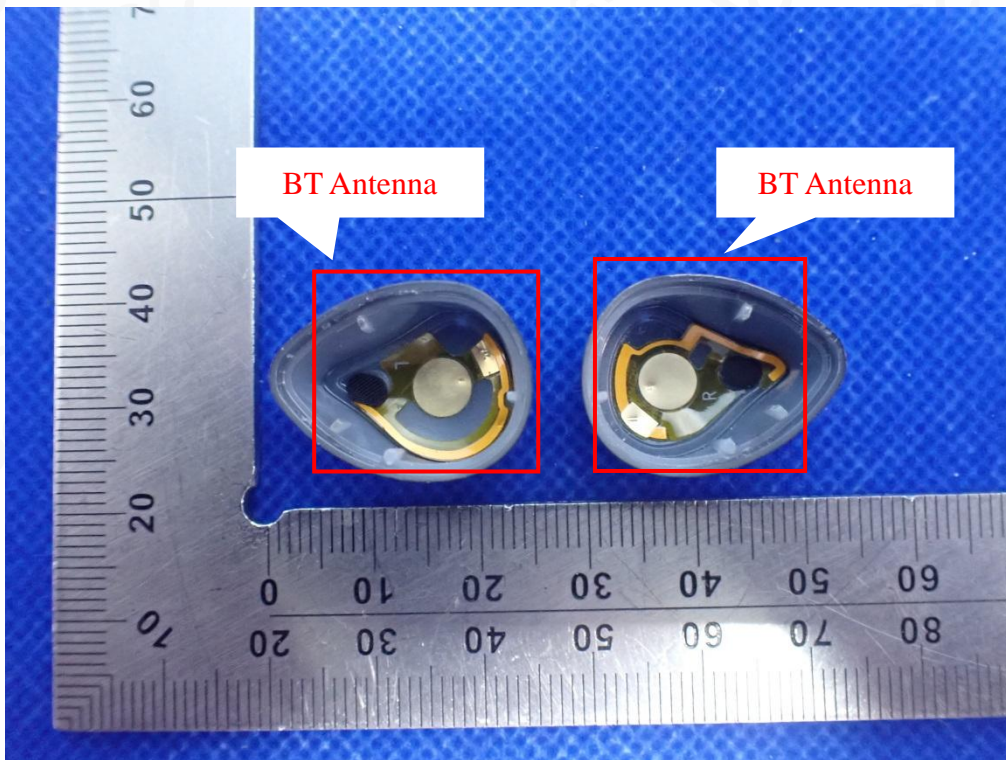

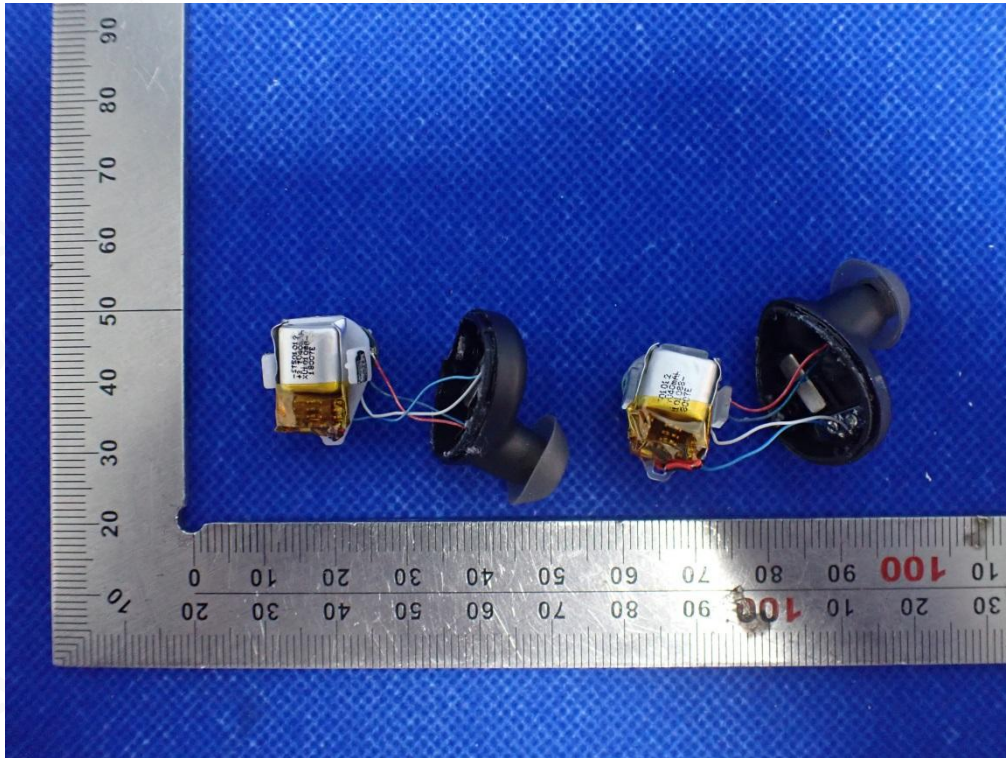

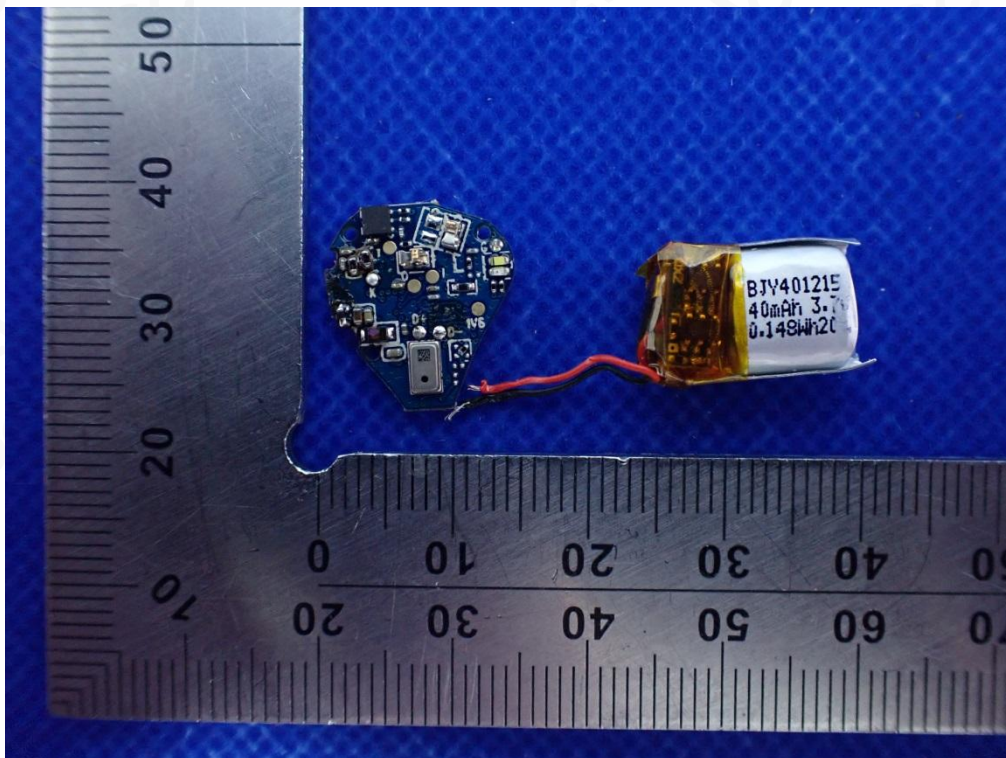

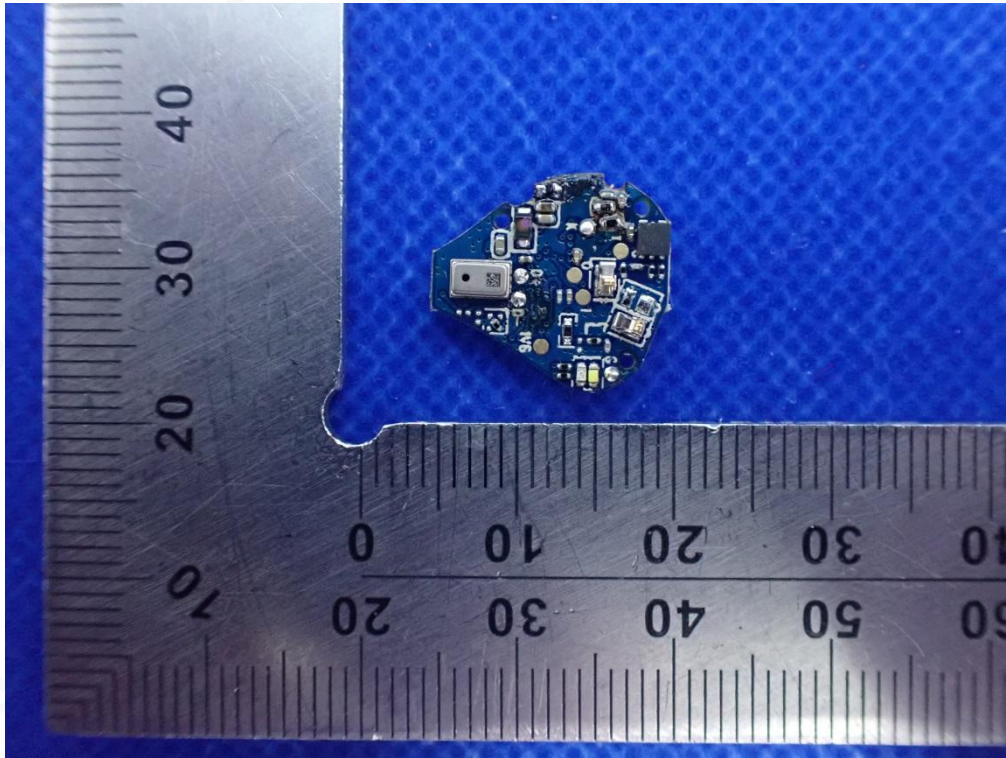

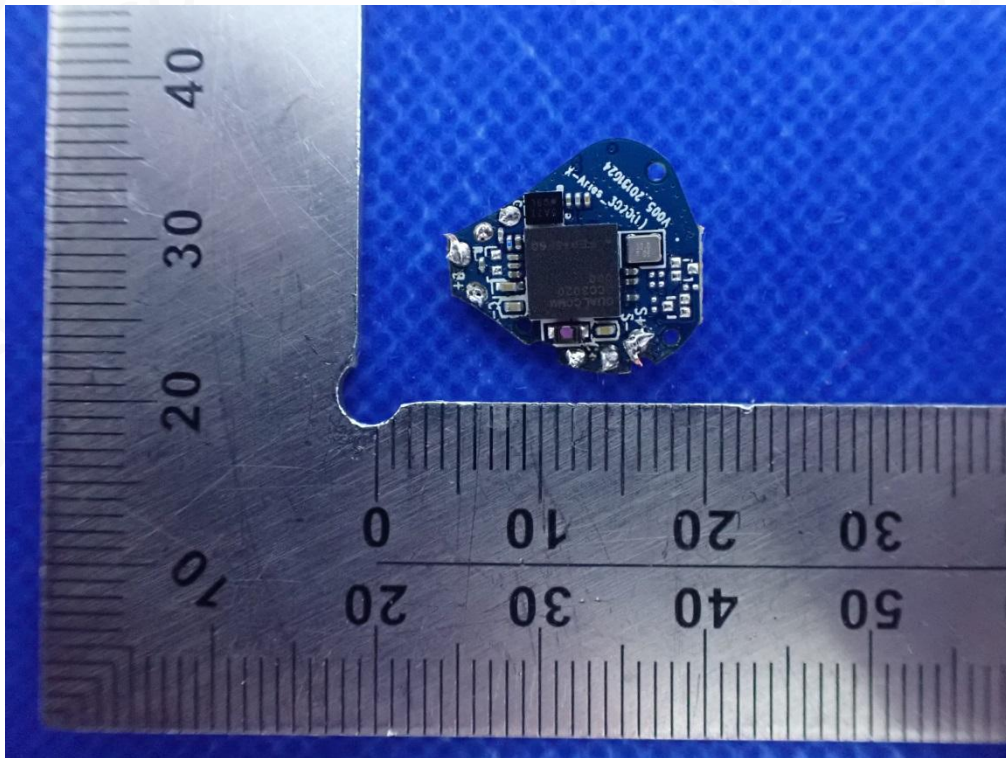

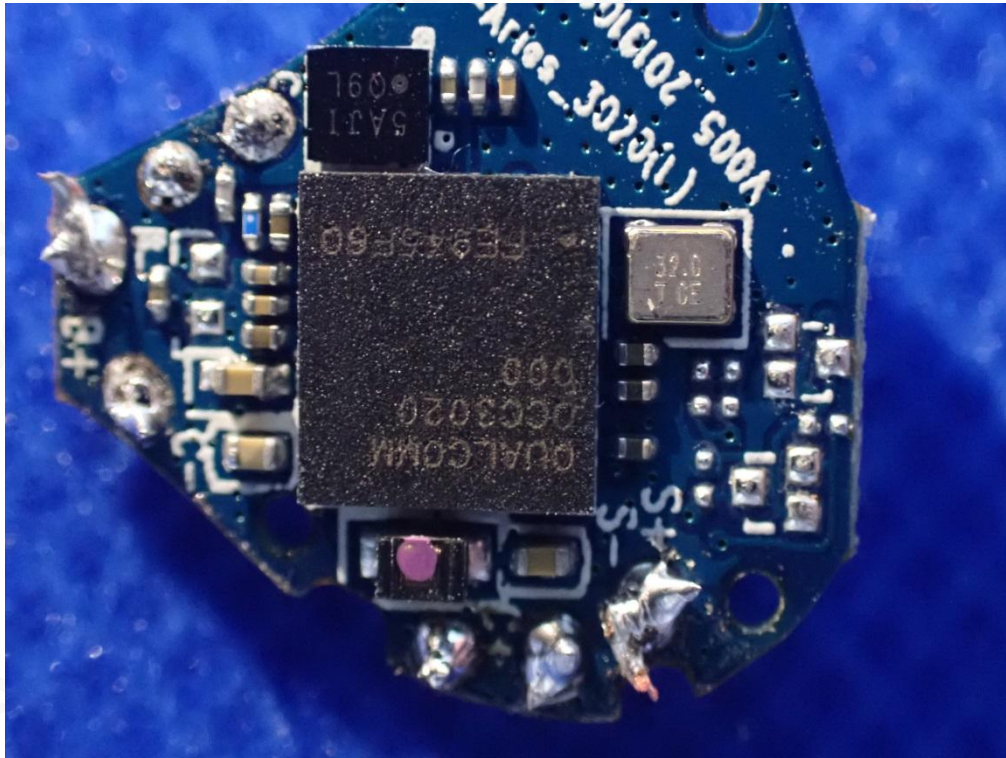

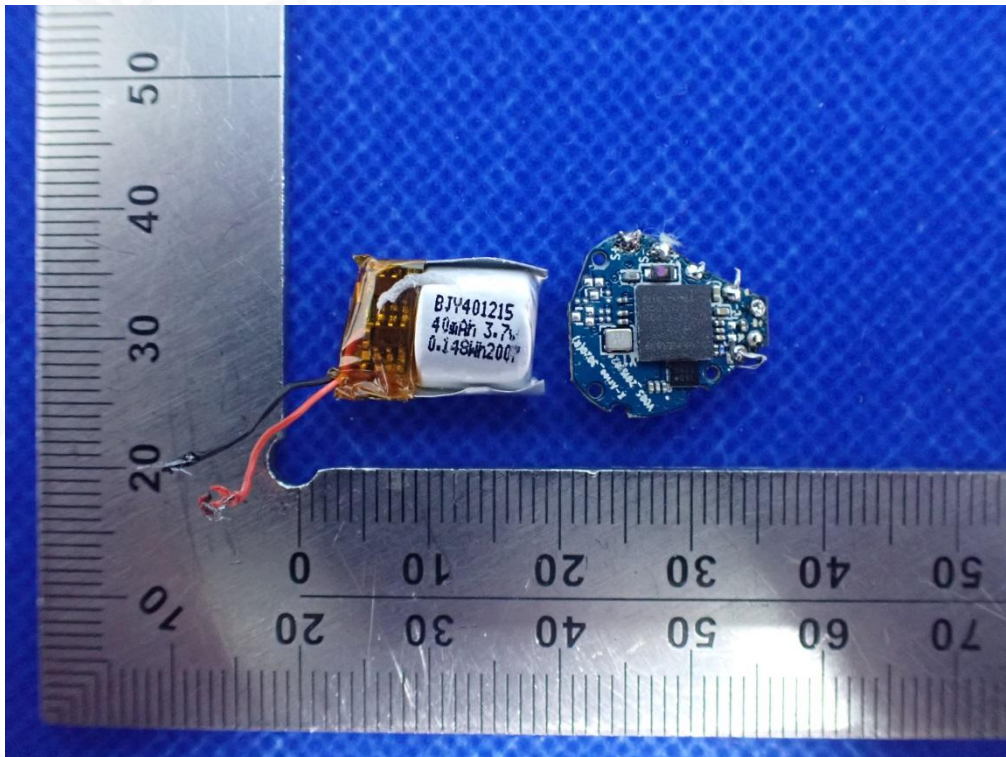

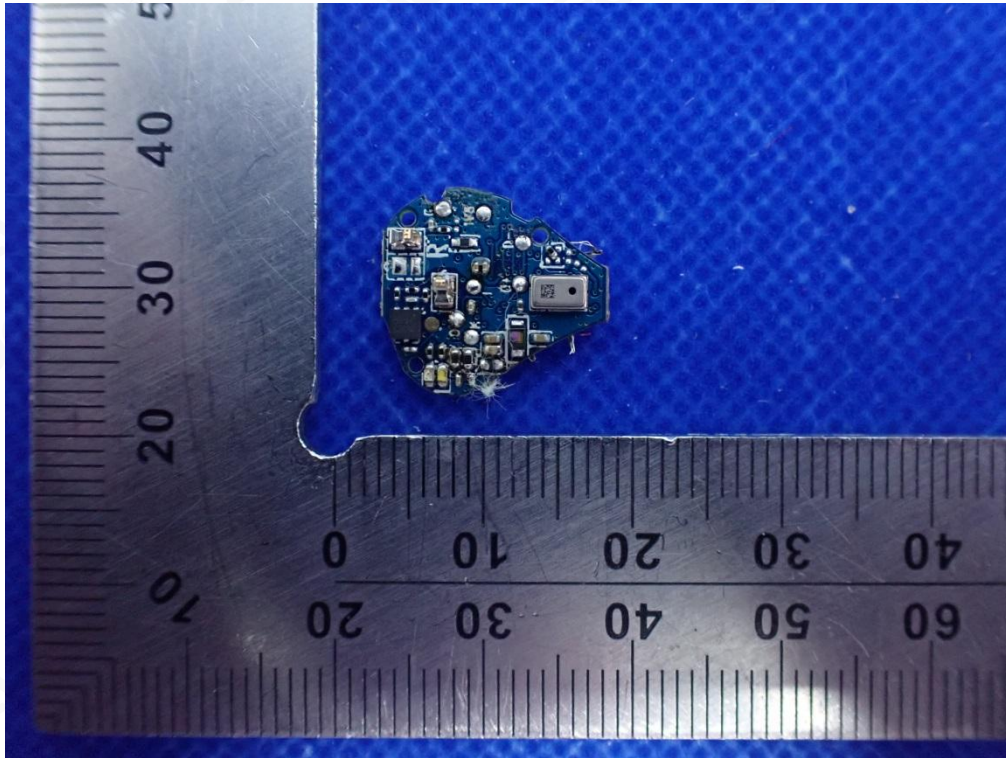

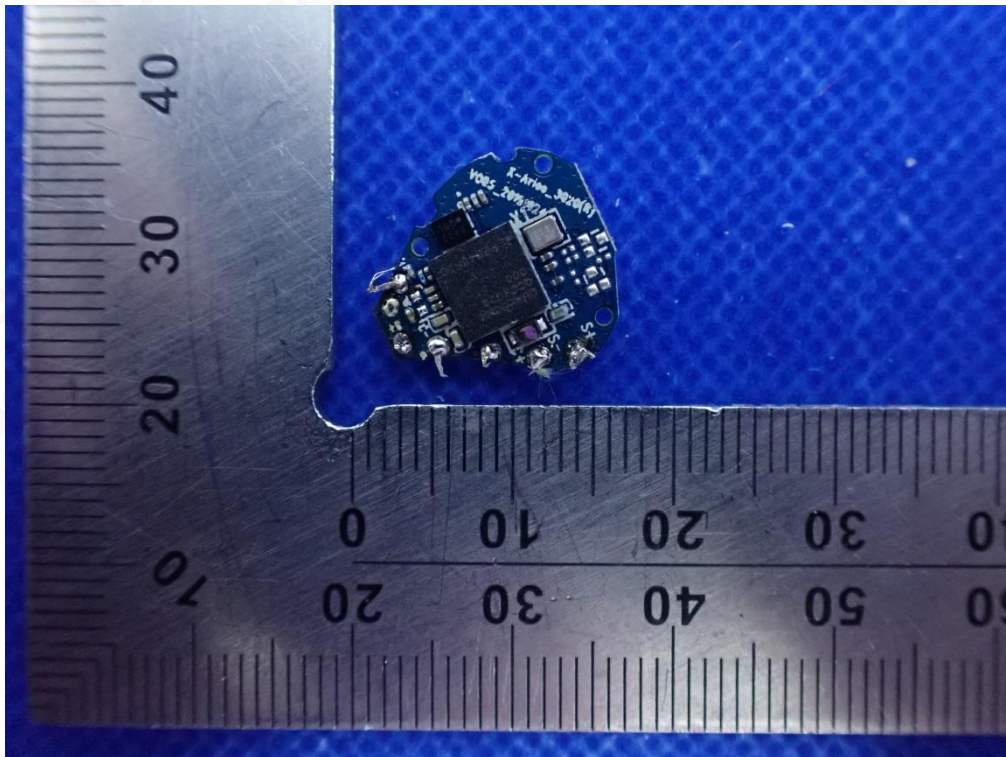

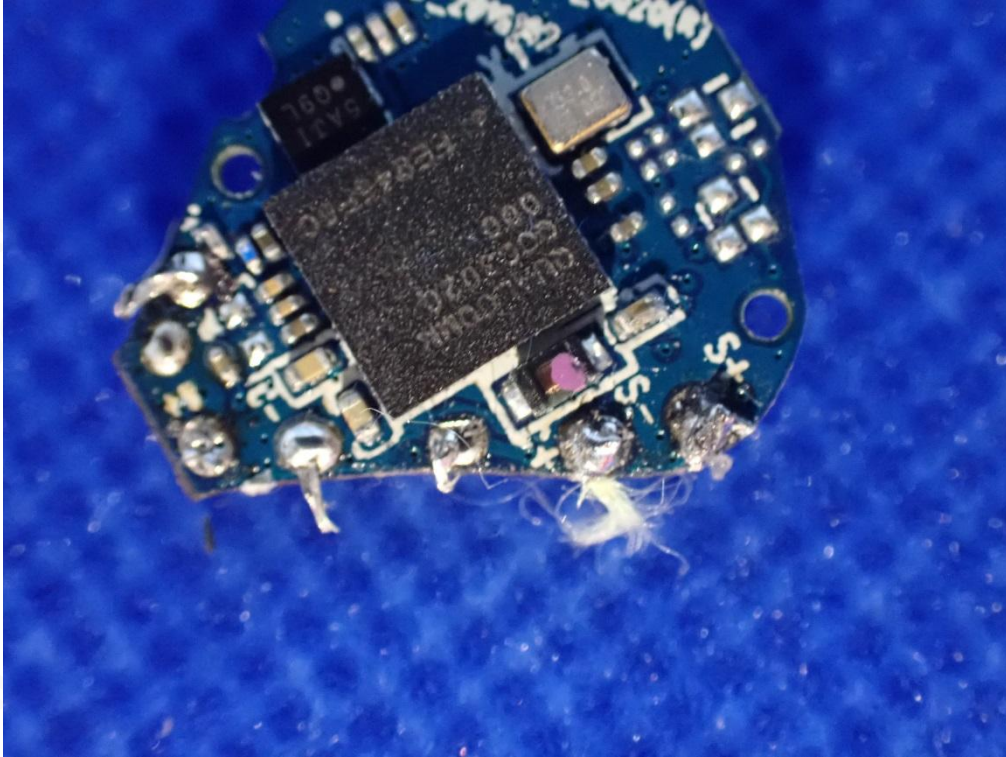

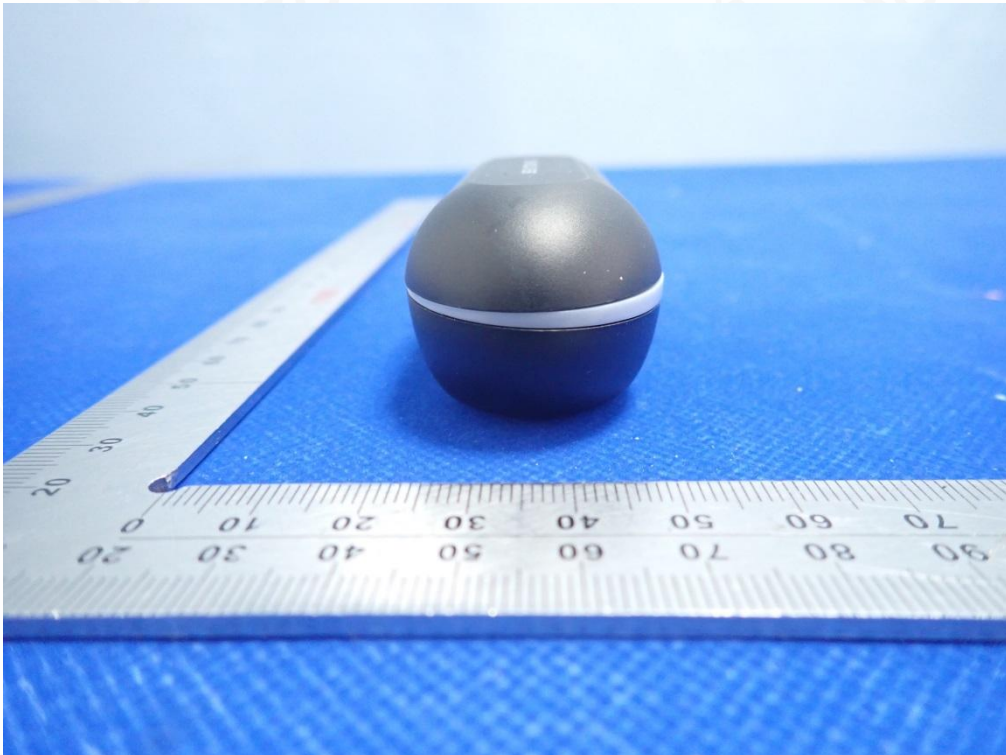

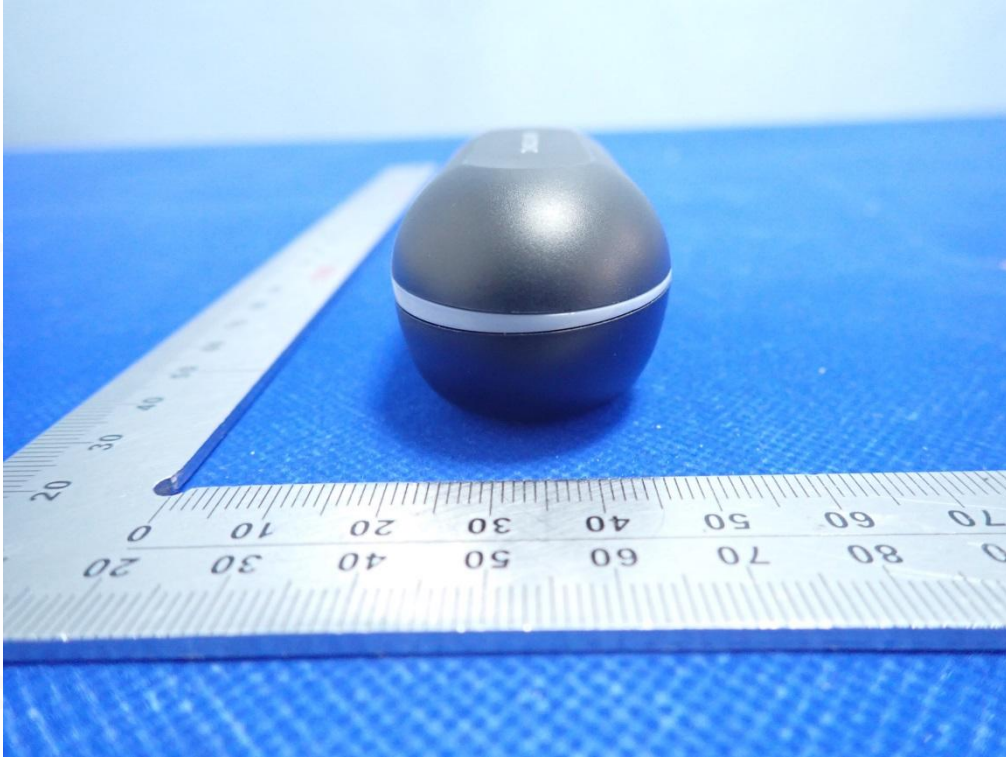

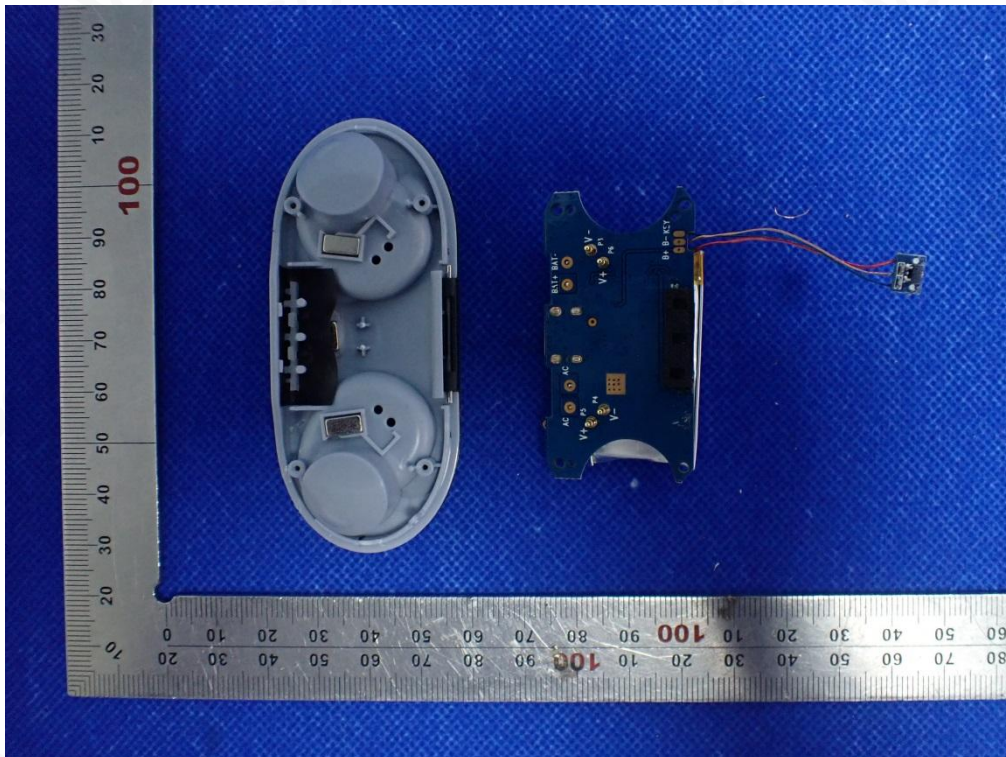

INTERNAL VIEW-3 OF Charging case



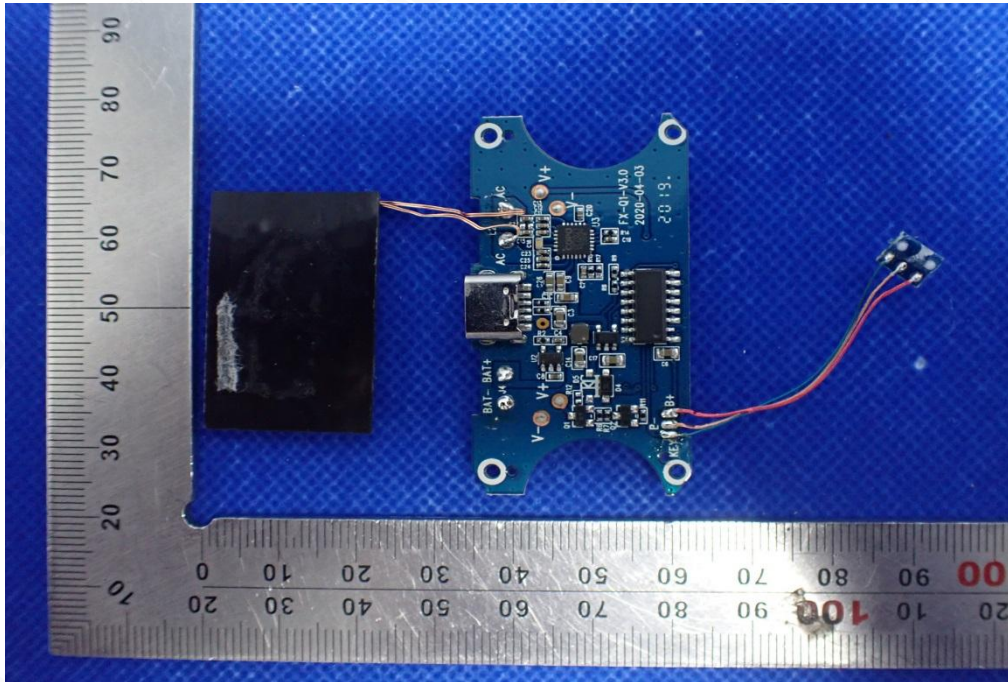

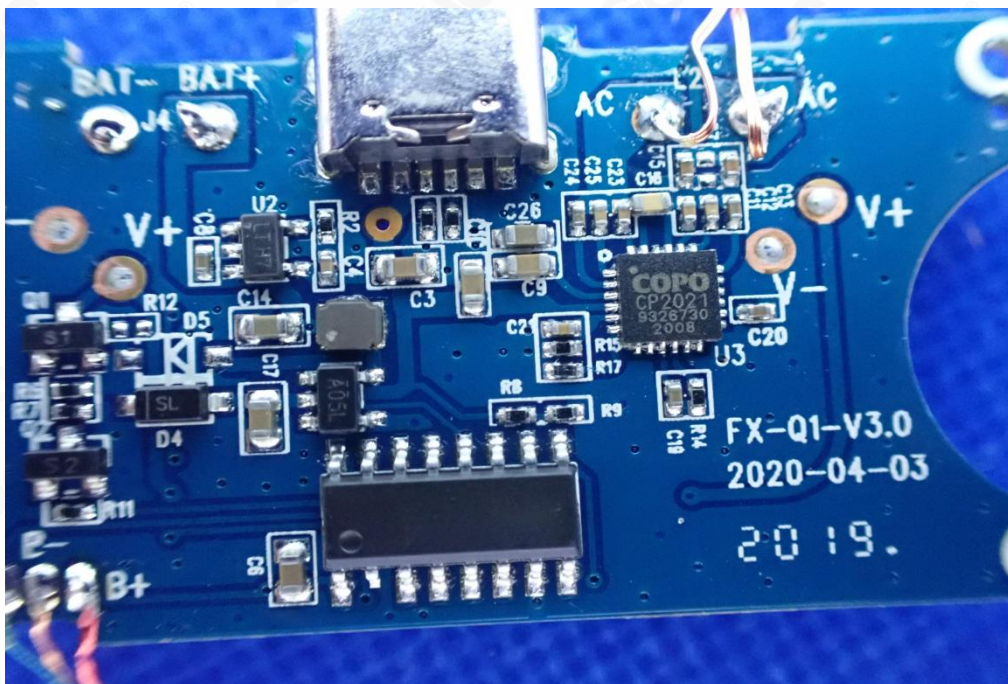
