Objective

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.209, 15.35(c) and 15.231 rules.







Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude ($dB\mu V/m$) = Meter Reading ($dB\mu V$) + Antenna Factor (dB/m) + Cable Loss (dB) - Amplifier Gain (dB)

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin (dB) = Limit (dB μ V/m) – Corrected Amplitude (dB μ V/m)





Zoom in Pulse Train N1=10, N2=15




Duty Cycle Burst 1




