### 5.1.2 Test Graph



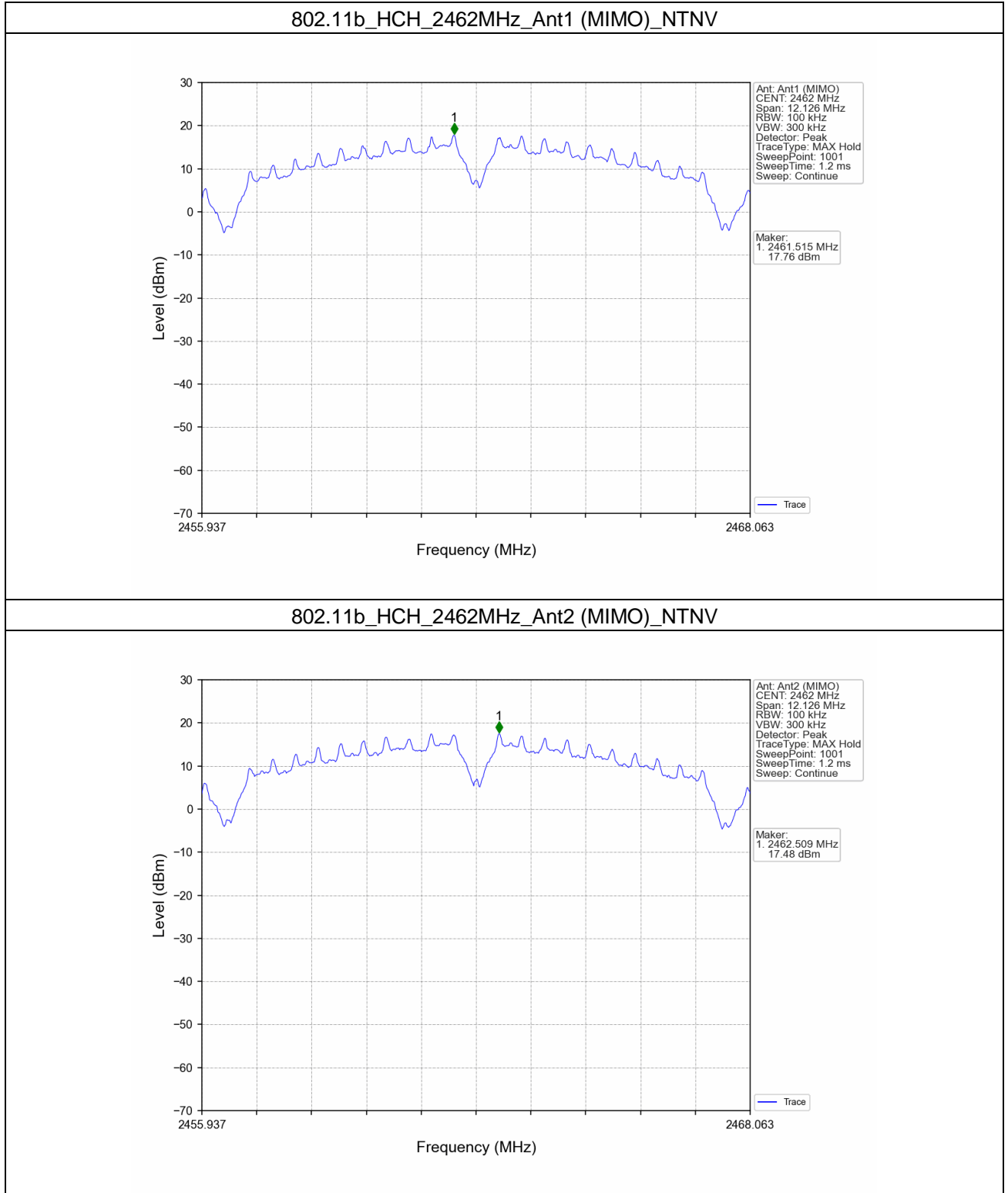
