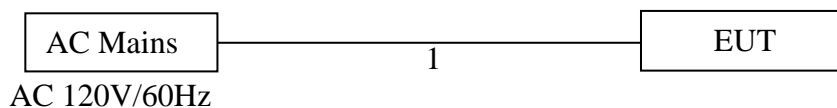

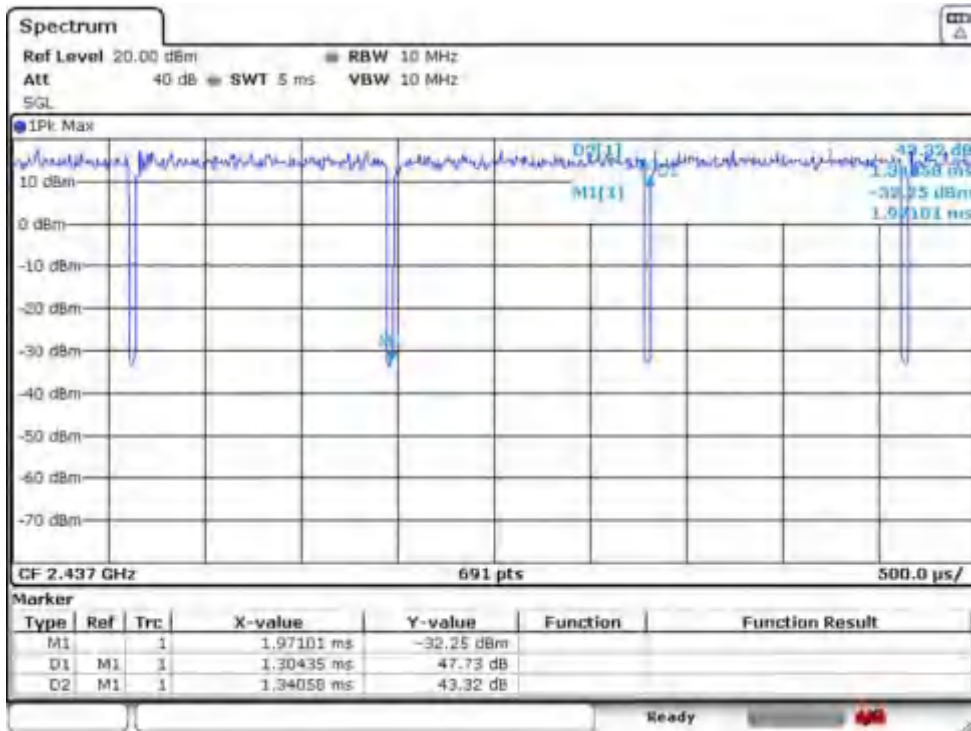
IEEE 802.11b 2437MHz



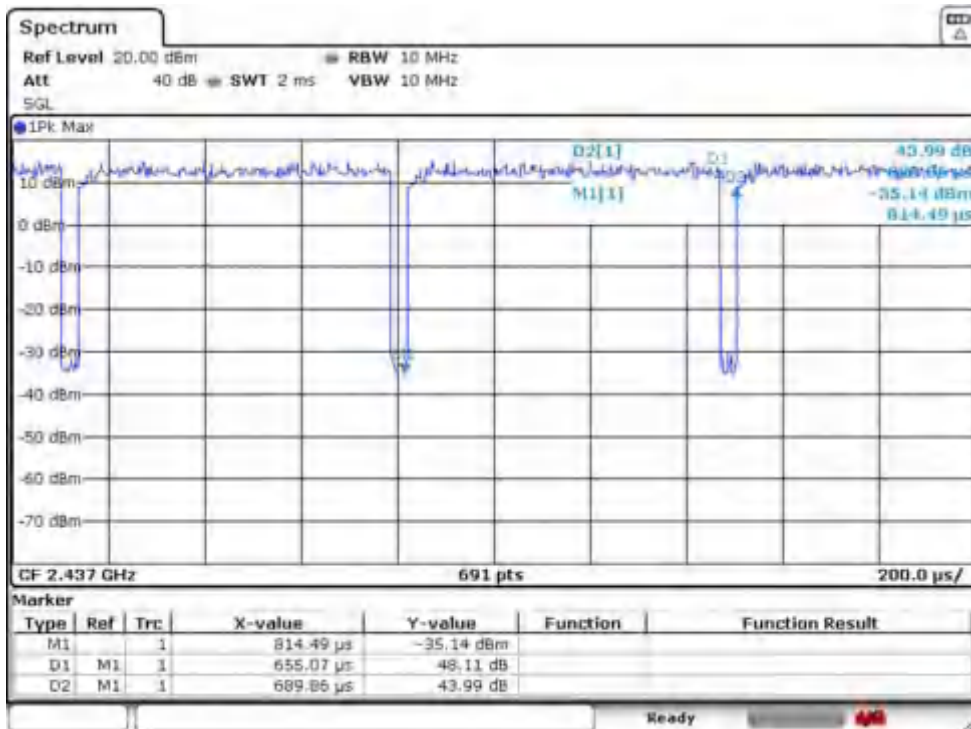
IEEE 802.11g 2437MHz

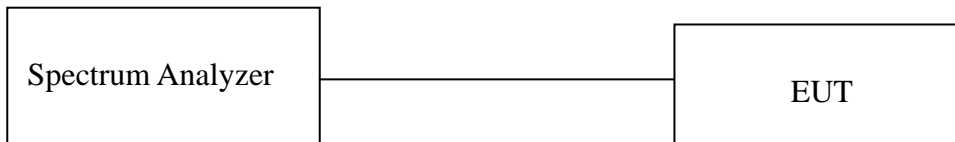

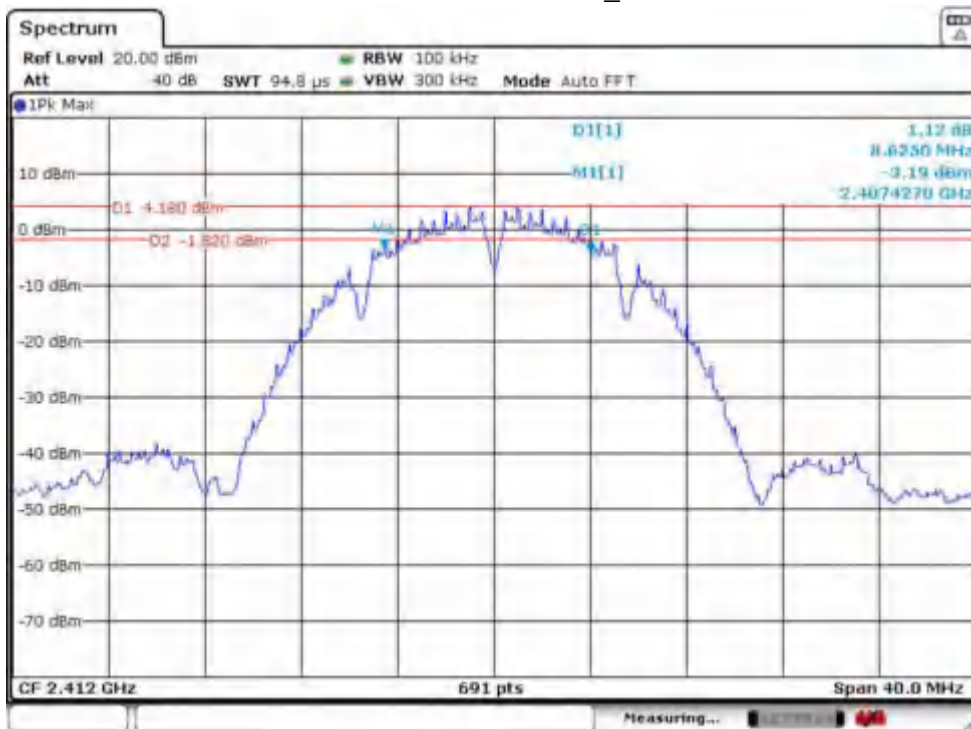
3.4. Test Procedure

- a. Connect EUT antenna terminal to the spectrum analyzer with RF cable.
- b. Spectrum analyzer setting parameters in accordance with section 3.3.
- c. Set the EUT transmit continuously with maximum output power.
- d. Allow trace to stabilize, measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.
- e. Repeat above procedures until all modes and channels were measured.
- f. Record the results in the test report.

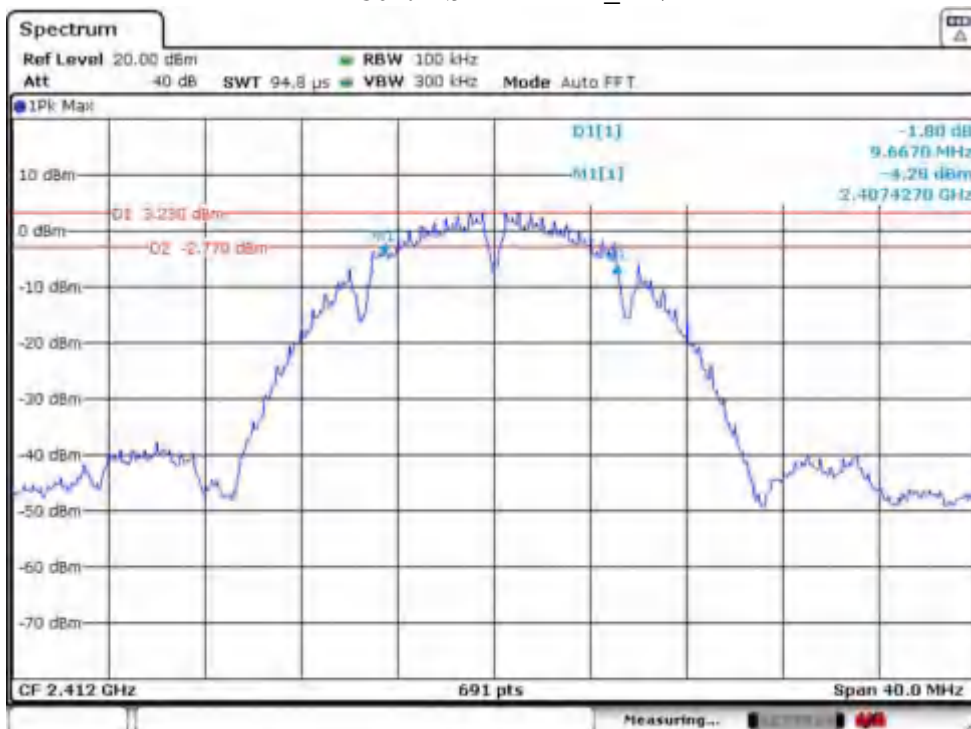

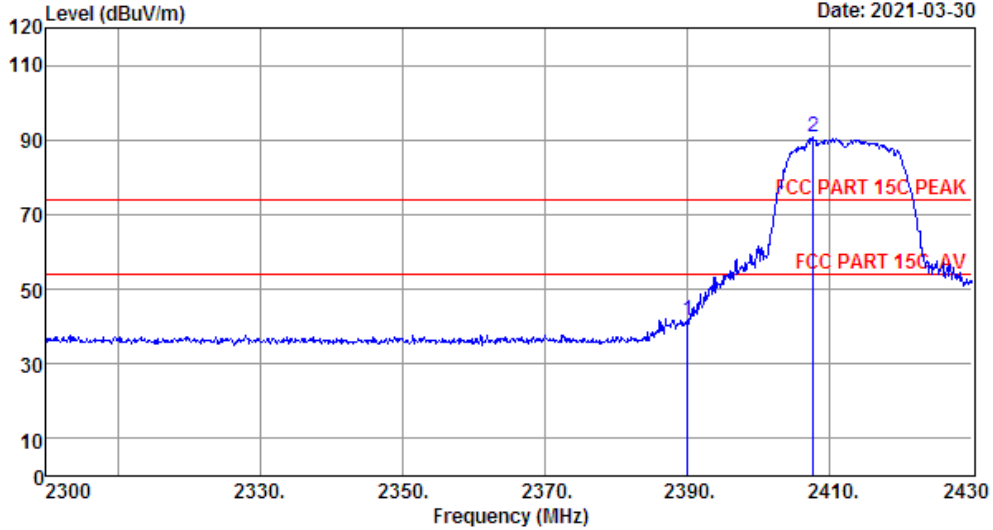


Radiated Band Edge

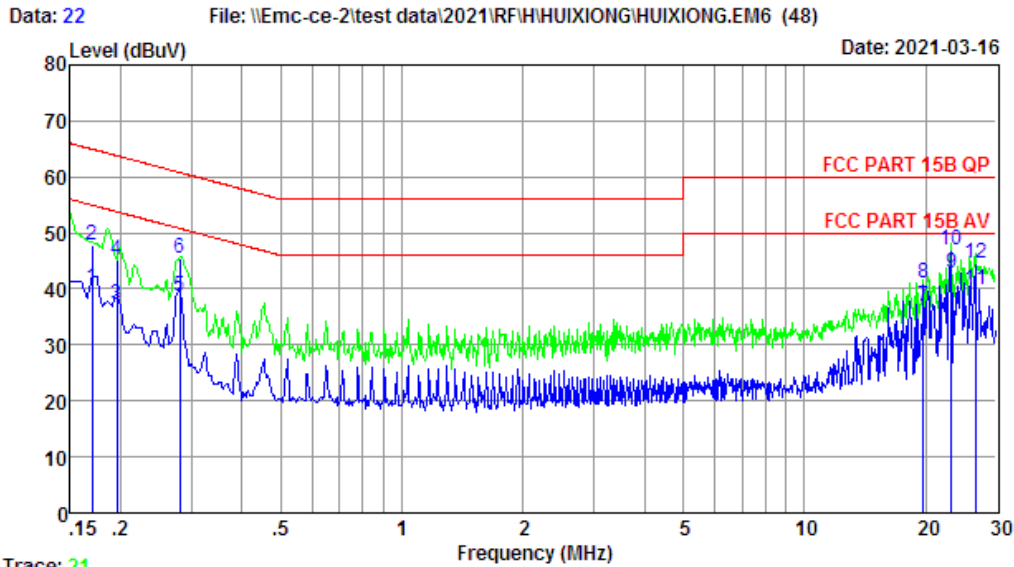
9.4. Test Procedure

- a. The EUT was placed on a non-metallic table, 80cm above the ground plane.
- b. The EUT Power connected to the power mains through a line impedance stabilization network.
- c. Provides a 50 ohm coupling impedance for the EUT (Please refer the block diagram of the test setup and photographs).
- d. Set the EUT transmit continuously with maximum output power.
- e. Spectrum analyzer setting parameters in accordance with section 9.3.
- f. The AC line are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10: 2013 on Conducted Emission Test.
- g. Record the results in the test report.

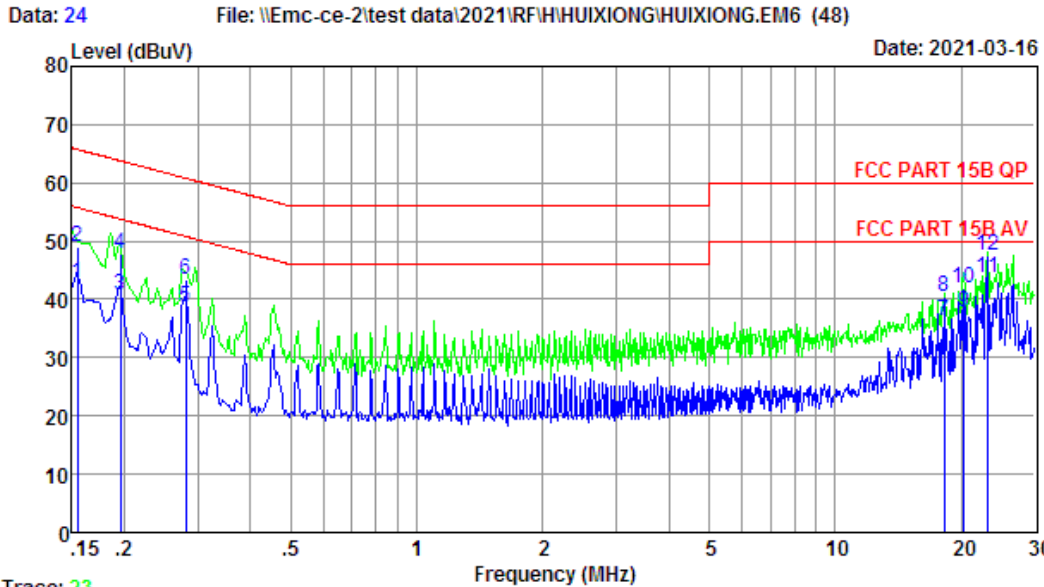

10. ANTENNA REQUIREMENTS

10.1. Limit

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §§15.211, 15.213, 15.217, 15.219, 15.221, or §15.236. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.
