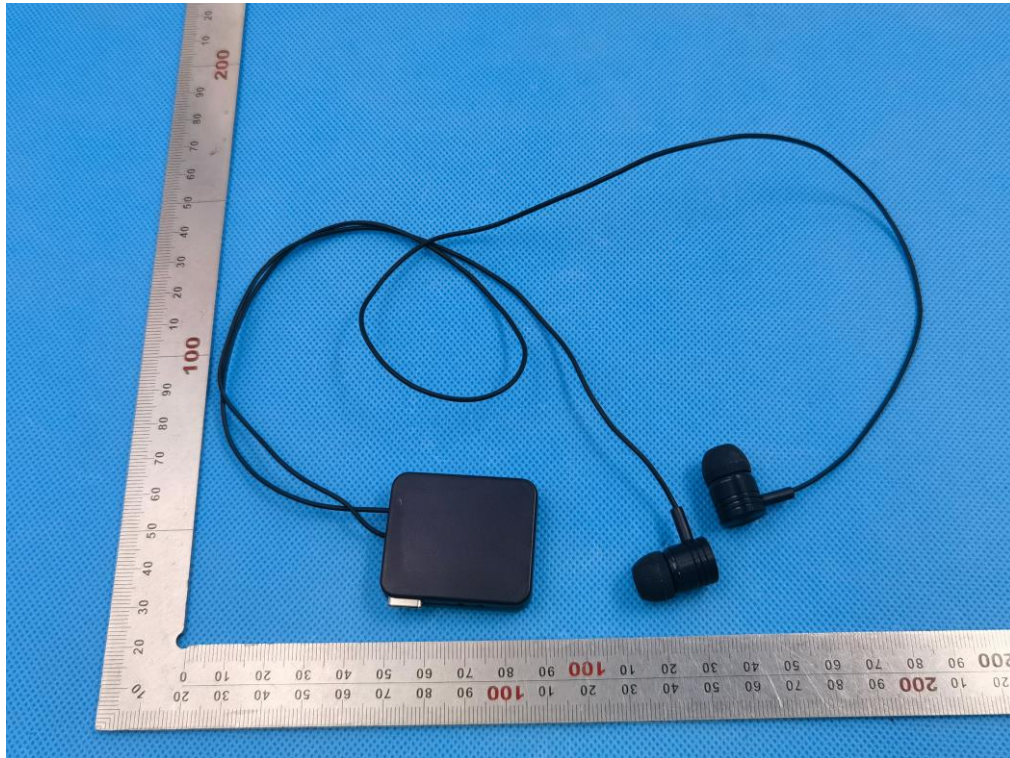


Series Model 3(L7-B) TOP VIEW OF EUT

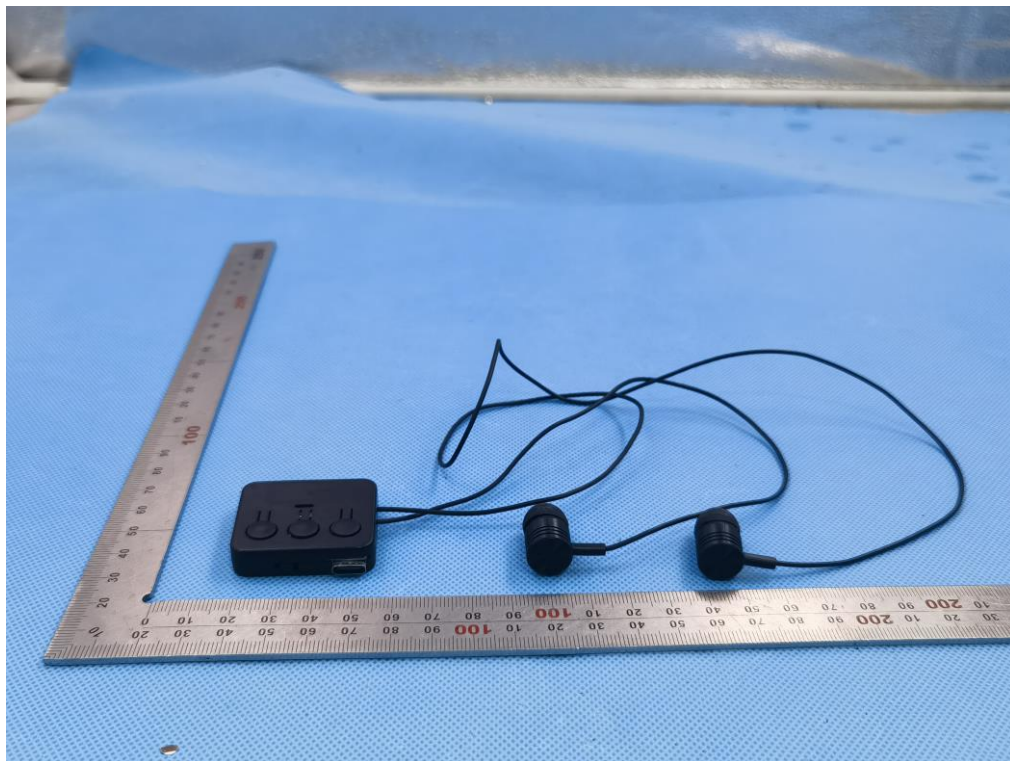

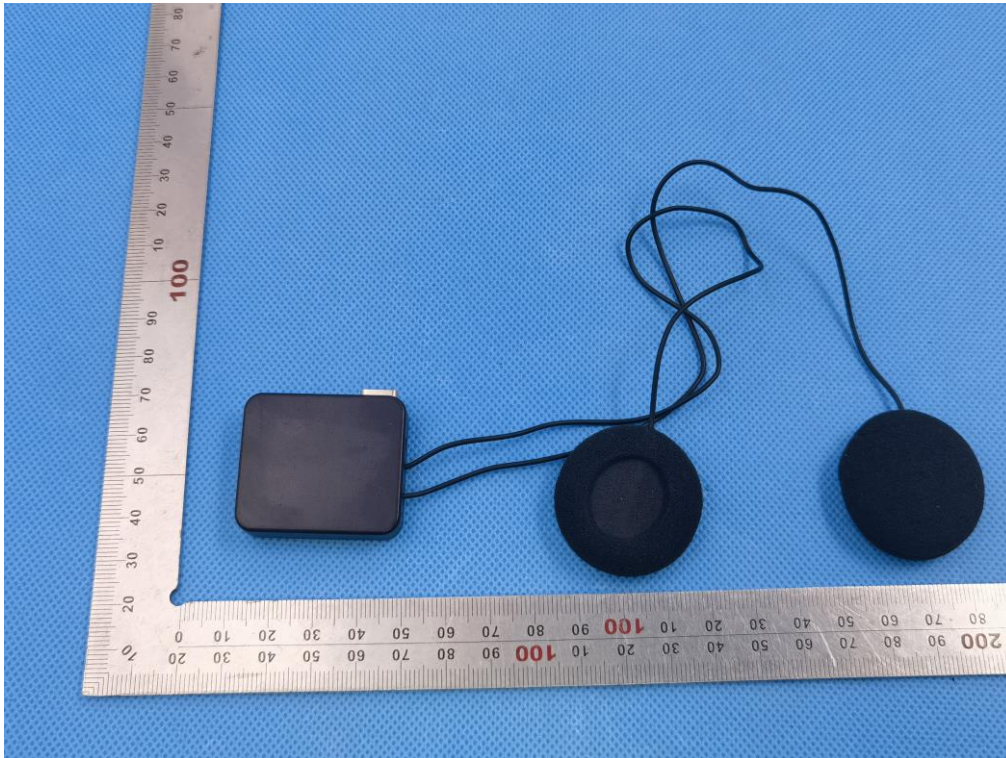


Series Model 4(YN-9) TOP VIEW OF EUT

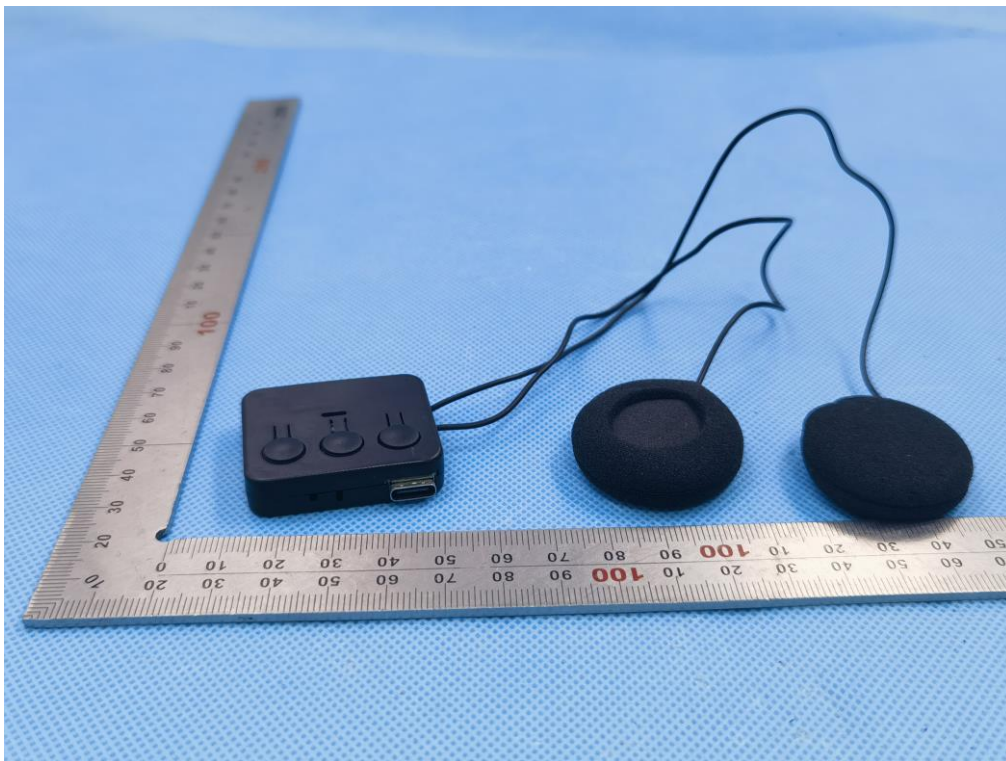
