

Charging Function Operation Instruction

Connect the Data Cable to USB charger(or computer USB port), the other end connect to the device which hide in a small hole under the Wireless module, our device have a LED indication in the middle red light constant on shows that device is charging, Red light off when fullly charged.

Wireless Version

If your mobile phone or other Wireless audio device is not equipped with the AVRCP function, the earphone's CHANGE/PREVIOUS song and PLAY/STOP commands will not pass to the device when pressed. Make sure to check whether a software update is available for your audio device.
