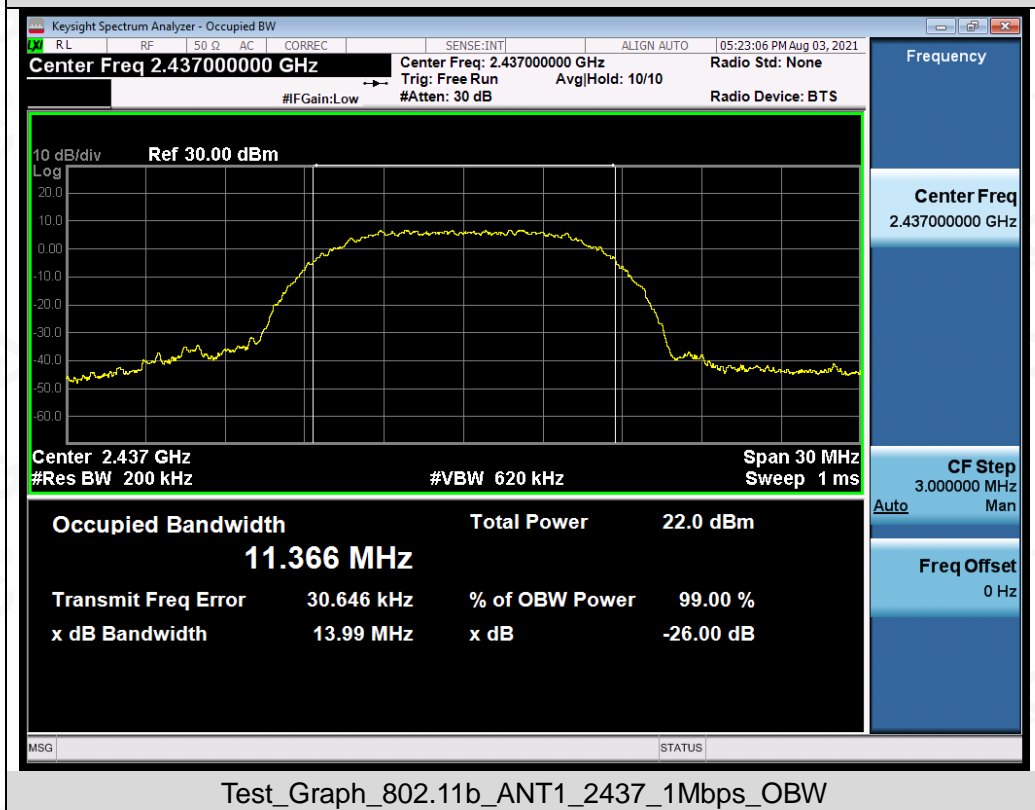




### Test Graphs of Occupied Bandwidth



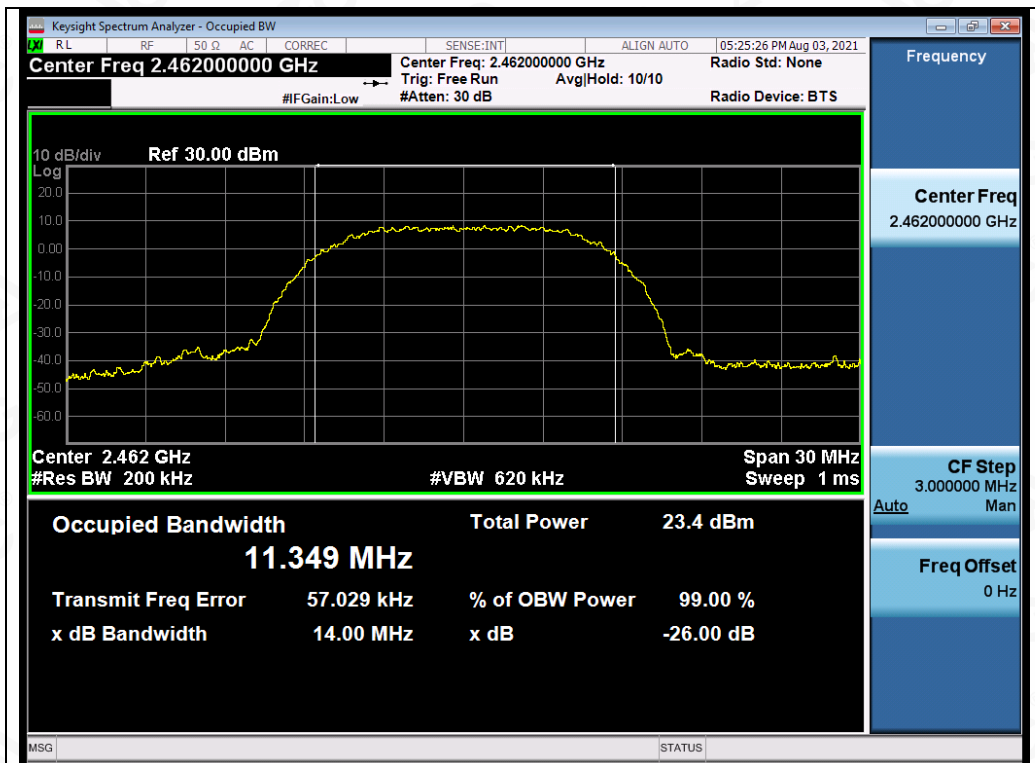

### Test Graphs of DTS Bandwidth



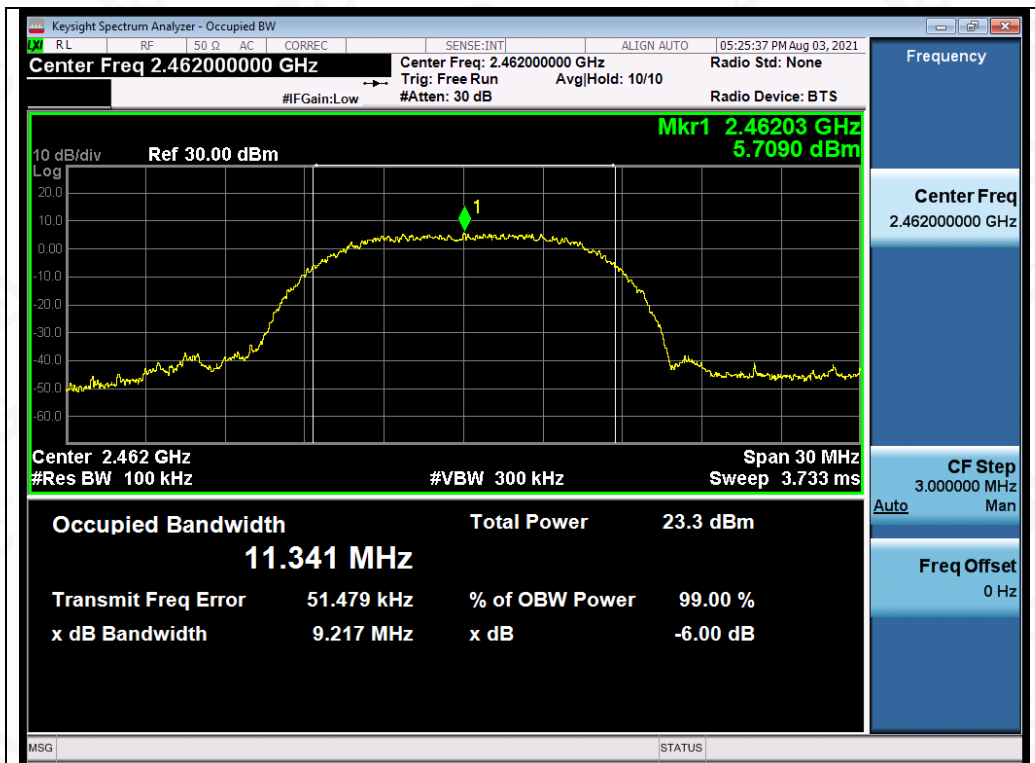

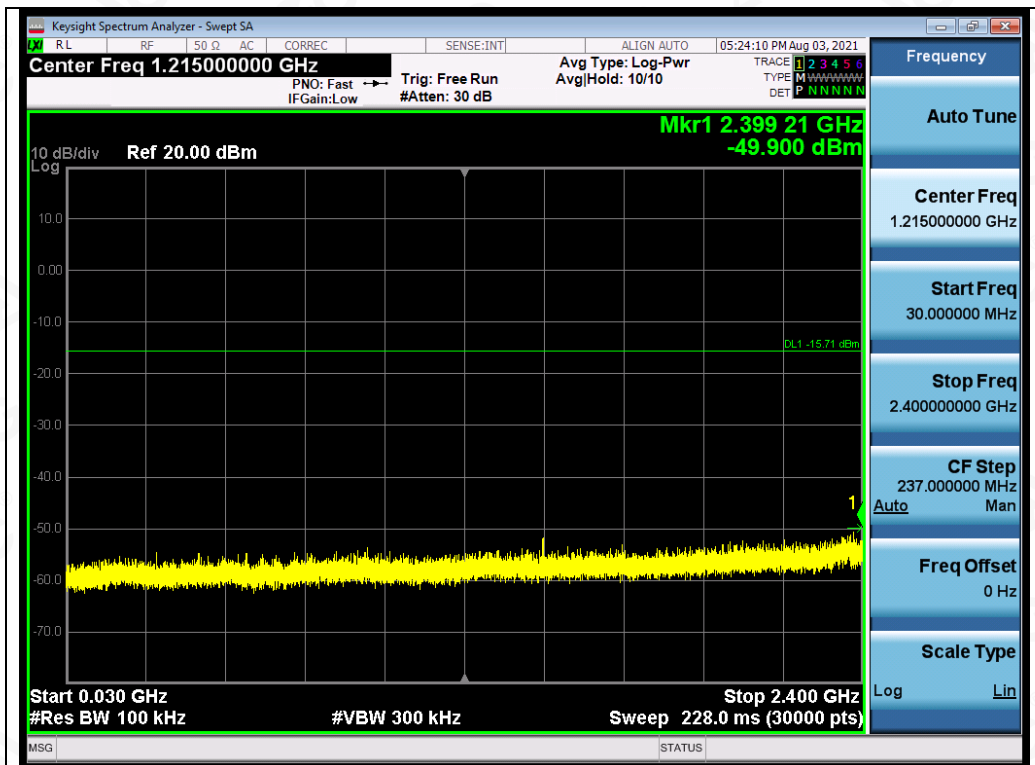

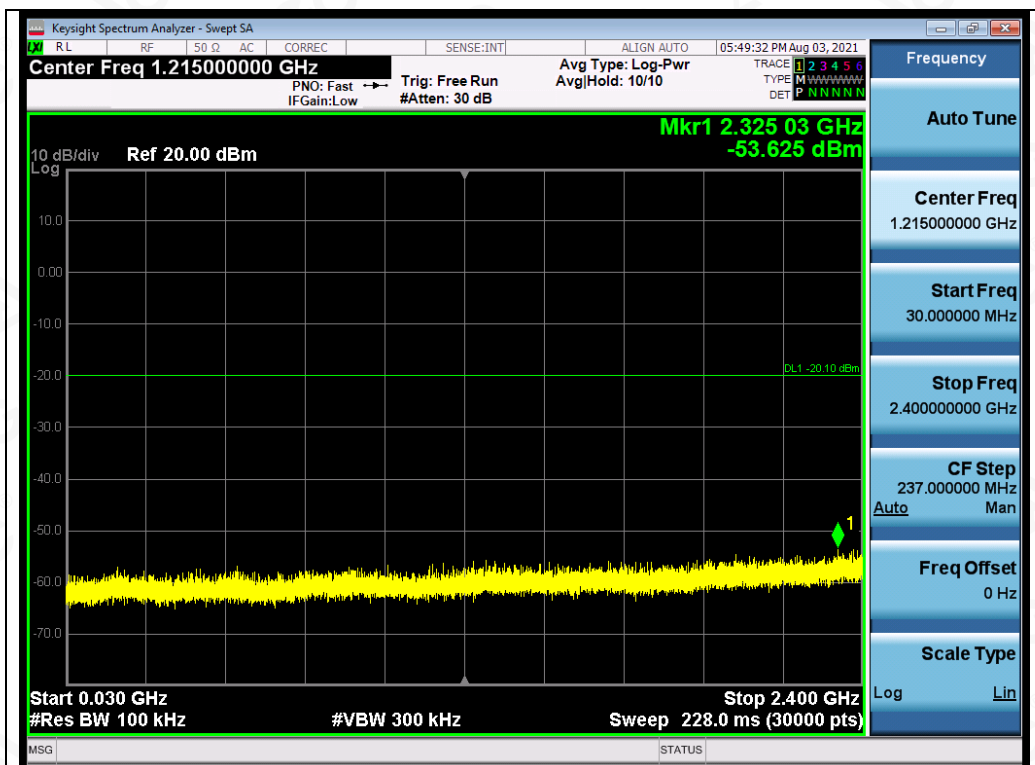

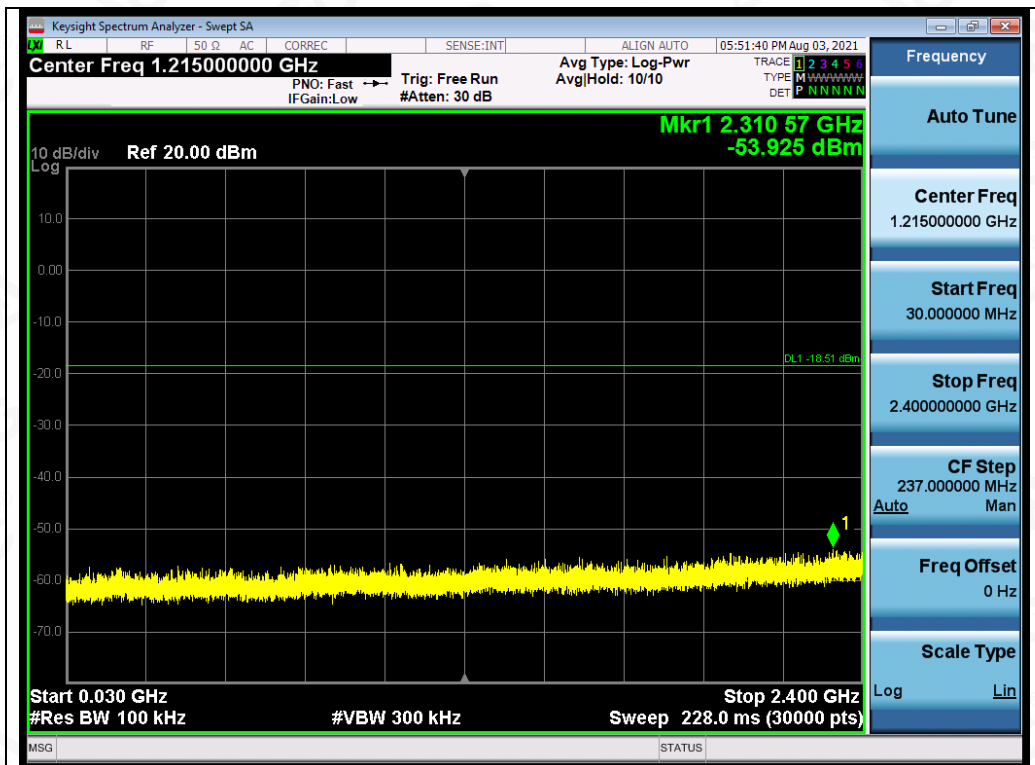

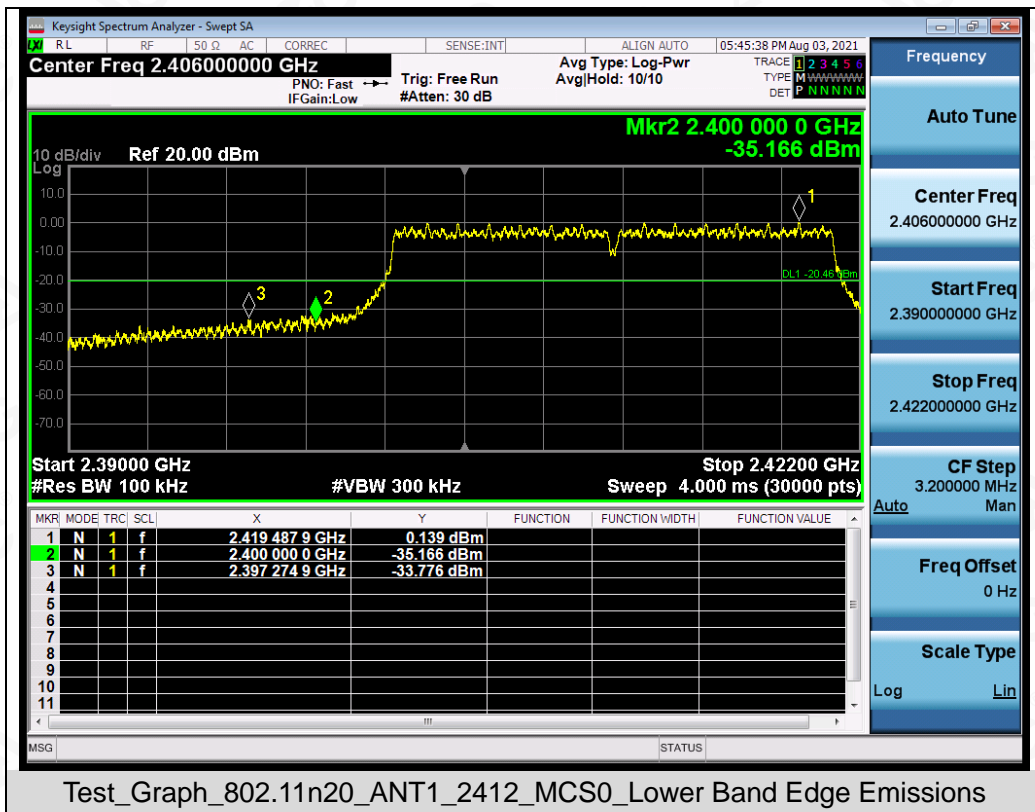
