
## 1. INTRODUCTION



f= Frequency in MHz

Calculation Formula:  $Pd = (Pout^{*}G)/(4^{*}pi^{*}r^{2})$ 

Where

 $Pd = power density in mW/cm^2$ 

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

r = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

#### CONCLUSION:

WLAN 2.4GHz Band and WLAN 5GHz can transmit simultaneously.

The max Power Density at R (20 cm) = 0.0514mW/cm<sup>2</sup> + 0.2036mW/cm<sup>2</sup> = 0.2549mW/cm<sup>2</sup> < 1mW/cm<sup>2</sup>.

So the safety distance is 20cm for device installed without any other radio equipment.
