
2. INTRODUCTION

4.2. MPE Exemptions

For single RF sources (i.e., any single fixed RF source, mobile device, or portable device, as defined in paragraph §1.1307(b)(2) of this section): A single RF source is exempt if:

(Option A) The available maximum time-averaged power is no more than 1 mW, regardless of separation distance. This exemption may not be used in conjunction with other exemption criteria other than those in paragraph §1.1307(b)(3)(ii)(A) of this section.

Medical implant devices may only use this exemption and that in paragraph §1.1307(b)(3)(ii)(A);

(Option B) Or the available maximum time-averaged power or effective radiated power (ERP), whichever is greater, is less than or equal to the threshold P (mW) described in the following formula. This method shall only be used at separation distances (cm) from 0.5 centimeters to 40 centimeters and at frequencies from 0.3 GHz to 6 GHz (inclusive). P is given by:

$$P th(mW) = \{ERP_{20cm}(d / 20cm)^x d \le 20cm\}$$

$$Pth(mW) = \{ERP_{20cm} \text{ 20cm} < d \leq 40cm\}$$

Where

$$x = -\log_{10}\left(\frac{60}{ERP_{20cm}\sqrt{f}}\right)$$
 and f is in GHz;

and

$$ERP_{20cm}(mW) = \{2040f \ 0.3GHz \le f < 1.5GHz\}$$

$$ERP_{20cm}(mW) = \{3060 \ 1.5GHz \le f \le 6GHz \$$

(**Option C**) Or using Table 1 and the minimum separation distance (R in meters) from the body of a nearby person for the frequency (f in MHz) at which the source operates, the ERP (watts) is no more than the calculated value prescribed for that frequency. For the exemption in Table 1 to apply, R must be at least $\lambda/2\pi$, where λ is the free-space operating wavelength in meters. If the ERP of a single RF source is not easily obtained, then the available maximum time-averaged power may be used in lieu of ERP if the physical dimensions of the radiating structure(s) do not exceed the electrical length of $\lambda/4$ or if the antenna gain is less than that of a half-wave dipole (1.64 linear value).

(B) in the case of fixed RF sources operating in the same time-averaging period, or of multiple mobile or portable RF sources within a device operating in the same time averaging period, if the sum of the fractional contributions to the applicable thresholds is less than or equal to 1 as indicated in the following equation.

c = number of existing fixed, mobile, or portable RF sources with known evaluation for the specified minimum distance including existing evaluated transmitters.

The EUT supports Wi-Fi 2.4GHz (DTS) + Wi-Fi 5GHz (NII-1/2a) + Wi-Fi 5GHz (NII-2C/3) simultaneous transmissions.

So the Max Simultaneous Transmission = 871.0/3060 (DTS) + 762.1/3060 (NII-1/2a) + 762.1/3060 (NII-2c/3)= 0.7827 < 1

Therefore, the device qualifies for RF exposure test exemption.
