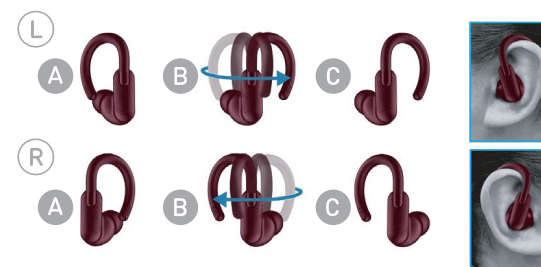

[CF] **A** Retirez les écouteurs du boîtier. **B** Faites pivoter l'écouteur vers vous **[NE FAITES PAS pivoter le earhook loin de vous dans la mauvaise direction, car cela pourrait endommager le crochet].** **C** Placez le crochet d'oreille sur votre oreille, et l'écouteur fermement dans votre oreille.
