the first step is to make sure that the Bluetooth of the phone is off. Take out two earphones, wait 10 seconds, earphones light changes from fast flashing to synchronous slow flashing, which means that the earphone has been paired. (two mode)



Turn on Bluetooth on your mobile phone, search for SP20 devices and click on the connection.



Call phone connection successful, two earphone light off.

the earphone touch control is marked in red circle



If only one side has sound, please first delete the SP20 that has been connected, turn off the Bluetooth of your phone, the earphones need to be paired once, enter the two mode, and return to the first step.

Important: Plug in the charging wire for charging at the first time after receiving the goods, and use it after fully charging, which can make the Bluetooth headset last longer.

Important: Do not use super fast charging with current above 2A to avoid damaging the circuit chip due to excessive current.

The connection steps are as follows:

1. Open the cover, the first step to make sure that the Bluetooth of the phone is off.
2. Take out two earphones from charge box, wait 10 seconds, the earphones light changes from fast flashing to synchronous slow flashing, which means that the earphone has been paired. (two mode) earphones makes a sound "paired".
3. Turn on the Bluetooth of your phone, search for "SP20", click Connect.

Touch function

1. Click on the earphone touch area: play/pause
2. Double-click the earphone touch area: pull-back/volume up
3. Triple-tap earphone touch area: volume down/volume up
4. Quadruple tap left earphone touch area: summon Siri function
5. Long press 2 seconds earphone touch area: previous/next song



Charging method:

Plug in the cable we sent, and be careful to plug it in to the end. The number of the display flashes to recharge the earphone charging compartment. When you charge the display "100", it is full. (with power display)
