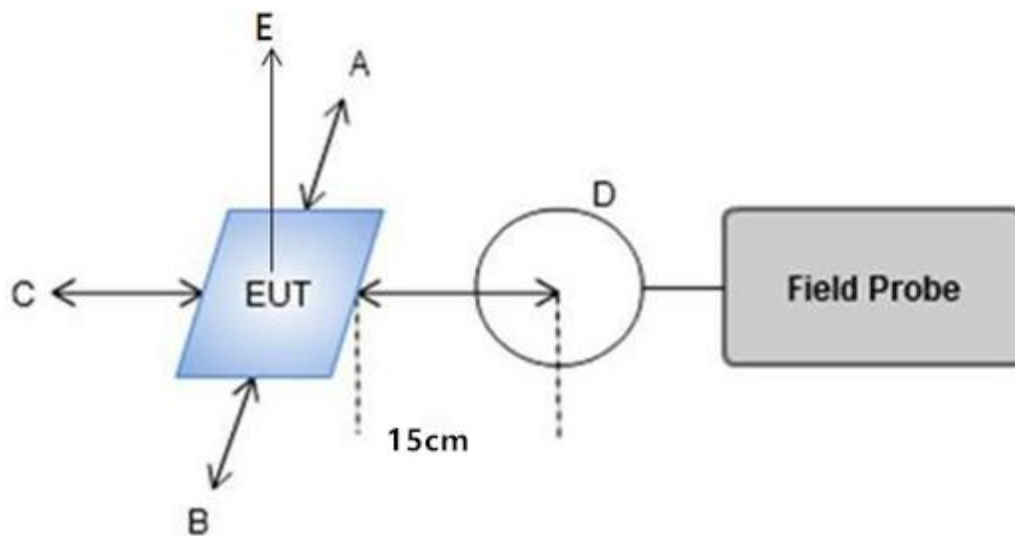

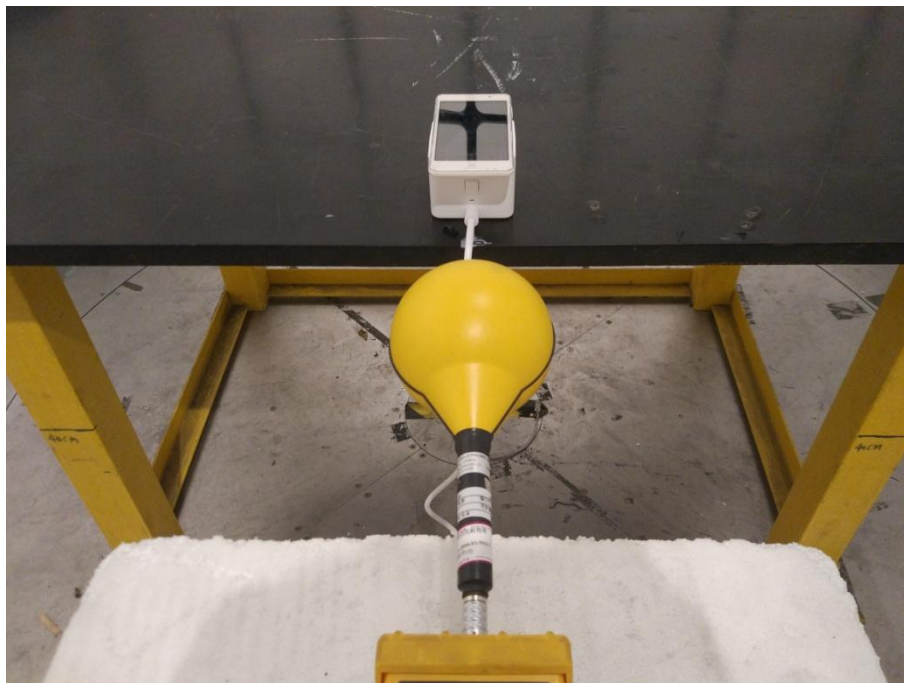
2.2 TEST PROCEDURE

For devices designed for typical desktop applications, such as wireless charging pads, RF exposure evaluation should be at 15 cm surrounding the device and 20 cm above the top surface. E and H field strength measurements or numerical modeling may be used to demonstrate compliance. Measurements should be made from all sides and the top of the primary/client pair at 15 cm surrounding the device and 20 cm above the top surface.
