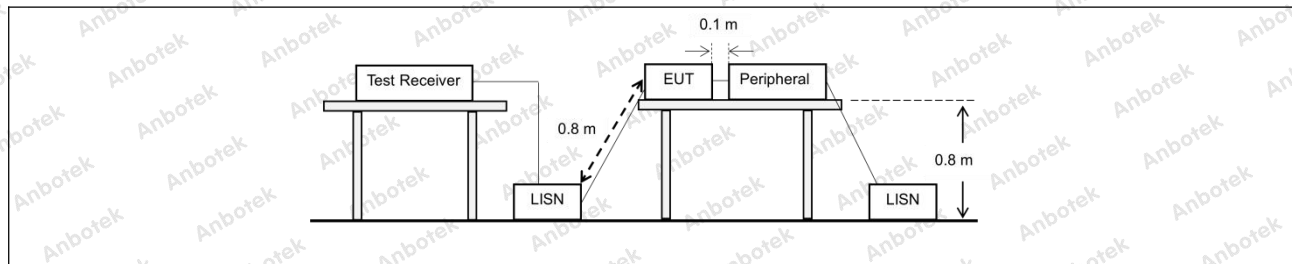

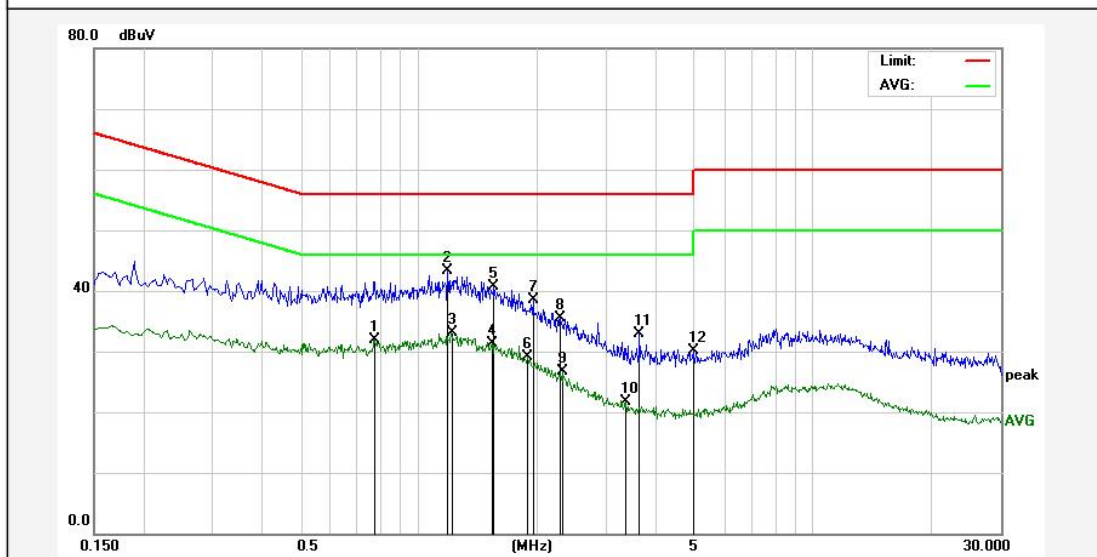

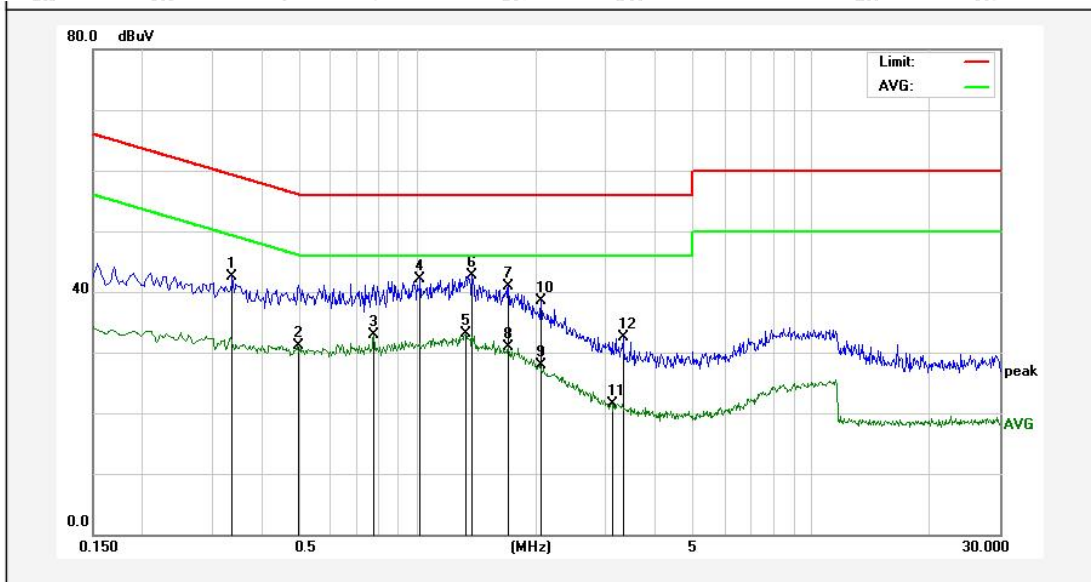

## 4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)
