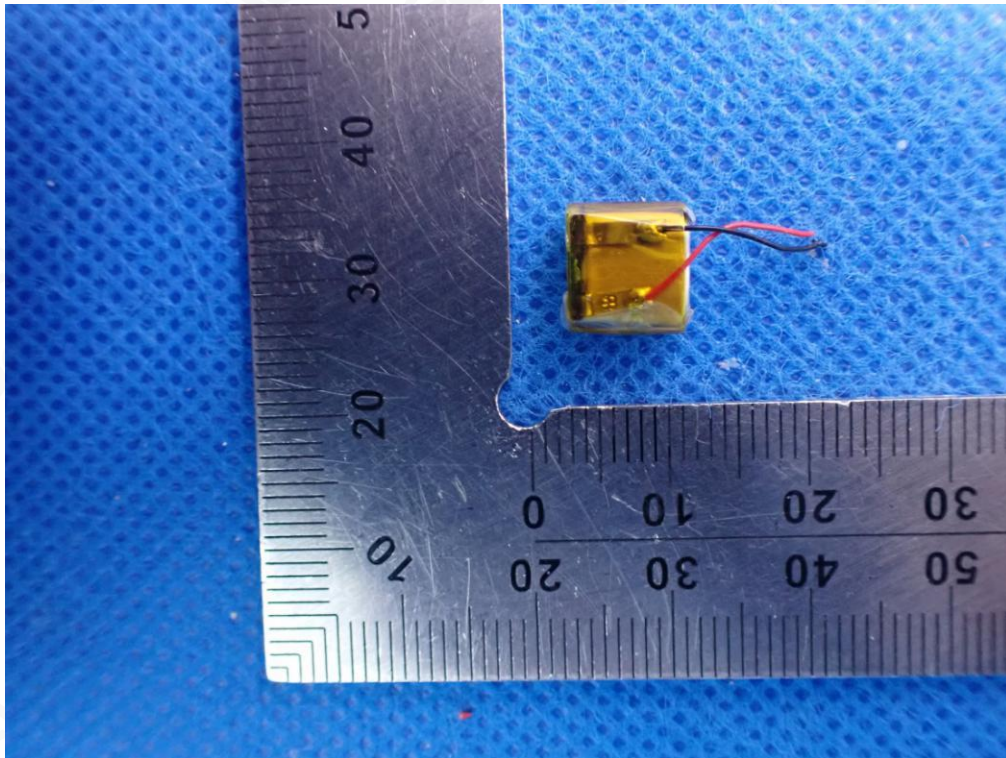
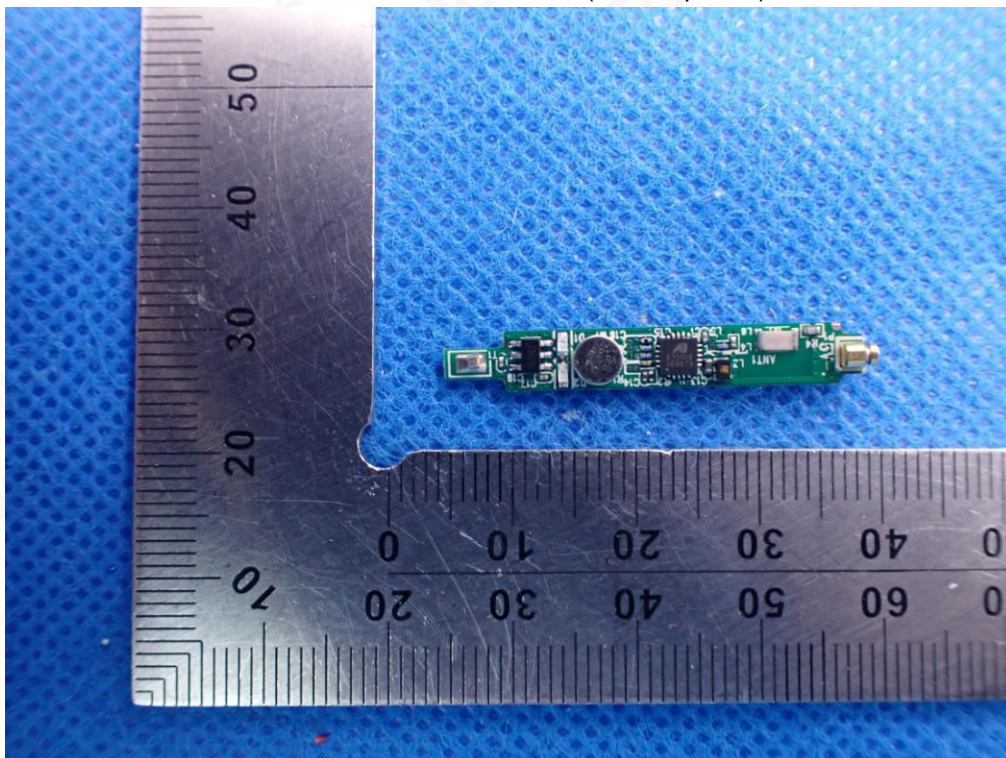


INTERNAL VIEW-2 OF EUT(Left earphone)



INTERNAL VIEW-3 OF EUT(Left earphone)

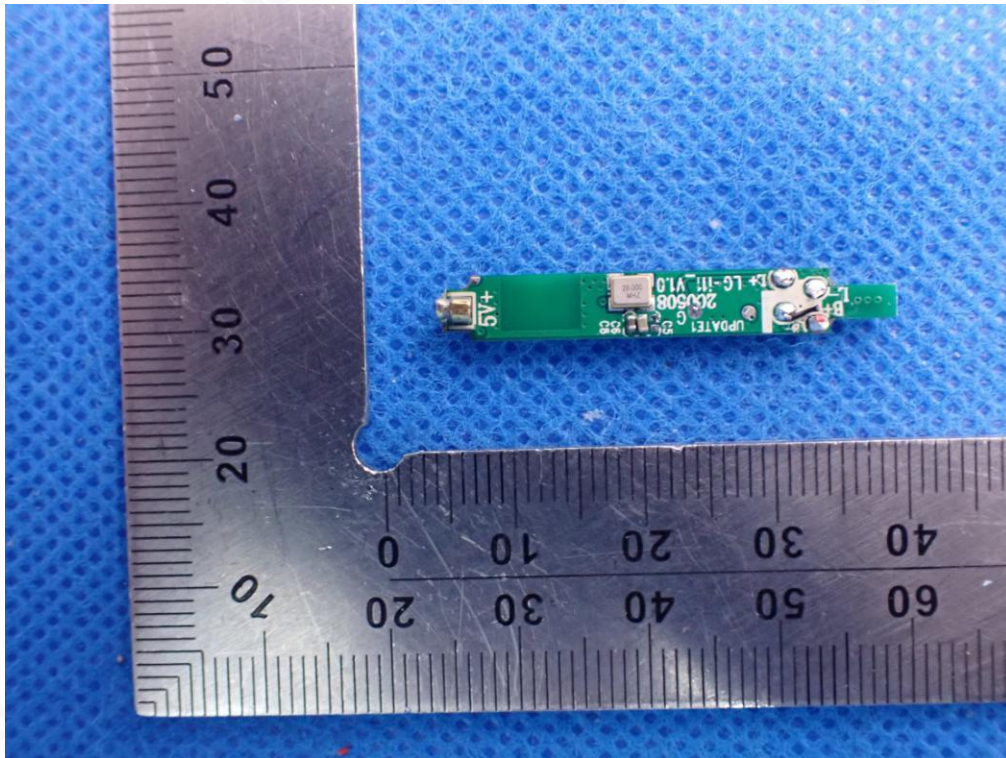

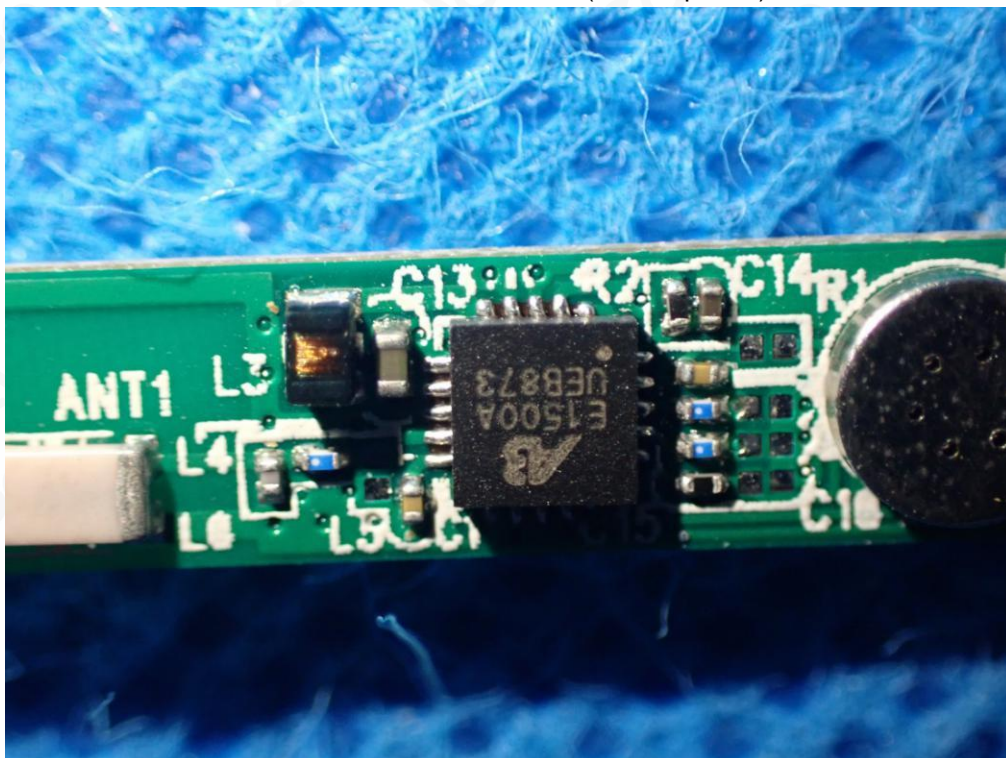

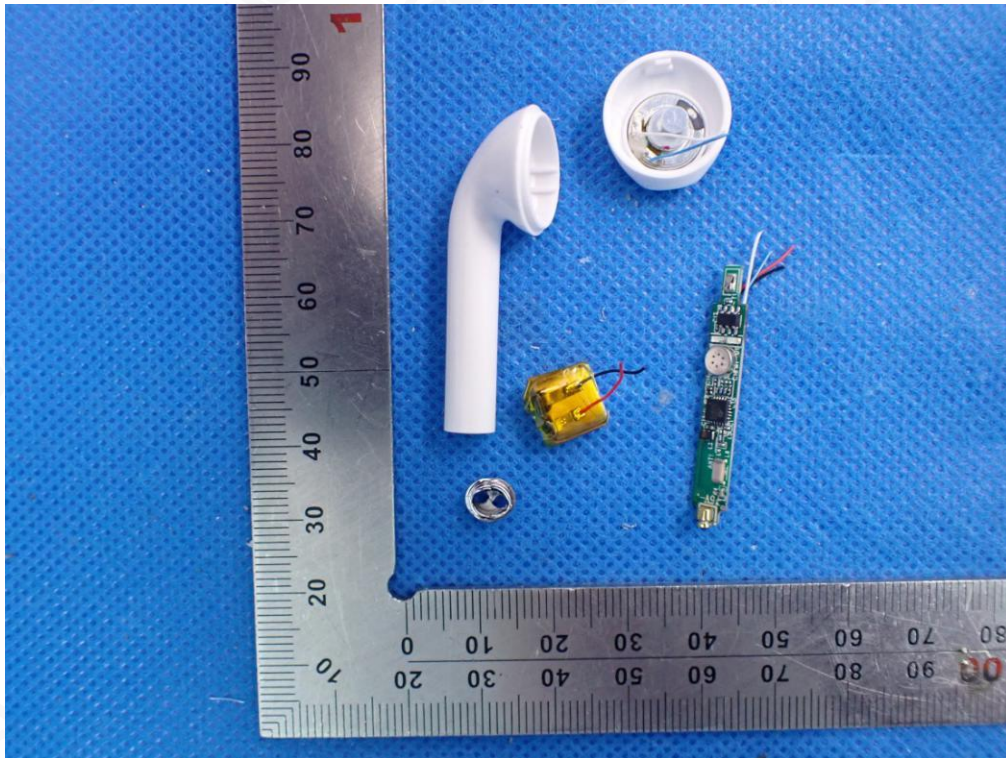

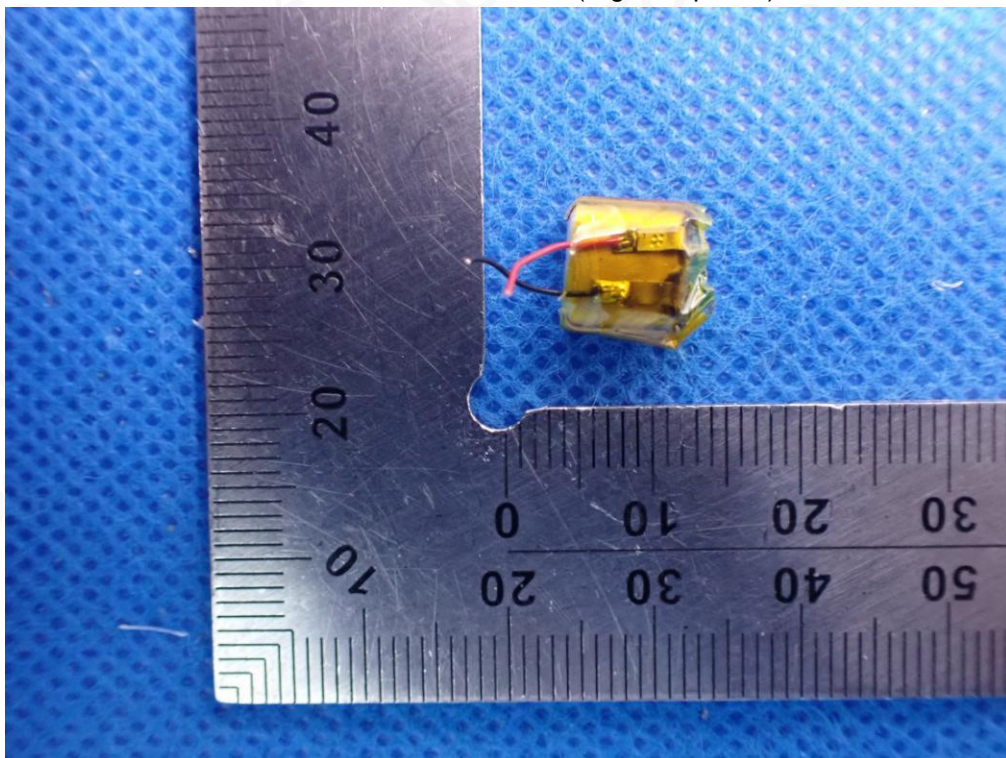

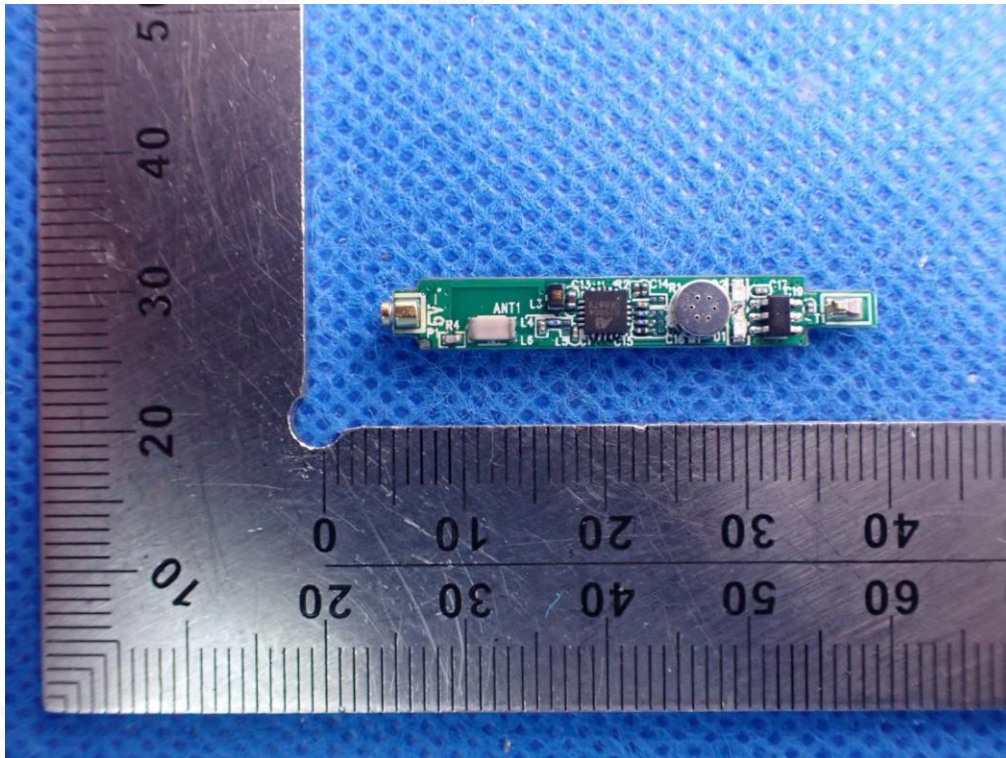

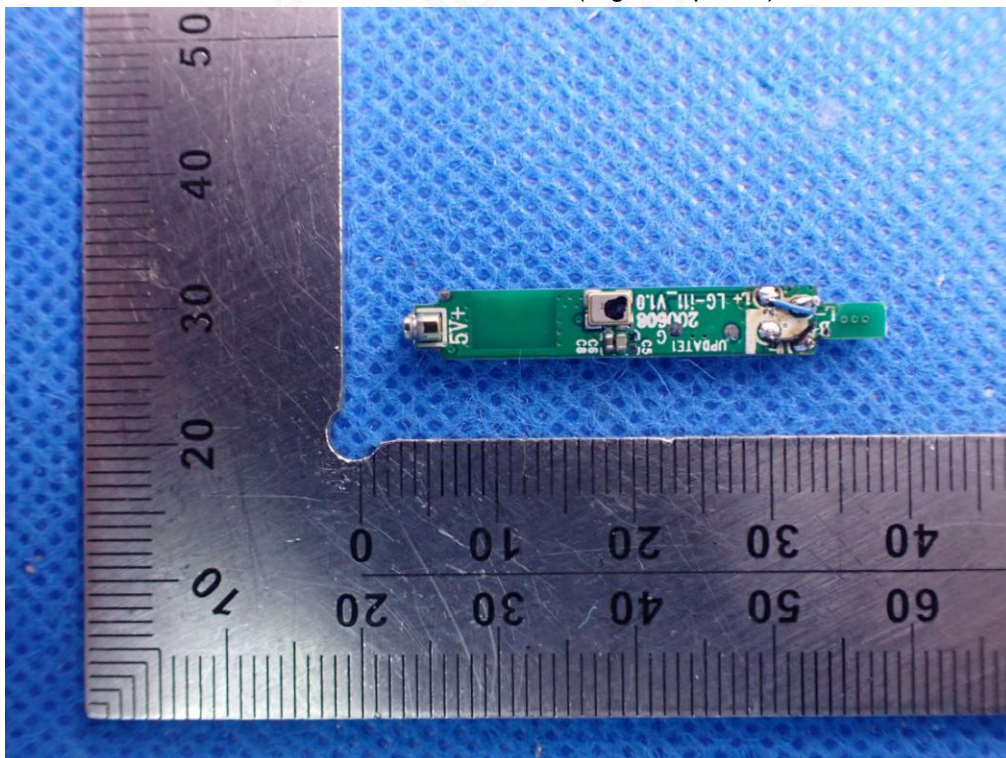

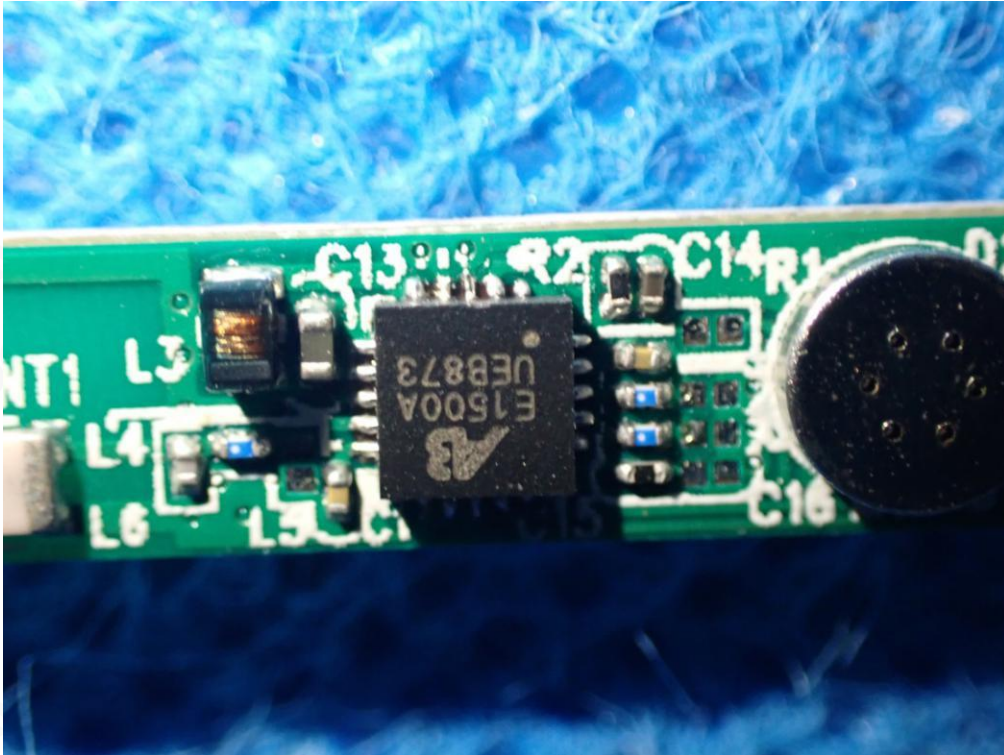

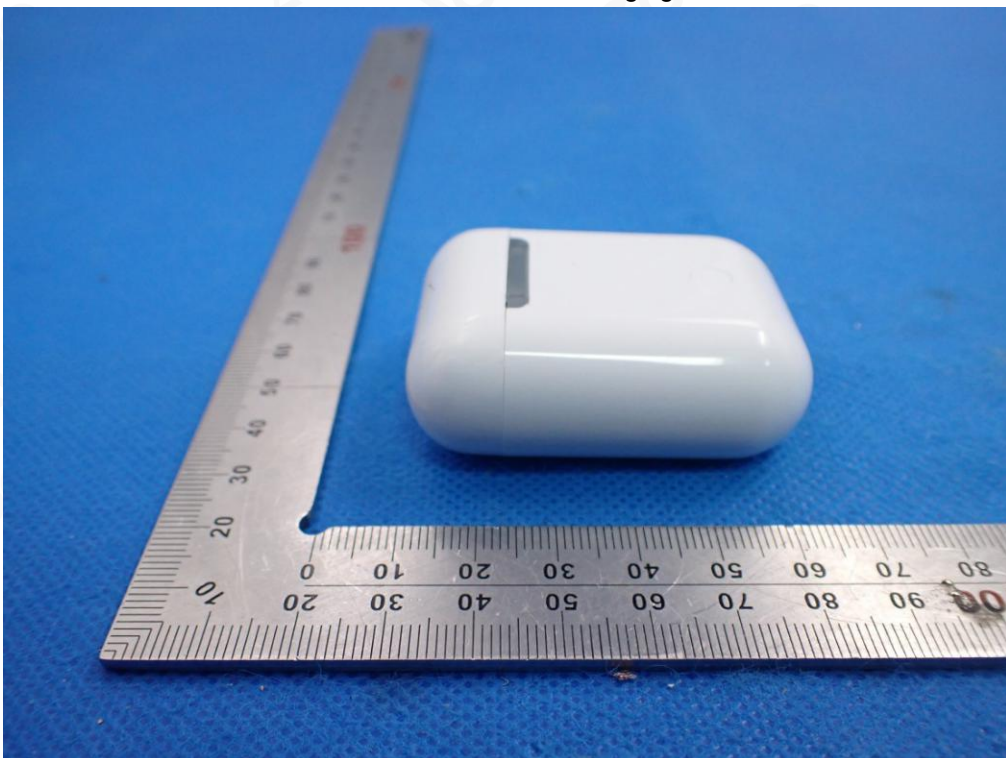

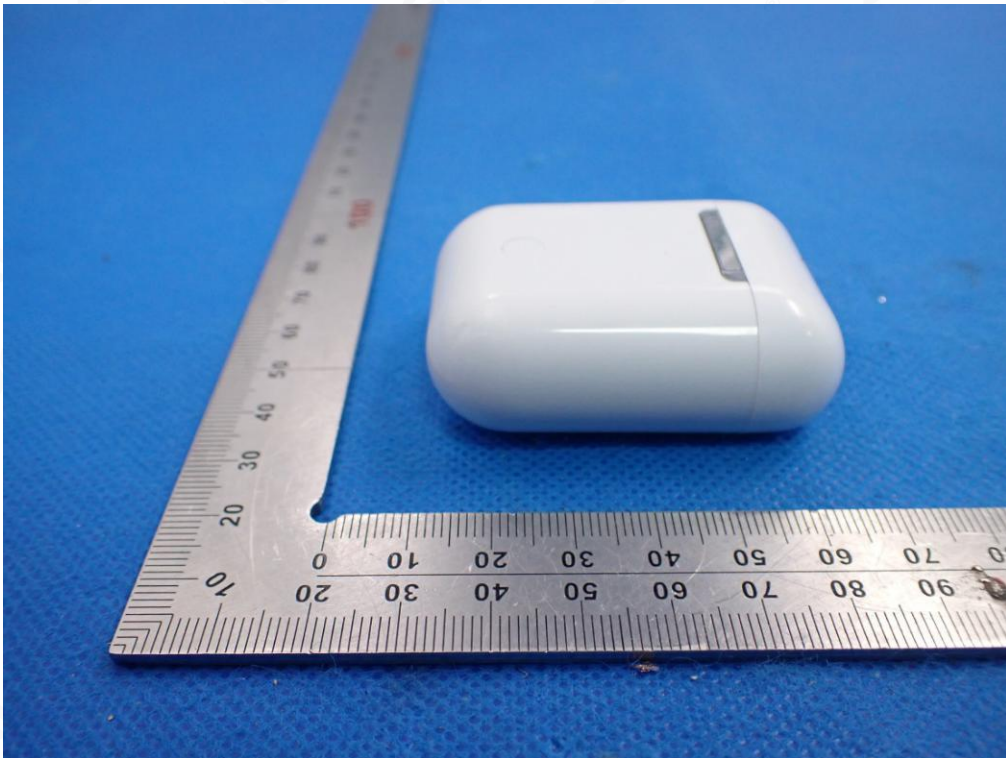

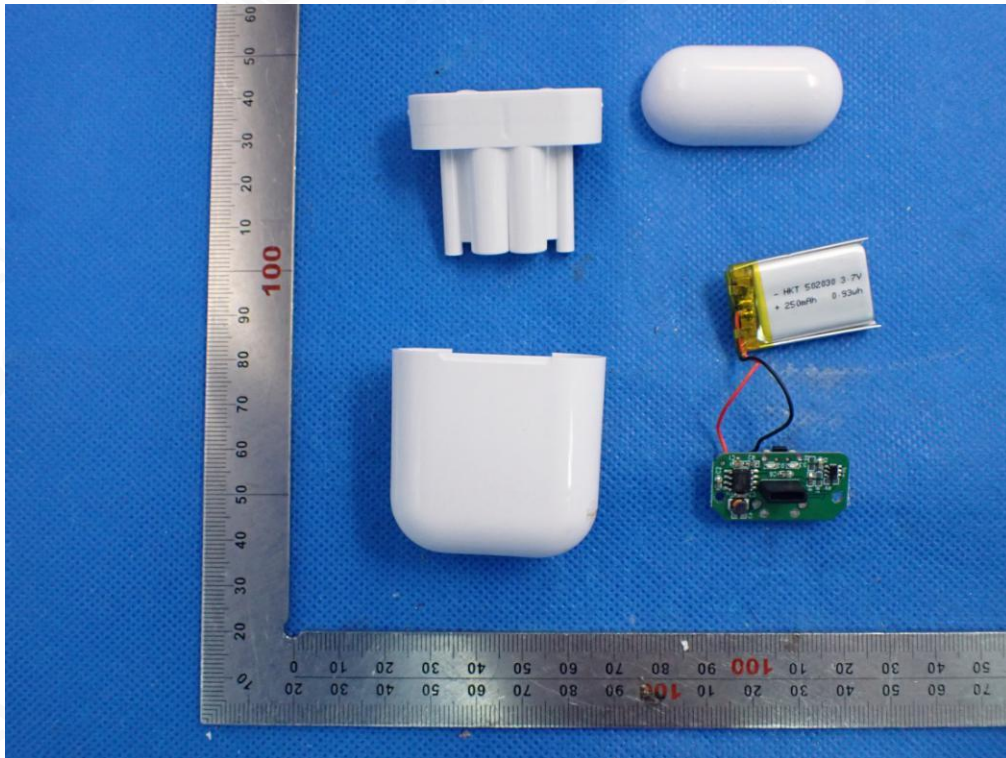

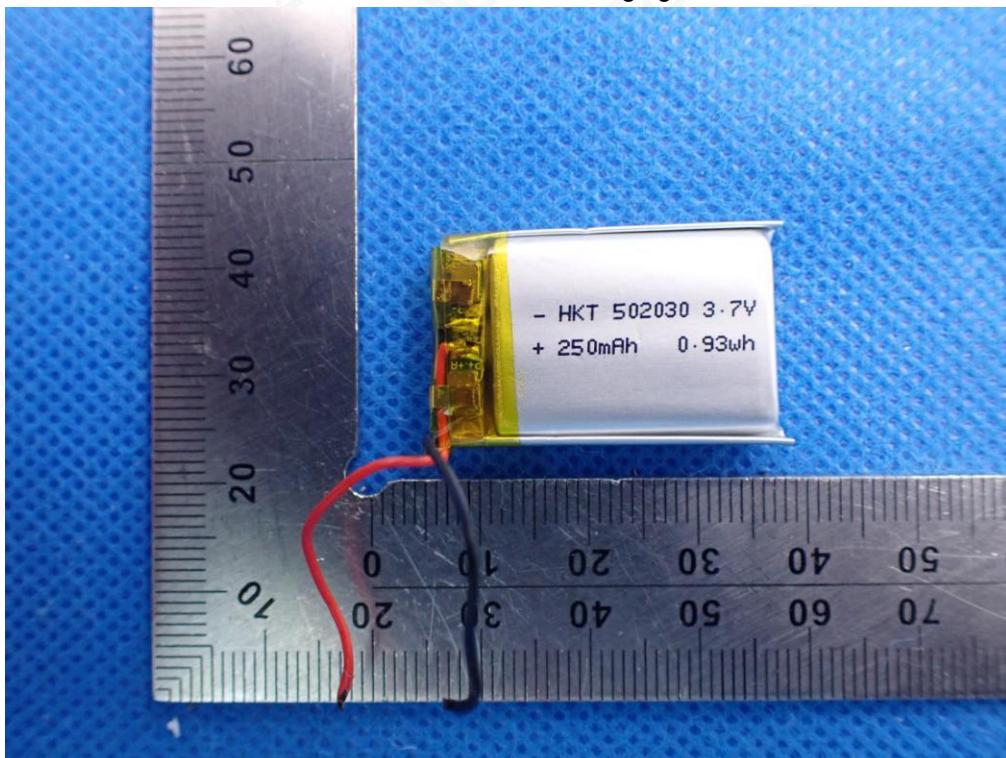

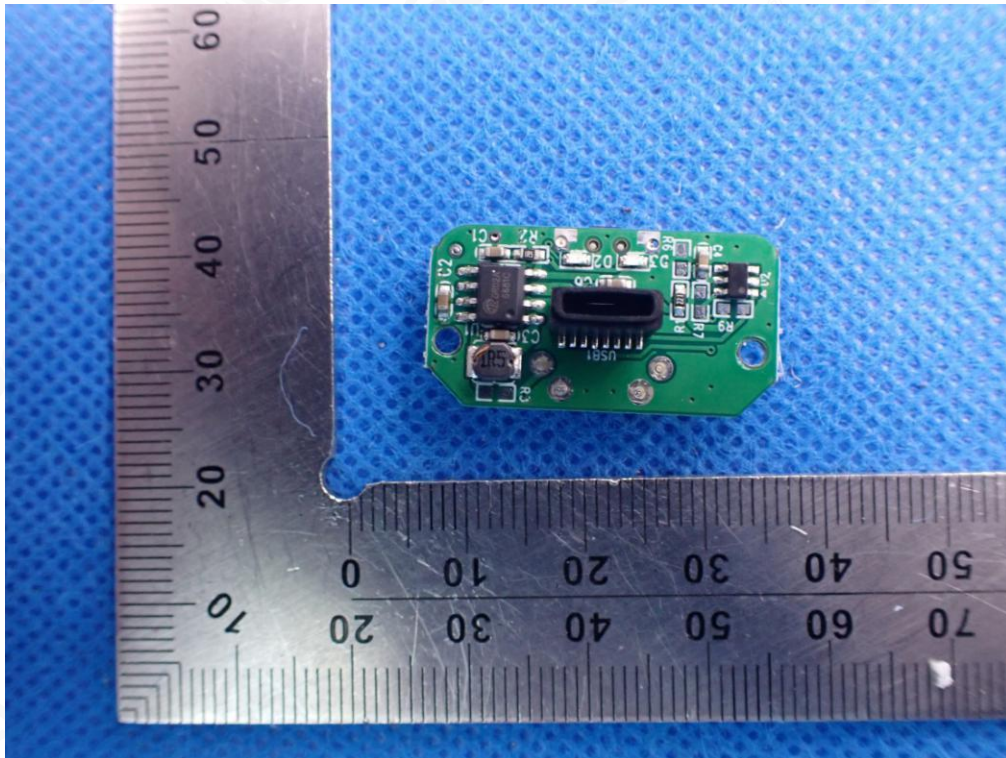

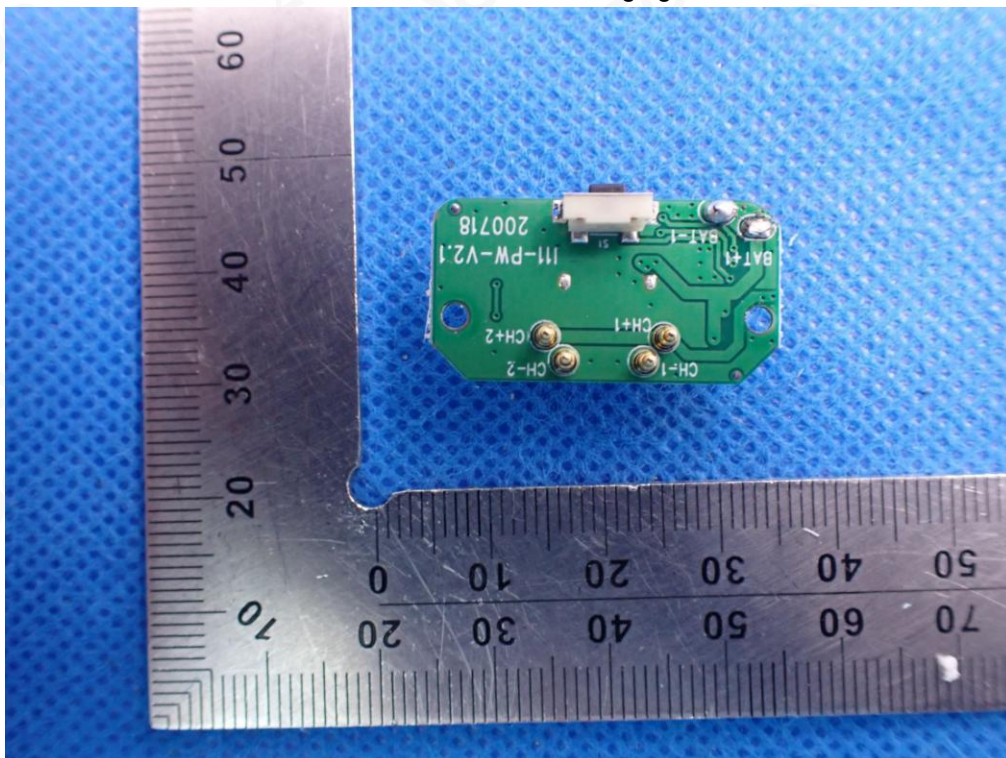
