

5.2 MPE Calculation

The E.I.R.P. is: 31.26mW;

According to the formula $S = \frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

- 1) P (Watts)
- 2) G (Antenna gain in numeric)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

$$S = \frac{PG}{4R^2\pi} = 31.26 / (4 \times 400 \times 3.14) = 0.0062 \text{mW/cm}^2 < 1 \text{mW/cm}^2$$

So the device is exclusion from SAR test.
