# 2. Exposure Evaluation of Portable or Mobile Devices

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq$  50 mm are determined by

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance,

mm)] •  $[\sqrt{f(GHz)}] \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR

where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
