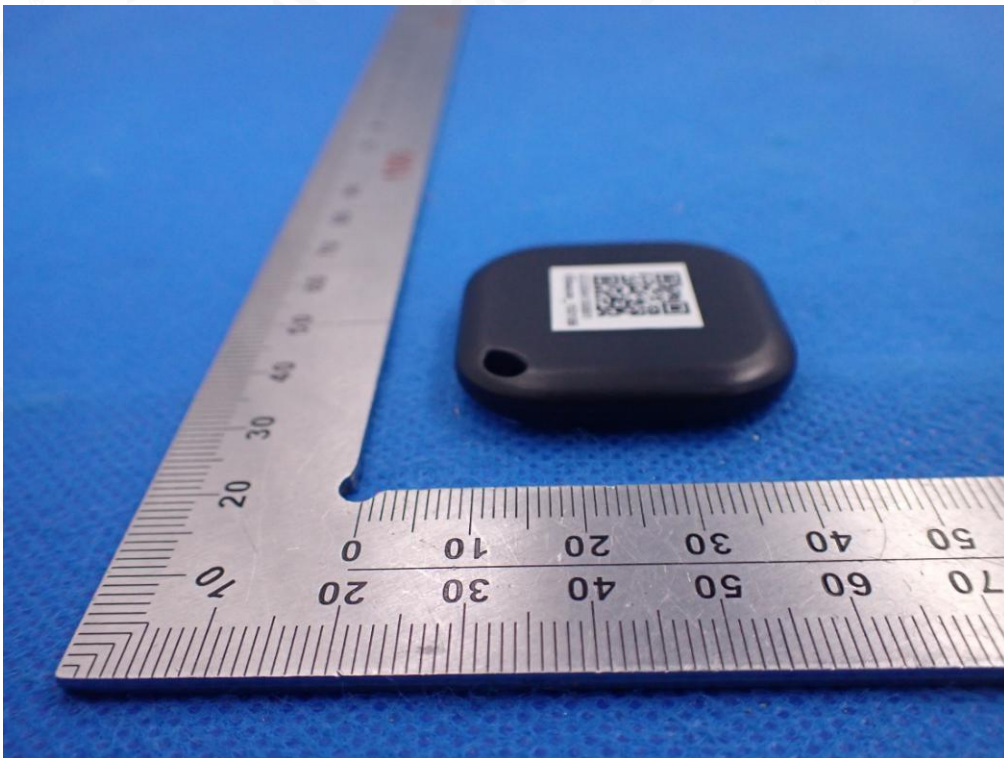


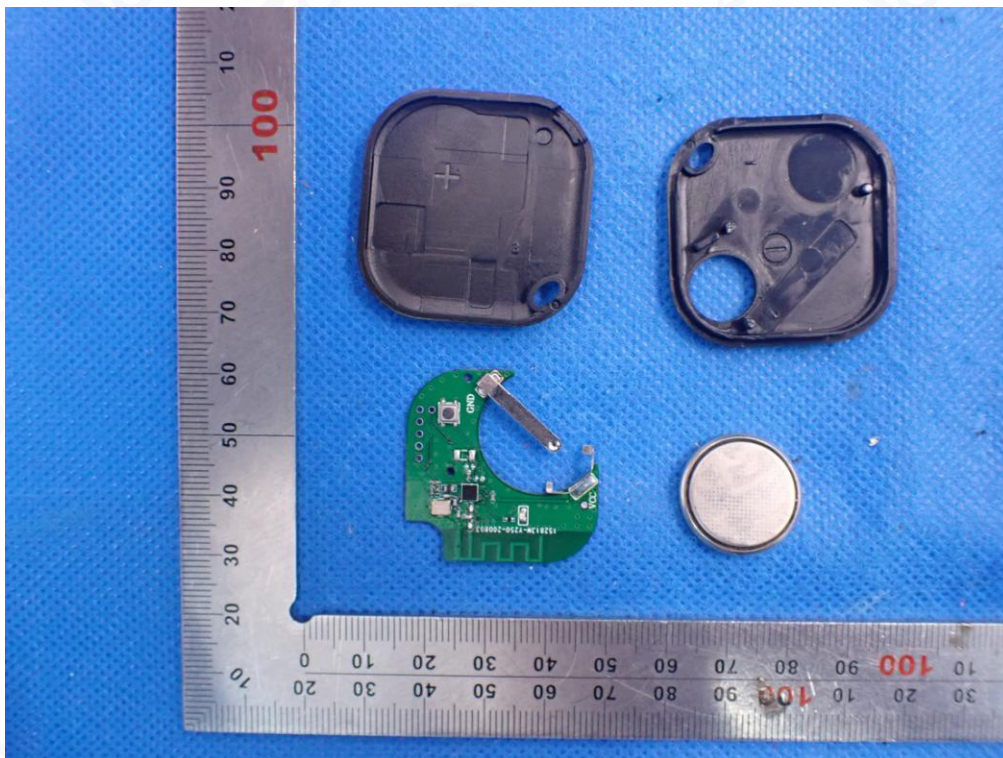
EXTERNAL VIEW-6 OF EUT(K11)



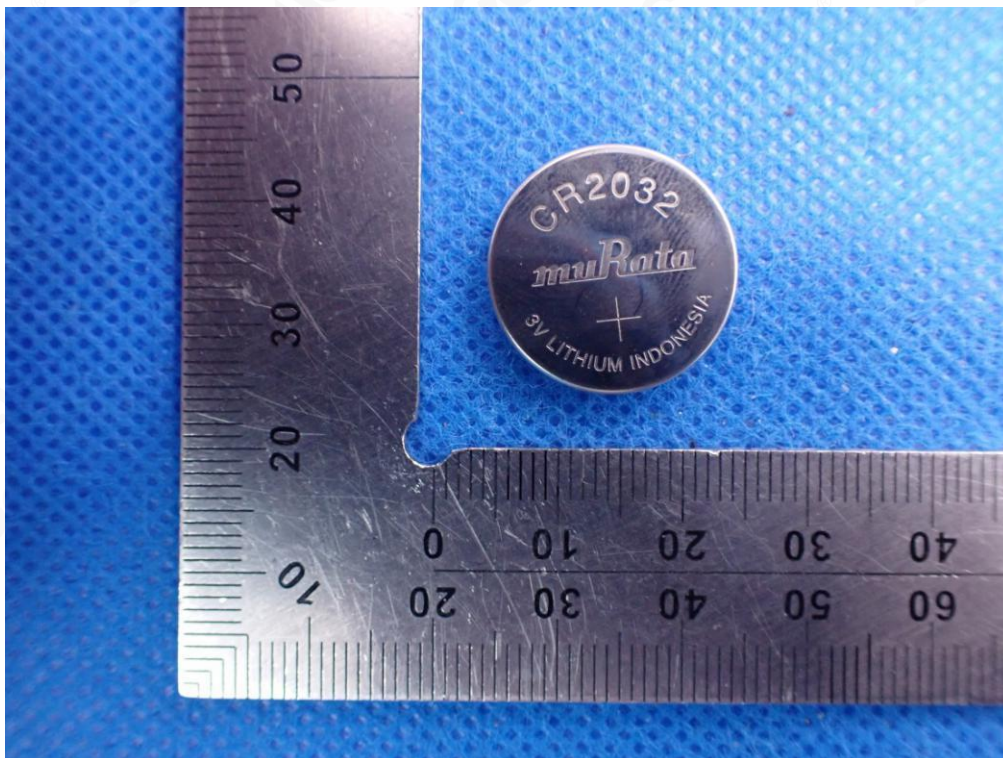

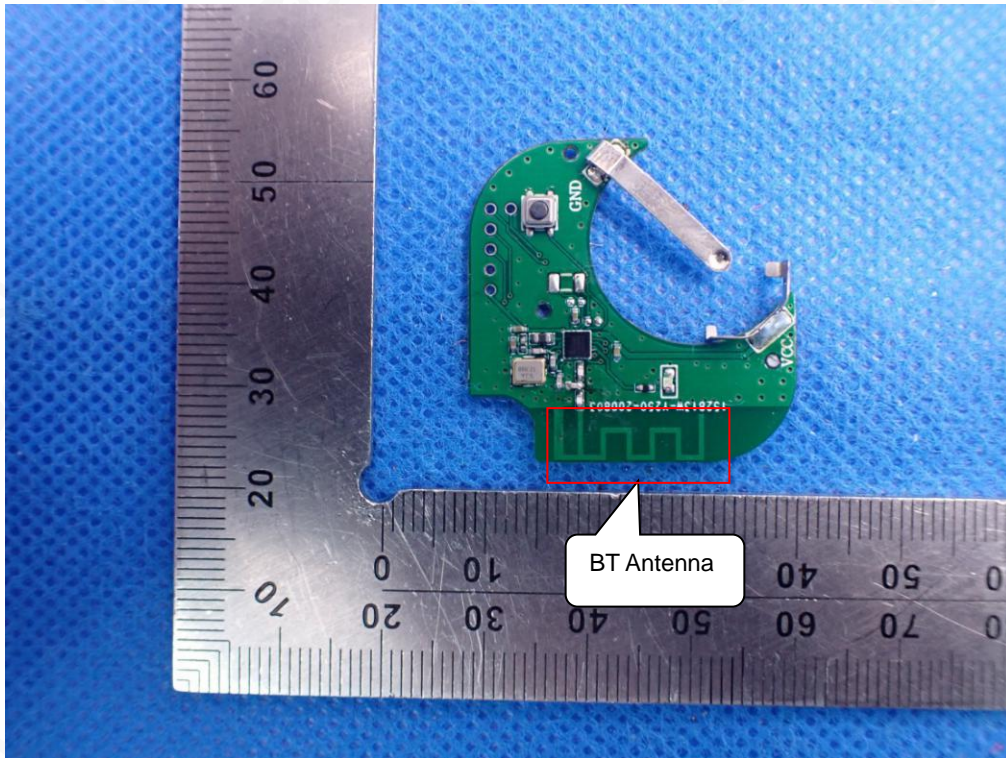
INTERNAL VIEW-2 OF EUT(K11)



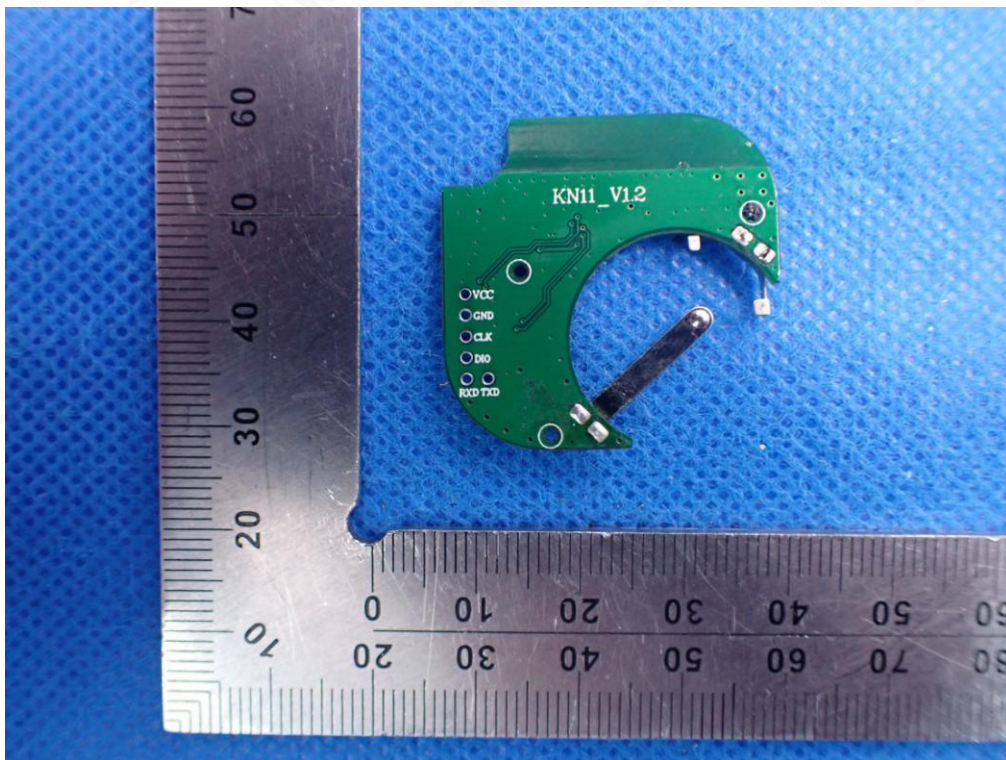

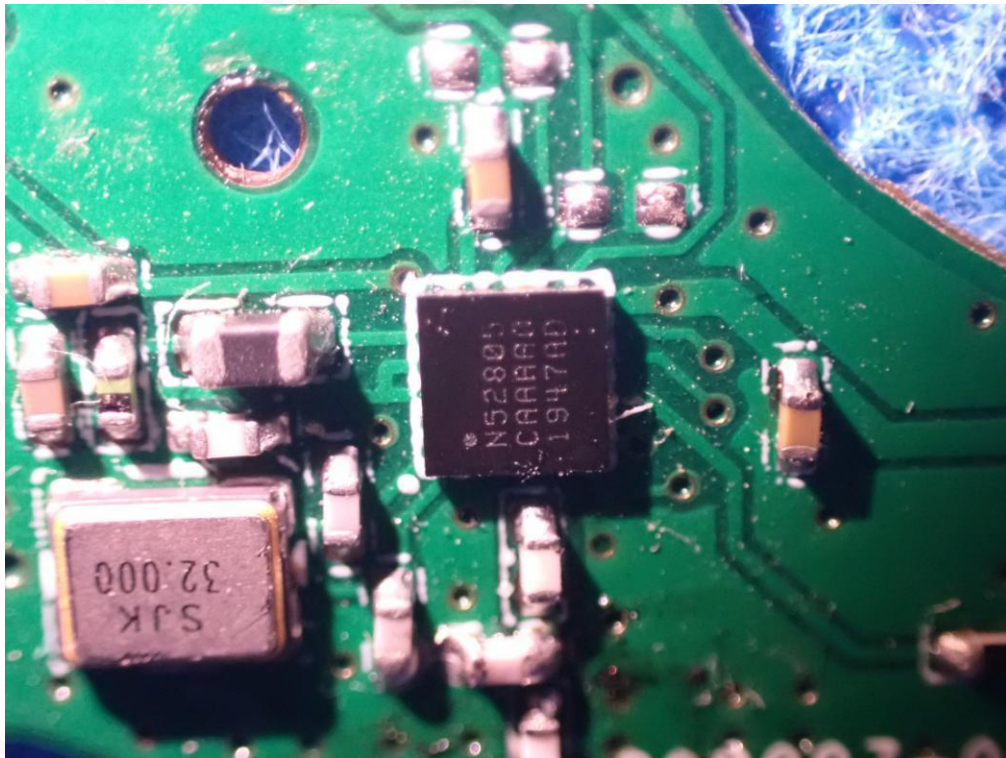
INTERNAL VIEW-4 OF EUT(K11)



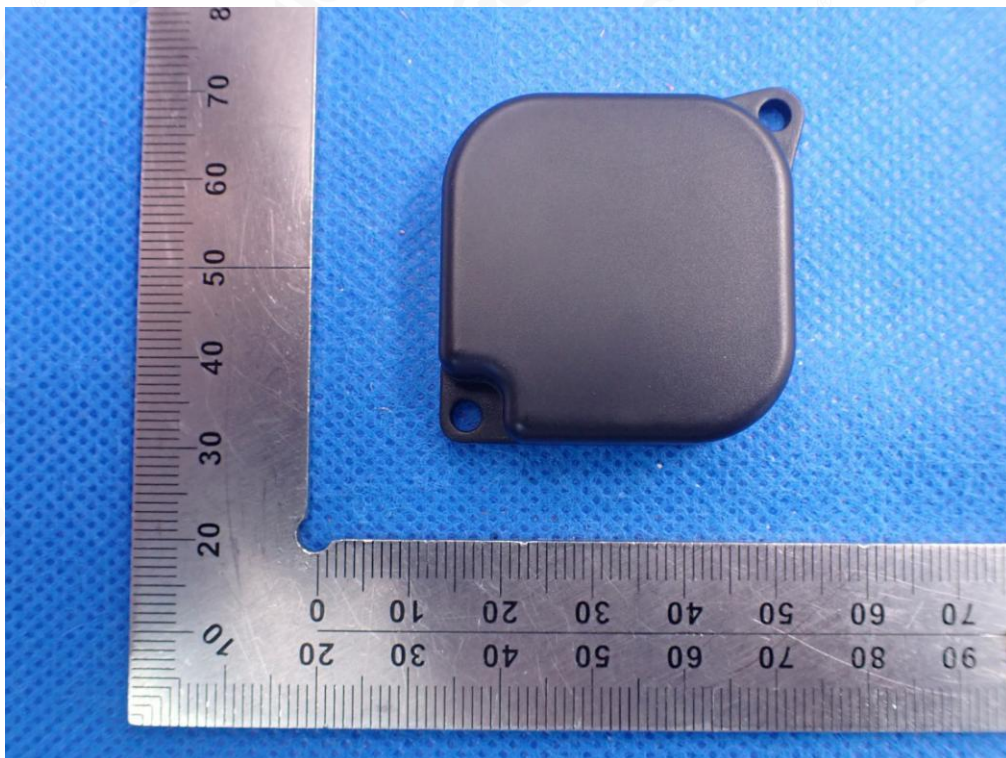

EXTERNAL VIEW-1 OF EUT(K12)

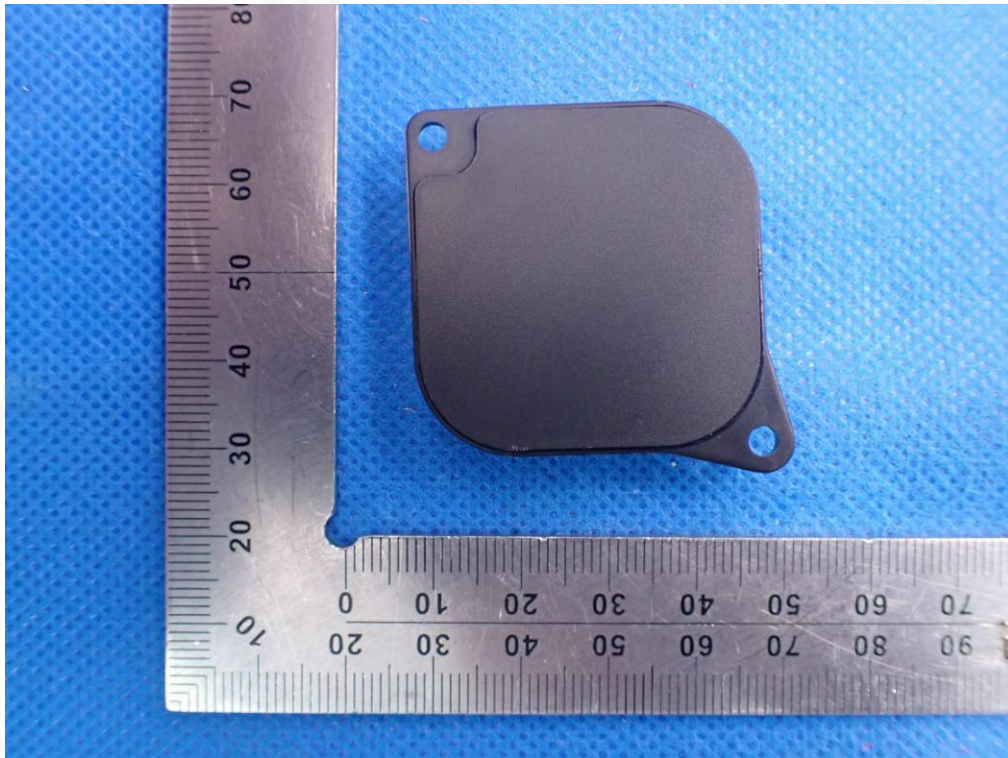

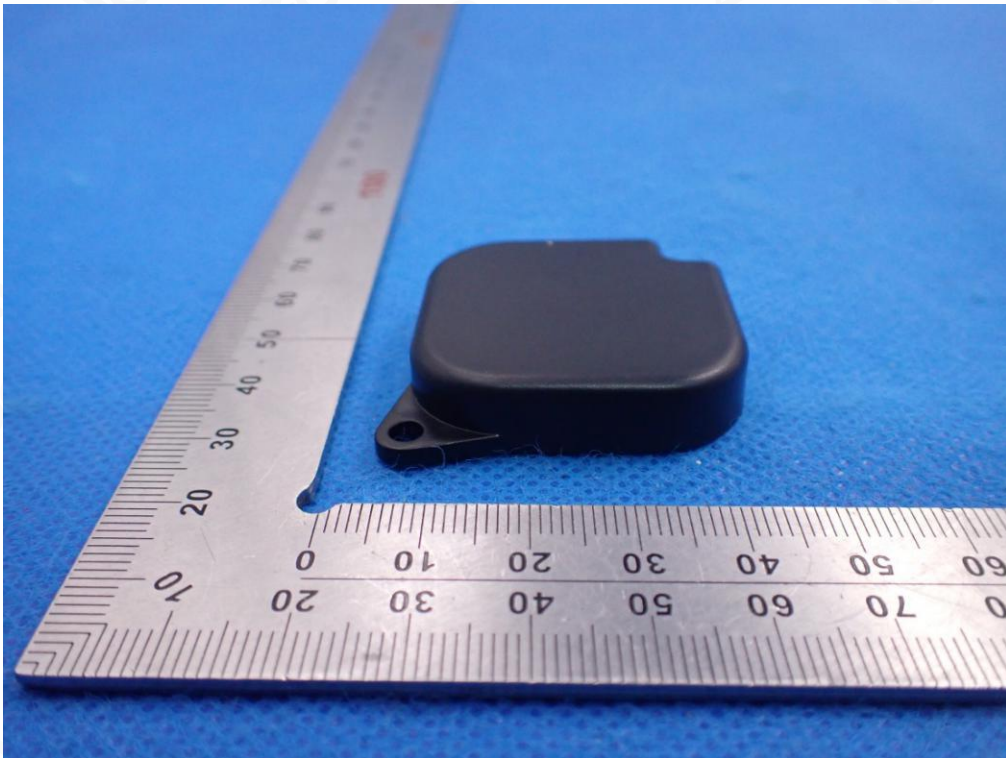

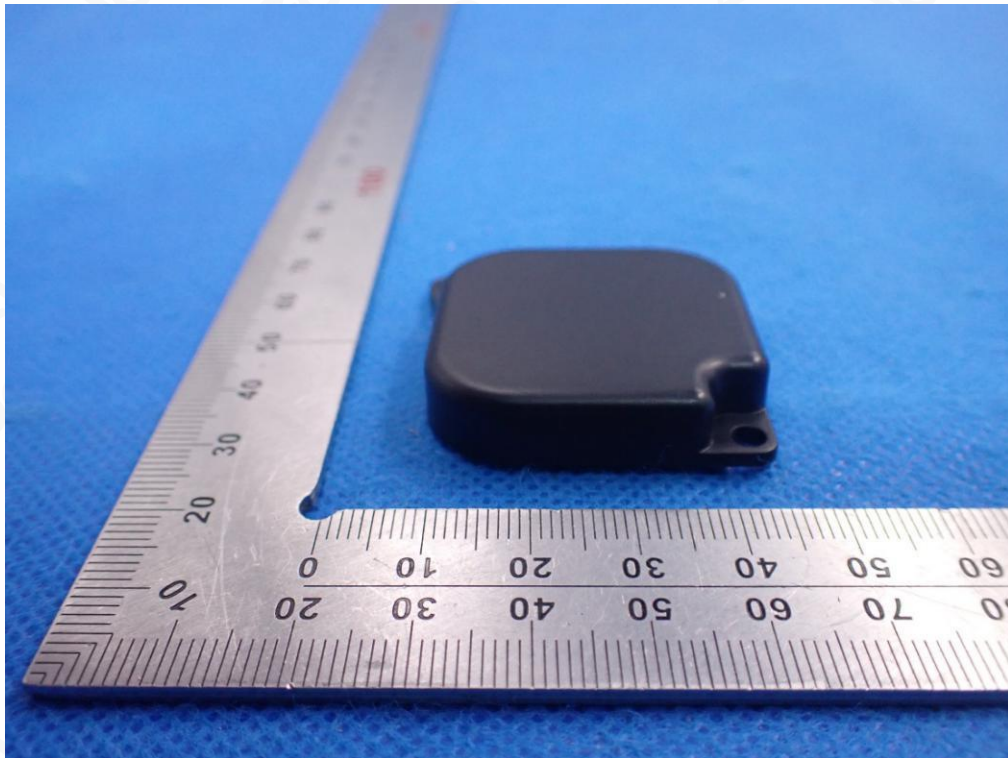

INTERNAL VIEW-3 OF EUT(K12)

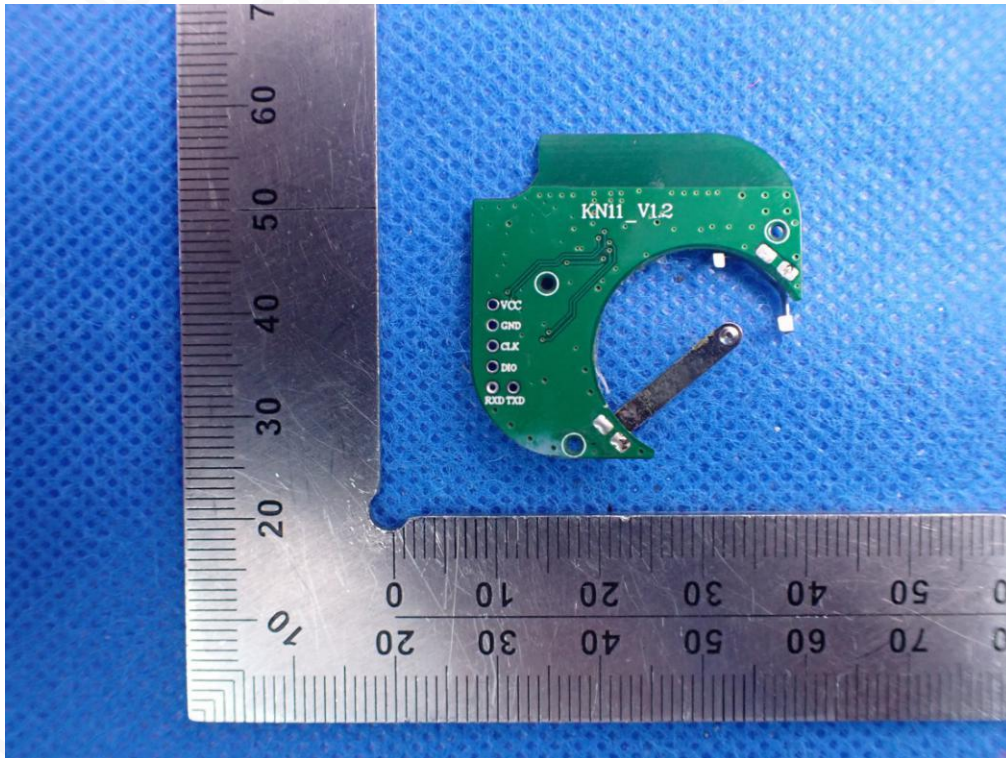

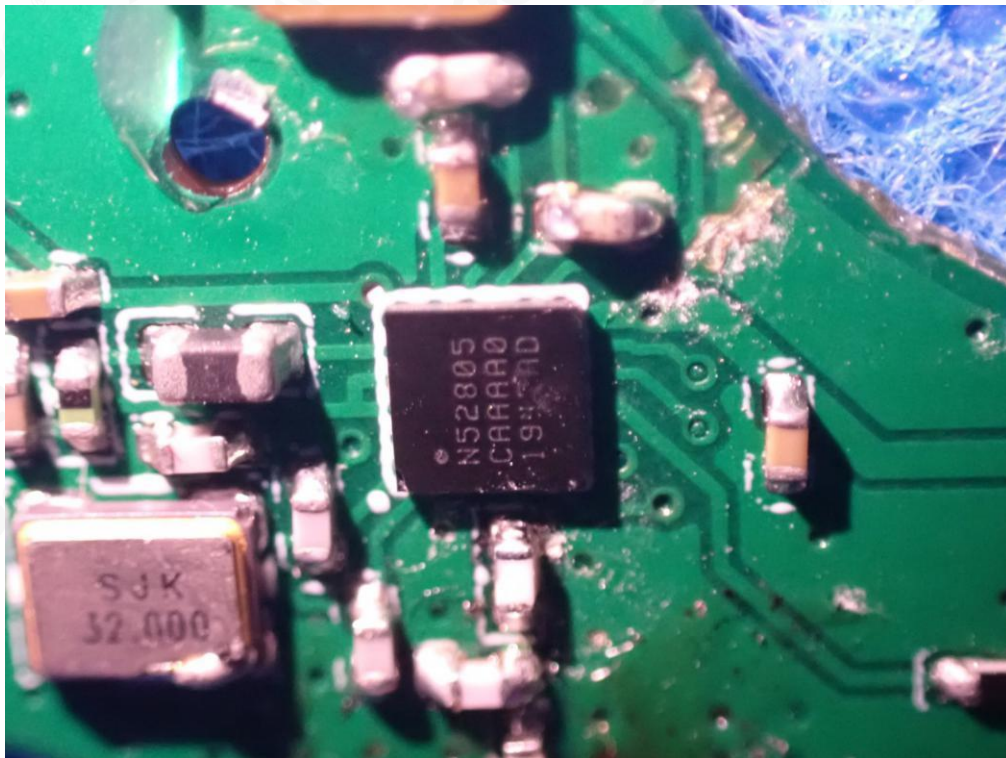
