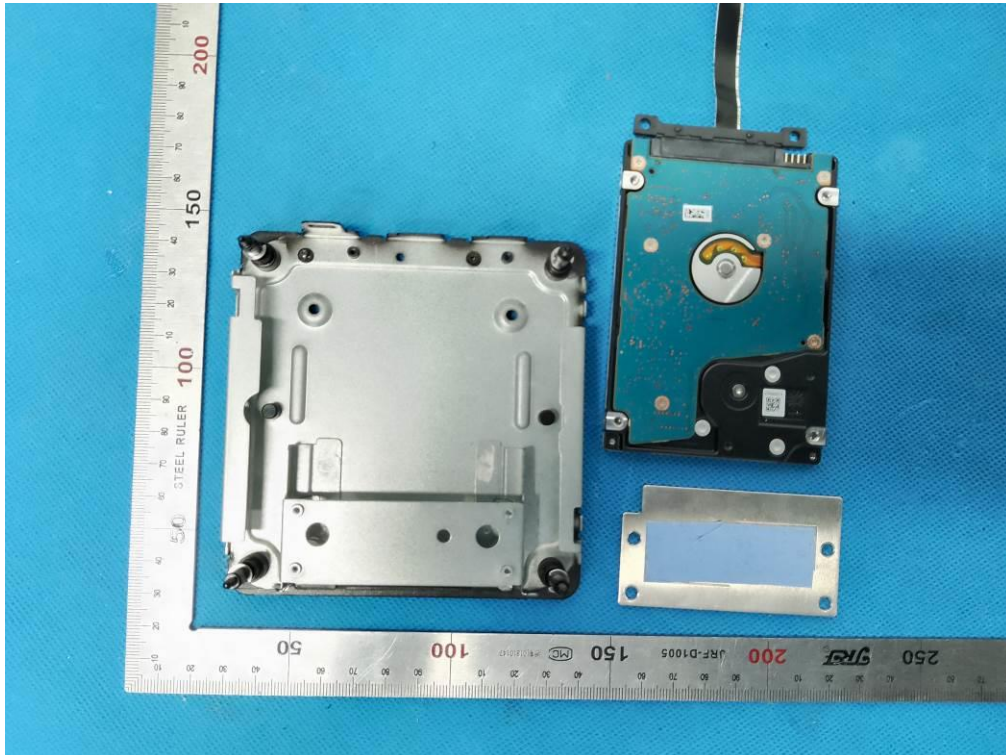

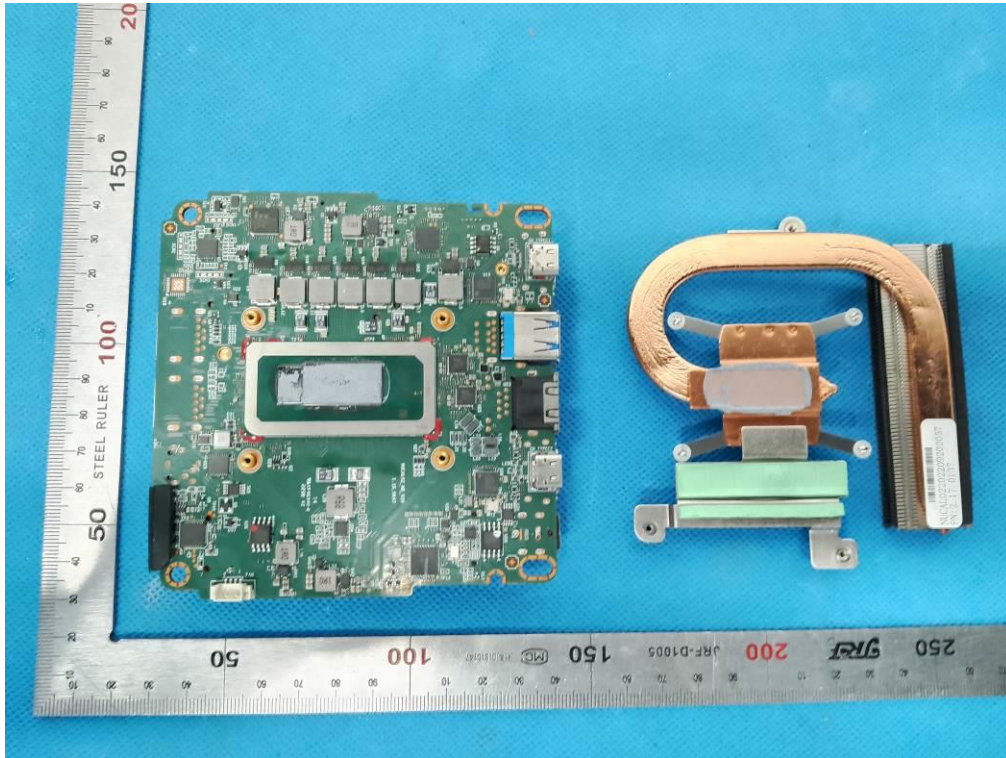

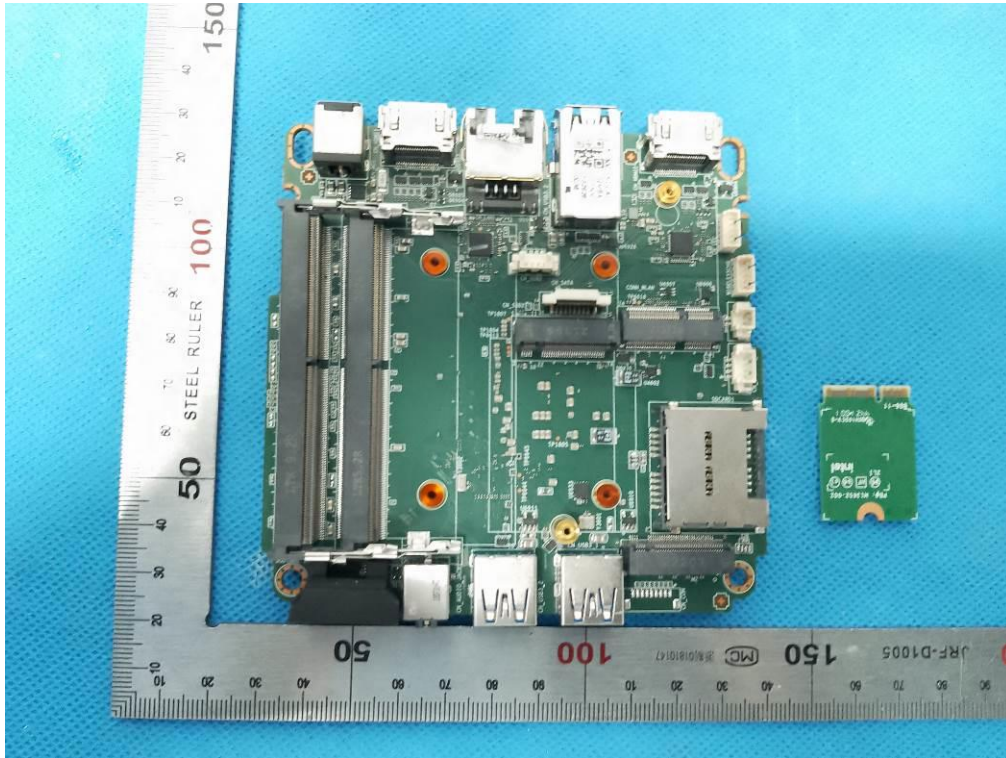

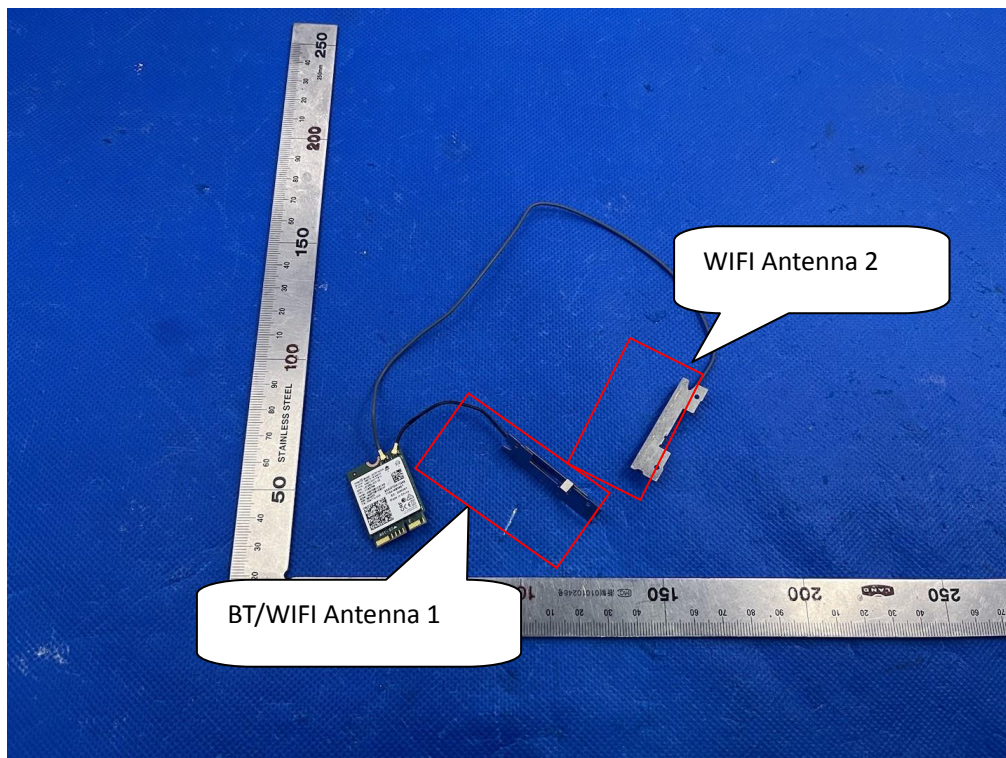

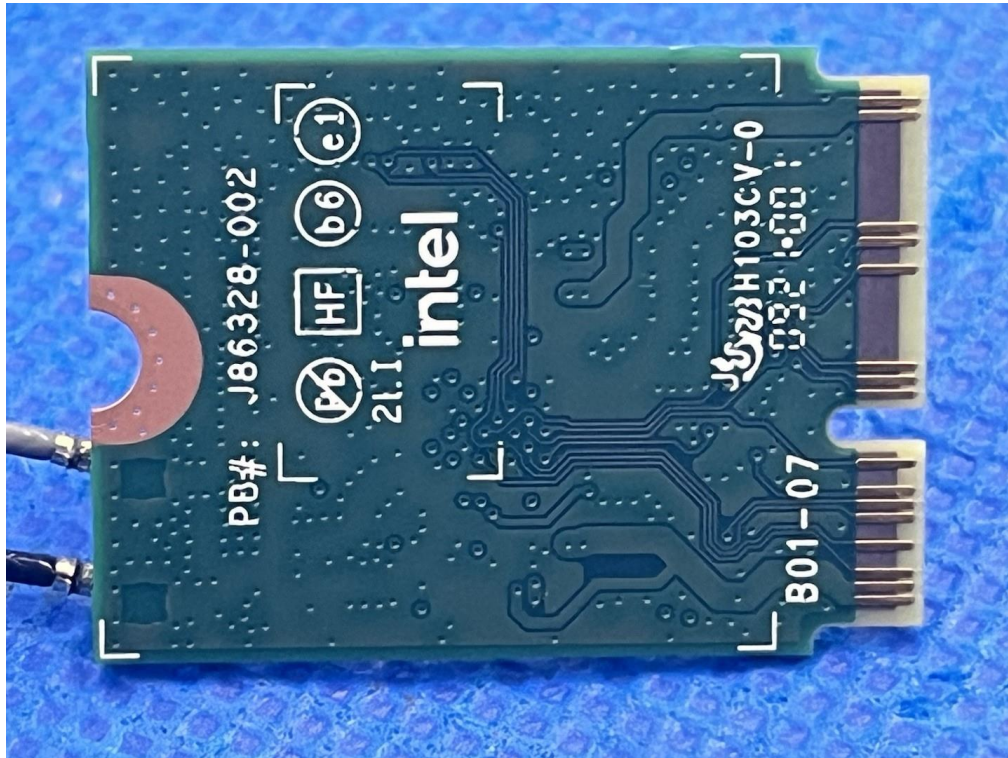

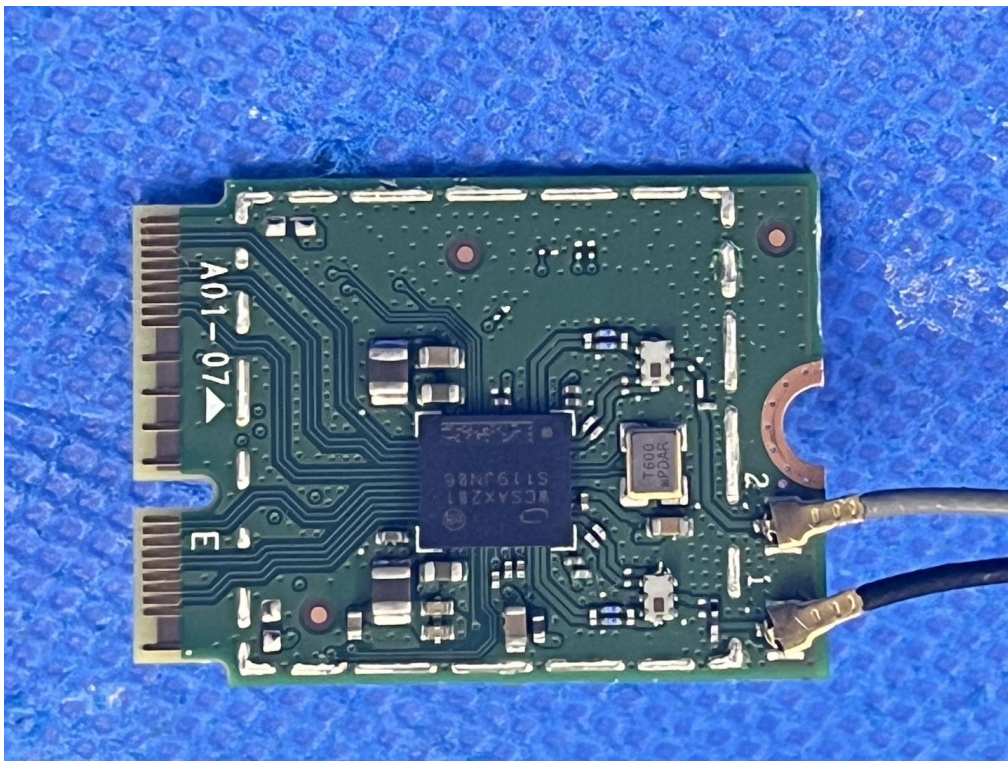

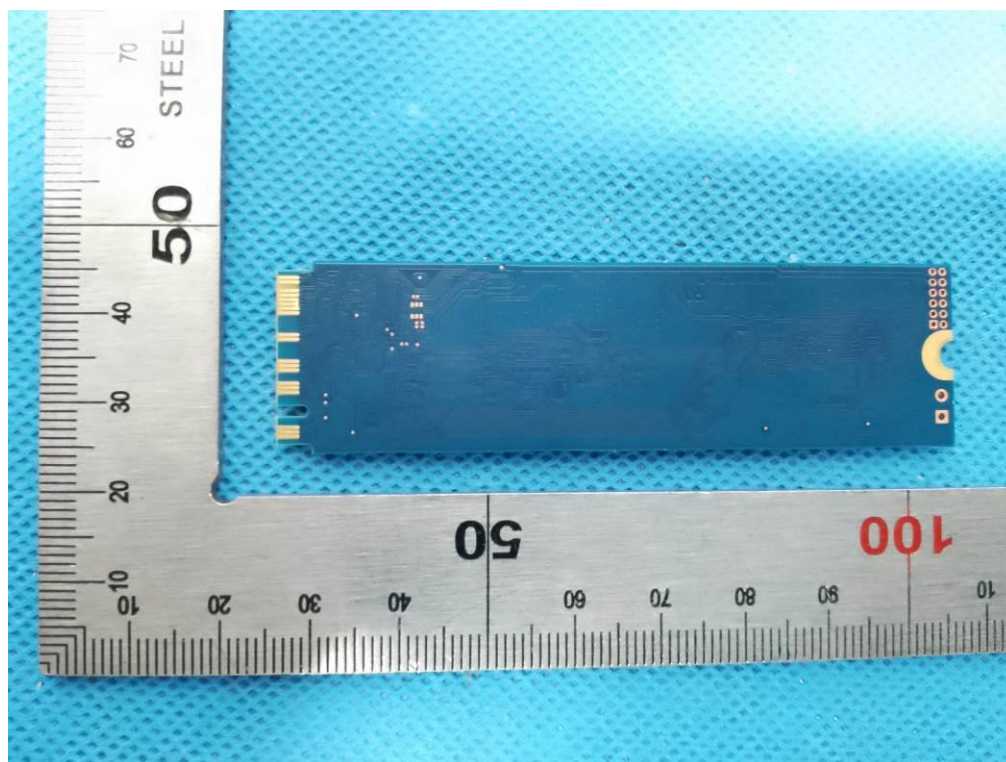

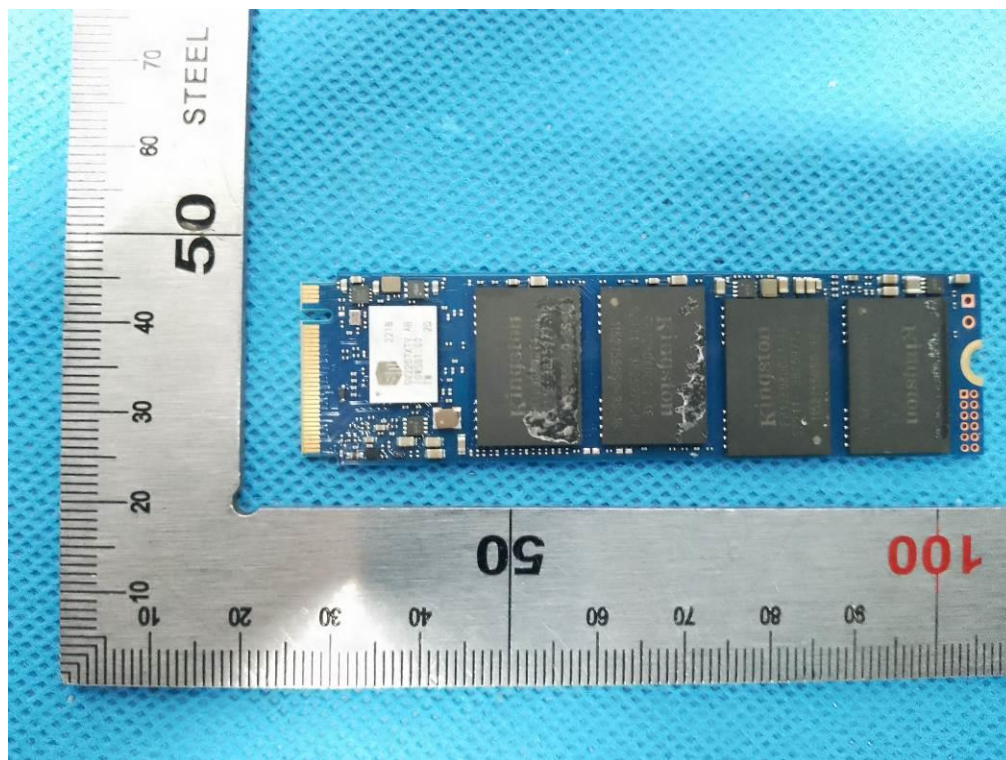

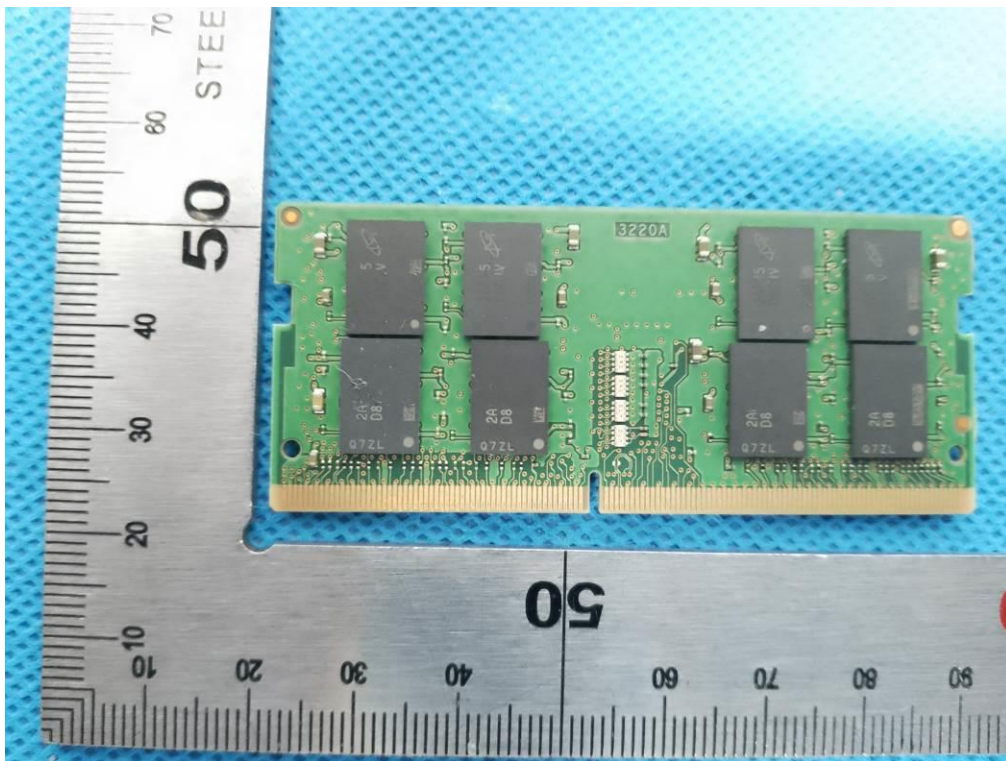

INTERNAL VIEW OF EUT (FIGURE 14)

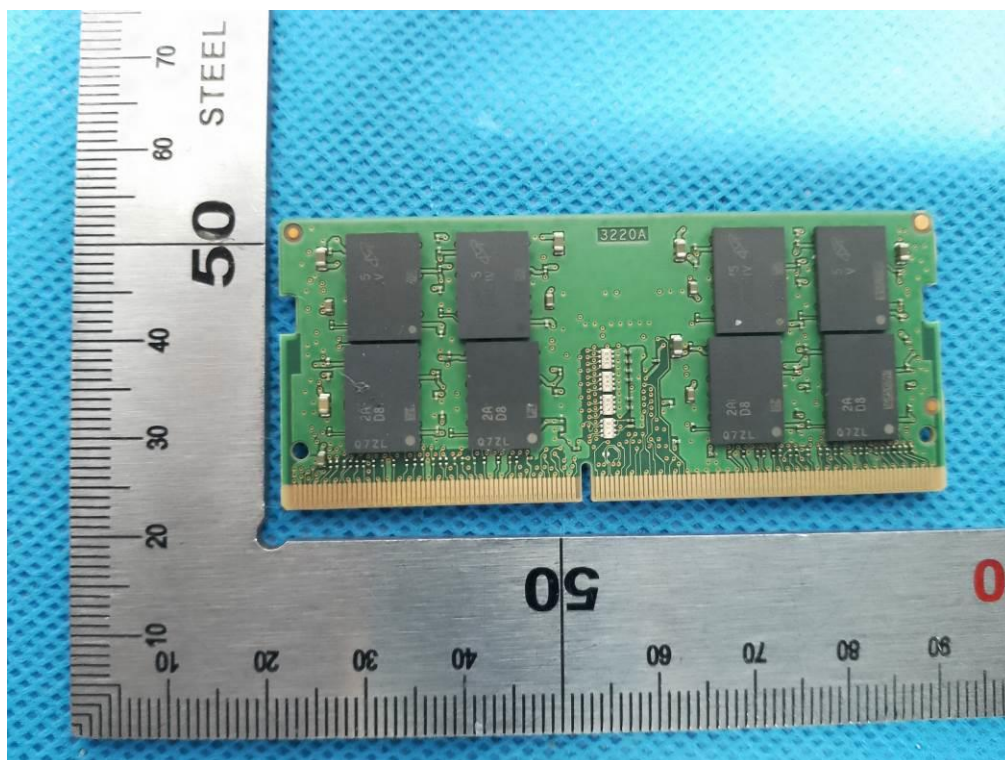


INTERNAL VIEW OF EUT (FIGURE 15)

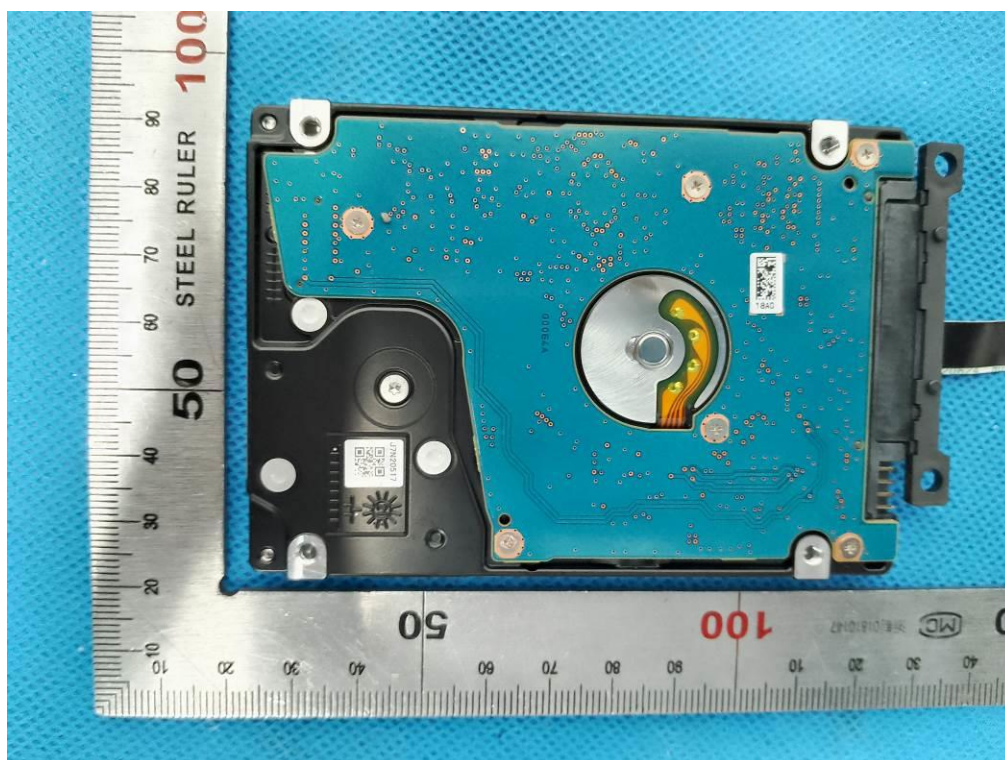

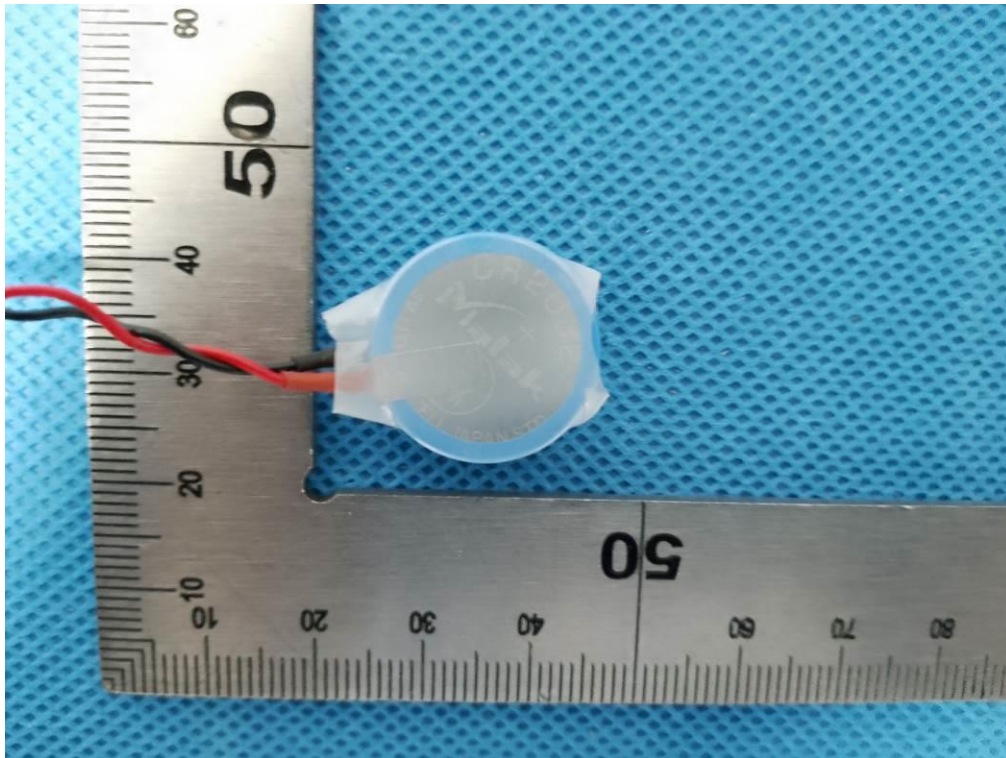

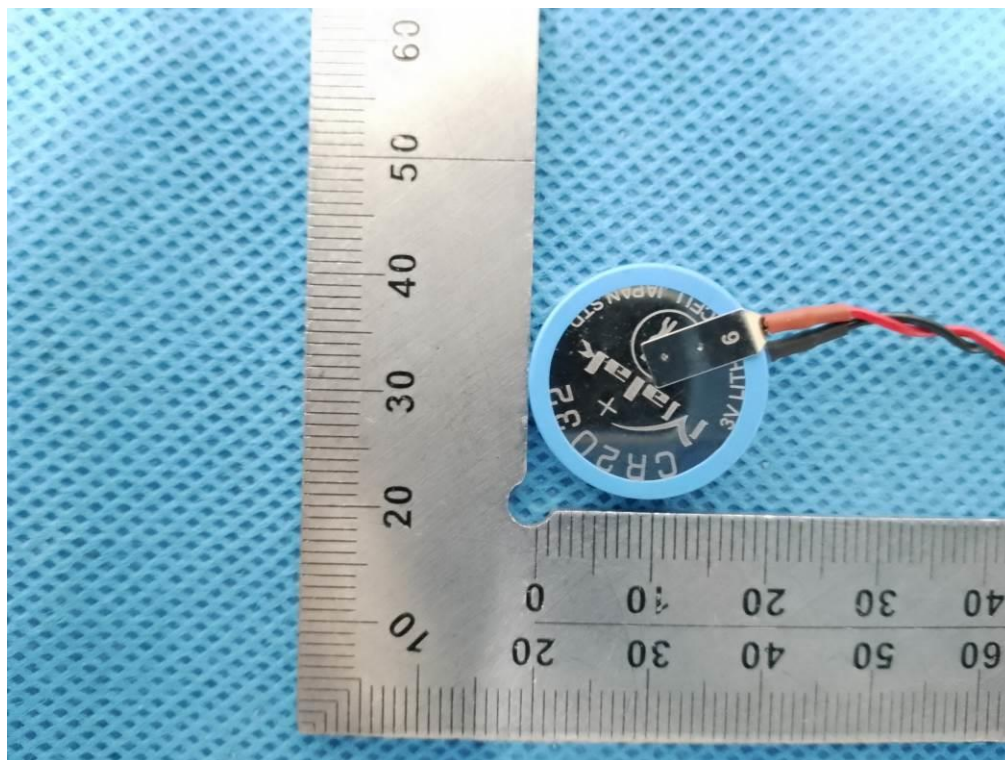
