Application for Class II Permissive Change

Dear Sir/Madam:

We respectfully wish to apply for a Class II permissive change for the above referenced FCC Identifier under the provisions of FCC rule 2.1043.

The change filed under this application entails adding a Wi Fi module/antenna and *Bluetooth* function to the radio. The change is made through updated software application and hardware change.

Previously certified device:

The device contains a 400MHz MICS band transceiver module, which incorporates a 2.4GHz transmitter that is used only for waking up implants. The MICS band transceiver has two quarter wavelength surface mount helical antennas. The wakeup transmitter has two inverted-F PCB antennas. The original antenna type is 2.4GHz Monopole Antenna and 5GHz Monopole Antenna. The use of the antenna with gain less than 1.2 dBi(2.4GHz) and 2.5 dBi(5GHz).

The device also includes a Wi-Fi module that can connect to Wi-Fi access points. The Wi-Fi module uses a small chip antenna mounted on the circuit board.
