### Compliance statements

#### FCC / ISED Radio Warning (English)

This device complies with Part 15 of the FCC Rules and with Industry Canada licence-exempt RSS standards.

Operation is subject to the following two conditions:

- (1) this device may not cause harmful interference, and
- (2) this device must accept any interference received, including interference that may cause undesired operation.

#### ISED Radio Warning (French)

### Class B Digital Device

This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This equipment generates, uses and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. Bed Pod is a continuous monitoring solution for bed bugs designed for permanent installation in multi-room accommodation establishments, for example, hotels and guesthouses.

Bed Pods are completely wireless and communicate using LoRa technology.



### Installation Instructions

Correct placement of the Bed Pods is essential for good performance

#### Insert the cartridge

After inserting the cartridge, you should see the pod flash. If not, please contact us to let us know.



#### Remove the backing

Peel off the backing to reveal the sticky pad.



#### Affix to the bed frame

Stick the Bed Pod to the bed frame. **The black areas of the Bed Pod must be exposed.**
