

4.3. Test Procedures

1) Sequence of testing 9 kHz to 30 MHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna height is 1.0 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Final measurement:

- --- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).
- --- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

2) Sequence of testing 30 MHz to 1 GHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.
- --- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

Final measurement:

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position (± 45°) and antenna movement between 1 and 4 meter.
- --- The final measurement will be done with QP detector with an EMI receiver.
- --- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. 

8. LINE CONDUCTED EMISSIONS




8.2. Block Diagram of Test Setup



9. ANTENNA REQUIREMENTS

The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

9.2.1. Standard Applicable

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.



Photo of Radiated Emissions Measurement




