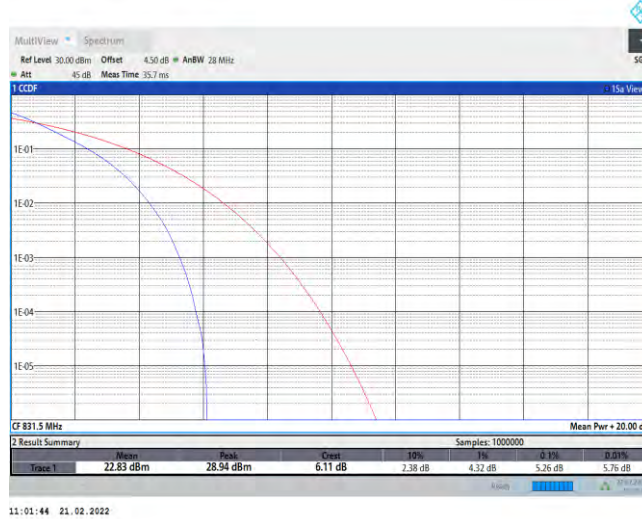

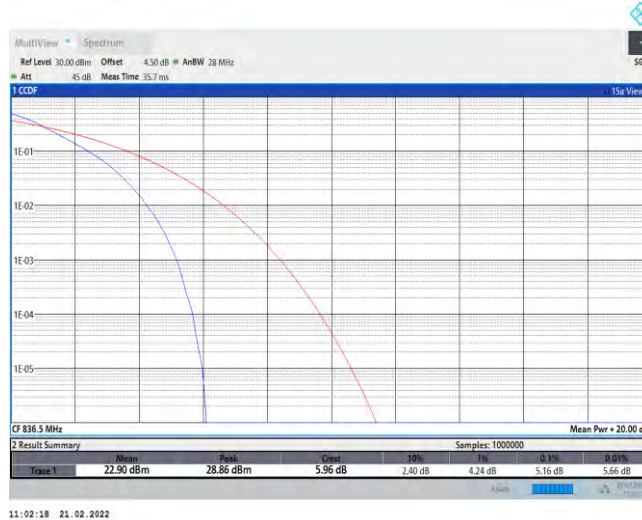

Band26-15MHz-QPSK-26915-75RB#0

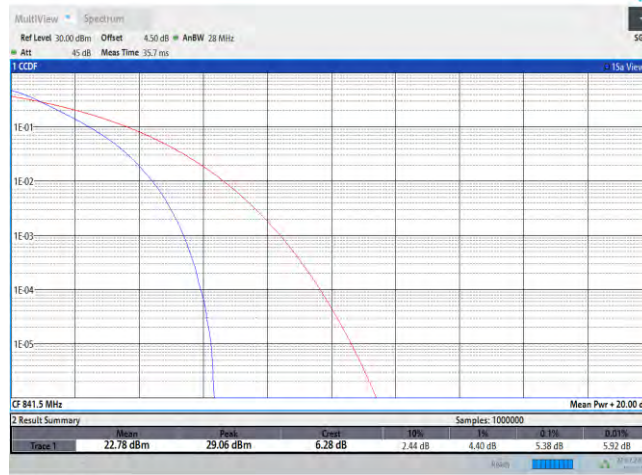
