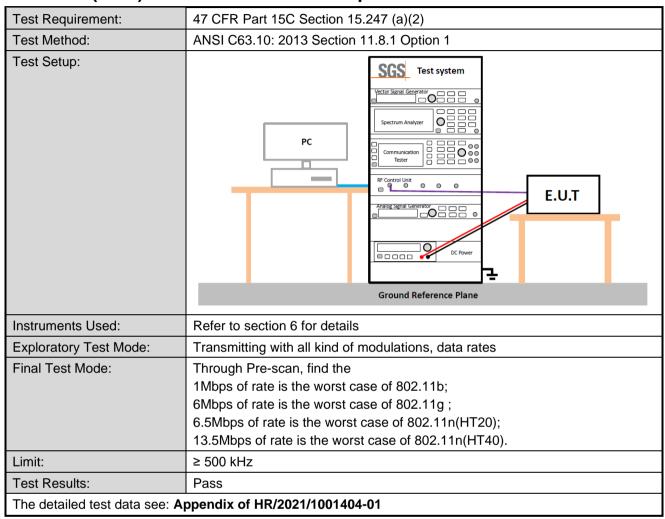

4.5 DTS (6 dB) Bandwidth & 99% Occupied Bandwidth



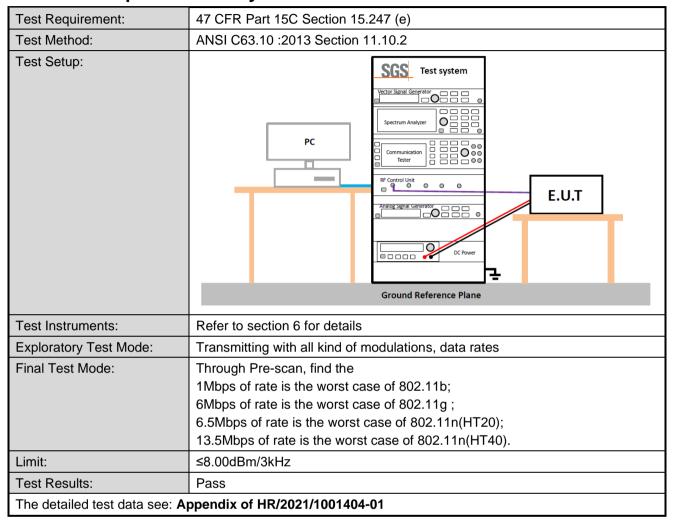

4.6 Power Spectral Density



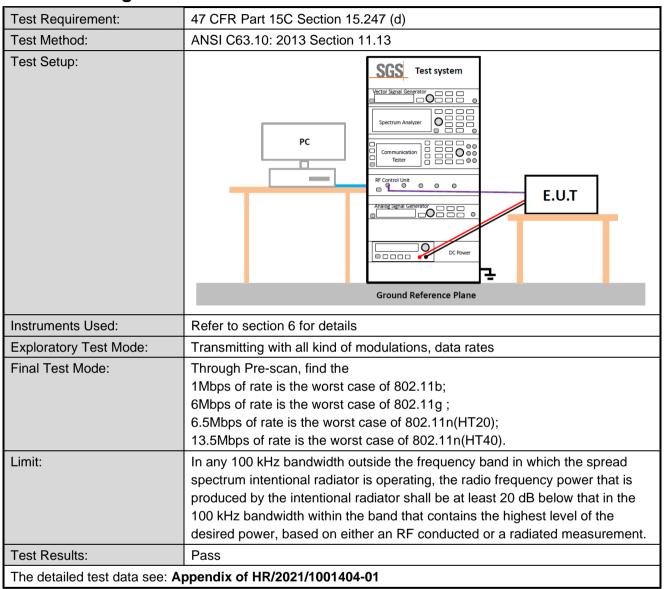

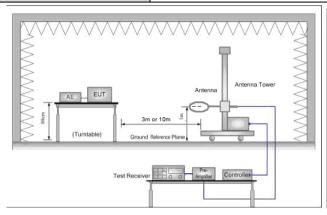

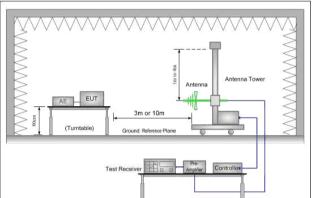


Figure 1. Below 30MHz

Figure 2. 30MHz to 1GHz

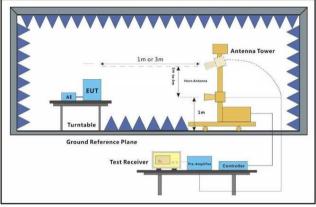


Figure 3. Above 1 GHz

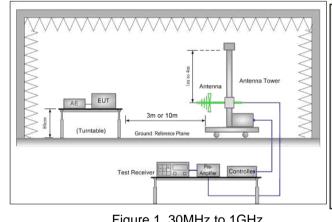

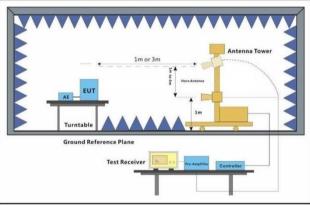


Figure 1. 30MHz to 1GHz
