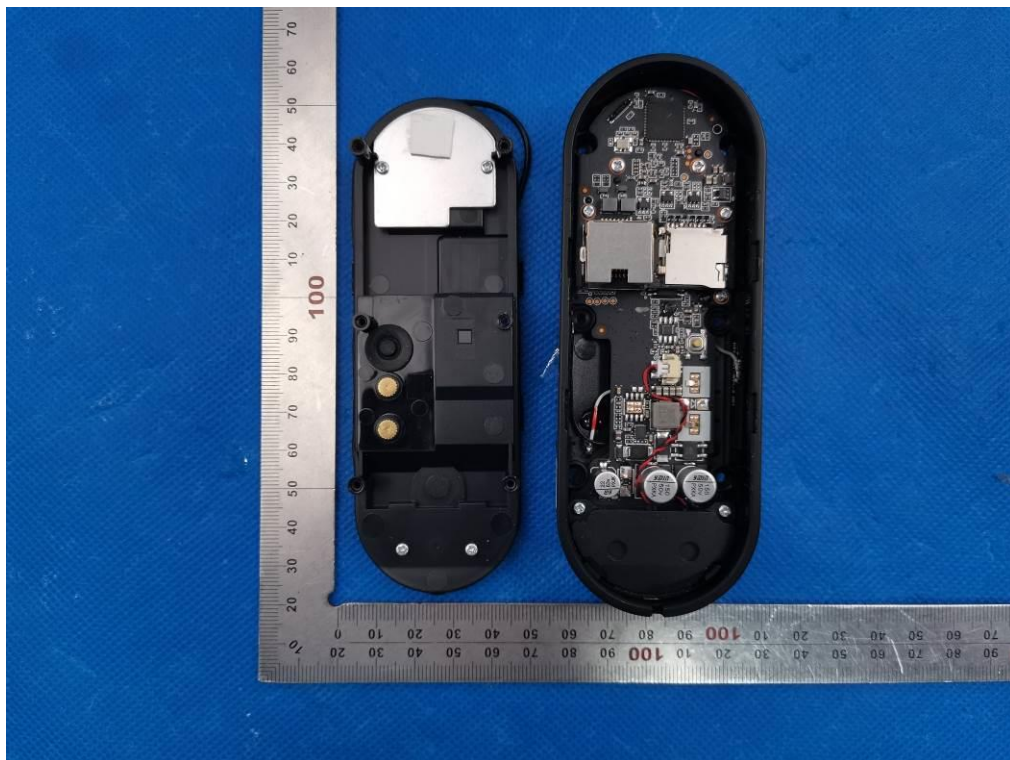

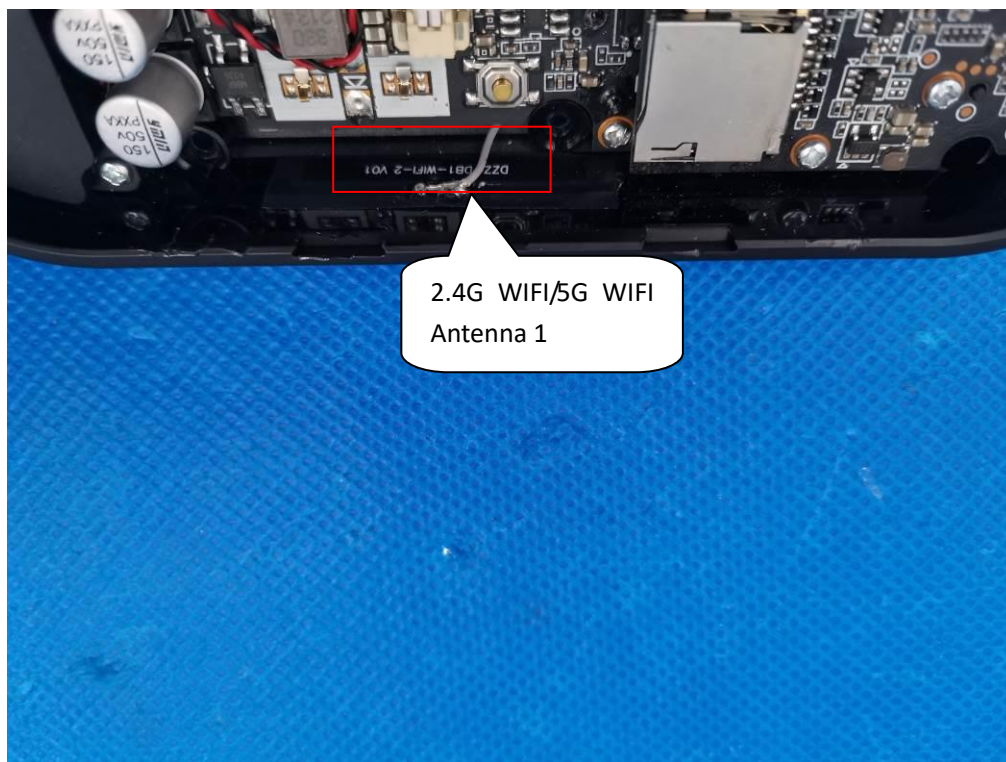

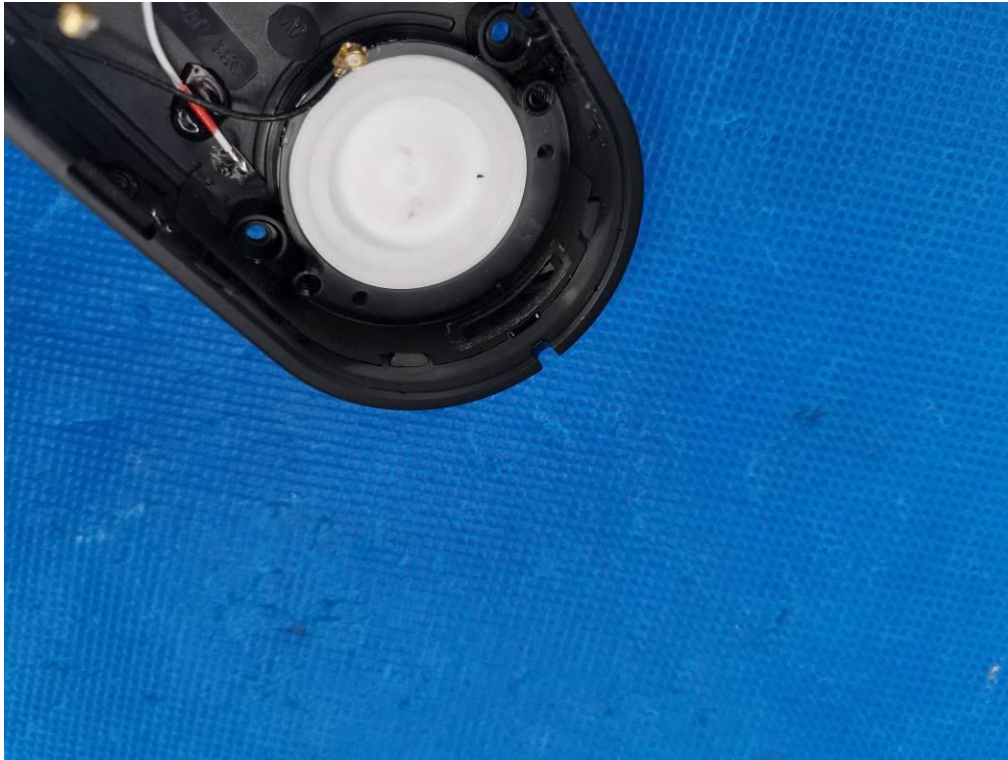

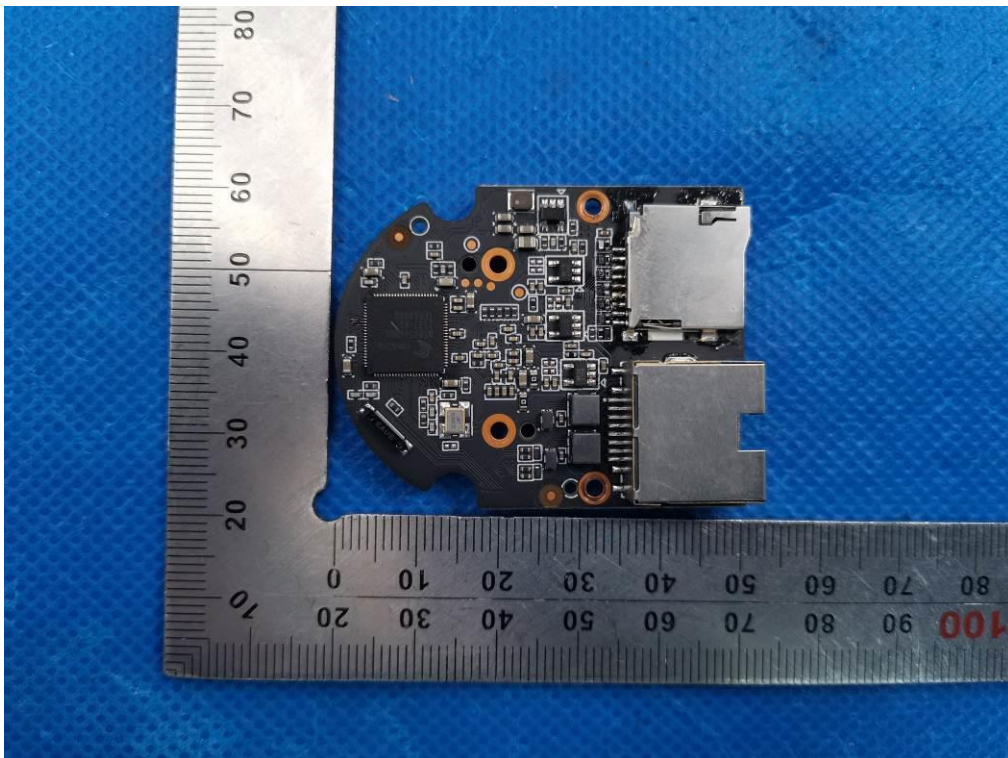

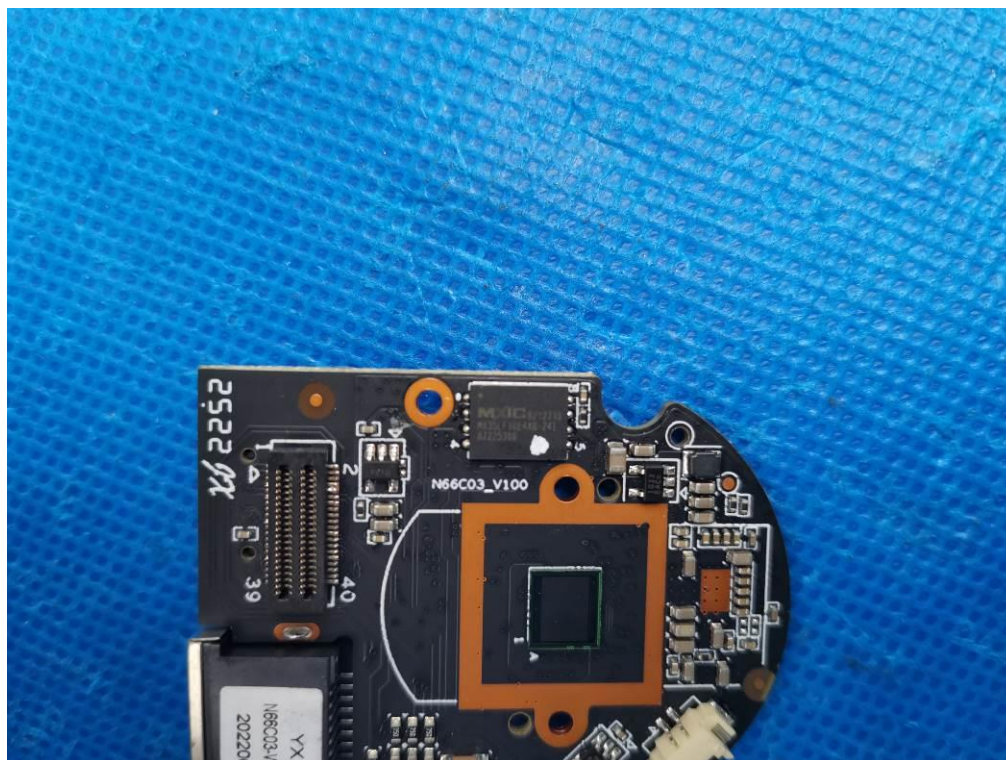

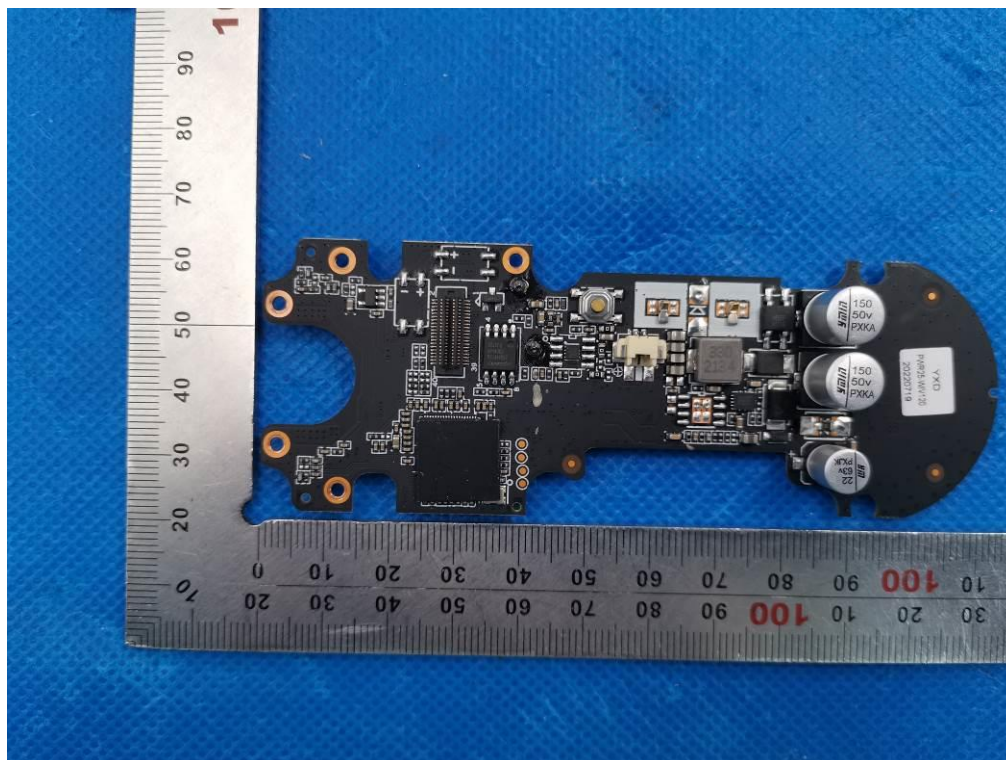

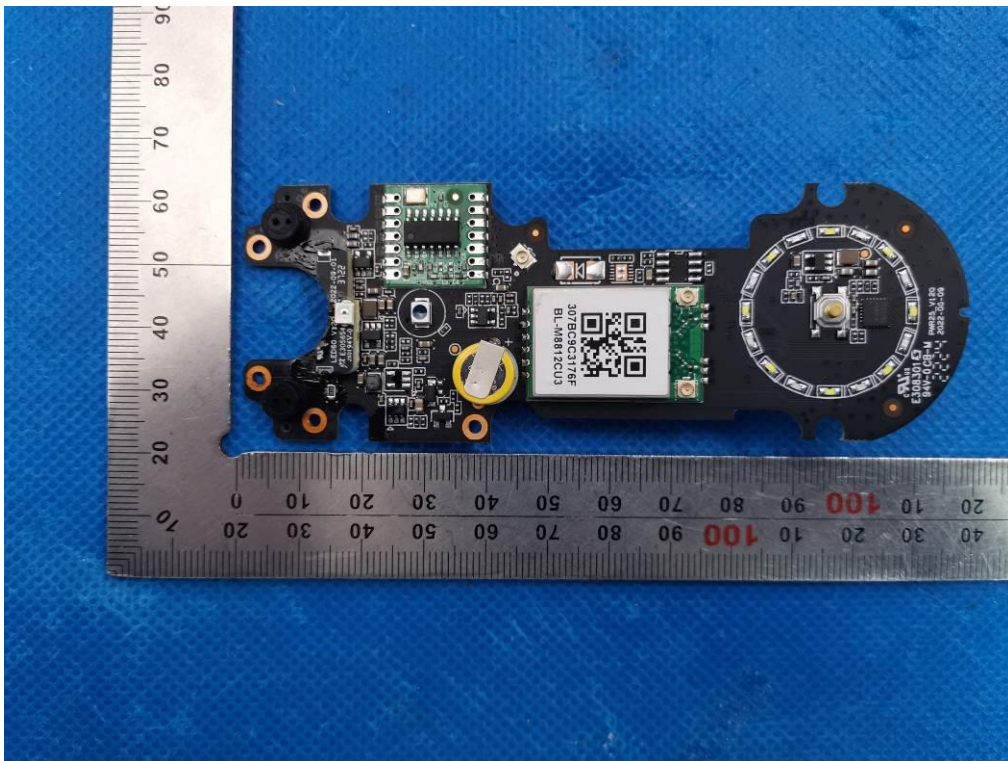

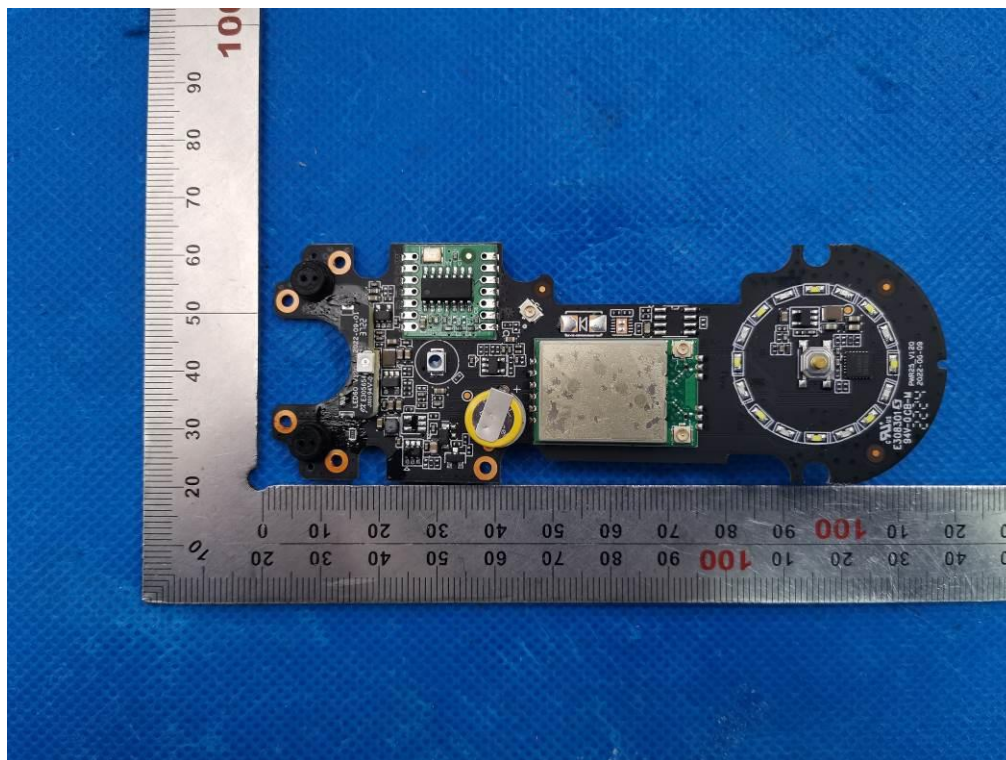


INTERNAL VIEW OF EUT (FIGURE 7)

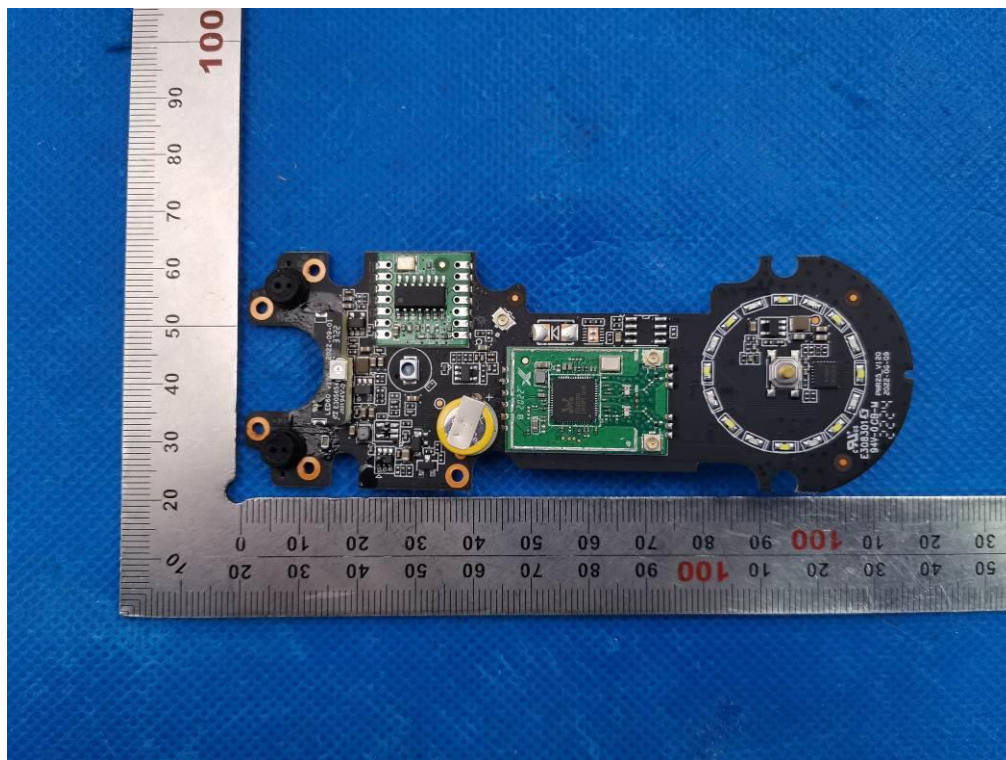

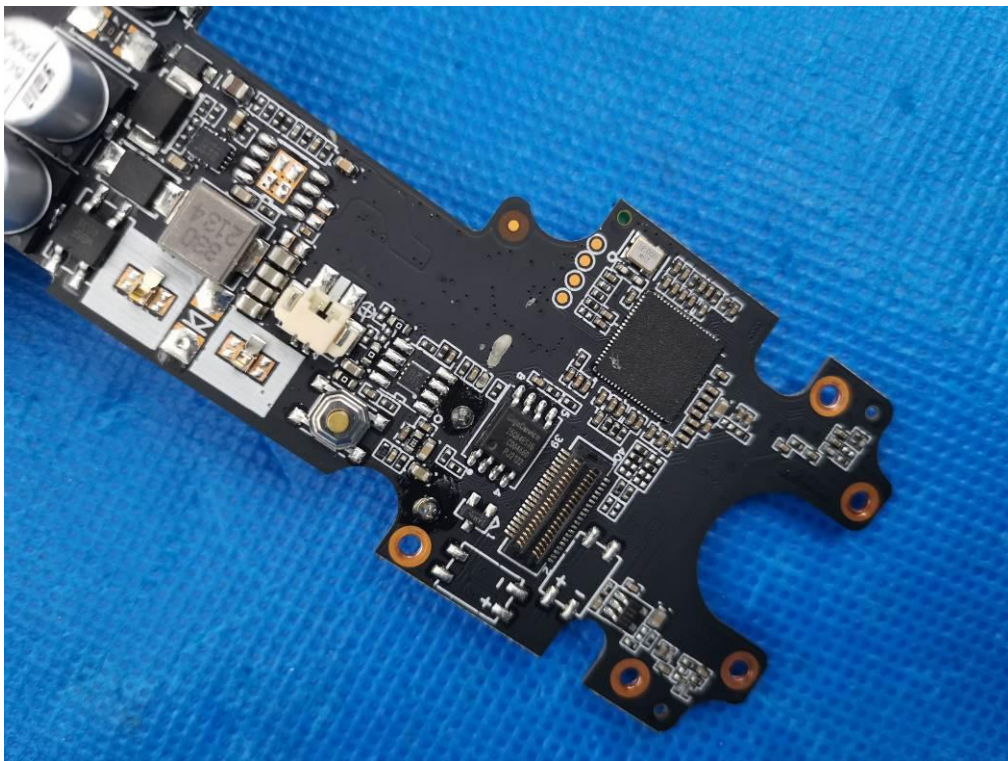

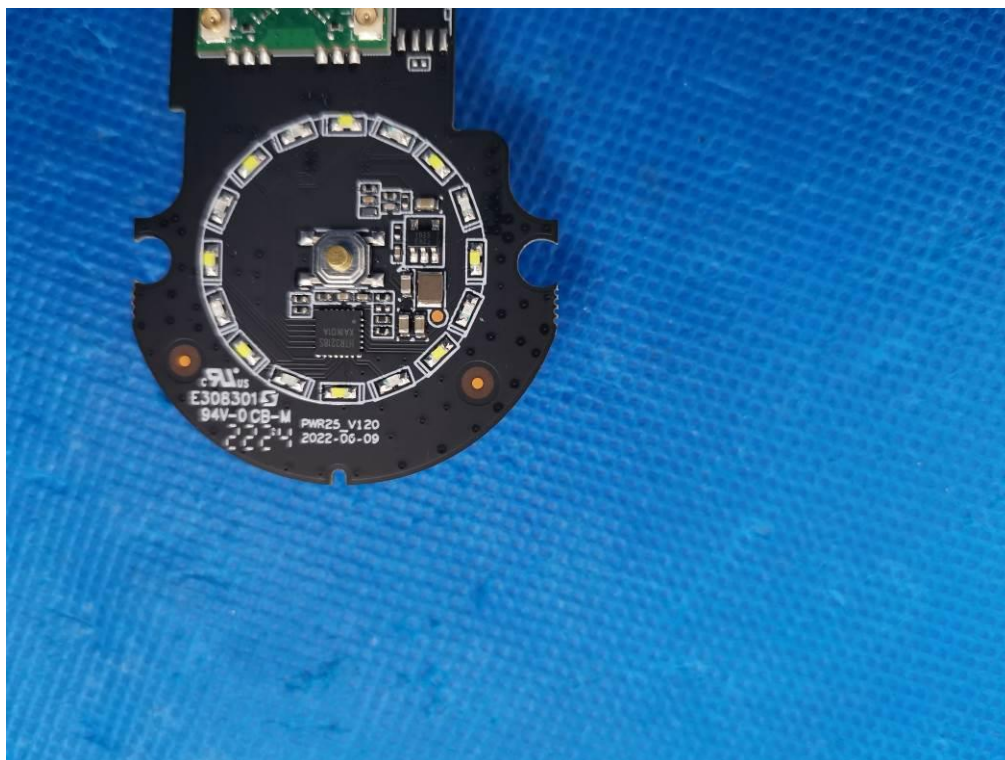

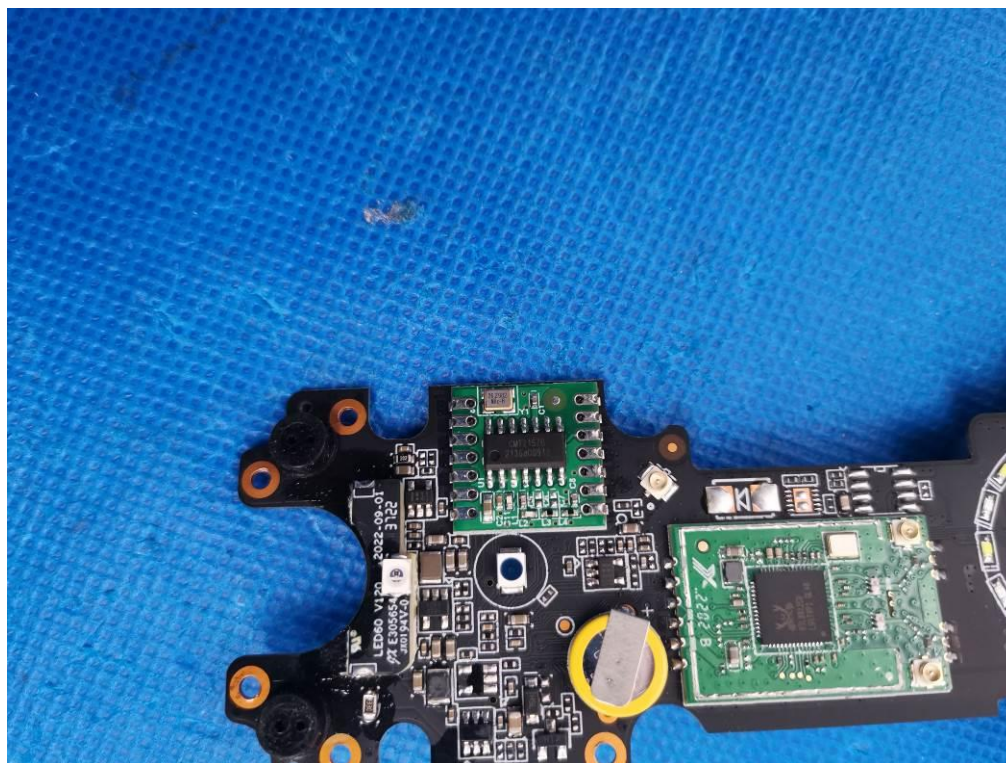
