

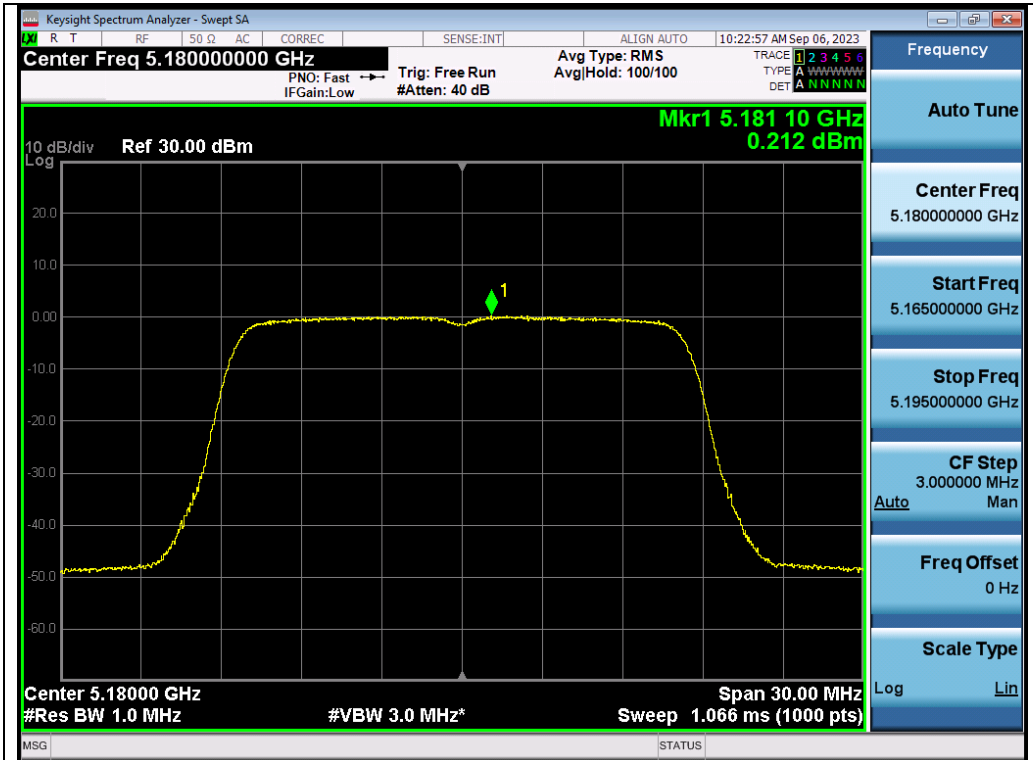

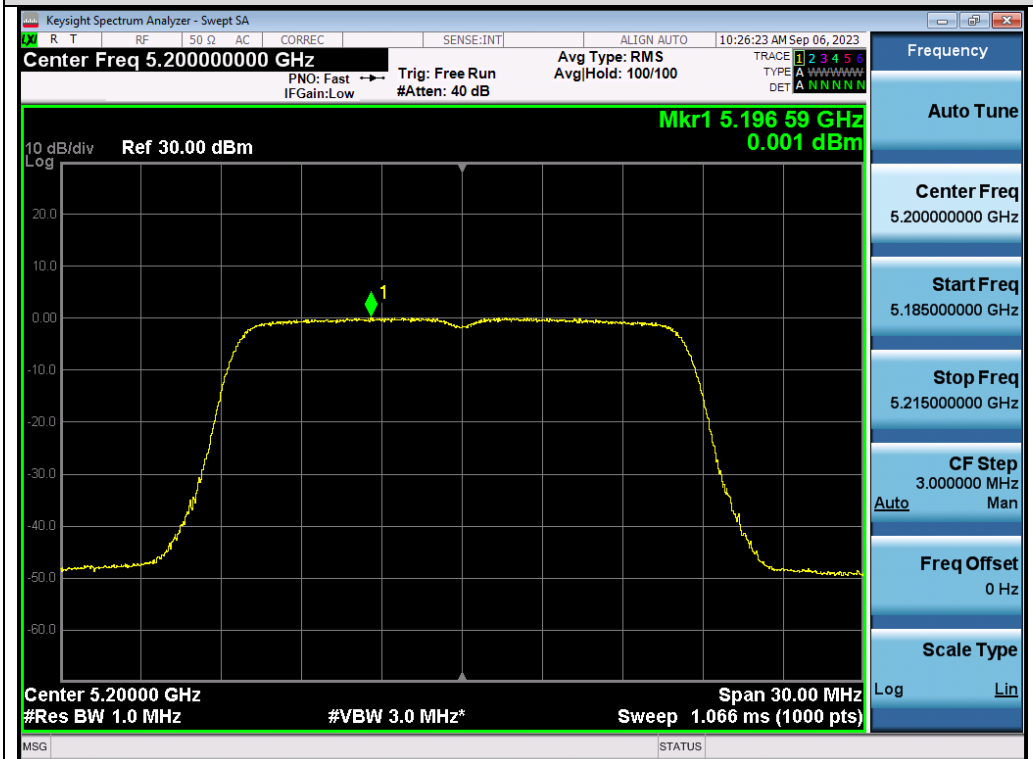

**Test Graphs of Conducted Output Power Spectral Density for band 5.15-5.25 GHz**

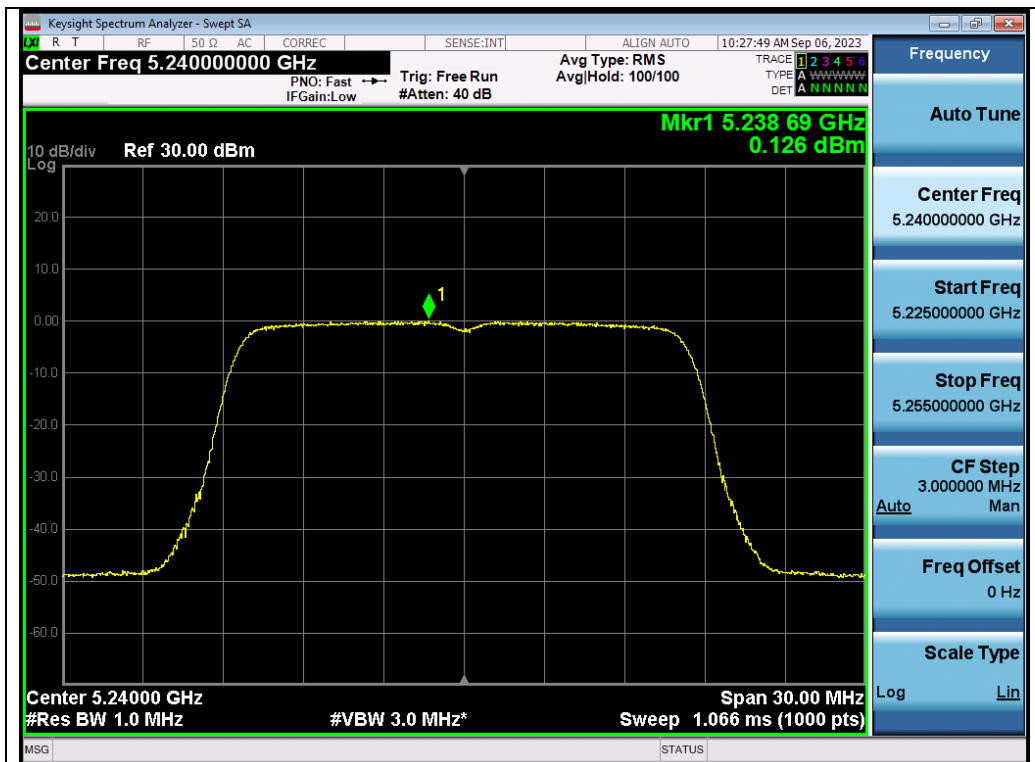

**Test Graphs of Conducted Output Power Spectral Density for band 5.25-5.35 GHz**

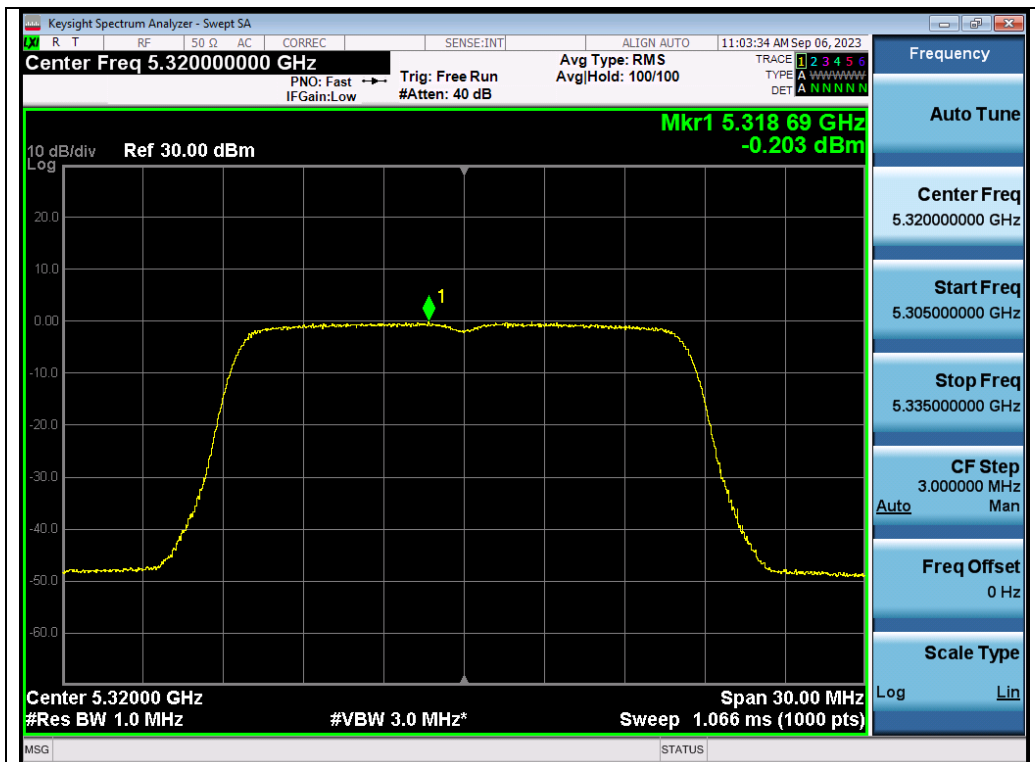

**Test Graphs of Conducted Output Power Spectral Density for band 5.470-5.725 GHz**

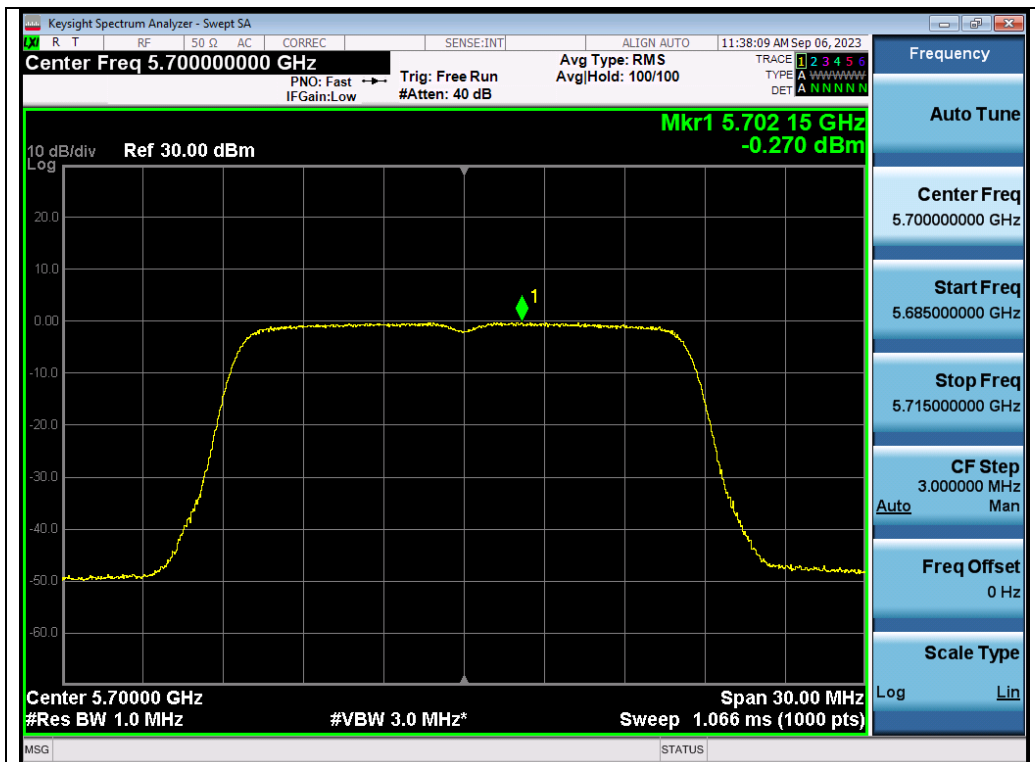
