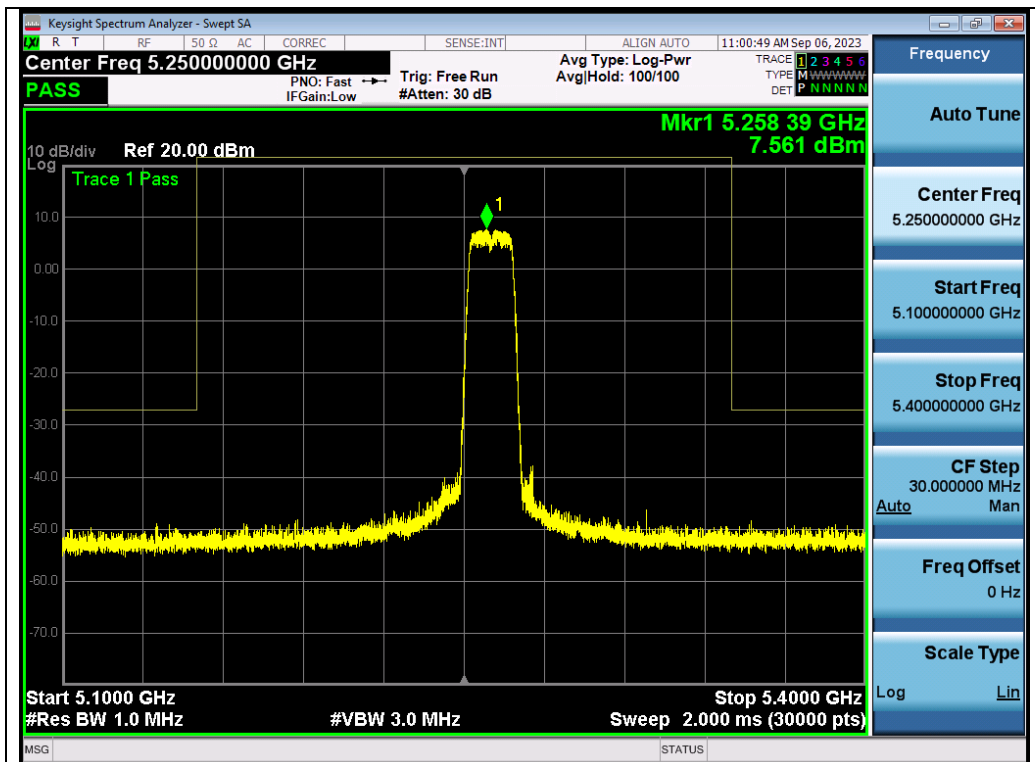

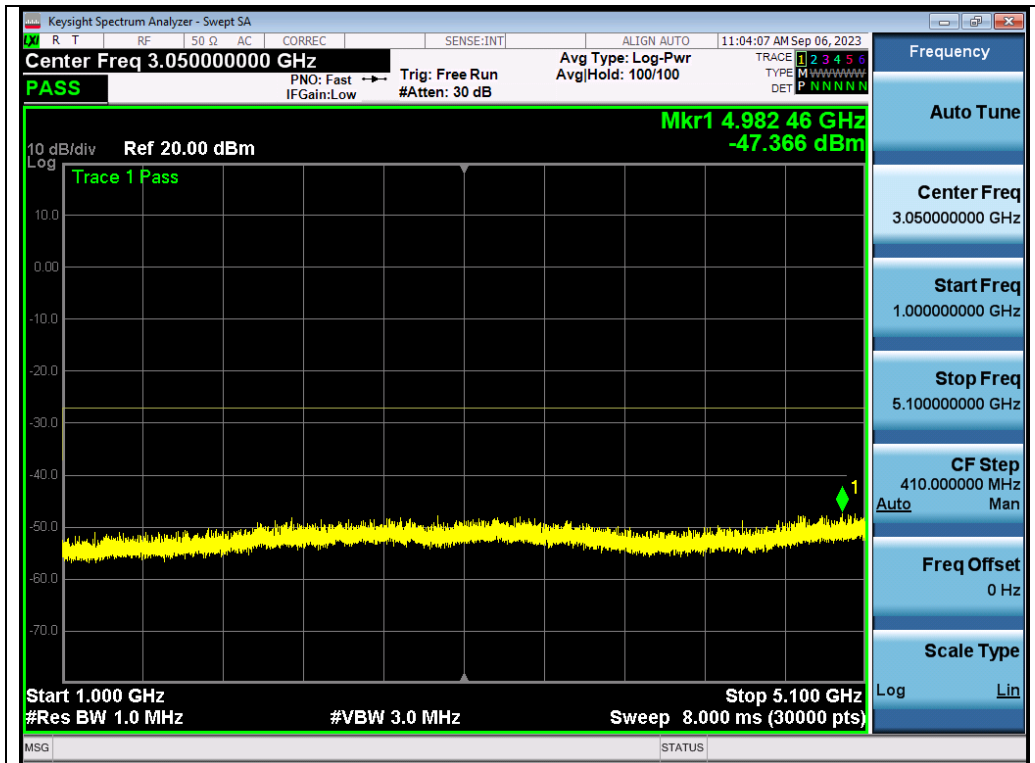


Test_Graph_802.11a_ANT1_5260_6Mbps_Frequency Band 5

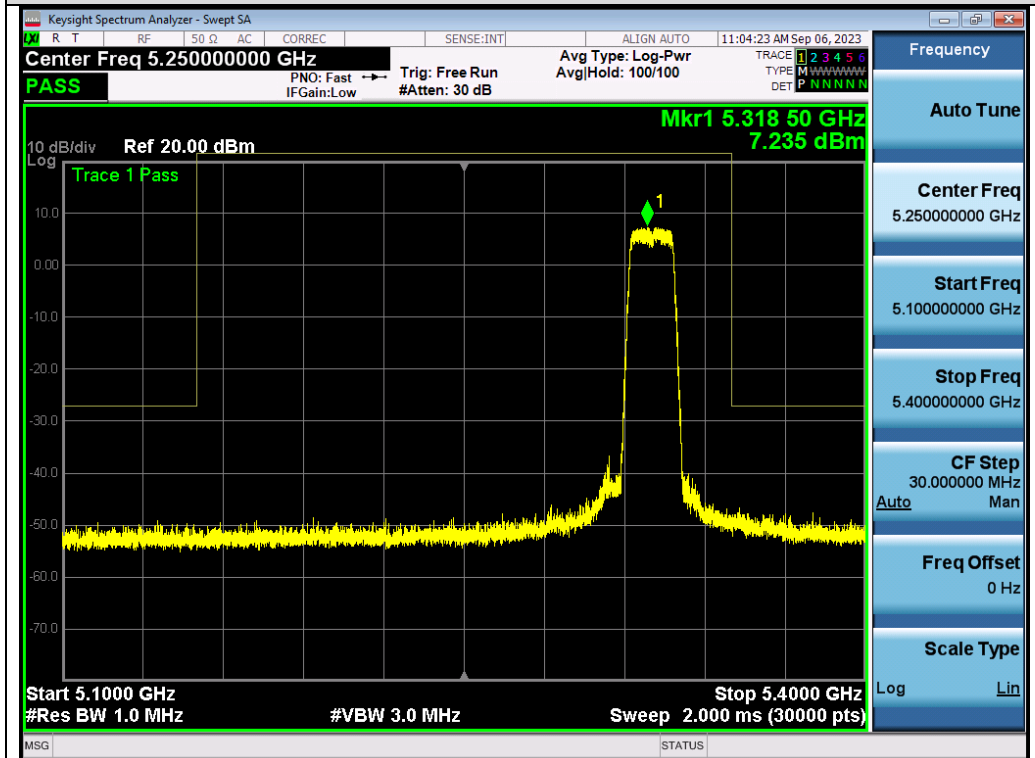

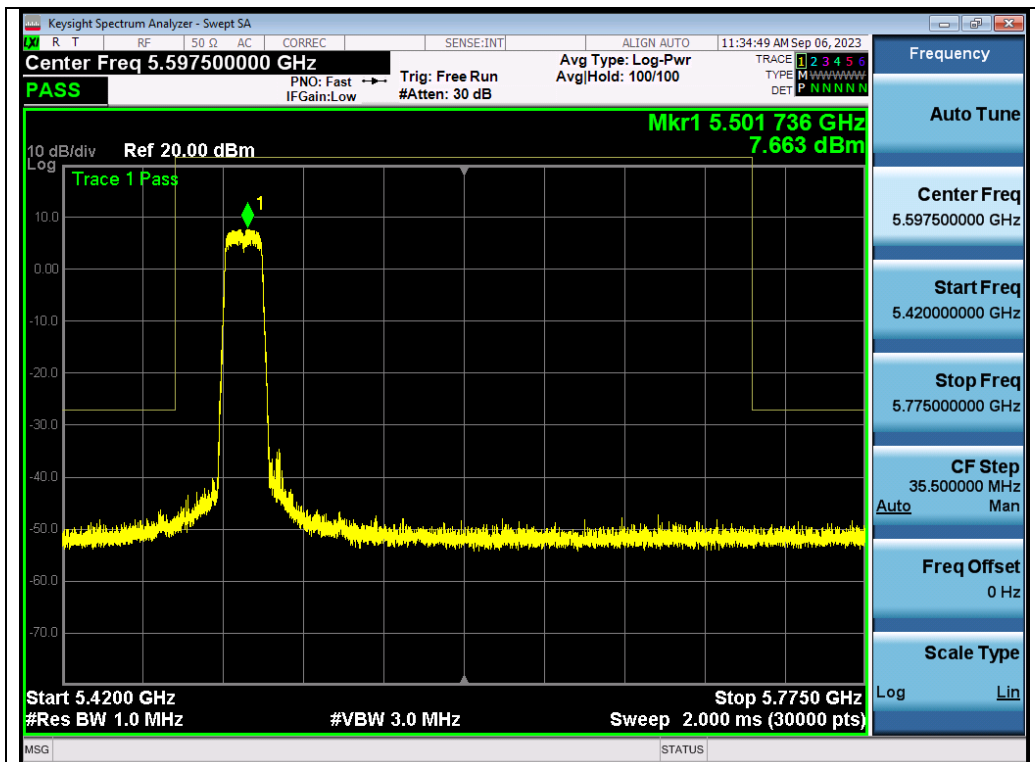

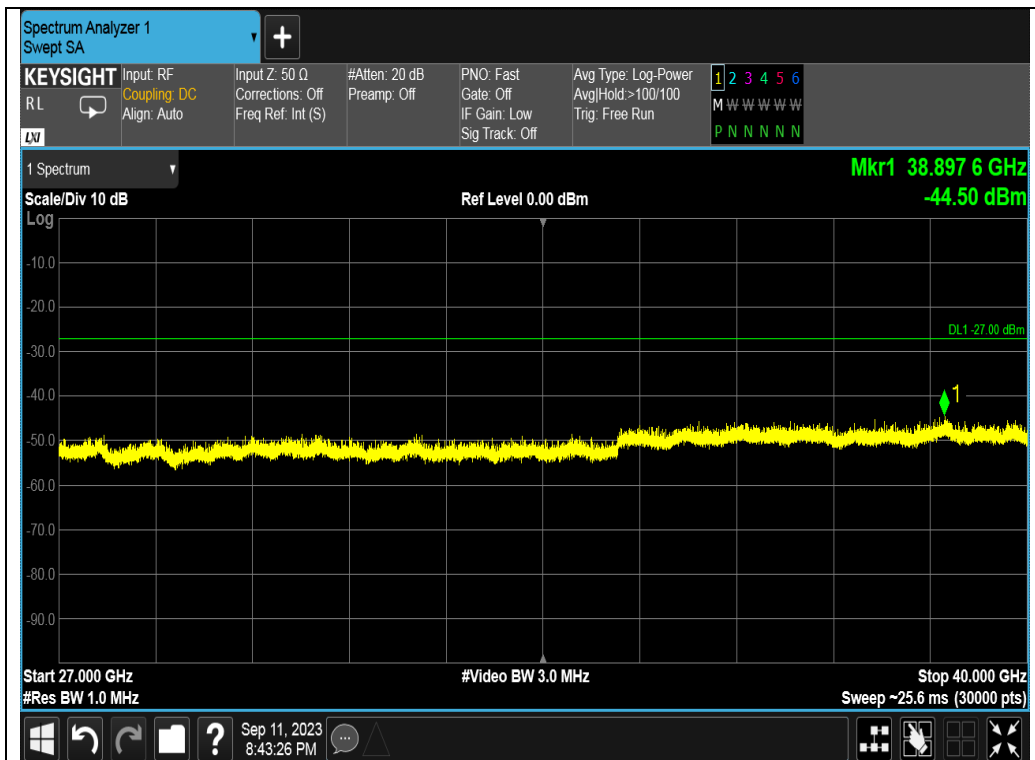


Test_Graph_802.11a_ANT1_5500_6Mbps_Frequency Band 3

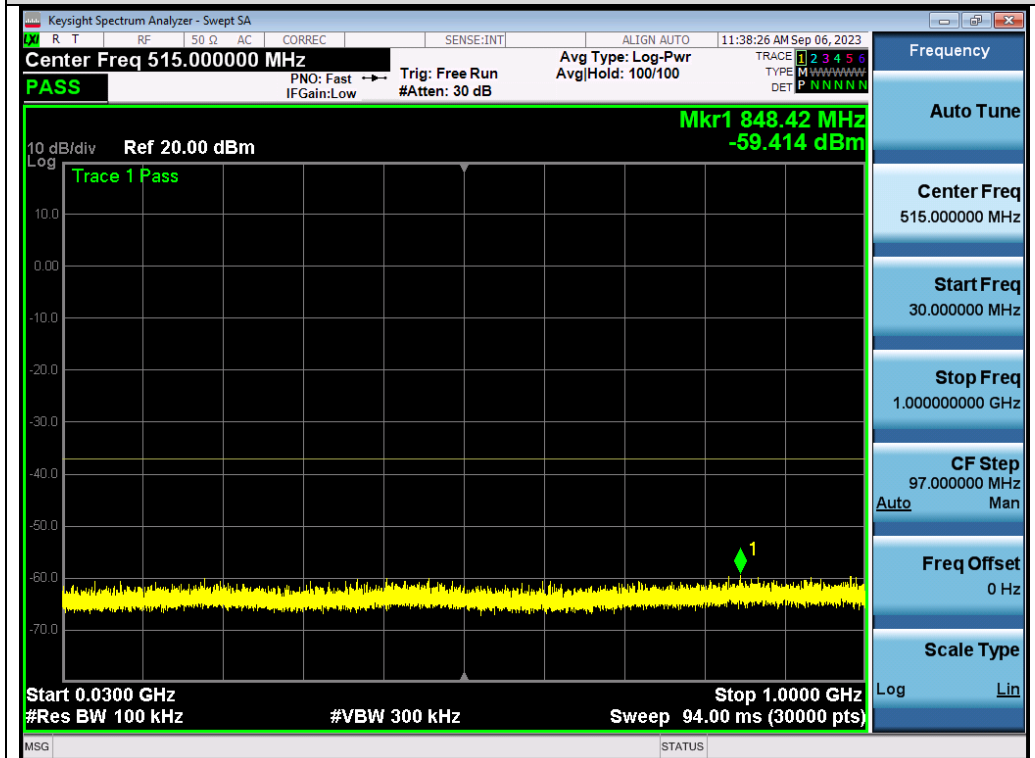

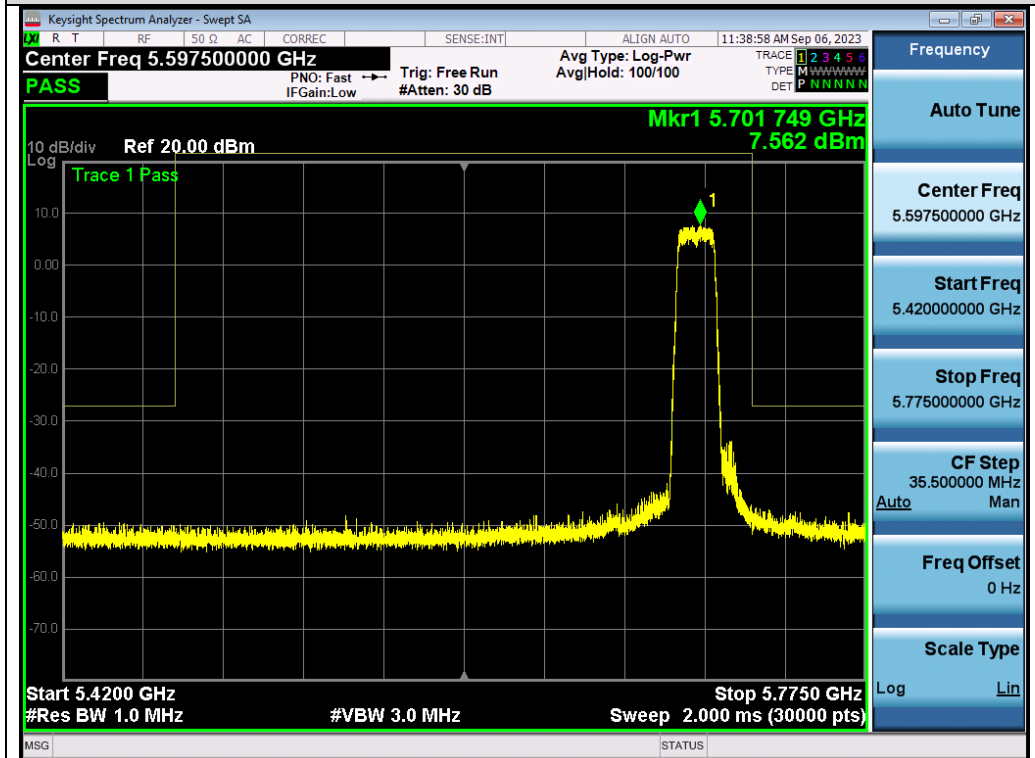

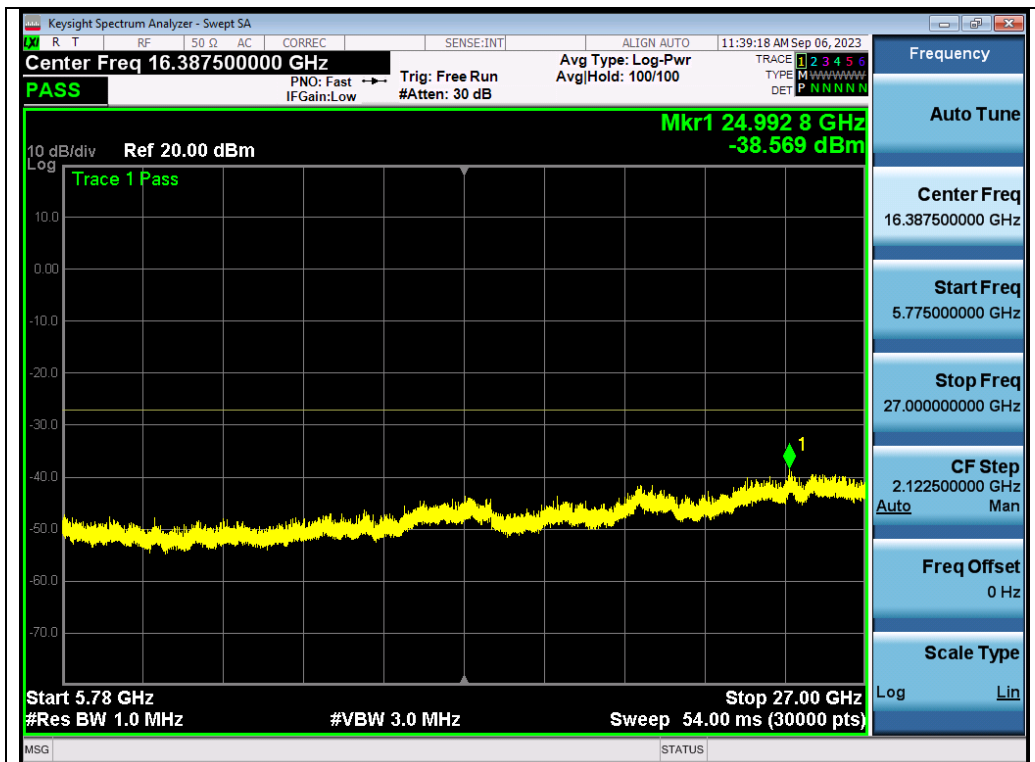


Test_Graph_802.11a_ANT1_5700_6Mbps_Frequency Band 2

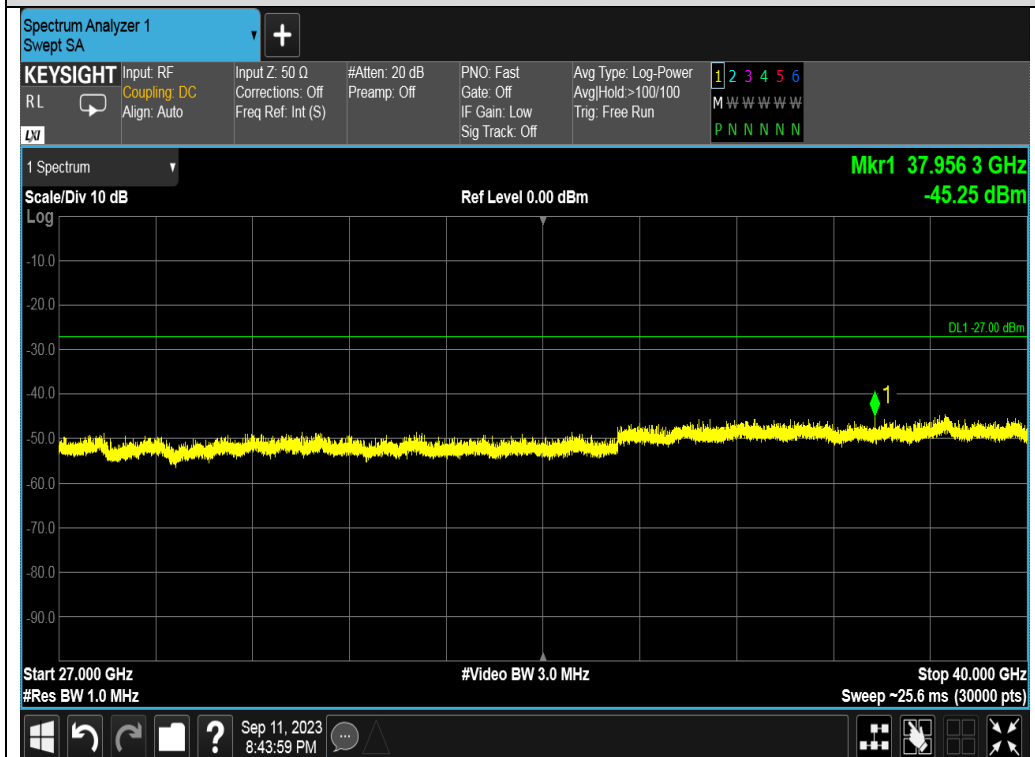

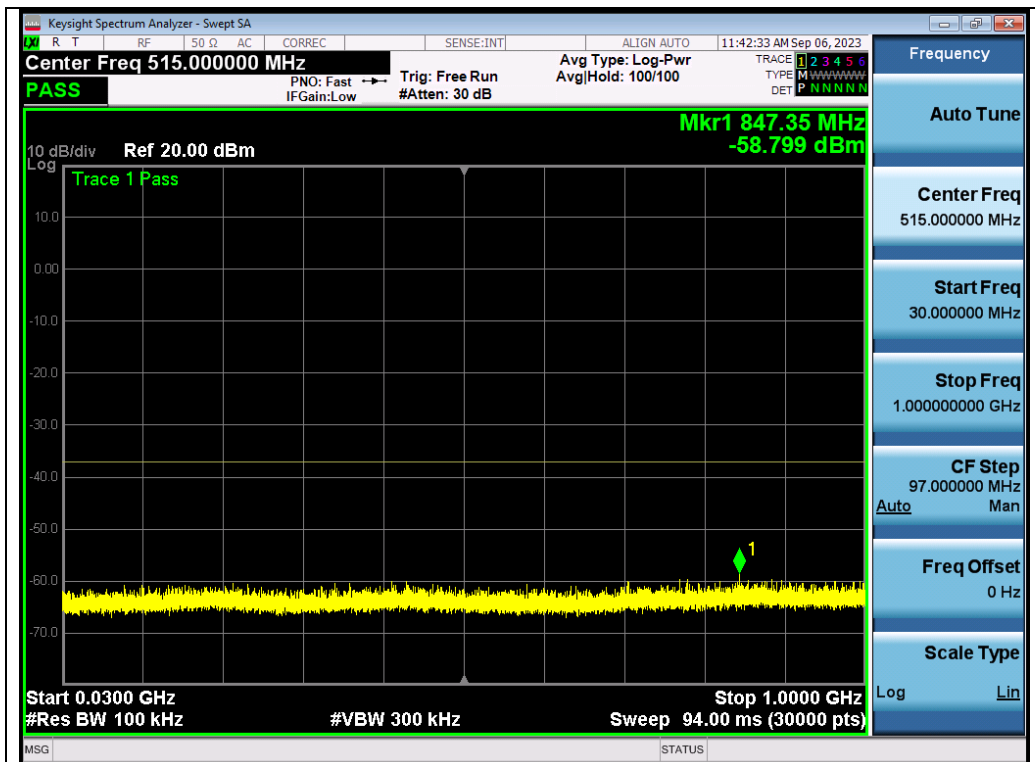


Test_Graph_802.11a_ANT1_5700_6Mbps_Frequency Band 4

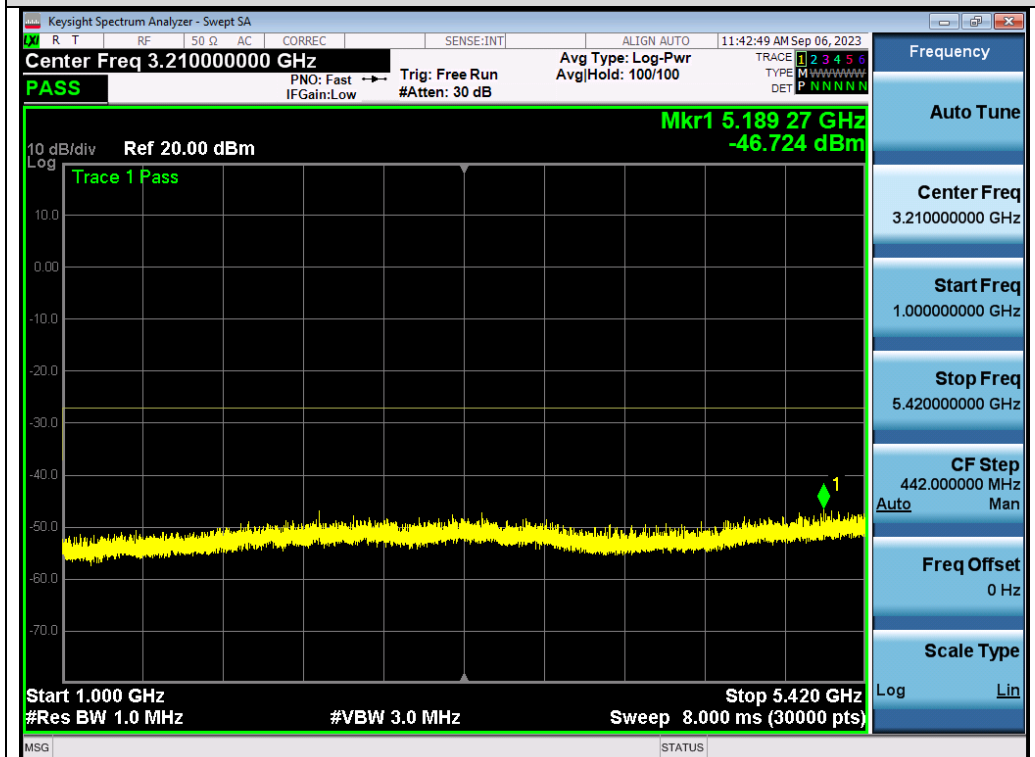

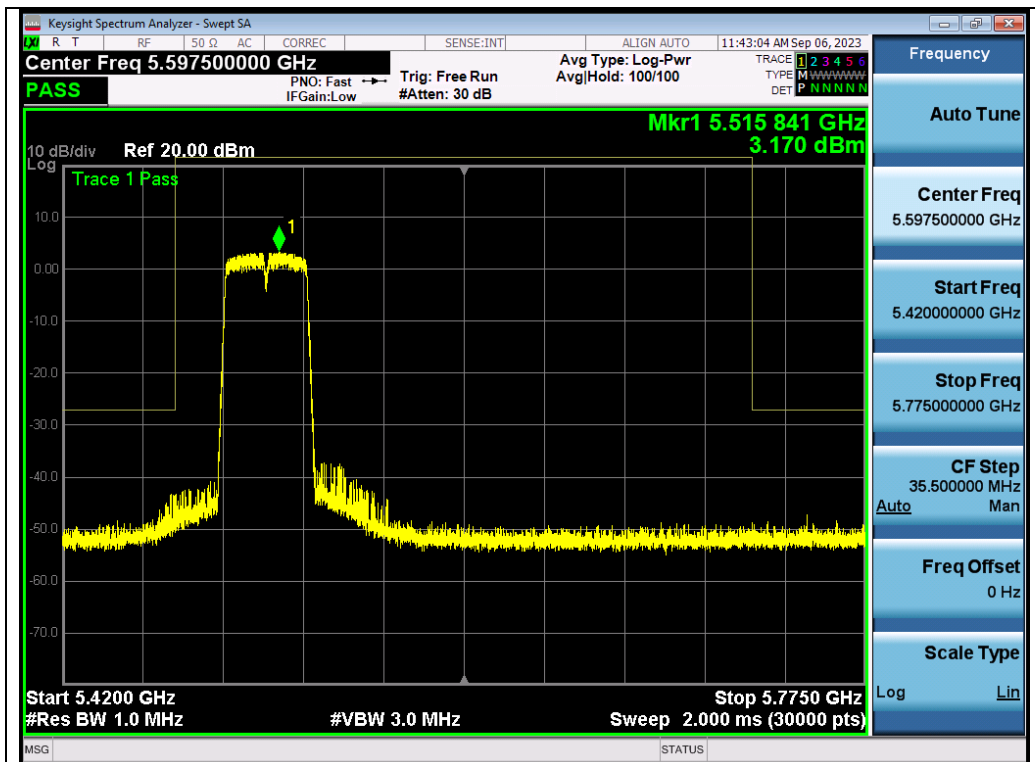


Test_Graph_802.11n40_ANT1_5510_MCS0_Frequency Band 1

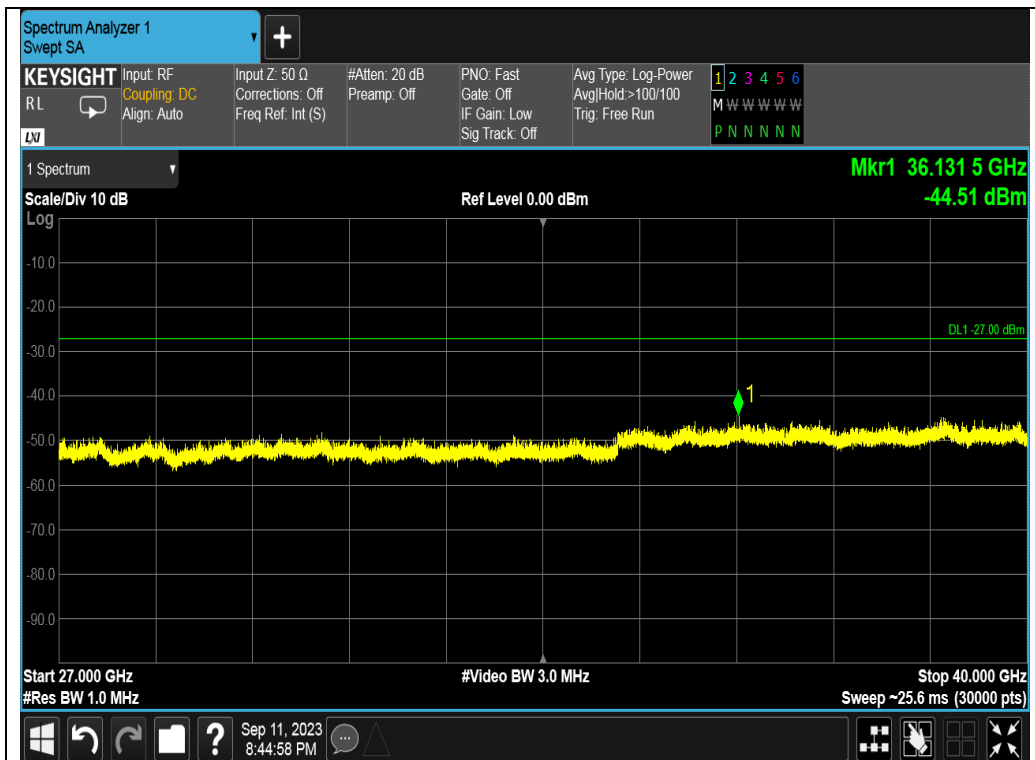


Test_Graph_802.11n40_ANT1_5510_MCS0_Frequency Band 3

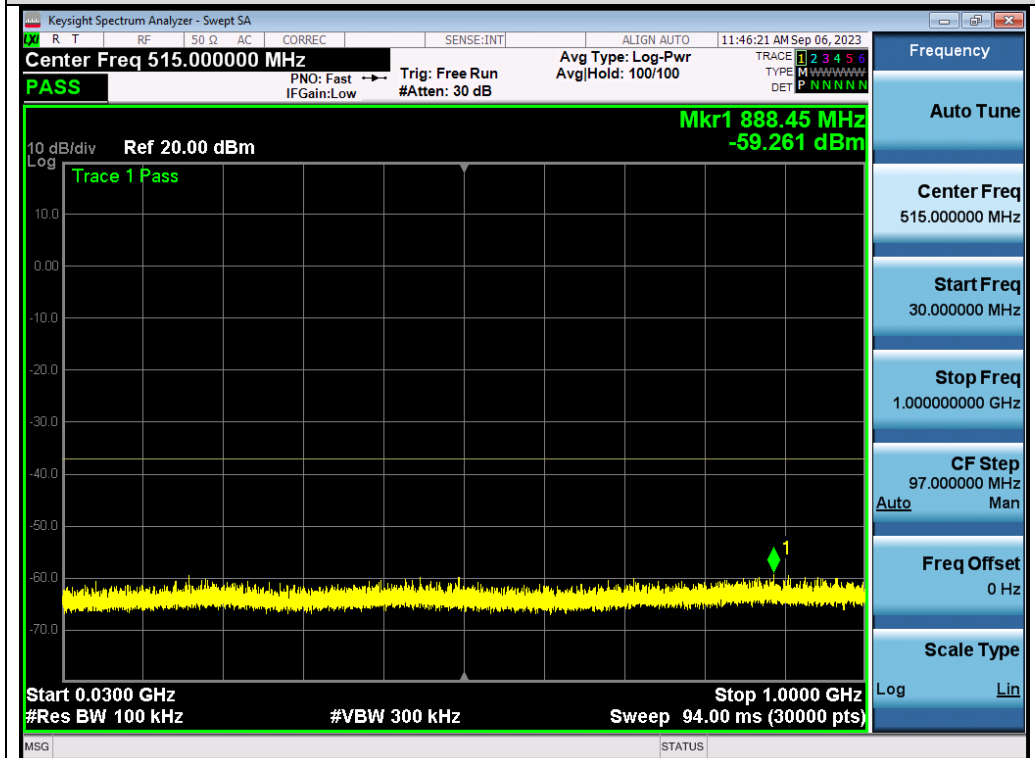

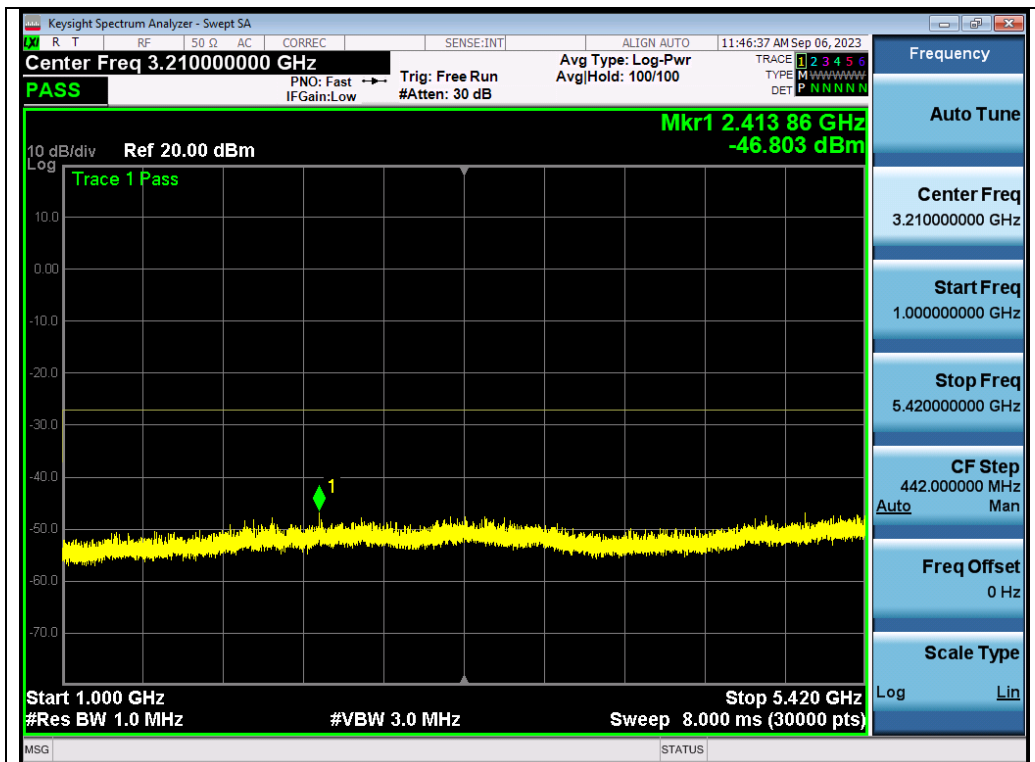


Test_Graph_802.11n40_ANT1_5510_MCS0_Frequency Band 5

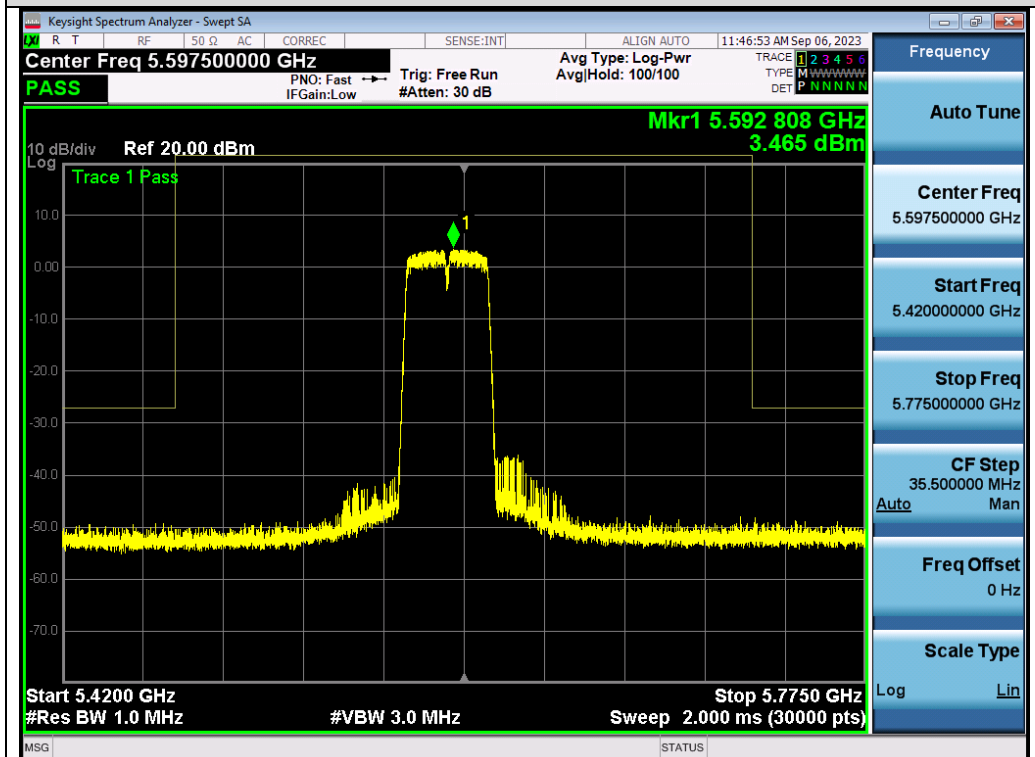

Test_Graph_802.11n40_ANT1_5590_MCS0_Frequency Band 2

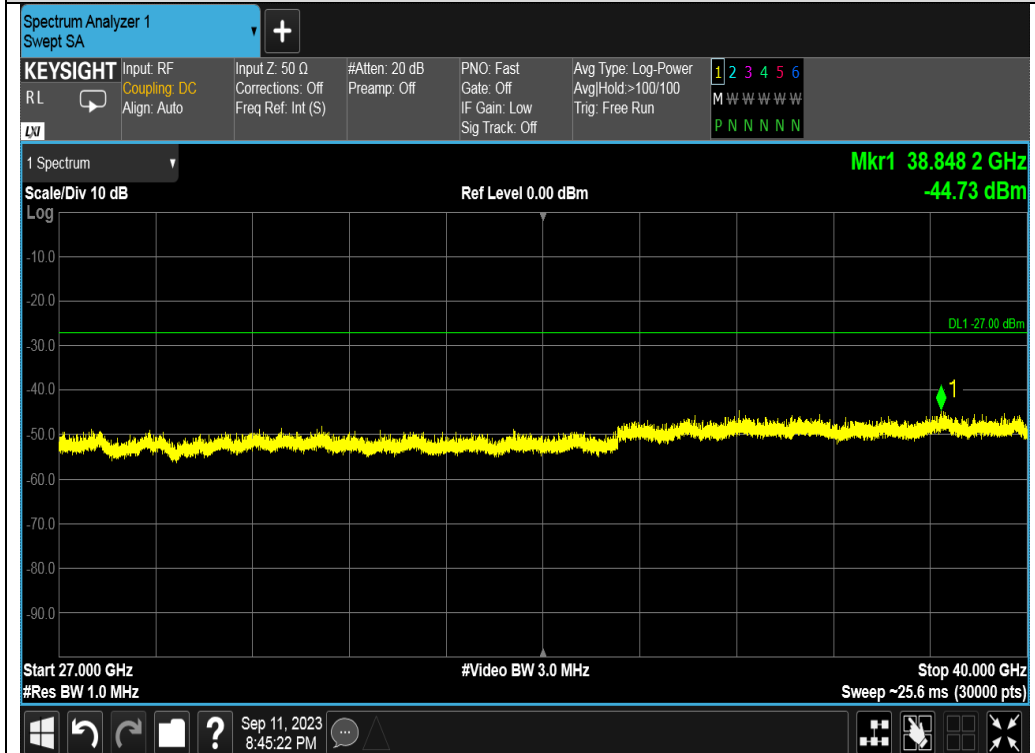

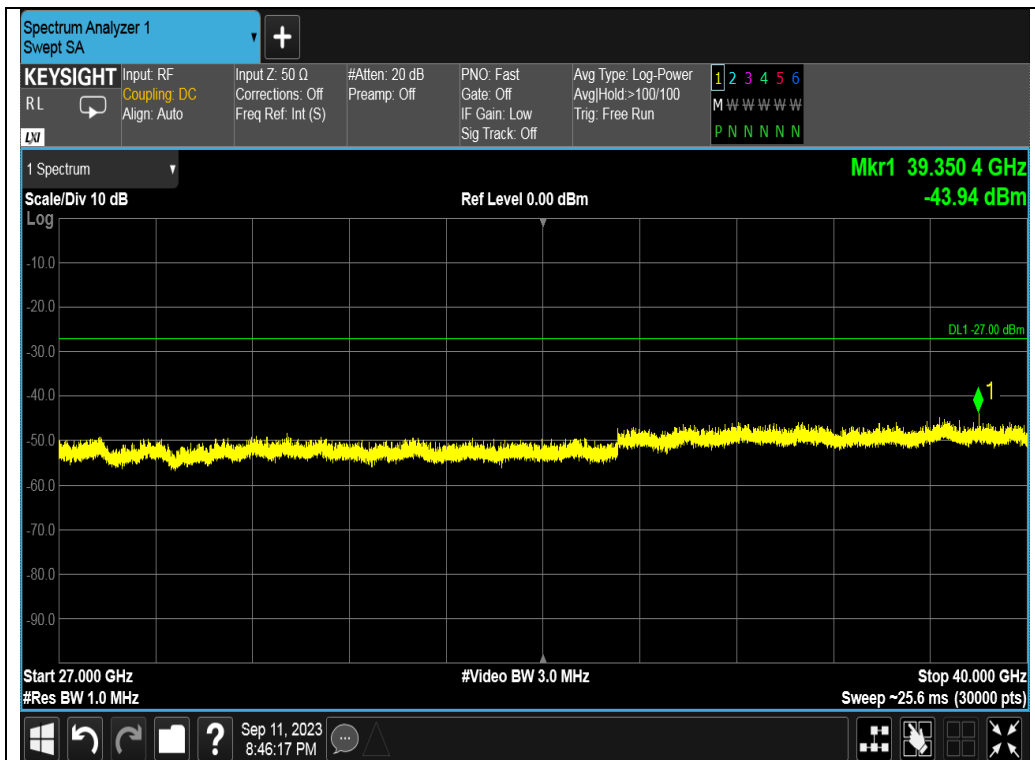


Test_Graph_802.11n40_ANT1_5670_MCS0_Frequency Band 3

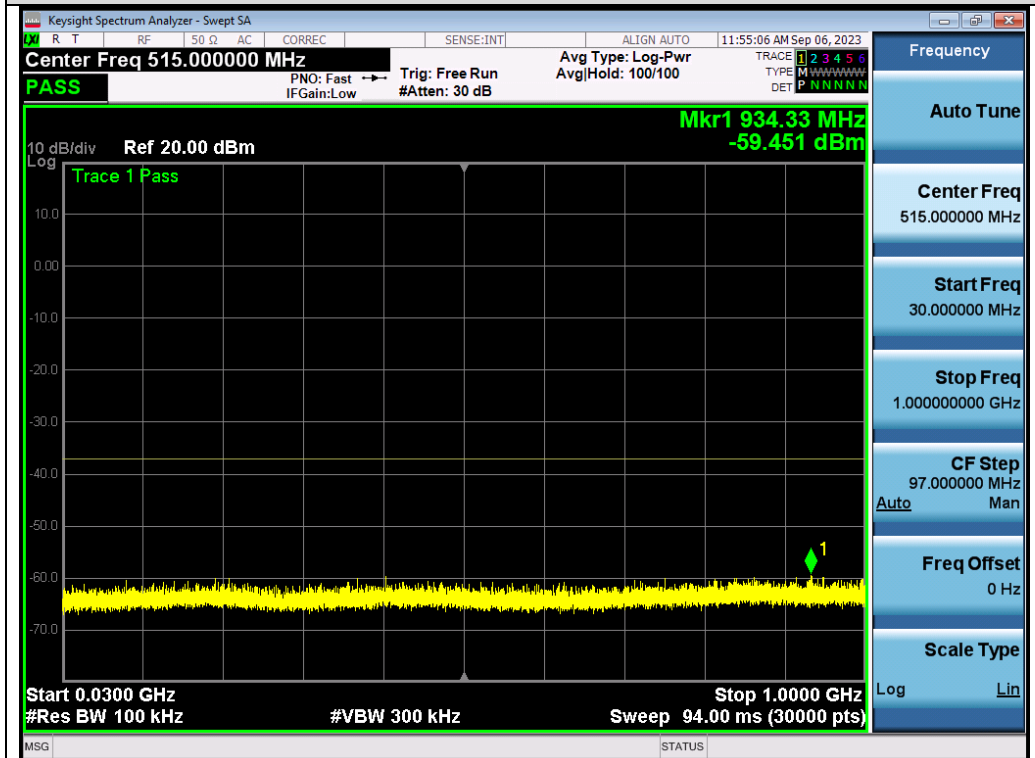
