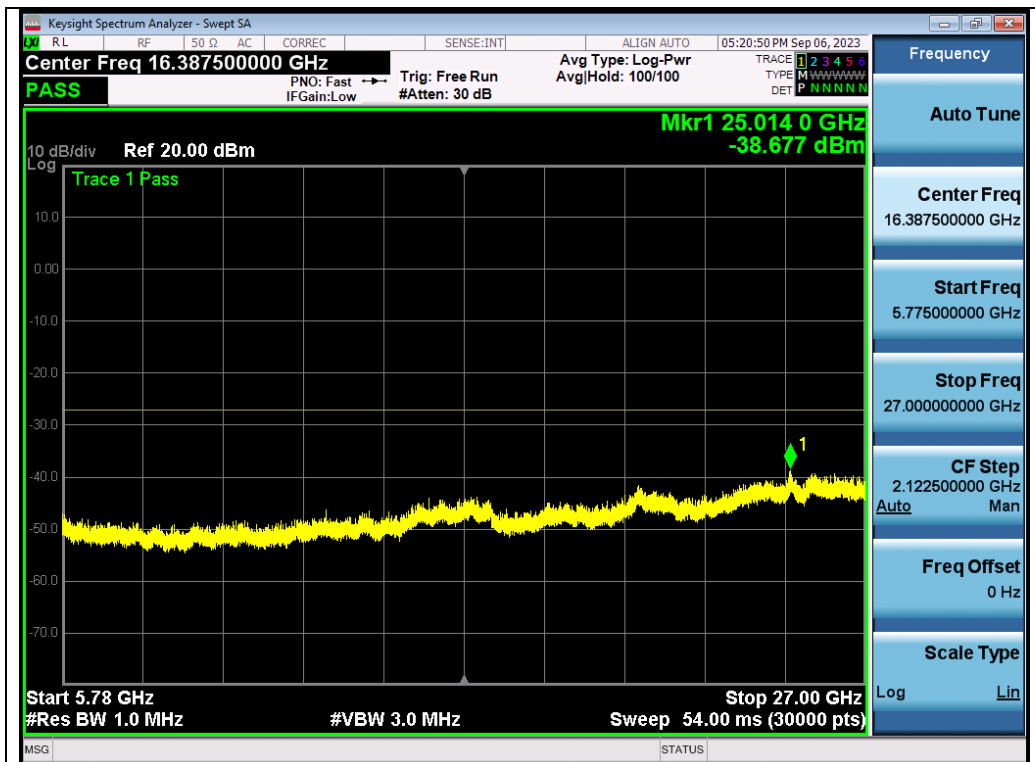


Test_Graph_802.11a_ANT2_5500_6Mbps_Frequency Band 2

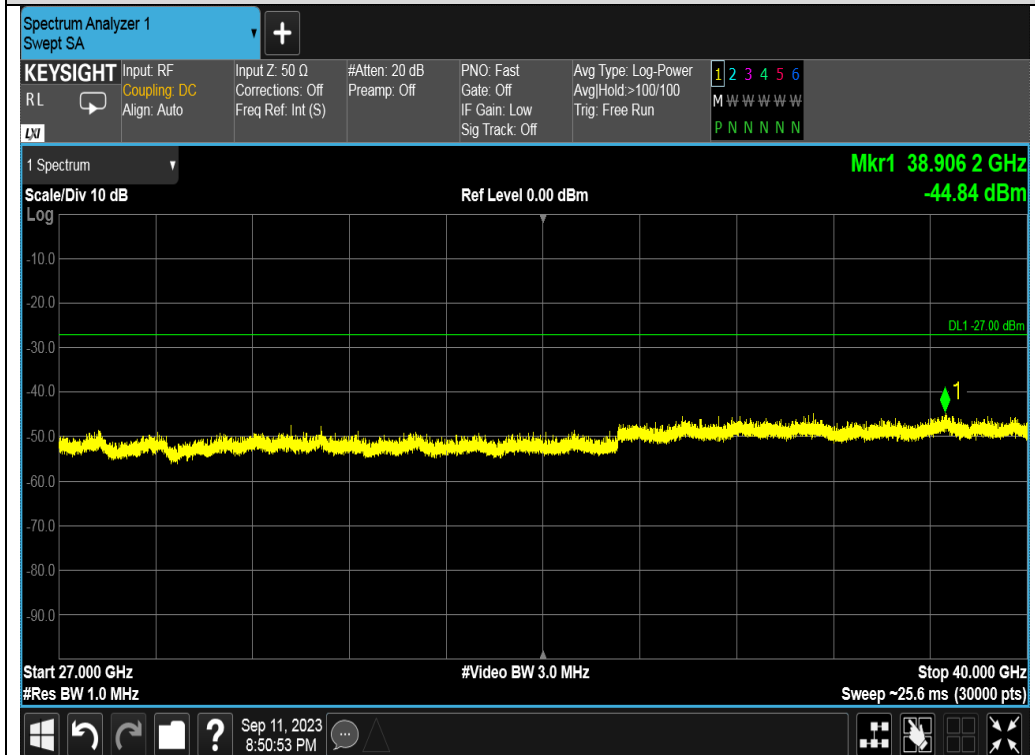

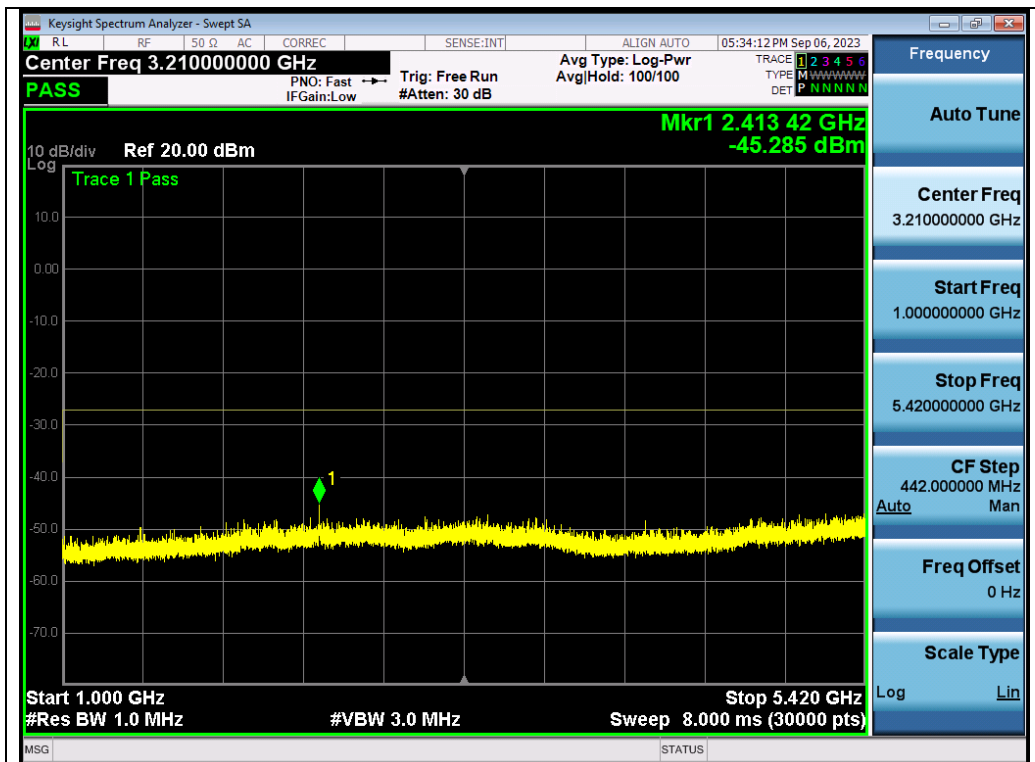


Test_Graph_802.11a_ANT2_5700_6Mbps_Frequency Band 5

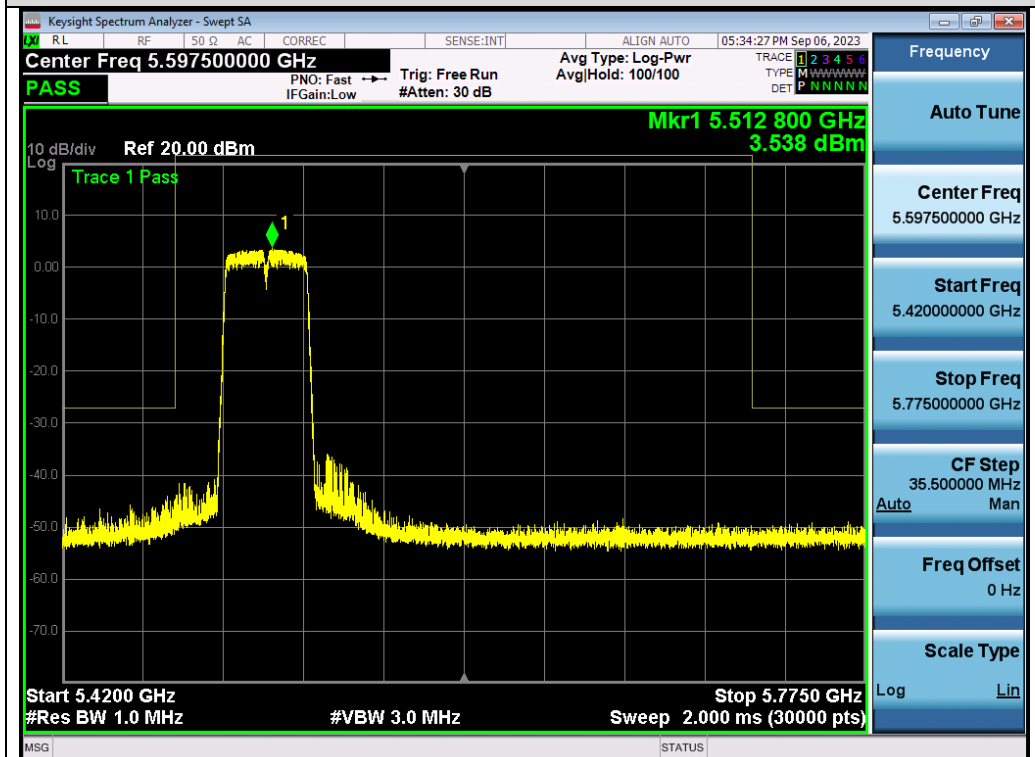

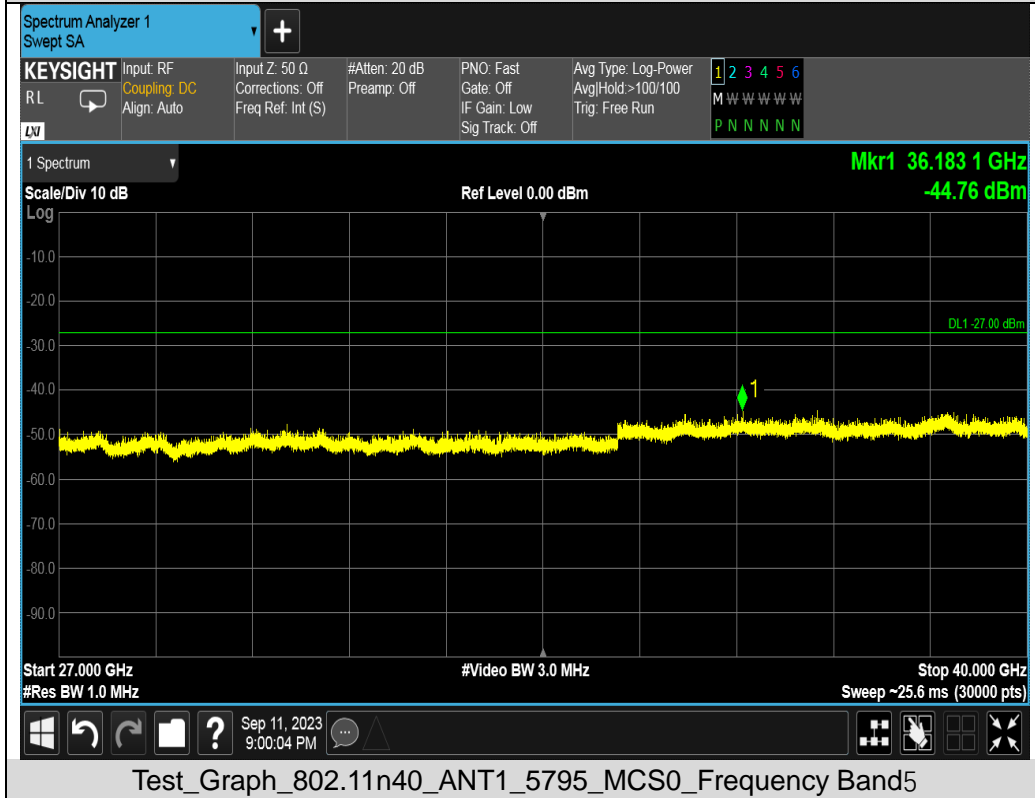

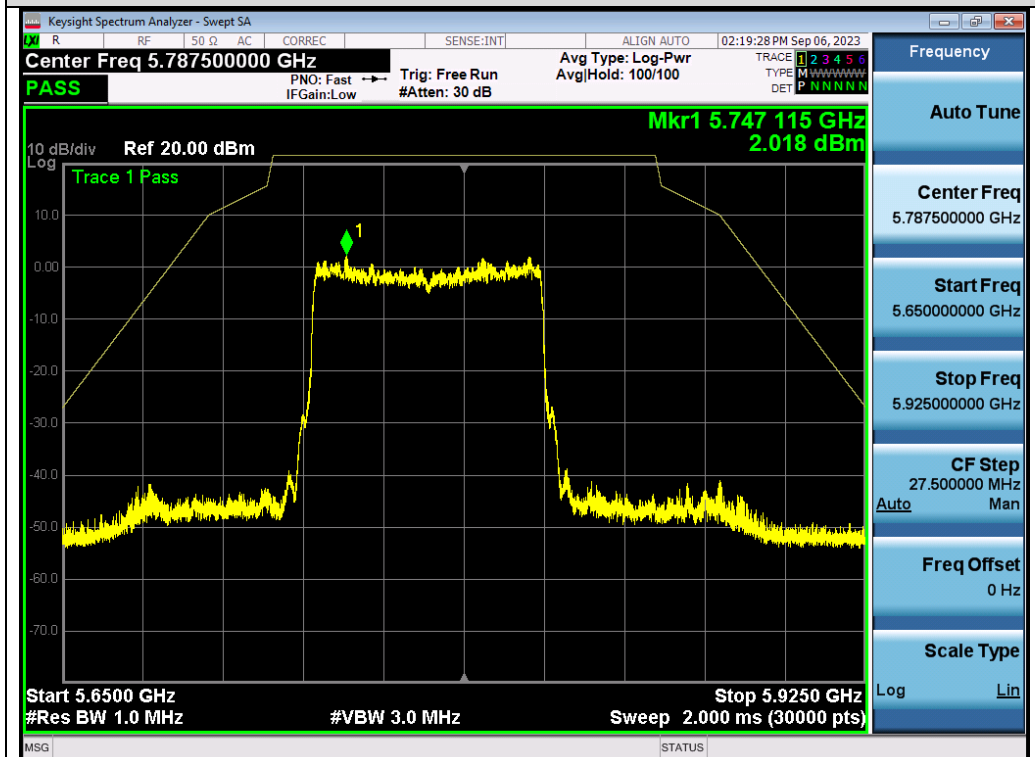

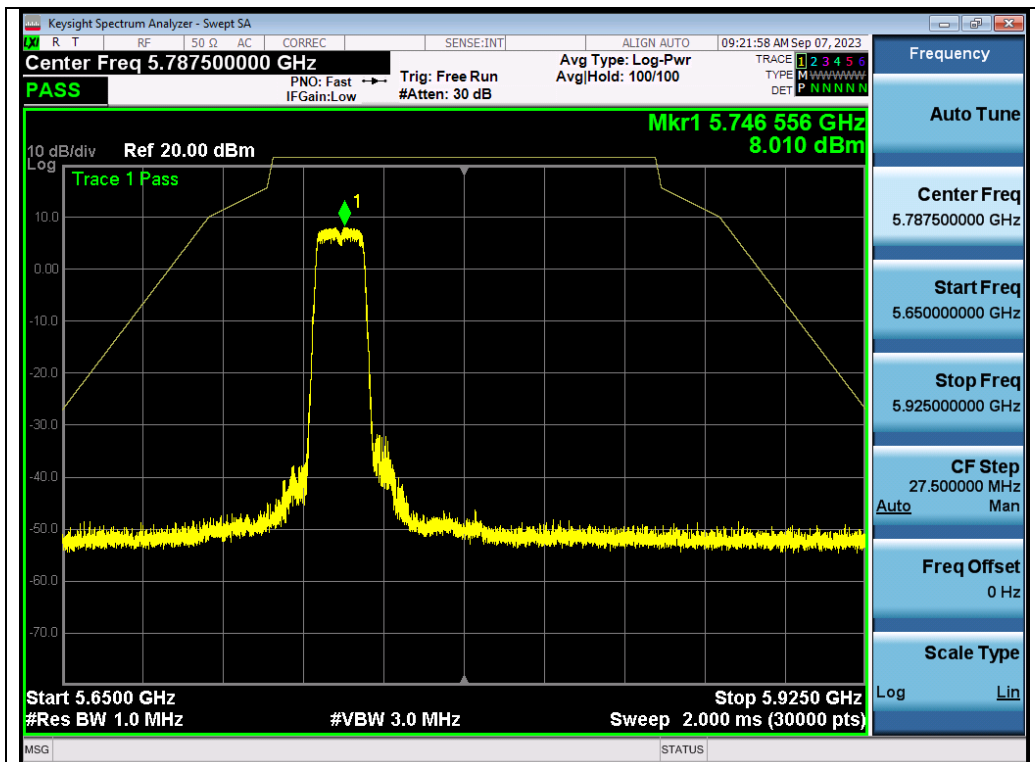


Test_Graph_802.11a_ANT2_5745_6Mbps_Frequency Band1
