## **1. RF EXPOSURE EVALUATION**

#### **1.1 Applicable Standard**

According to §1.1307(b)(3)(ii)(B)

Simultaneous Transmission with both SAR-based and MPE-Based Test Exemptions

This case is described in detail in § 1.1307(b)(3)(ii)(B) and covers the situations where both SARbased and MPE-based exemption may be considered for test exemption in fixed, mobile, or portable device exposure conditions. For these cases, a device with multiple RF sources transmitting simultaneously will be considered an RF exempt device if the condition of Formula (1) is satisfied.

1. The Maximum Conducted Power including Tune-up Tolerance was declared by manufacturer.

2. For SRD, This device maximum E-Field level is 93.38  $dB\mu V/m$  at 3m, so the EIRP power is -1.82 dBm.

3. EIRP (dBm)=Field Strength of Fundamental(dBuV/m)-95.2

4. ERP(dBm) = EIRP(dBm) - 2.15

The Wi-Fi and SRD can transmit simultaneously.
