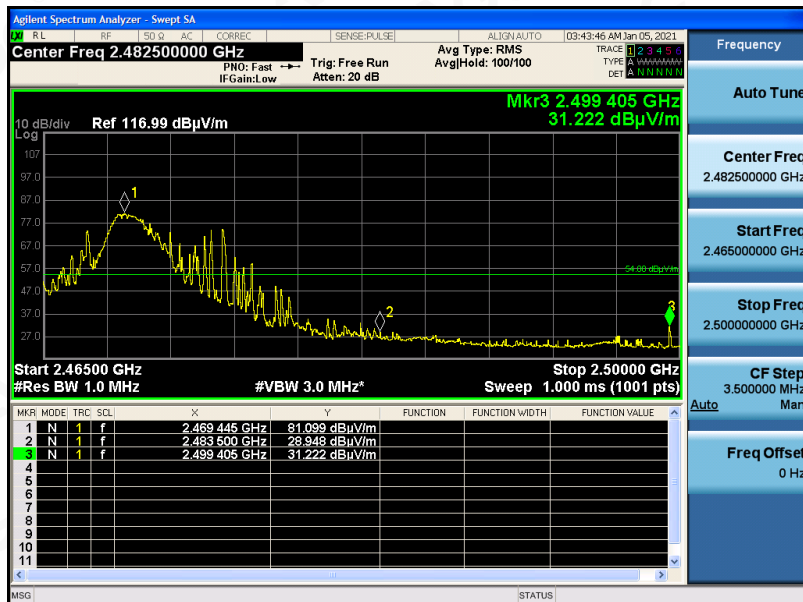

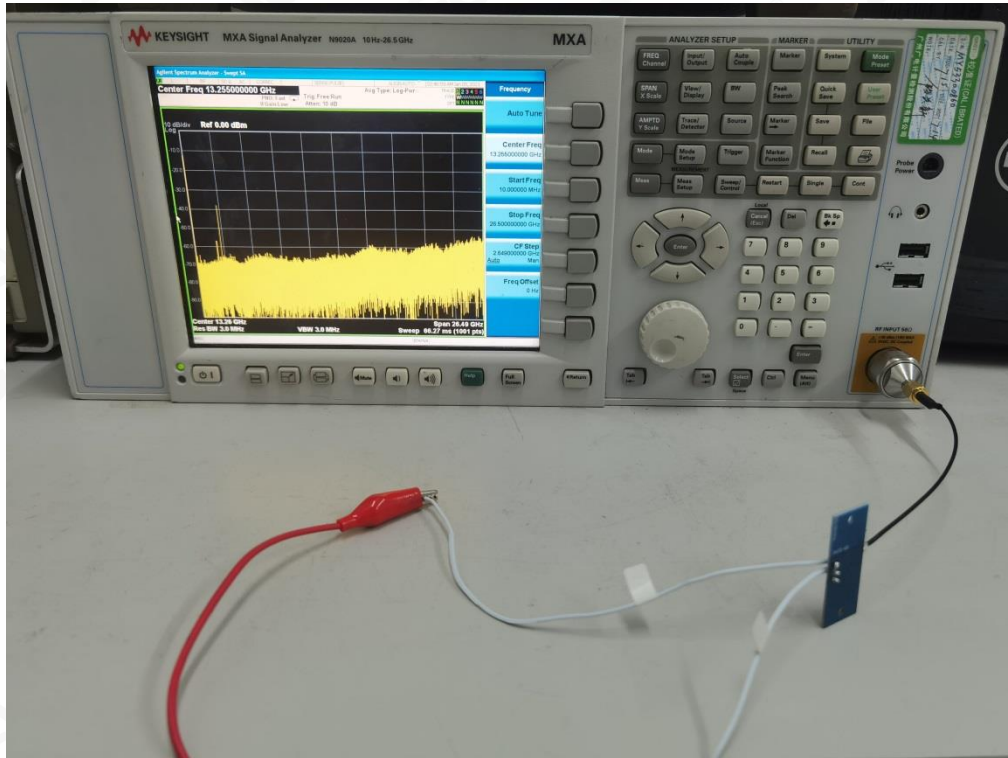

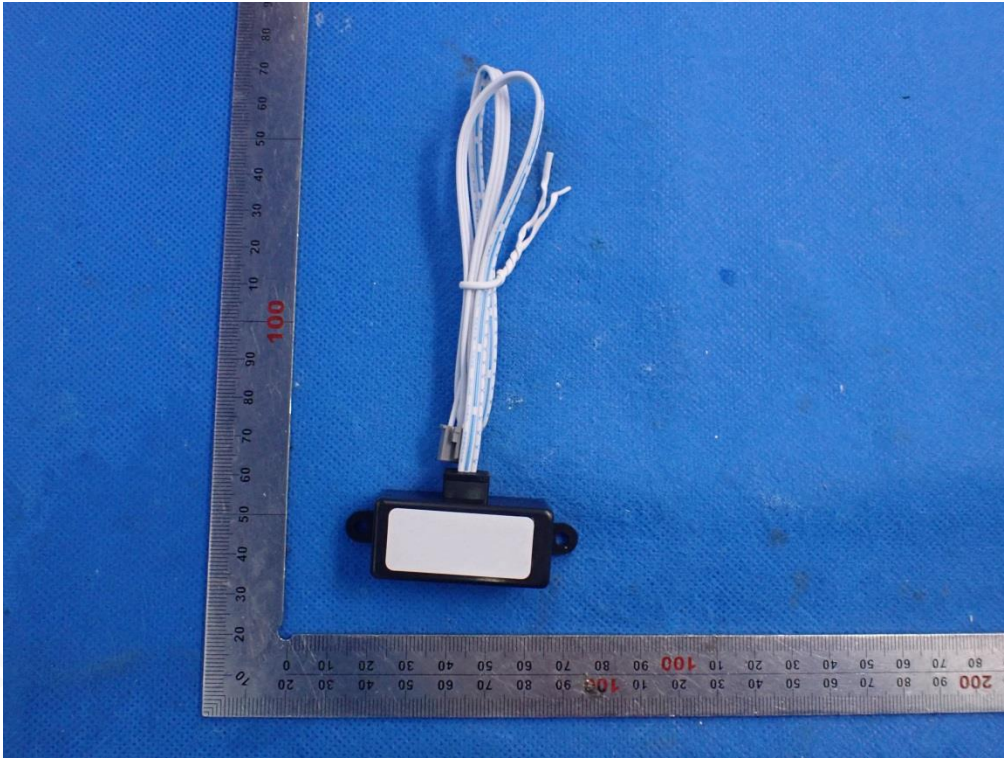

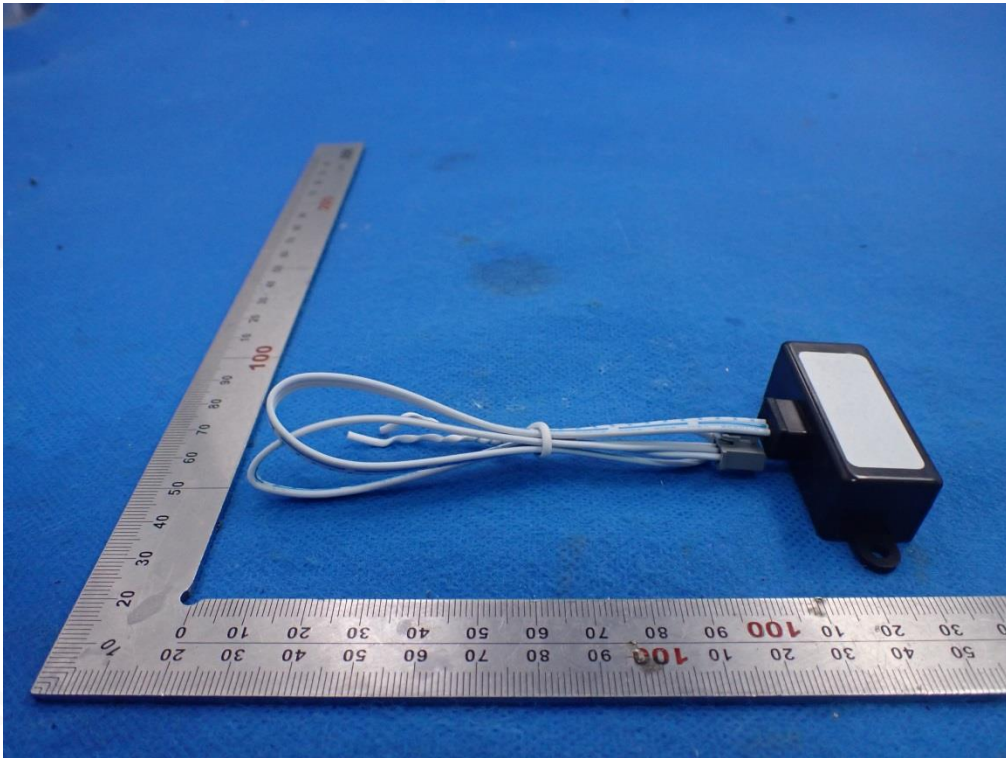

RIGHT VIEW OF EUT

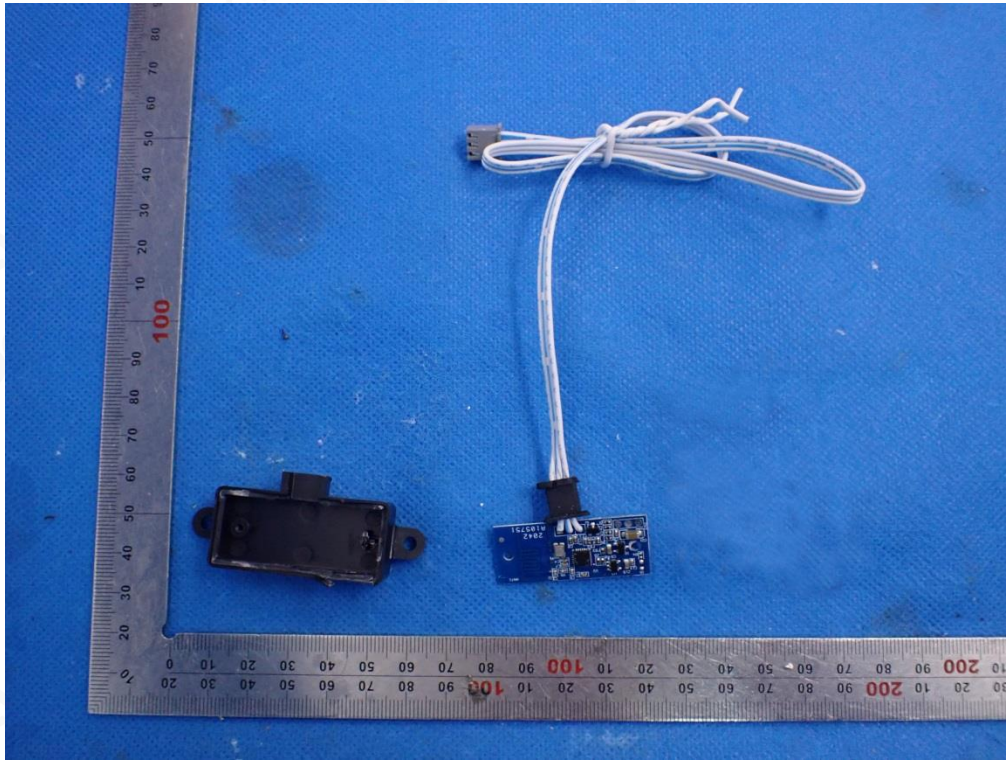

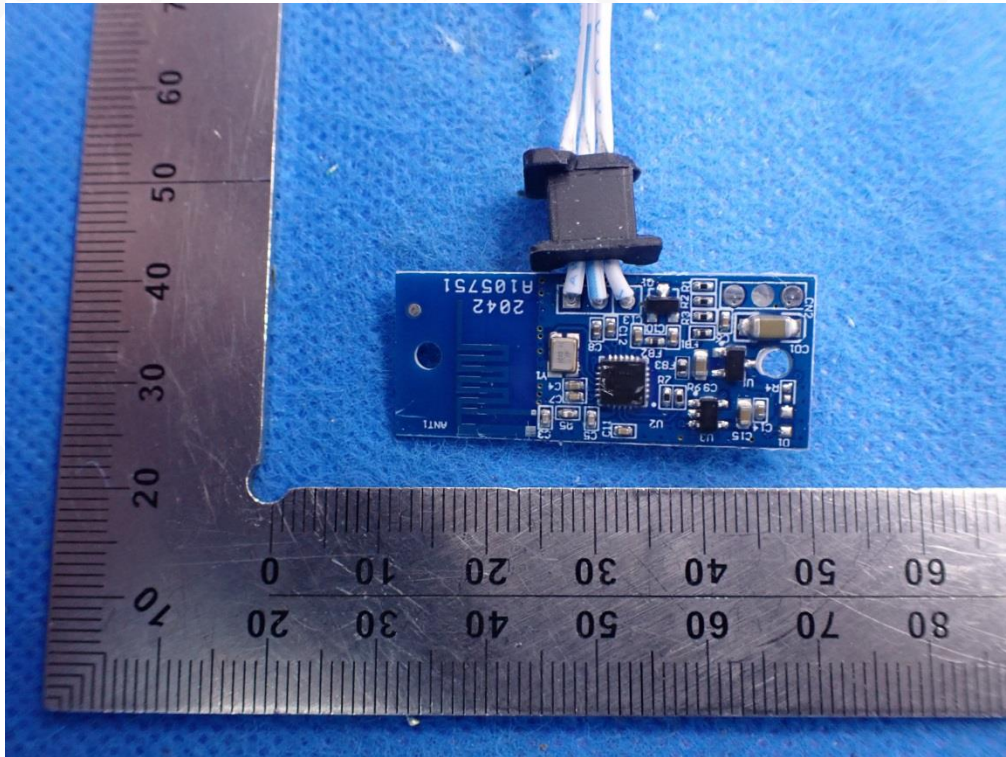

INTERNAL VIEW OF EUT-1

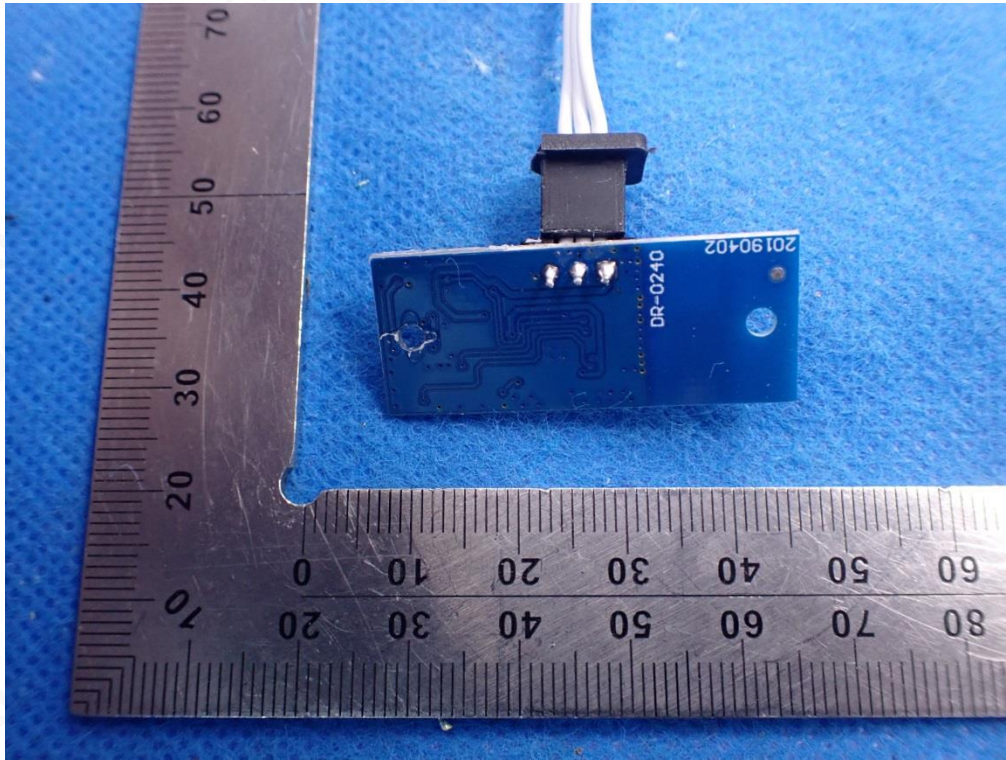

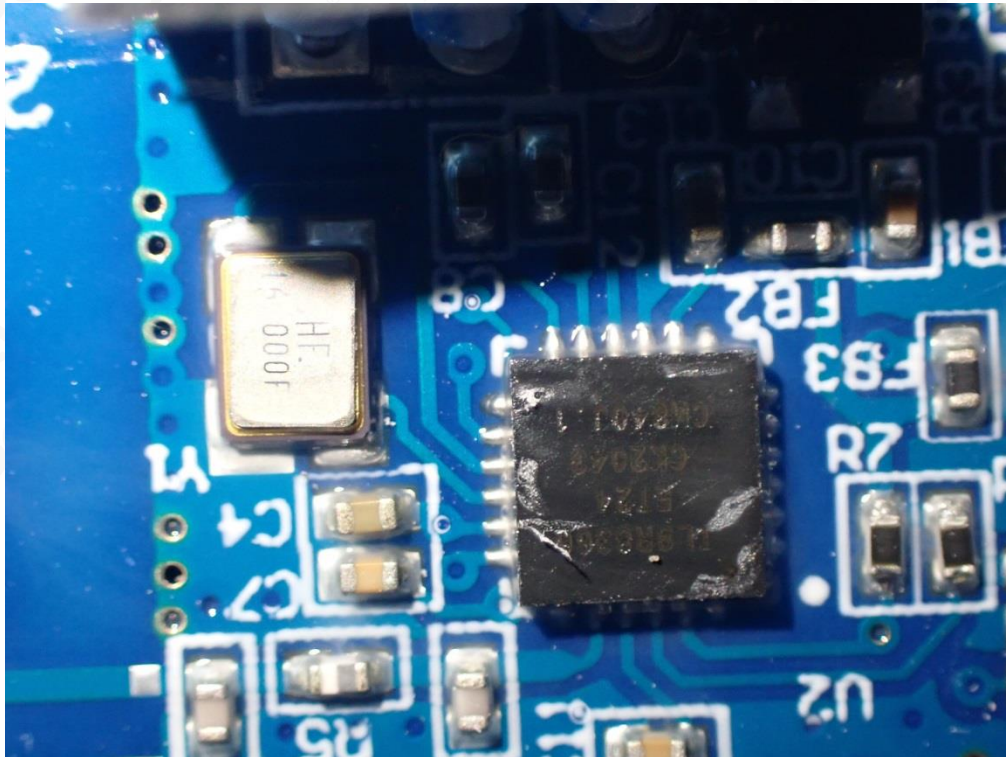

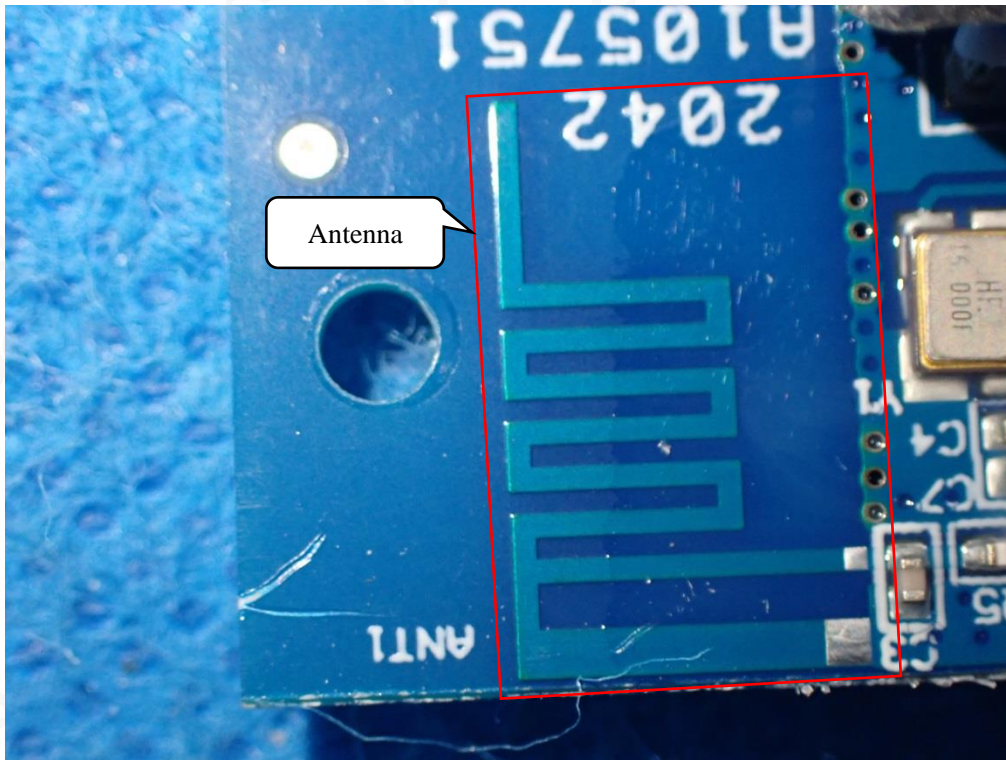
