

In order for you to use this product correctly, please read and follow the following safety guidelines carefully.



Function

Press and hold the power button for 2 seconds, the instrument is turned on, mode & power indicator Light.

• Shortly press the button after switching on to switch the mode: Soft (soft)/

Normal / Strong/ Standby.

• When the battery is low, the battery indicator light flashes slowly.

• The white indicator of the battery indicator flashes slowly during charging, and the indicator of the battery



The white light is always on.

• Each gear works for about 5 minutes. Standby mode after 5 minutes, wait

The machine will automatically shut down if there is no operation within 10 minutes.

• Press and hold the power button for 2 seconds to shut down.

Procedure

APP download and installation

After scanning the QR code in the user manual with your mobile phone, click to download and install. (If you use WeChat to scan, you need to manually jump to the browser to open)



APP function

The camera connected to the instrument through the APP is more straight during use Easy to clean pores.

①After turning on the instrument, set the WIFI connection ID on the mobile phone, such as: UDU Beau ty-1234.

② Open the "UDU" APP and enter the home page. If the device is not connected, the APP will The operation guide prompt appears.

③After clicking "Open", you can see the transmission of the instrument camera in the APP window image.



④When using, you can adjust the work of the blackhead according to the skin condition of the face position.

⑤ After clicking "Video", the image transmitted by the camera of the instrument can be saved to the mobile phone.

([®] After clicking "Take Photo", the image transmitted by the instrument camera can be taken as a photo Save to phone.

 \bigcirc If you need to switch windows, you can click "AR" to switch windows.

Nursing

Download and install the APP (see APP download and installation steps for details)

②Connect the instrument through APP (see APP function description for details)

③ Clean the face before use, apply a hot compress or use a steamer to help pores

Open, and then use the blackhead export solution to soften the blackhead, you can easily suck out the blackhead.

④ Choose the tip suitable for your needs, install it on the top of the instrument and on the palm or forearm Test the suction power.


⑤When in use, you can press the button to select the appropriate mode according to your skin condition.

⑧ After using, long press the power button to turn off the instrument, you can apply ice to the skin,

Or use with pore astringent to calm the skin.

⑨ Facial care is recommended 1-2 times a week.

Charging

① Please charge the instrument before using it for the first time.

② Please use standard qualified DC5V/1A adapter for charging.

③ During charging, the power indicator white light flashes breathing.

④ When fully charged, the power indicator white light is always on.

(5) When the power is low, the red indicator light flashes slowly. Please use it after fully charging.

% If the connection has not started after 10 seconds of charging, please confirm whether the USB cable is light Poor micro-contact.

Maintenance and protection

① When cleaning, please make sure that the instrument is turned off, the instrument can not be washed to avoid electric shock.

② When cleaning the tip, please remove the tip from the machine and rinse it with warm water.

③ The instrument is not waterproof, you can wipe the body clean with a wet paper towel or a damp cloth after each use, cut

Do not rinse with water.

④ The lens of the product camera is cleaned with a cotton swab. It is forbidden to touch the lens with hard objects.

(5) It is forbidden to use corrosive solution to wipe the body.
