**1**

**Connect earbuds**

Turn on Bluetooth on smartphone, search and connect to "DIZO GoPods D"

**Touch operation**

**Touch twice:** Play/pause music; Answer/hang up.

**Touch three times:** Next Song.

**Press and hold for 2s:** Reject incoming call.

**Press and hold both left and right earbuds for 2s:** Enter/Exit Game Mode.
