



# BEFORE USING FOR THE FIRST TIME

# **HOW TO INSTALL THE BATTERIES**

- Uncover the battery compartment by rotation;
- Insert two AAA batteries according to the positive and negative indications;
- Restore and tighten the cover.



## HOW TO USE THE PRODUCT FOR WINE AERATION

#### Manual Wine Aeration

 According to the illustration, insert the stainless steel telescopic tube into the jack at the indicator tightly.



•Extend the telescopic tube to suitable lengt and insert it into the bottle of wine, press th switch lightly, the wine aerator then begin to work with its indicator light kept on in rec The default working time is 60 seconds and the wine aerator will stop working 60



Important note: the wine aeration efficiency of the product is extremely high, so the actual working time is not equal to the normal aeration time with a decanter. Wine aeration of 60 seconds with this product is almost equal to 30 minutes of static wine aeration with traditional decanter)

#### Wine Aeration via Bluetooth Mobile Control

The product can be connected with dedicated APP through Bluetooth and controlled remotely on mobile terminals. The APP supports Android system and Apple IOS system

•IOS users can search "Cheer Moda" in APP Store, and download it for installation, or scan the QR code below to enter the APP Store. Android users can scan the following QR code directly for download and installation

- After the APP installation, turn on your cellphone Bluetooth and the APP, an interface of "Searching Cheer device" will pop up for Bluetooth pairing, long press the button at the top of the wine aerator for 3 seconds, when the indicator flashes in blue, it indicates that the product is ready for Bluetooth connection. After successful connection, the indicator will be in blue, and off after 5 seconds.
- Click "Cheer Moda" to access the APP interface, you can click "Set wine
  aeration time manually" for choosing the proper wine aeration time,
  click "Start", then the wine aerator will begin to execute wine aeration.
- If you do not know the wine aeration time for a certain wine, you can click "Scan to identify the wine aeration time", i.e., you can scan the wine label in the front of the wine bottle, find information of the corresponding wine in the APP scan results and set the wine aeration time according to the system suggestion.

#### APP IDENTIFICATION AND FUNCTION DESCRIPTION

- •The APP of the product has been accessed to the database of professional wine information website "9kacha.com", so the system is able to identify a specific wine automatically by scanning wine labels and provide you with suggestions of wine aeration time (the time of static aeration in traditional decanter).
- If there is no matched information in the scan result, you can analyze the wine using the tips given by the APP system and select the proper wine aeration time (The tips are only for reference).

## FUNCTION SETTING MENU

- Click " " to edit the name of the wine aerator.
- Click "Software update" to view software information
- Click "Problem feedback" to contact for customer support by email or telephone.
- Click "Disconnect Bluetooth" for easy disconnection

## LOW BATTERY WARNING

If the indicator flashes in red during product operation, it indicates low battery. Please replace with new batteries timely.

**Note:** It is not suggested to mix new batteries with old ones, or batteries of different brands.

## TROUBLESHOOTING

If there is no response when pressing the button, or the product stops working during its operation

- Please check whether the batteries are installed correctly.
- Please check whether the battery capacity is sufficient.

If all above operations are correct and the product still works abnormally please contact the dealer for repair.

# **CLEAN AND MAINTENANCE**

- Clean the surface of the product with a soft and wet cloth.
- Do not immerse the product in water or other liquids.
- •To clean the telescopic tube, please take off the telescopic tube from the jack, extend it to its maximum length and wash it directly with clean water. Do not use any detergent.
- Please store the product in a clean and dry place in its idle time

## WARRANTY

Under normal conditions, this product is guaranteed for 2 years from the date of purchase. The warranty service is only valid if the product is returned to your vendor with proof of purchase (warranty card duly completed or receipt of purchase).

Free maintenance is invalid in the following cases:
