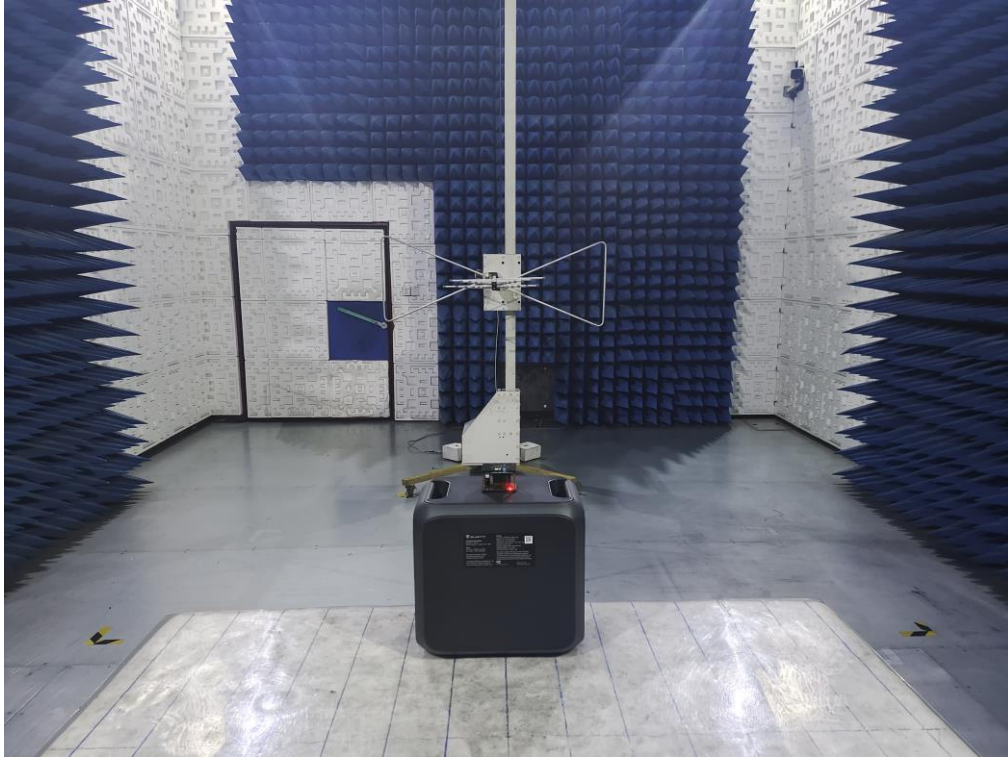


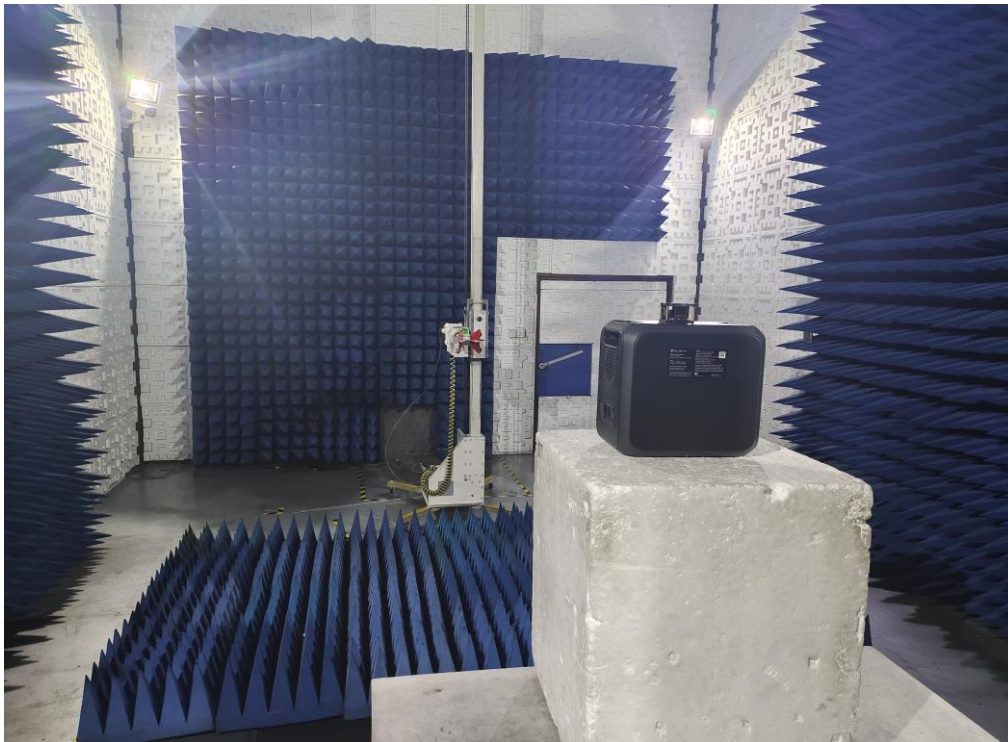

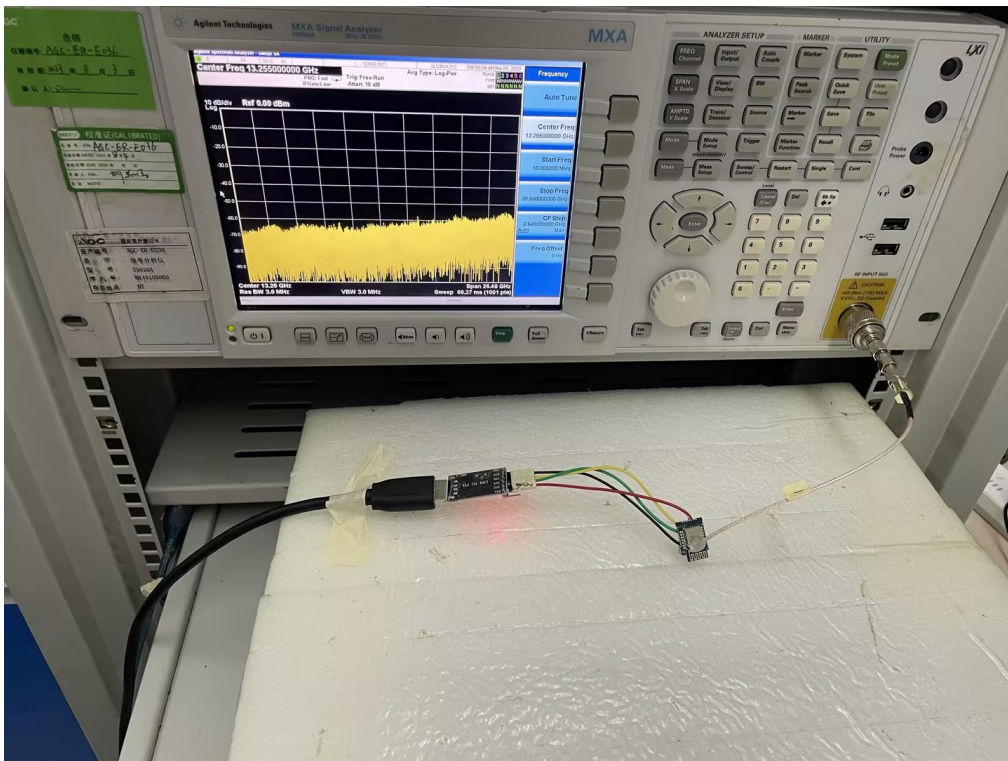

AC POWER LINE CONDUCTED TEST SETUP



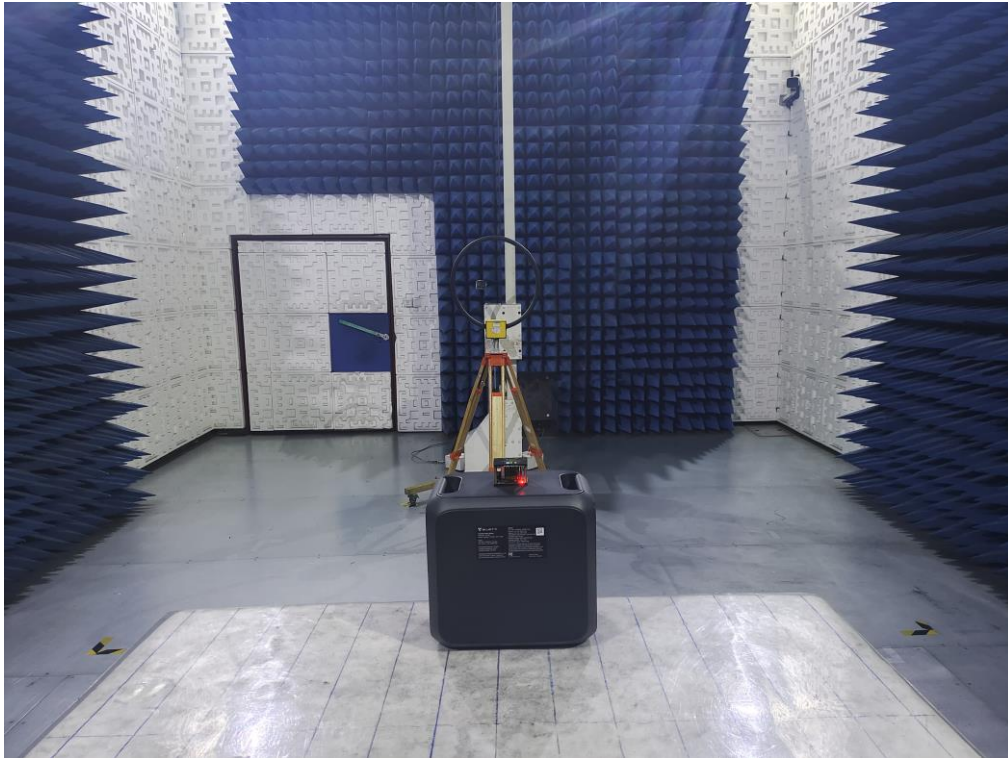
RF CONDUCTED TEST SETUP



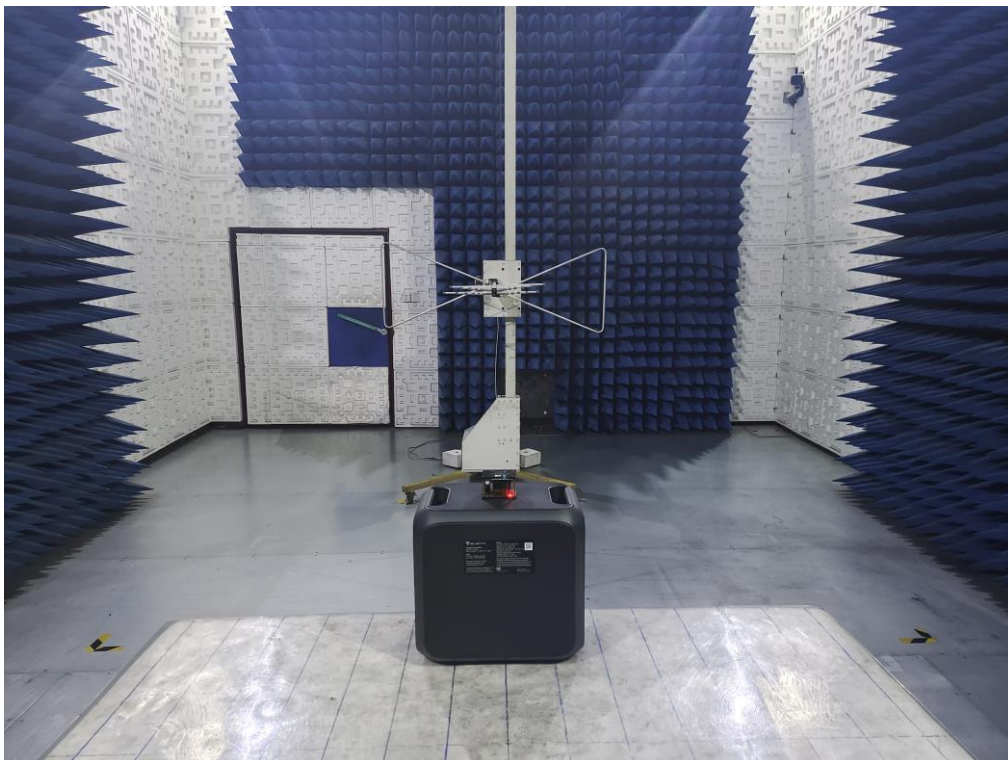
