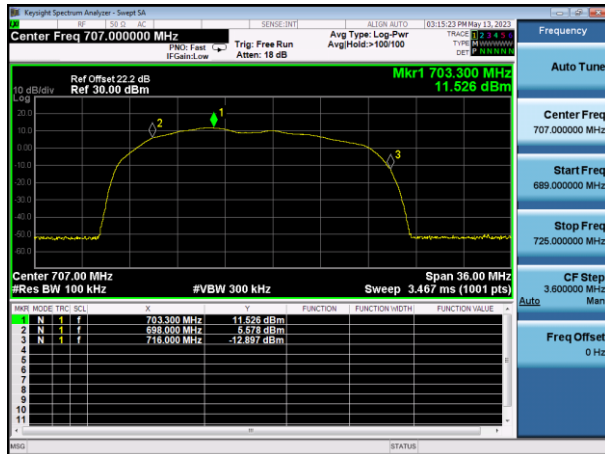

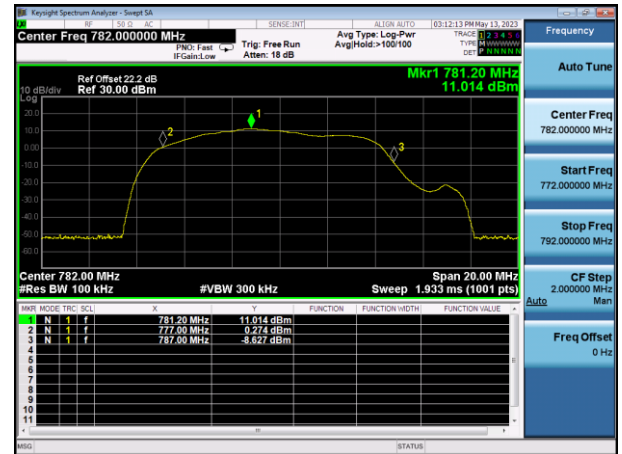

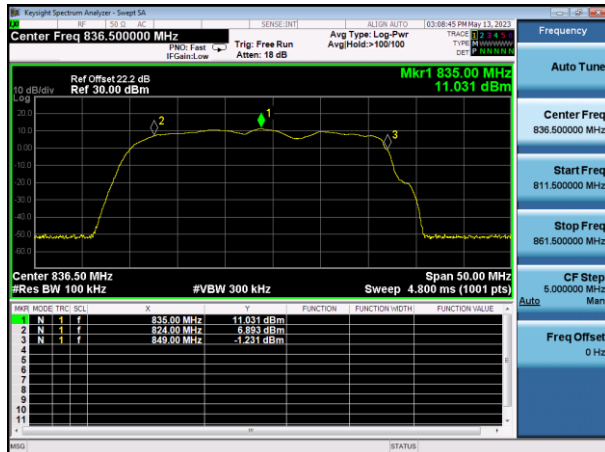

Upper 700MHz Band



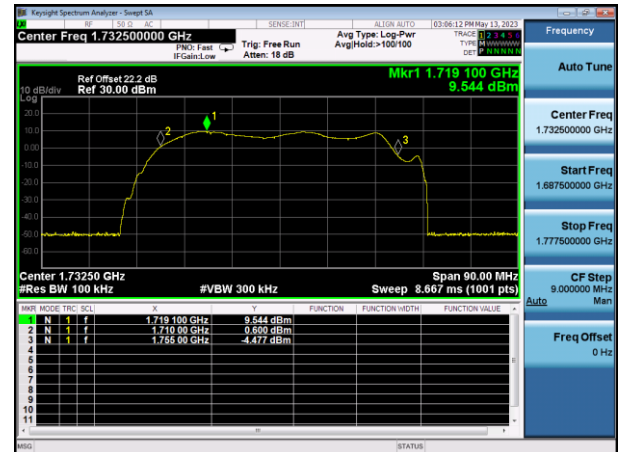

1.25MHz AWGN signal input_Upper band edge_10dB above AGC

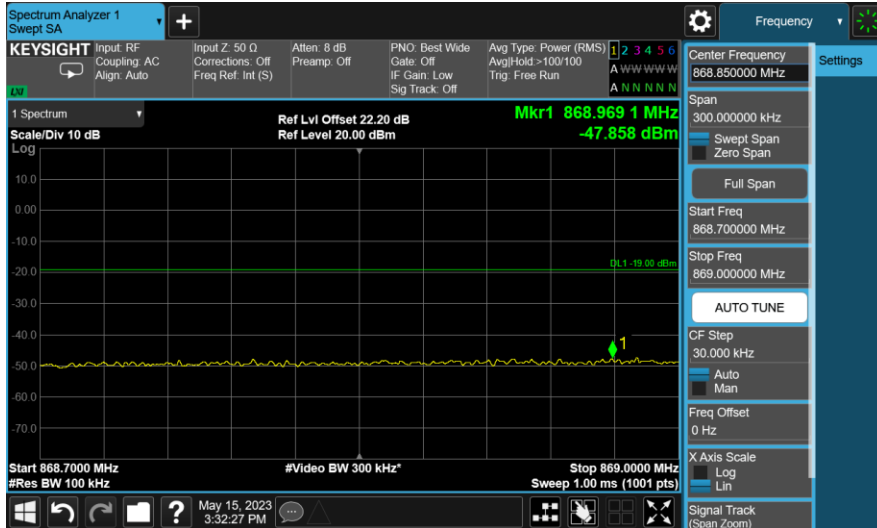
