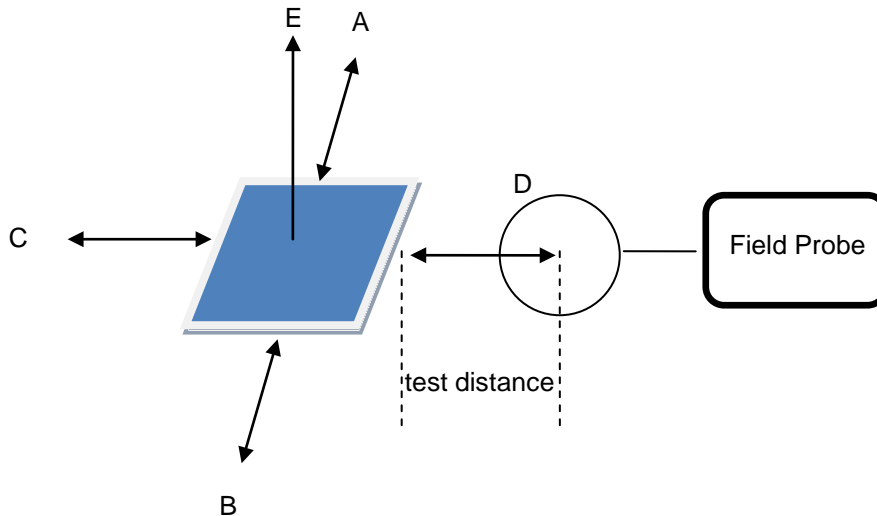

## 7 RF Exposure

### 7.1 Test Setup



The RF exposure test was performed in anechoic chamber.

The probe was placed at test distance which is between the edge of the charger and the geometric centre of probe.

The EUT was put in different directions (Left(26cm), Right(12cm), Front(14cm), Rear(12cm), Top and Bottom(20cm) to obtain the maximum reading.

The EUT was measured according to the dictates of KDB 680106 D01 RF Exposure Wireless Charging App v03.

### 7.2 Equipment approval considerations (clause 5 b) of KDB 680106 D01 v03

Remark: The device meets the RF exposure limit at separation distance as specified in §1.1310 of the FCC Rules and meeting all of the following requirements as follows.

- (1) Power transfer frequency is less than 1 MHz.
- (2) Output power from each primary coil is less than or equal to 15 watts.
- (3) The transfer system includes only single primary and secondary coils. This includes charging systems that may have multiple primary coils and clients that are able to detect and allow coupling only between individual pairs of coils.
- (4) Client device is placed directly in contact with the transmitter.
- (5) Mobile exposure conditions only (portable exposure conditions are not covered by this exclusion).
- (6) The aggregate H-field strengths at 12 cm surrounding the device and 20 cm above the top surface from all simultaneous transmitting coils are demonstrated to be less than 50% of the MPE limit.



### 7.3 FCC Rules

§1.1310: The criteria listed in the following table 1 shall be used to evaluate the environment impact of human exposure to radio frequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of FCC part 2.1093 of this chapter.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

NOTE 2 TO TABLE 1: General population/uncontrolled exposures apply in situations in which the general public may be exposed, or in which persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or can not exercise control over their exposure.

RF exposure compliance will need to be determined with respect to 1.1307(C) and (d) of the FCC rules. The emissions should be within the limits at 300kHz in Table 1 of 1.1310(use the 300kHz limits for 150Khz:614V/m, 1.63A/m).
