### 5.1 RF Exposure

#### 5.1.1 Test Requirement:

Limit:

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\left[ \frac{\text{(max. power of channel, including tune-up tolerance, mW)}}{\text{(min. test separation distance, mm)}} \cdot \sqrt{f(\text{GHz})} \right] \leq 3.0$$
 for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.2 Conclusion

The Max Conducted Peak Output power is -1.79 dBm on the lowest channel 2.48GHz

-1.79 dBm logarithmic terms convert to numeric result is nearly 0.66 mW

According to the formula. calculate the test exclusion thresholds:

General RF Exposure =  $(0.66 \text{ mW} / 5 \text{ mm}) \times \sqrt{\phantom{x}}$  0.21 (1)

SAR requirement:

S = 3.0 (2)
