





<div><div>SKG</div><div>V9 Smart Watch</div></div> <div></div> <div>User Guide</div>	<div>Product Overview</div> <div></div> <div><p>※ For the best heart rate measurement results, wear the watch away from your wrist bone and fit it comfortably on your wrist, but not too tightly.</p><p>※ The watch and strap are made of materials that are safe to wear, so you can wear the watch with confidence. If you have issues such as skin discomfort while wearing the watch, stop using it and contact a doctor.</p></div>	<div><div>1</div><div>Enter Pairing Mode</div><div>Press and hold the Function button (side button) for 6 seconds the first time you turn it on. The startup logo will appear on the screen and the watch will vibrate when it turns on to indicate it has entered pairing mode.</div><div></div><div><div>2</div><div>Download "SKG Watch V9" APP</div><div>Search "SKG Watch V9" in the APP Store, then download and install it to your phone.</div><div></div><div><div>3</div><div>Settings and Pairing</div><div>Click the plus icon in the APP "SKG Watch V9" to add device.
