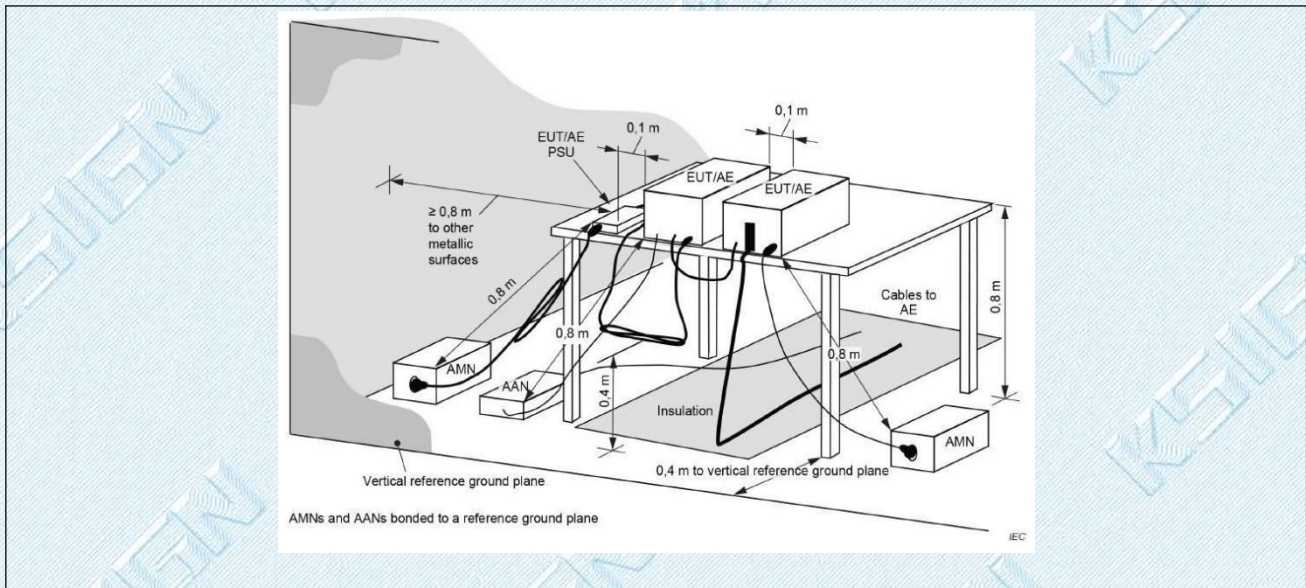

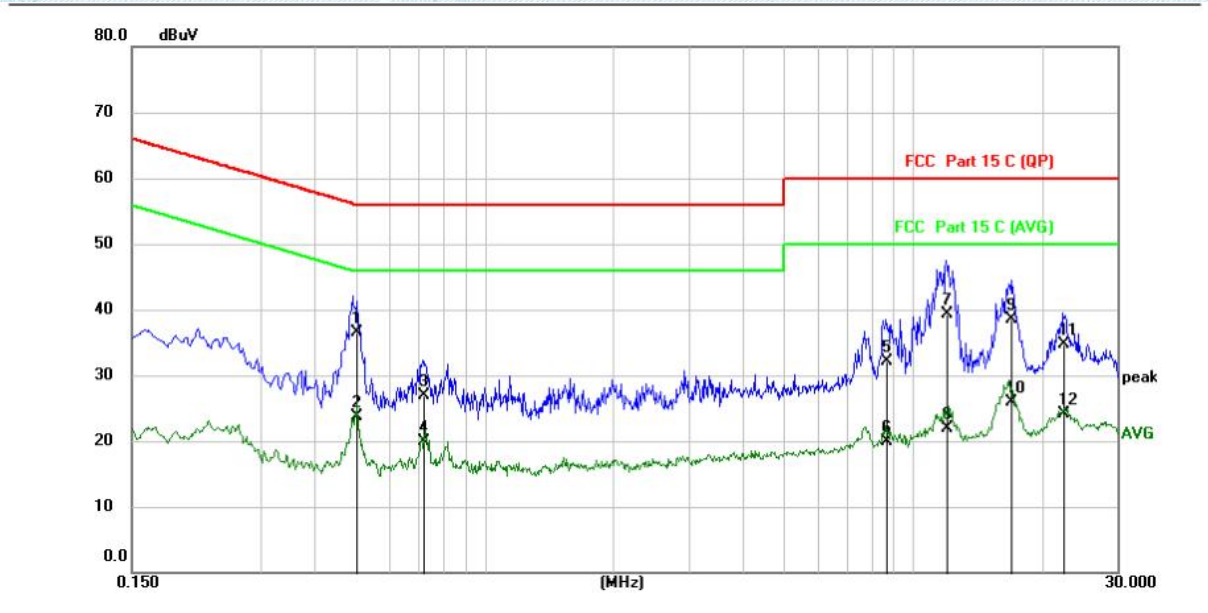

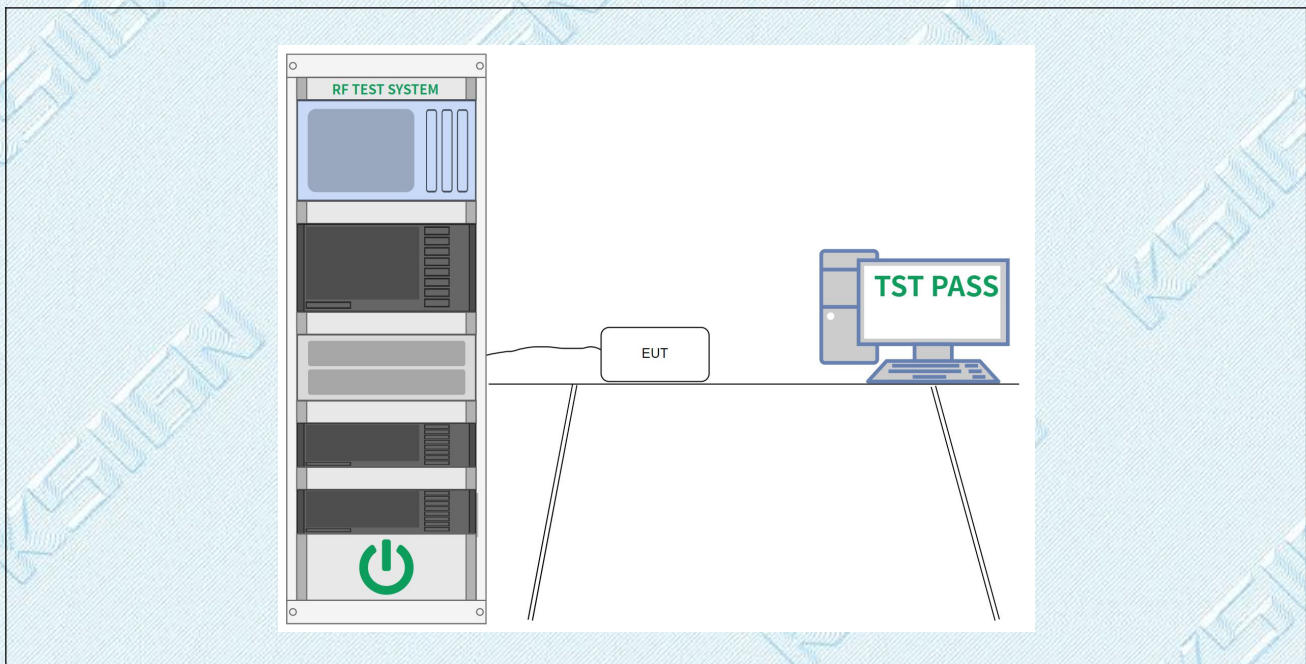

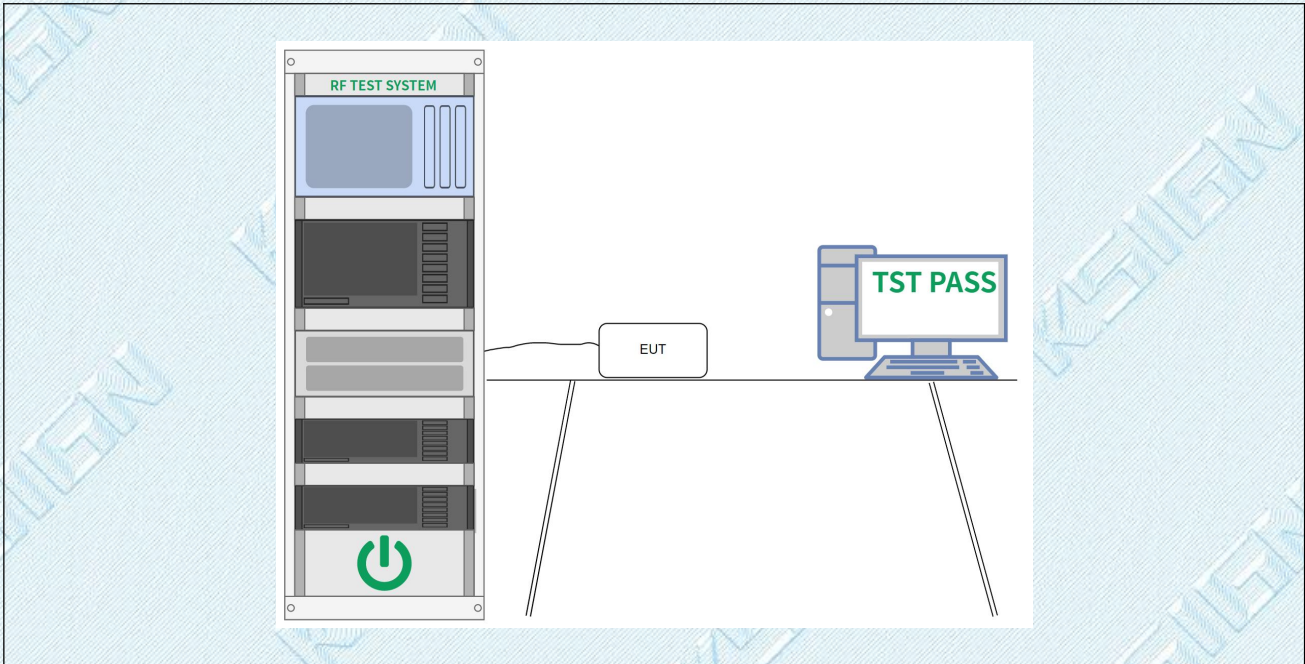

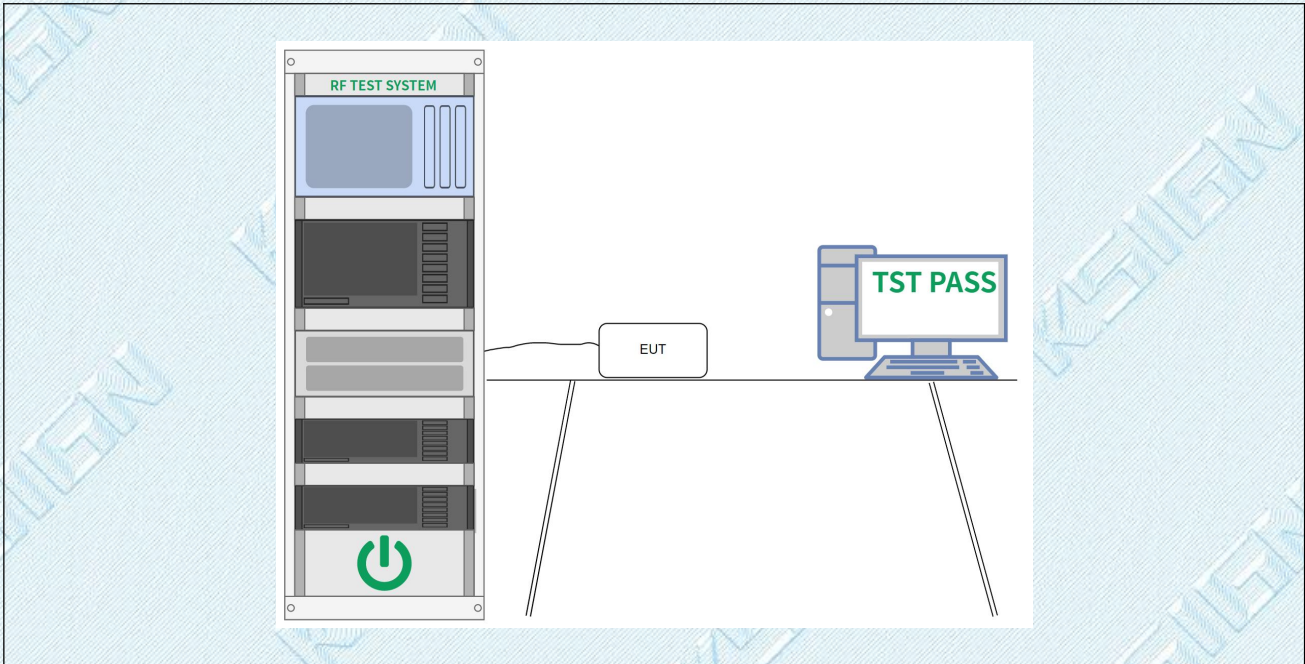



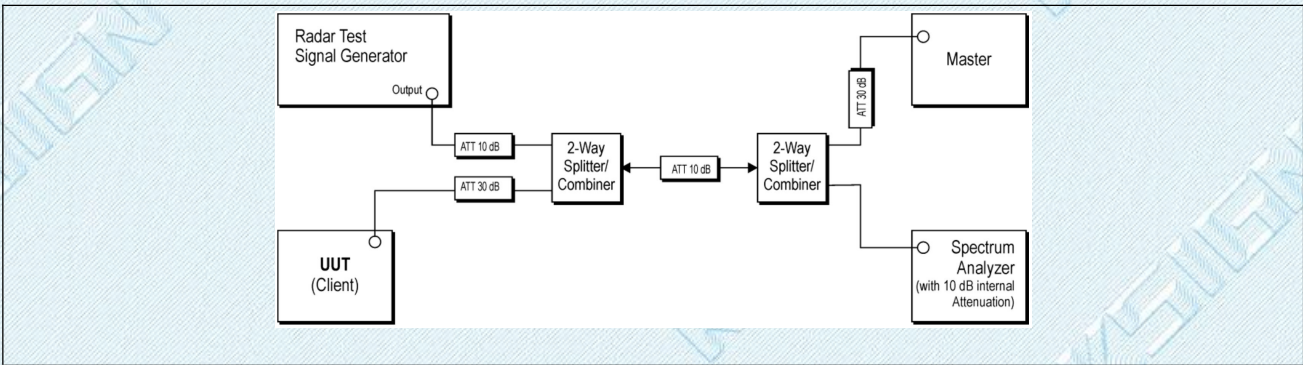

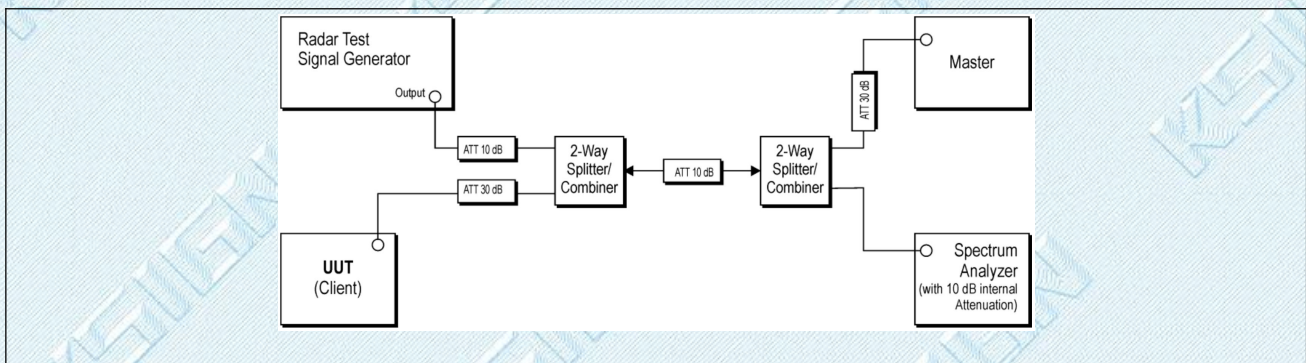

3.10.2. Test Setup Diagram:



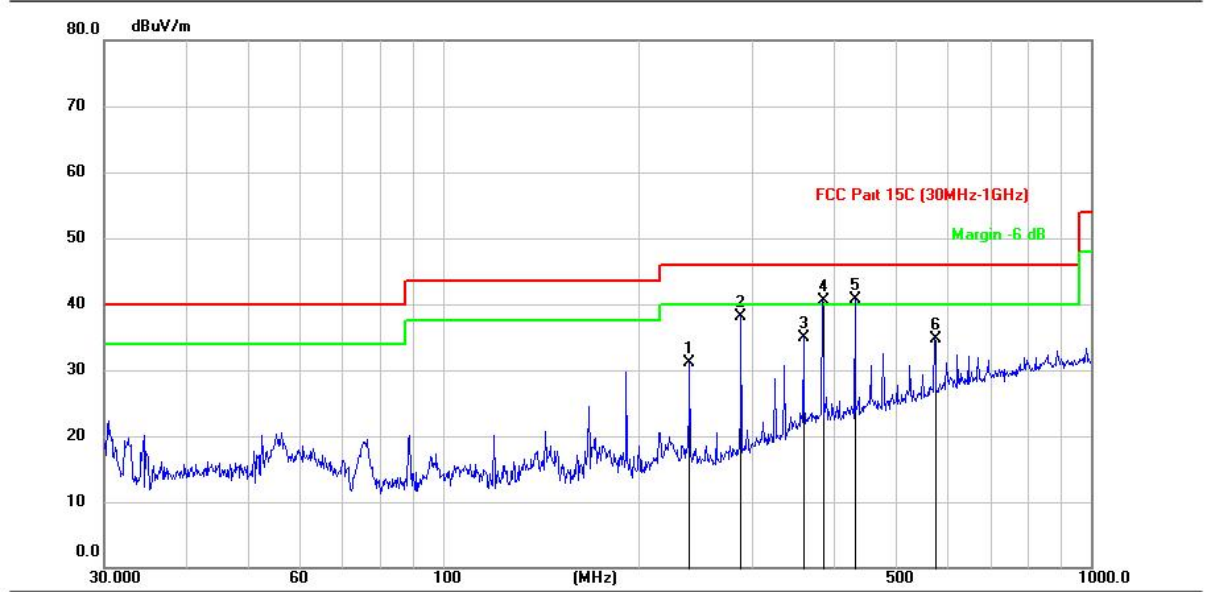

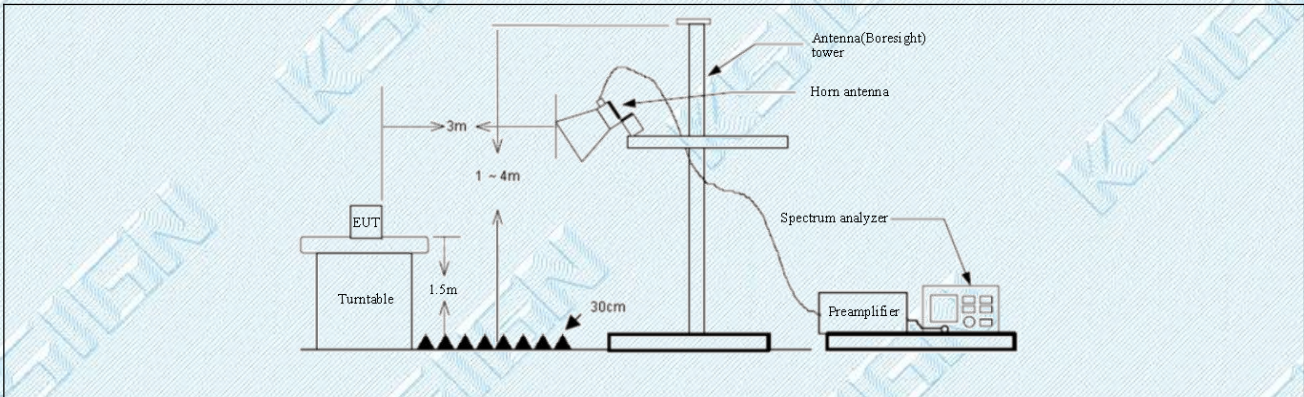

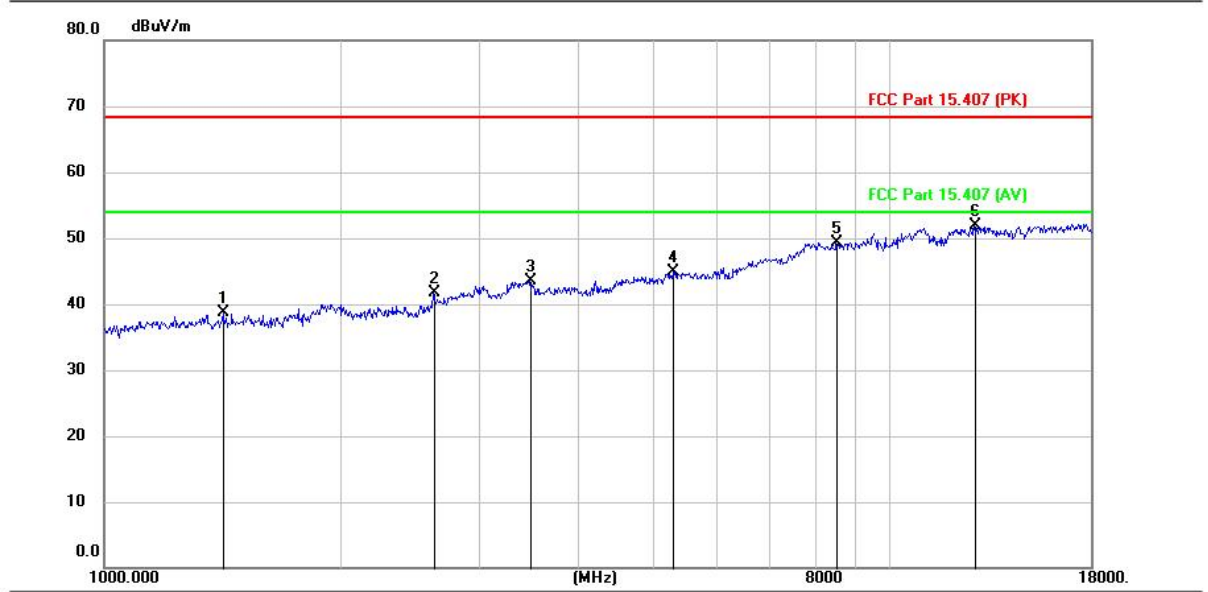

3.11.2. Test Setup Diagram:



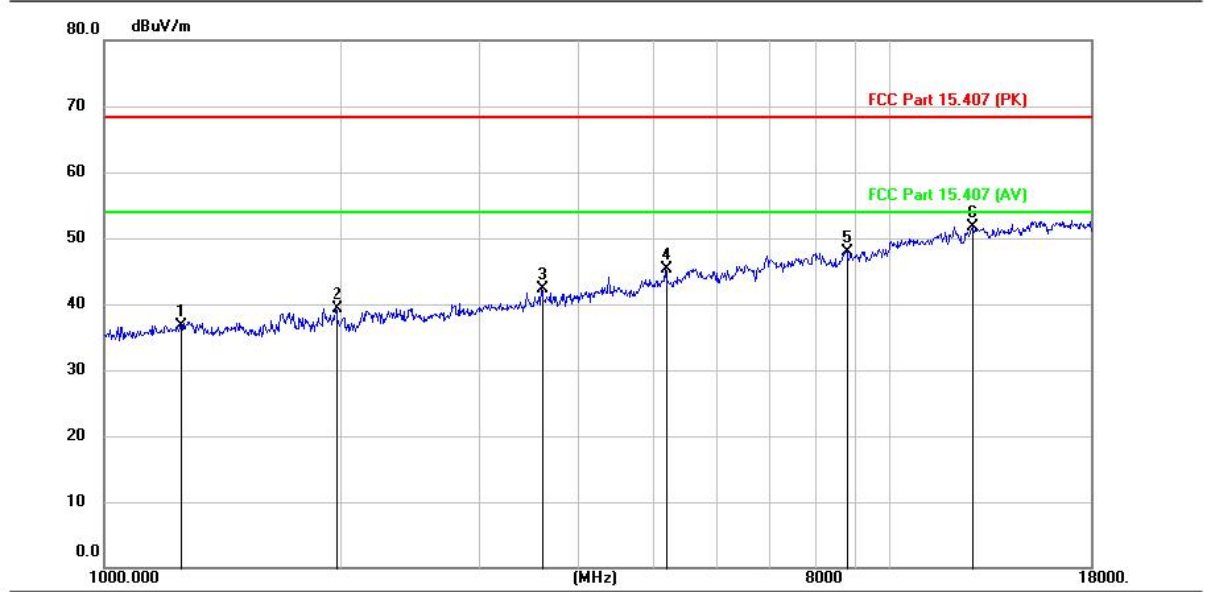
