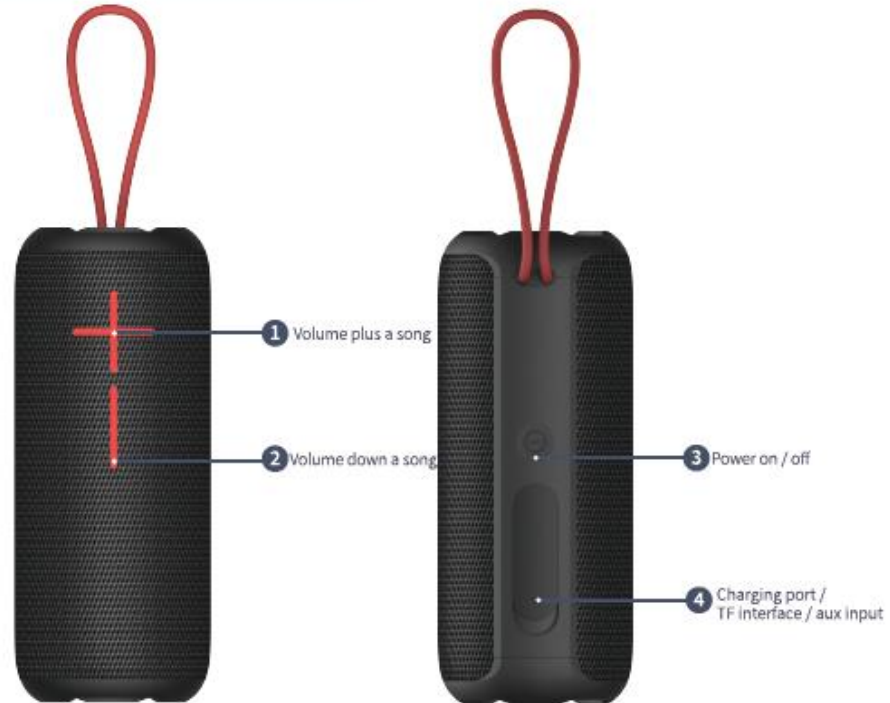

## Instructions for use



- 1 Short press volume plus and long press to switch to the previous song
- 2 Short press volume down, long press to switch to the next song
- 3 Press on / off for a long time; press pause / play briefly
- 4 Insert TF card play function, aux input function, USB charging port

Charging state (the blue light flashes when it is fully charged and goes out when it is fully charged)

## Common problems and precautions

### Can't turn on speaker:

Check whether the speaker has no power, if there is no power, please charge it first.

### Unable to connect with Bluetooth device:

Check whether the speaker is connected to the third Bluetooth device. If it is, disconnect it first. If it still fails to connect, restart it and try again.

- Avoid children exposure.
- Do not knock on the speaker.
- Don't charge for too long, so as not to damage the battery.
- Do not clean the Bluetooth speaker when it is charging.
- Do not force open the built-in battery of the Bluetooth speaker.

### **1.Fail to turn on the speaker?**

Check if the speaker has power.Try to charge it and try again later.

### **2.Fail to connect bluetooth devices?**

Check if it is connected to another bluetooth device. If connected, disconnect and try again. It still doesn't work, try restarting the speaker.

### **3.Whether the speaker is waterproof?**

Useful waterproof speaker, great for in the shower, by the pool, outside etc.

### **4.Can I play music while charging?**

Of course, if you feel that the playing time is not long enough, you can charge the battery while listening to music.

### **5.Does the speaker have a microphone and support calling?**

Yes, the speaker has a built-in microphone and has a hands-free call function. Just short press the power button to answer and hang up calls.

### **6.Does this speaker have automatic shut off to save battery life?**

Right, when you don't listen to music, disconnect your phone 's bluetooth and it will automatically turn off after 15 minutes.Next time you want to listen, turn on the speaker and the phone's bluetooth will automatically connect.
