2.2 Assessment Results

Power density (S) is calculated according to the formula: $S = PG / (4\pi R^2)$ Where S = power density in mW/cm² P = Radiated transmit power in mW G = numeric gain of transmit antennaR = distance (cm)

As we can see from the test report 21100371SHA-001:

The calculations in the table below use the highest gain of antenna for client EUT. These calculations represent worst case in terms of the exposure levels.

The MPE assessment value is 0.0071 < 1.0, therefore, the MPE requirement is deemed to be satisfied without test.



Appendix I

Definition below must be outlined in the User Manual:

To satisfy FCC RF exposure requirements, a separation distance of 20 cm or more should be maintained between the antenna of this device and persons during device operation. To ensure compliance, operations at closer than this distance is not recommended.
