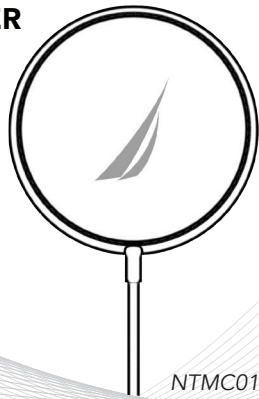

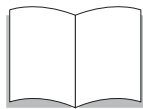

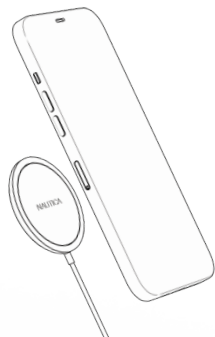

### HOW TO USE

Place your Nautica Magnetic Wireless Charger on a flat, smooth surface. Place your mobile phone on the charger pad and make sure it is aligned in the center.

Failure to align your device in the center of the charger will prevent charging.

Clean your magnetic wireless charger with a soft dry cloth, do not use any chemical detergents. Make sure the charger is unplugged before cleaning.

Do not modify, disassemble and attempt to repair this product. Repairs to electrical equipment should only be performed by a qualified electrician. Improper repairs may place the user at serious risk.

Do not use your magnetic wireless charger for any other purpose than intended.

This product is not a toy. Keep it out of reach of children.

### WARRANTY INFORMATION

We do our best to make sure that this product is free from defects in materials and workmanship for a period of 1 year.

The following conditions must be met for your warranty claim to be approved:

You must have purchased the product from a Nautica or Technofashion authorized dealer.

You must provide proof as to the date of purchase from the Nautica or Technofashion authorized dealer.

You must have used the product only as intended and in accordance with the product's care instructions.

Within 12 months after the purchase, in case the product is determined to be defective (at the date of original purchase) due to improper materials or workmanship, you are entitled to free repair
